IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1956, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby declare that all those portions of Western Australian waters described in the schedule hereto shall be closed against the use of fishing nets for a period of five years from the date of publication hereof.

Schedule.

All those portions of Warnbro Sound, the Indian Ocean and Shoalwater Bay bounded by lines starting from a point on the high water mark of Warnbro Sound, situate in prolongation southerly of the eastern side of June Road, and extending southerly along that prolongation to a line parallel to and half a mile from the high water mark of Warnbro Sound aforesaid; thence generally westerly along that line to its intersection with a line parallel to and one mile from the high water mark of Penguin Island; thence generally southerly, generally westerly, generally northerly and generally easterly along that line to the high water mark of Shoalwater Bay, and thence generally southerly, and generally easterly along that high water mark and the high water mark of Warnbro Sound aforesaid, to the starting point. (Public Plan 341D/40.)

The Proclamation dated 23rd December, 1959, and published in *Government Gazette* (No. 1) of 8th January, 1960, is hereby revoked.

WHEREAS it is enacted by section 5 of the Road Districts Act, 1919, that for the purposes of the said Act the word "Town" or "Townsite" means and includes *inter alia* any land (including privately owned subdivided land) which the Governor may see fit as he is thereby empowered, to declare by Proclamation, to be a town or townsite for the purposes of the said Act; and whereas all that land, situate within the Bruce Rock Road District, more particularly described, defined and delineated in the schedule hereunder, is land which the Governor may by virtue of section 5 of the said Act declare by Proclamation to be a town or townsite for the purposes of the said Act: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council, and in exercise of the power conferred upon me by the said Act, and of all other powers in this behalf enabling me, do hereby declare that all that land situate within Bruce Rock Road District, more particularly described, defined and delineated in the schedule hereto, shall be a townsite, to be known as "Shackleton" within the meaning and for the purposes of the Road Districts Act, 1919.

The Proclamation published in the *Government Gazette* of the 27th April, 1951, at page 1123, is hereby cancelled.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956.

ORDER IN COUNCIL.

M.W.S. 809/60.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct, provide and extend water works, sewerage works and metropolitan main drainage works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect

of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Main Drainage.

Cannington Area.

Cockram Street Main Drain—Pt. Section 1 and Section 2.

Improvement and construction of open channel and pipe drains from the north-eastern side of Albany Highway to the north-eastern side of Railway Parade, Cannington. The above works, together with all other apparatus necessary for the undertaking, as shown on Plan M.W.S.S. & D.D., W.A. No. 8430.

This Order in Council shall take effect from the 16th day of September, 1960.

Stipendiary Magistrates Act, 1957.

ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by subsection (1) of section 10 of the Stipendiary Magistrates Act, 1957, that the Governor may, from time to time, assign to one or more Stipendiary Magistrates any local court or courts, or court or courts of session, or magisterial district or districts for and in which he or they may be required to act, and may, from time to time, revoke or vary those assignments; and whereas by Order in Council made the 20th day of February, 1958, His Excellency the Governor did assign—

- (a) to Maurice Harwood, Stipendiary Magistrate, the Local Courts at Boulder and Kalgoorlie, the Eastern Goldfields Court of Session and the Hannans Magisterial District; and
- (b) to Bernard Matthew O'Sullivan, Stipendiary Magistrate, the Local Courts at Coolgardie, Esperance, Leonora, Norseman, and Southern Cross and the Magisterial Districts of Coolgardie, Collier, Dundas and Esperance:

Now, therefore, His Excellency the Governor, in exercise of the powers conferred by the aforementioned provisions of the said Act, and with the advice and consent of the Executive Council, doth hereby revoke the assignments aforesaid, with effect from the 19th day of September, 1960.

The Constitution Act, 1889-1950.

ORDER IN COUNCIL.

Corres. No. 3844/11.

WHEREAS the enactment contained in section 74 of the Constitution Act, 1889-1950, by which the appointment of all public officers under the Government of the State is vested in the Governor in Council, does not apply to minor appointments, which by Order in Council are vested in heads of departments, or other officers or persons within the State; and whereas it is desirable that the minor appointments of persons who are exempt from the provisions of the Public Service Act, 1904, employed by the Department of Lands and Surveys should be vested in Albert Ernest Heagney (Accountant) and Ronald George Sproxton (Sub-Accountant) and that the like powers vested in William Norman Fingland by Order in Council dated the 23rd May, 1956, shall be cancelled: Now,

therefore, His Excellency the Governor in Executive Council, by and with the advice of the Executive Council, hereby declares that the power of making such minor appointments shall vest and the same is hereby vested in Albert Ernest Heagney (Accountant) and Ronald George Sproxton (Sub-Accountant), and that the like powers vested in William Norman Fingland by Order in Council dated the 23rd May, 1956, shall be cancelled accordingly.

ORDER IN COUNCIL.

Corres. No. 4473/18.

WHEREAS by section 33 of the Land Act, 1933-1958, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that reserve No. 17252 (Dalwallinu Lot 127) and reserve No. 21847 (Kununoppin Lot 65) should, subject as aforesaid, be granted in fee simple to The Congregational Union of Western Australia Incorporated in trust for the purpose of "Church Sites (Congregational)": Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall be granted in fee simple to the aforesaid body to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

Corr. No. 14344/03.—That reserve No. 21780 should vest in and be held by the Wagin Municipal Council in trust for the purpose of a Caravan Park.

(The Order in Council respecting this reserve issued under Executive Council Minute No. 2324, dated the 9th November, 1937, is hereby superseded.)

Corr. No. 668/15.—That Class "A" reserve No. 15962 should vest in and be held by the Quairading Road Board in trust for the purpose of Parklands and Recreation.

WHEREAS by section 33 of the Land Act, 1933-1958, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of sub-leasing; and whereas it is deemed expedient as follows:—

Corres. No. 786/40.—That Class "A" reserve No. 22156 should vest in and be held by the Peppermint Grove Road Board in trust for the purpose of Park and Recreation.

(The previous Order in Council, dated the 24th April, 1940, is hereby superseded.)

Corres. No. 3586/56.—That reserve No. 25747 should vest in and be held by the Dalwallinu Road Board in trust for the purpose of Recreation (Golf Links).

Dunsborough Water Area.

ORDER IN COUNCIL.

P.W.W.S. 517/60.

WHEREAS by the Water Boards Act, 1904, the Governor is empowered, by Order in Council, to constitute the district of a local authority or two or more local authorities or any part or parts of such district or districts a Water Area under such name as may be directed: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council doth hereby constitute an area having the boundaries described in the schedule hereto a Water Area for the purposes of the said Act under the name of the "Dunsborough Water Area."

- (4) In any other position required by a Fire Officer.

If it is impracticable for any reason to clear firebreaks in the position required by this notice, the approval of the Fire Officer must be obtained to provide them in an alternative situation.

Firebreaks in the situations described hereunder will be accepted as complying with the requirements of this notice as far as it applies to the common boundary between the land of any owner or occupier and the abutting lands referred to hereunder:—

- (a) Where the land of an owner or occupier abuts on a declared road and the owner or occupier has burned or cleared the bush between the road formation and the common boundary.

(c) Lead Bonus as per Schedule "B" attached to this Award, subject to automatic increases or reductions as follows:—

(i) The domestic lead price, as quoted by the London Metal Exchange and converted to Australian currency at the ruling rate of exchange at the date of this Award, shall be taken as the norm. For the purposes of this Clause the domestic lead price shall be deemed to be the average of the "spot" and "forward" prices so quoted.

(ii) For each increase or decrease of five pounds (£5) the said bonus shall increase or decrease as the case may be by the sum of three shillings (3s.) per week.

(iii) The bonus shall be adjusted quarterly and such adjustment shall be based on the average realised price of lead which shall be ascertained in accordance with subclause (i) of this subclause on the figures of each calendar quarter.

Any variations in rates of pay made pursuant to the provisions hereof shall take effect as from the beginning of the first pay period commencing in the calendar month following the calendar quarter for which the calculations are made.

(iv) The bonus due shall be added to the wage or piecework earnings of each worker each fortnight.

(v) Hours of overtime worked shall not carry the bonus unless the ordinary hours worked are insufficient to make a full fortnight when the hours of overtime actually worked shall be taken into account to make up the deficiency.

(d) Notwithstanding anything contained in subclause (c) of this Clause should the Commonwealth Government or the State Government of Western Australia at any time after the date of this Award impose a tax or levy on lead or lead concentrates the lead bonus herein referred to shall be calculated as set out in subclause (c), after deducting from the domestic price of lead as provided in subclause (c) hereof the amount of tax or levy above referred to.

(e) Liberty is reserved to the employer to apply to the Court for an amendment of subclause (c) of this clause in the event of the Commonwealth Government or State Government of Western Australia, placing any restriction on the export of lead concentrates.

(2) Clause 13.—Holidays.
