To William John Wallwork, Esq., of 15 Birdwood Parade, Nedlands, in the State of Western Australia, Stipendiary Magistrate:

I, the said Governor, acting with the advice and consent of the Executive Council, do hereby appoint you William John Wallwork, Esq., S.M., to be a Royal Commission to investigate and report upon the following matters:-

- (a) Was any member or were any members of either House of Parliament offered any bribe or other inducement to vote against or not to vote for the Totalisator Agency Board Betting Bill, 1960, or any part thereof?
- (b) If any such member or members was or were offered any such bribe or induce-ment, by whom was it offered, and, if to more than one member, by whom was it offered in each case?
- (c) Was any person offering such bribe or inducement acting for himself or any other person or persons, and, if the latter, who were the persons concerned?
- (d) If it is shown that any such bribe or inducement was offered, what was the amount of the bribe, or the nature of the inducement?

And I hereby declare that by virtue of this Commission you may, in the execution of this Commission, do all such acts, matters and things and exercise all such powers as a Royal Commission or the chairman thereof may lawfully do and

exercise, whether under or pursuant to the Royal Commissioners' Powers Act, 1902-1959, or otherwise.

## Fisheries Act, 1905-1956. PROCLAMATION

WESTERN AUSTRALIA, TO WIT, CHARLES HENRY GAIRDNER, LL.S.J Berry Gairdner, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Vic-torian Order, Knight Commander of the Most Excellent Order of the British Empire, Com-panion of the Most Honourable Order of the Bath, Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

F.D. 87/39, Ex. Co. No. 1883.

IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1956, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters speci-fied in the schedule hereto from 1st January, 1961, to 31st December, 1965, inclusive.

#### Schedule.

1. The whole of the waters of the Channel Entrance to Peel's Inlet (Mandurah) bounded on Entrance to Peel's Inlet (Mandurah) bounded on the north by a line drawn in an easterly direction from the extremity of the western point of en-trance (at the bar) to a point on the mainland on the eastern shore, and on the south by lines drawn in an easterly direction from the south-eastern corner of Murray Location No. 5 to the southern extremity of Channel Island; thence to the south-western extremity of Creety Island and by its southern foreshore to the eastern extremity of that island; thence by a line drawn in a porthof that island; thence by a line drawn in a northeasterly direction to a point on the foreshore of the mainland.

2. The whole of the waters of the Serpentine River, the Murray River and the Dandalup River River, the Murray River and the Dandalup River (including estuaries, tributaries, lakes and lagoons the waters of which during any time of the year have access directly or indirectly to the sea) lying north, east and south-east of a line drawn from a point on the eastern foreshore of Peel's Inlet situated east of the southernmost point of Goon-roolum Island and artending in a water line direction goolup Island and extending in a westerly direction half a mile; thence in a northerly direction to the foreshore of Peel's Inlet to a point lying west of the western side of the entrance to the Serpentine River.

3. The whole of the waters of the Harvey River and that portion of the Harvey Estuary south of a line, being the prolongation easterly to the eastern shore of the estuary of the northern boundary of Murray Location No. 479.

WHEREAS it is enacted by section 115 of the Fac-tories and Shops Act, 1920-1959, that during every Christmas Day, New Year's Day, Good Friday, Anzac Day and Easter Monday and any other day that the Governor may by Proclamation declare to be a public holiday to be observed under the said Act, all shops (except those mentioned in the Fourth Schedule and registered small shops) and Fourth Schedule and registered small shops) and warehouses shall be closed: Now, therefore I, the said Governor, acting with the advice and con-sent of the Executive Council and in exercise of the powers conferred by the said Act, do by this

Proclamation declare that Monday, the 26th day of December, 1960, Tuesday, the 27th day of December, 1960, and Monday, the 2nd day of January, 1961, shall be days to be observed as public holidays under the Factories and Shops Act, 1920-1959, throughout the State with the intent that on the said days all shops (except those mentioned in the Fourth Schedule to the said Act and registered small shops) and ware-houses throughout the State shall be closed houses throughout the State shall be closed.

AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, on the 17th day of November, 1960, the following Orders in Council were authorised to be issued:—

Traffic Act, 1919-1959.

Pingelly Road Board.

ORDER IN COUNCIL.

Police T.O. 58/456.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, hereby makes the following order under section 49 of the Traffic Act, 1919-1959, namely: That the Pingelly Road Board is hereby empowered to make by-laws in pursuance of-

- clause (a) of paragraph (i) of subsection
   (1) of section 47 of the said Act, prescribing the rules to be observed in respect of any vehicle being driven or used on roads, and the use of footpaths;
- (2) clause (y) of paragraph (i) of subsection clause (y) of paragraph (1) of subsection (1) of section 47 of the said Act, provid-ing for the placing, erection or installa-tion on roads or footpaths of traffic signs, lights and directions for the control and direction of traffic, both vehicular and pedestrian, and including the driving of peterstrian, and including the driving of animals, for the marking on roads or foot-paths of signs for the control and direc-tion of the traffic and for the regulation and prohibition of the traffic in relation to the signs, lights and directions;
- (3) clause (zd) of paragraph (i) of subsection (1) of section 47 of the said Act, appoint-ing stands and parking places for dif-ferent classes of vehicles and regulate the use thereof;
- (4) clauses (zl) and (zm) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting or restricting the parking of vehicles or vehicles of a specified class or classes in all roads or in specified roads, or specified parts of roads, at all times or at specified times and at all times or at specified times, and prescribing a penalty for any breach thereof:

subject to the condition that no such by-law shall be valid and effectual unless it has prior to notification of its making being published in the *Government Gazette*, been submitted to and approved by the Governor.
