IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1956, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters specified in the Schedules hereto, from 1st January, 1961, until 31st December, 1965, inclusive.

## First Schedule.

All that area of Western Australian waters in Cockburn Sound commencing at a point on the foreshore one hundred and fifty (150) yards north of Robbs Jetty and extending to a point on the foreshore one hundred and fifty (150) yards south of the said jetty, and extending into the waters aforesaid to a distance of a quarter-of-a-mile from high-water mark.

## Second Schedule.

That area of Western Australian waters in Cockburn Sound commencing at a point on the foreshore one hundred and fifty (150) yards north

of Douro Road, South Fremantle, to a point on the foreshore one hundred and fifty (150) yards south of the said road, and extending into the waters aforesaid to a distance of a quarter-of-a-mile from high-water mark.

#### Third Schedule.

All that portion of the waters of Cockburn Sound (near Rockingham Beach) lying south of a line drawn from the north-western extremity of Point John, intersecting the north-western extremity of the northernmost pier or jetty at Rockingham Beach, and extending to a point on the foreshore at the said Rockingham Beach.

#### Pig Industry Compensation Act, 1942-1957.

WHEREAS by section 15 of the Pig Industry Compensation Act, 1942 (as amended), it is provided that in respect of every sale of any pig or carcass there shall be payable stamp duty of such amount as the Governor may by Proclamation prescribe; and whereas by Proclamation dated the 5th day of June, 1946, and published in the *Government Gazette* of the 14th day of June, 1946, the stamp duty payable in respect of every such sale was prescribed to be one penny for every pound or part of a pound exceeding ten shillings;

and whereas it is now deemed desirable and expedient to cancel and revoke the said Proclamation and in lieu thereof to issue this Proclamation making other provision as hereinafter mentioned: Now, therefore I, the said Governor, do hereby, with the advice and consent of the Executive Council, cancel and revoke the said Proclamation dated the 5th day of June, 1946, and published in the *Government Gazette* of the 14th day of June, 1946, and proclaim in lieu thereof that on and after the 1st day of January, 1961, the stamp duty payable on every sale of any pig or carcass shall be one half-penny for every pound or part of a pound exceeding ten shillings—

- (a) of the amount of the purchase money in respect of one pig or one carcass sold singly; or
- (b) of the total amount of the purchase money in respect of any number of pigs or carcasses as the case may be, sold in one lot;

but so that the stamp duty in respect of the amount of the purchase money of any one pig or any one carcass, as the case may be, whether sold singly or as part of a lot, shall not exceed five shillings.

##### ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1960, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient as follows:—

Corr. No. 6304/97.—That reserve No. 6724 should vest in and be held by the Cuballing Road Board in trust for the purpose of Road Board Requirements.

Corr. No. 716/59.—That reserve No. 25815 should vest in and be held by the Darling Range Road Board in trust for the purpose of Drainage and Road Board Purposes.

Corr. No. 1716/26.—That reserve No. 19210 should vest in and be held by The Fauna Protection Advisory Committee of Western Australia in trust for the purpose of Water and Conservation of Flora and Fauna.

Corr. No. 4604/53.—That reserve No. 23864 should vest in and be held by the Tableland Road Board in trust for the purpose of Sports Ground, Race-course and Caravan Park.

(The Order in Council issued under Executive Council Minute No. 2562, dated 17th December, 1953, is hereby superseded.)

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall vest in and be held by the abovementioned bodies in trust for the purposes aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

## Land Act, 1933-1960.

## ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1960, it is, *inter alia*, made lawful for the Governor, by Order in Council to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section), subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose of which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

Corres. No. 4039/99.—That reserve No. 6656 (Katanning Lot 253) should, subject as aforesaid, be granted in fee simple to John Coventry, Claude Revel Kemble, Harold Norman Wells, Stanley Hamilton Hoglin, Edward Halley Dennis, Arthur William Poett, Albert Edward Wanke, Ernest Malcolm Ladyman, Reginald Clement Escott, Thomas Shaw Robertson, Brian Smith, Ralph Jefferies Patterson and Clarence Harold Eaton as Trustees under the Methodist Church Model Deed of Western Australia, 1912, to be held in trust for the purpose of a "Church Site (Methodist)."

Corres. No. 2086/38.—That reserve No. 21937 (Manjimup Lot 320) should, subject as aforesaid, be granted in fee simple to The Commissioners of the Presbyterian Church in Western Australia, in trust for the purpose of "Church Site (Presbyterian)."

Corres. No. 306/41.—That reserve No. 25719 (Perth Lot 813) should, subject as aforesaid, be granted in fee simple to The State Government Insurance Office, to be held in trust for the purpose of "Use and Requirements of The State Government Insurance Office."

(The Order in Council issued under Executive Council Minute No. 1446, dated 3rd August, 1960, is hereby superseded.)

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserves shall be granted in fee simple to the aforesaid bodies, to be held in trust for the purposes aforesaid, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

## Country Town Sewerage Act, 1948-1954.

## Katanning Sewerage Area.

## ORDER IN COUNCIL.

P.W.W.S. 478/60.

WHEREAS by section 4 of the Country Towns Sewerage Act, 1948-1954, the Governor may, by Order in Council, constitute any part of parts of the State outside the boundaries of the Metropolitan Water, Sewerage and Drainage Area as constituted and defined by the Act No. 43 of 1909 as a Sewerage Area; and whereas by section 4 (f) of the Country Towns Sewerage Act, 1948-1954, the Governor may, by Order in Council, constitute sewerage districts by dividing any sewerage area into sewerage districts under such names as may be directed: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby constitute that part of the State defined in Schedule "A" hereunder a sewerage area and assign the name of "Katanning Sewerage Area" thereto and also doth hereby divide the Katanning Sewerage Area into two sewerage districts, namely:—

(a) No. 1 Katanning Sewerage District;

(b) No. 2 Katanning Sewerage District;

defined in Schedule "B" hereunder.

## Schedule "A."

## Katanning Sewerage Area.

All that portion of land contained within a circle having a radius of five miles with its centre situate within Katanning Townsite at the intersection of the north-western alignment of Albion Street and the south-western alignment of Austral Terrace. As shown on Plan P.W.D., W.A. 38480, bordered red.

## Schedule "B."

## Katanning Sewerage Districts.

## Katanning No. 1 Sewerage District.

All that portion of land contained within the boundaries of Katanning Townsite. As shown on Plans P.W.D., W.A. 38480, bordered blue.

## Katanning No. 2 Sewerage District.

All that portion of land contained within the Katanning Sewerage Area excluding the land contained within the boundaries of Katanning Townsite. As shown on Plan P.W.D., W.A. 38480, bordered green.

## Companies Act, 1943-1959.

## ORDER IN COUNCIL.

WHEREAS it is enacted by subsection (1) of section 28 of the Companies Act, 1943-1959, that no company shall be registered by a name which,

*inter alia*, is identical with that by which a company in existence is already registered under the law relating to companies, or in the opinion of the Registrar of Companies, so nearly resembles that name as to be calculated to deceive; and whereas it is provided, *inter alia*, in proviso (a) to subsection (7) of that section that where in the opinion of the Governor (on being satisfied that it would be inequitable or unreasonable to require a company incorporated outside Western Australia to which Part XI of that Act applies to change its name before complying with the requirements of that Part), it is expedient, the Governor may authorise the Registrar to accept for filing the documents and particulars specified in subsection (1) of section 329 of that Act; and whereas registration under Part XI of the Act of a company incorporated in the State of Victoria by the name of J. C. Taylor & Sons Proprietary Limited was refused by the Registrar on the ground that in his opinion that name so nearly resembles the name by which a company in existence (namely, J. C. Taylor Pty. Ltd.) is already registered under the said Act, as to be calculated to deceive; and whereas His Excellency the Governor is satisfied that it would be inequitable or unreasonable to require J. C. Taylor & Sons Proprietary Limited to change its name before complying with the requirements of that Part of the Act and is of the opinion that the circumstances of the case render it expedient: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by proviso (a) to subsection (7) of section 28 of the Companies Act, 1943-1959, doth hereby authorise the Registrar of Companies to accept for filing from J. C. Taylor & Sons Proprietary Limited the documents and particulars specified in subsection (1) of section 329 of the Act.

WHEREAS it is enacted by subsection (1) of section 28 of the Companies Act, 1943-1959, that no company shall be registered by a name which, *inter alia*, is identical with that by which a firm is registered and is carrying on business under the Business Names Act, 1942-1946, or in the opinion of the Registrar of Companies, so nearly resembles that name as to be calculated to deceive; and whereas it is provided, *inter alia*, in proviso (a) to subsection (7) of that section that where in the opinion of the Governor (on being satisfied that it would be inequitable or unreasonable to require a company incorporated outside Western Australia to which Part XI of that Act applies to change its name before complying with the requirements of that Part) it is expedient, the Governor may authorise the Registrar to accept for filing the documents and particulars specified in subsection (1) of section 329 of that Act; and whereas registration under Part XI of the Act of a company incorporated in the State of South Australia by the name of Tubular Steel Industries Limited was refused by the Registrar on the ground that in his opinion that name so nearly resembles the name by which a firm (namely, Tubular Steel Structures) is already registered and carrying on business under the Business Names Act, 1942-1946, as to be calculated to deceive; and whereas His Excellency the Governor is satisfied that it would be inequitable or unreasonable to require Tubular Steel Industries Limited to change its name before complying with the requirements of that Part of the Act and is of the opinion that the circumstances of the case render it expedient: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by proviso (a) to subsection (7) of section 28 of the Companies Act, 1943-1959, doth

hereby authorise the Registrar of Companies to accept for filing from Tubular Steel Industries Limited the documents and particulars specified in subsection (1) of section 329 of the Act.

## PLANT DISEASES ACT, 1914-1960.

Department of Agriculture,  
South Perth, 7th December, 1960.

I, the undersigned, Minister for Agriculture, being the Minister charged with the administration of the Plant Diseases Act, 1914-1960, acting in exercise of the power in this behalf conferred upon me by section 12 of the said Act, do hereby declare that the notice issued under the provisions of the Act and published in the *Government Gazette* on the 9th day of May, 1958, is cancelled and, for the purposes of subsection (2) of the said section do further declare that the portions of the State of Western Australia as described in the Schedule hereto, are infested with the disease called Fruit Fly (*Ceratitidis capitata*), which is a disease to which section 12 of the said Act and the regulations made under the said Act apply.

## Schedule.

(a) All that portion of the State of Western Australia, bounded on the south by the 33rd parallel of South latitude from the west coast to a point immediately south of Saddleback Hill, on the east by a straight line drawn from that point to a point midway between Baker's Hill and Clackline; on the north by a straight line drawn at right angles to the eastern boundary line from the lastmentioned point to the west coast, and on the west by the west coast; and all that portion of the State of Western Australia bounded on the north by the 33rd parallel of South latitude from the west coast to a point 15 miles east of the Great Southern Railway; on the east by a line commencing at such point and running in a south-easterly direction parallel with the Great Southern Railway to a point which is 15 miles due east of the Great Southern Railway on a line drawn from Cape Clairault on the west coast running due east; on the south by the lastmentioned line from Cape Clairault running due east to a point 15 miles due east of the Great Southern Railway, less the area in paragraph (b) of this schedule described and called the South Suburban District.
