WESTERN AUSTRALIA.

No. 26 of 1960.

Between Hospital Employees' Industrial Union of
Workers, W.A., Applicant, and Home of Peace
(Incorporated), Respondent.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement an Award of the Court: Now, therefore, the Court pursuant to Section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling it hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court:—

Memorandum of Agreement.

(Note.—Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

1.—Title.

This Award shall be known as the "Hospital Employees' (Home of Peace) Award" and replaces Award No. 27 of 1956.

3.—Term.

The term of this Award shall be for a period of three (3) years as from the beginning of the first pay period commencing after the date hereof.

4.—Area.

This Award shall be limited to the area occupied by the Home of Peace (Incorporated).

5.—Definitions.

"Orderly" shall be any male worker not covered by any other Award employed in and/or around a hospital or other institution who is not otherwise classified in this Award.

6.—Hours.

Laundry Workers.—Forty (40) hours shall constitute a week's work. Such hours shall be worked in five (5) days of eight (8) hours each, Monday to Friday inclusive.

All Others.—Forty (40) hours shall constitute a week's work and shall be worked on any five (5) days of the week; provided that eighty (80) hours may be worked in ten (10) days each fortnight at the option of the employer.

7.—Spread of Shifts.

No more than three breaks shall be allowed in any one shift, including meal breaks, and the spread of the shift shall not exceed eleven (11) hours.

"Spread of the shift" shall mean the period of time which elapses from the time when a worker signs on duty for the day and the time he signs off duty on that day or the day immediately following.

8.—Rosters.

(a) A roster shall be posted in a convenient place where it can be readily seen by the workers concerned, setting out the time each worker starts and finishes each shift and also each break in the shift together with the days each worker is booked off duty.

(b) When a worker is rostered off duty for any meal it shall not be for a lesser period than thirty (30) minutes for each meal.

(c) The roster shall be posted at least forty-eight (48) hours before the time it comes into operation and shall only be altered on account of any contingency that the employer could not reasonably foresee, and such altered time shall then become the rostered time.

9.—Overtime.

(a) All time worked in any day in excess of the time for which the worker is rostered shall be regarded as overtime and paid for at the rate of time and a half for the first two (2) hours and thereafter double time, provided that if the overtime is occasioned through the failure of another worker to report for duty, equivalent time off duty may be granted in lieu of paying for overtime.

(b) Workers required to work on any day on which they are rostered off duty shall be paid at the rate of double time for all time worked.

(c) Notwithstanding anything contained herein:—

(i) an employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement;

(ii) no organisation, party to this Award or worker or workers covered by this Award shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.

10.—Record.

(a) A time book, or books, or records, to be open for inspection by the Union Secretary, or his nominee at any reasonable time shall be provided. Each worker must record in such books the exact time he or she starts and finishes duty on each day and also the time booked off for meals or breaks in shifts.

(b) A wages sheet which shall clearly show the aggregate wage, deductions made, and cash paid to each worker, shall be kept at the head office of the institution, and shall be open for inspection by the Union Secretary or his nominee at all reasonable times.

11.—Holidays.

(a) The following days shall be observed as holidays, namely:— New Year's Day, Easter Monday, or Good Friday, at the option of the employer, Anzac Day, Labour Day, Christmas Day, and Boxing Day, provided that at the option of the employer one other day may be observed in lieu of either Christmas Day or Boxing Day. Any worker required to work on any of the foregoing days shall be paid for the time so worked at the rate of double time with a minimum of four (4) hours' ordinary time, or shall have one day added to his annual holiday for each day so worked, at the option of the employer.

(b) If any of these foregoing public holidays fall on a day on which a worker is rostered off duty such worker shall be granted an additional day off in lieu thereof.

(c) A holiday of three (3) weeks on full pay shall be granted to each worker on the completion of each year of service. A worker not completing one year of service shall be granted pay in lieu of holidays in proportion to the length of his or her service. Provided always that if the worker be dismissed for misconduct or any offence or illegally severs the contract of service, no payment for annual leave or holidays will be granted. A worker who has not completed one month's continuous service shall not be entitled to the benefits of this subclause.

(d) Before going on annual leave each worker shall be given at least two (2) weeks' notice of the date when such leave is to commence and such leave shall be taken in an unbroken period.

(e) Leave shall be paid for in advance at the rate of wage the worker has received for the greater proportion of the calendar month prior to his taking the leave.

12.—Sick Leave.

(a) Sick leave with pay shall be granted on the following scale on production of a medical certificate or, in regard to leave not exceeding two (2) days, other evidence satisfactory to the management.—

Workers with less than six (6) months' service—Nil.

Workers with six (6) months' and less than one (1) year's service—14 days.

Workers with one (1) year's and less than two (2) years' service—28 days.

Workers with two (2) years' service and over—42 days.

(b) The total sick leave in any one triennial period shall not exceed forty-two (42) days; the triennial period to be the three (3) years preceding the date of illness for which leave is claimed.

(c) No payment for sick leave shall be made when the illness is due to the worker's own misconduct or to an accident met with off duty.

(d) Sick leave, if granted, will only be recognised provided a medical certificate be placed in the hands of the hospital secretary within forty-eight hours of the rostered time for commencement of duty.

(e) The foregoing paragraphs of this clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(f) If the absence exceeds one week, the employment shall be deemed to have terminated after the expiration of the first week's absence, without prejudice to the worker's rights under the other paragraphs of this clause.

13.—Uniforms.

(a) All uniforms, i.e., uniformity of dress, shall be supplied free of cost to all workers required to wear them. Aprons shall be provided for all female workers on the kitchen and general staff.

(b) Suitable clothing shall be provided for all men on "dirty work."

(c) Boots shall be available for kitchenmen.

(d) Oilskin coats shall be provided for workers compelled to work in the rain.

(e) Laundry.—All washable clothing forming part of the uniform supplied by the employer shall be laundered free of cost to the worker.

(f) Safety Appliances.—Rubber gloves, gowns and a ready supply to suitable disinfectant or antiseptic shall be available to all workers who handle infectious cases or patients suspected to be suffering from any infectious disease.

14.—Contract of Service.

(a) Subject as hereinafter provided, no employee shall be dismissed unless he or she has received fourteen (14) days' previous notice of his or her dismissal or pay for such period in lieu thereof.

(b) No employee shall, without the consent of the employer, resign without first having given fourteen (14) days' previous notice of his or her intention so to do; and in the absence of such notice the employer may withhold holiday or other pay up to the amount of fourteen (14) days' wages.

(c) The employer may at any time without prior notice dismiss a worker for refusal or neglect to obey orders or for misconduct, or if after receiving the notice prescribed in subclause (a) hereof the worker does not carry out his or her duties in the same manner as he or she did prior to such notice.

(d) The employer shall be under no obligation to pay for any day not worked upon which the worker is required to present himself or herself for duty, except such absence from work is due to illness and comes within the provisions of Clause 12 (Sick Leave) or such absence is on account of holidays to which the worker is entitled under the provisions of this Award.

(e) The preceding provisions of this clause shall not apply to casual workers. One day's notice shall be sufficient to terminate the services of a casual worker, except where such a worker is dismissed for misconduct.

15.—Accommodation.

(a) Resident employees shall be provided with suitable healthy accommodation. The Union Secretary or his nominee shall be permitted to inspect the accommodation at all reasonable times and in the event of a dispute arising with respect to the suitability of the accommodation it shall be referred to the Board of Reference for decision. Provided that whether any employee lives in shall be a matter which shall be left to the decision of the employer.

A sitting room suitably furnished and sufficiently large to accommodate the resident staff shall be provided for their common use, provided that this shall apply only where there are four (4) or more domestics employed and living in.

Laundry facilities shall be available to all resident staff for the laundering of private clothes.

(b) Suitable dressing rooms shall be provided for all non-resident staff.

16.—Payment of Wages.

(a) Wages shall be paid fortnightly, and overtime, if any, shall be paid at least monthly.

(b) Overtime rates shall be calculated and based upon the aggregate wage, i.e. the amount provided for in the wages schedule before any deduction is made for board and/or lodging.

(c) A worker who is required to do work which carries a higher minimum rate than that which such worker usually performs shall be entitled to the higher minimum rate while so employed, provided that if engaged in such higher grade of work for more than half a day he shall be paid at the higher rate for the day.

(d) All workers engaged for a period of less than six (6) days in any one week shall be paid at the rate of ten per cent. (10%) in addition to the rates hereunder prescribed with a minimum engagement of one day; provided that this shall not apply in the case of a worker summarily dismissed for misconduct.

17.—Wages.

The minimum rates of wages payable to workers covered by this Award shall be as follows:—

18.—Deductions and Allowances.

(a) Where board and/or lodging is provided for a worker the employer shall be entitled to deduct in respect to each worker the following amounts:—

- (i) for full board an amount equal to 18.5 per cent. of the male basic wage.
- (ii) for lodging an amount equal to seven (7) per cent of the male basic wage.

(b) Where workers are provided with meals by the employer a deduction shall be made at the rate of one twenty-first (1/21st) of the value for board for each meal provided.

(c) The board and lodging allowances prescribed by this clause shall vary proportionately with the rise or fall in the basic wage.

19.—No Reduction.

Nothing contained in the Award shall operate to reduce the wage of any worker who at the date of this Award is being paid a higher rate of wage than the minimum prescribed for his or her class of work.

20.—Junior Workers.

(i) The proportion of male juniors shall be one (1) to every eight (8) adults or part thereof.

(ii) The proportion of female juniors shall be one (1) to every six (6) adults or part thereof.

21.—General Clauses.

(a) No female worker shall be called upon to clean male lavatories in or about an institution.

(b) A worker required to take a day off duty not already shown on the roster for such day must be informed before booking off on the day previous.

(c) Space shall be provided in the workers' dining rooms or lunch rooms for the purpose of posting Union notices and a copy of this Award.

22.—Under-rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

23.—Board of Reference.

(a) The Court hereby appoints for the purpose of this Award a Board of Reference.

(b) The Board shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties.

(c) There are assigned to such Board, in the event of no agreement being arrived at between the parties to the Award, the function of—

- (i) adjusting any matters of difference which may arise between the parties from time to time except such as involve interpretation of the provisions of the Award or any of them.
- (ii) deciding any other matter that the Court may refer to such Board from time to time.

(d) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

24.—Week-end Penalty Rates.

When work performed on Saturdays or Sundays is part of a worker's ordinary hours of duty, he shall be paid for all time worked between midnight on Friday and midnight Saturday at the rate of twenty-five per cent (25%) extra, and for all work performed between midnight Saturday and midnight Sunday he shall be paid at the rate of fifty per cent. (50%) extra.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement on Award of the Court: Now, therefore, the Court, pursuant to section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court.

Memorandum of Agreement.

(Note.—Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

1.—Title.

This Award shall be known as the Metal Trades (Metropolitan Perth Passenger Transport Trust) Award.

2.—Arrangement.

3.—Area.

This Award shall have effect over that portion of the State known as the South-West Land Division.

4.—Scope.

This Award shall apply to the workers classified in clause 27 hereof employed by the respondent.

5.—Term.

The term of this Award shall be for a period of one (1) year from the beginning of the first pay period commencing after the date hereof.

6.—Definitions.

(a) "Tradesman" means a worker, not being an apprentice, who in the course of his employment works from drawings or prints, or makes precision measurements or applies general trade experience.

(b) "Welder—Special Class" means a tradesman using electric arc and/or oxy-acetylene equipment and who is required to and is competent to apply general trade experience in welding all the following classes of metals:—Mild steel, stainless steel, cast iron, aluminium, copper, brass, diecast metal.

(c) "First Class Welder."—First class welder means a worker using electric arc or acetylene, petrol or coal gas blow pipe on any work other than—

- (a) filling castings; or
- (b) cutting scrap metal; or
- (c) welding with the aid of jigs; or
- (d) operations specifically mentioned as being the work of a second, third or fourth class welder in the definitions of those terms hereunder.

(d) "Second Class Welder."—Second class welder means a worker who—

- (a) uses any of the foregoing types of welding apparatus in filling castings; or
- (b) welds with the aid of jigs; or
- (c) operates automatic welding machines for the setting up of which he is not responsible; or
- (d) operates a profile cutting or a straight line cutting machine.

(e) "Third Class Welder."—Third class welder means a worker who uses any of the foregoing types of welding apparatus in tacking preparatory to the completion of work by any other worker.

(f) "Fourth Class Welder."—Fourth class welder means a worker using an electric spot or butt welding machine, or cutting scrap with oxy-acetylene blow pipe, petrol or coal gas blow pipe.

7.—Mixed Functions.

A worker engaged for more than four hours on any one day or shift on duties carrying a higher rate than his ordinary classification shall be paid the higher rate for such day or shift. If employed for four hours or less on any one day or shift he shall be paid the higher rate for the time so worked.

8.—Contract of Service.

(a) (i) The contract of service of all workers, except as hereinafter provided, shall be by the week and shall be terminable by one week's notice on either side or by the payment or forfeiture of one week's wages by the Trust or the worker concerned, as the case may be.

(ii) During the first month of employment the contract of service shall be by the day and during this period shall be terminable by one day's notice on either side, or by the payment or forfeiture of one day's wages, as the case may be.

(b) In the case of dismissal for serious and wilful misconduct, the reason for such dismissal must be given in writing.

(c) By agreement between the Trust and the worker concerned, the notice of payment prescribed herein may be varied either in whole or in part.

(d) This clause does not affect the right to dismiss for serious and wilful misconduct.

9.—Payment for Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the Trust in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from the Trust for any time lost through the result of an accident not arising out of or in the course of his employment or for any accident wherever sustained arising out of his own wilful default or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to the Trust for sickness, but the Trust shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) Sick leave shall accumulate from year to year so that any balance of the periods specified in subclause (a) of this clause which has in any year not been allowed to any worker by the Trust as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by the Trust in any subsequent year without diminution of the sick leave prescribed in respect of that year.

(e) For the purpose of this clause "calendar year" means a year from the 1st January to 31st December.

10.—Annual Leave and Holidays

(a) In addition to their annual leave, all workers other than casuals shall be granted the following holidays:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day, Boxing Day, and any other day proclaimed as a general public holiday.

(b) Any worker required to work on any of the days prescribed in subclause (a) hereof shall be paid for such time at the rate of double time.

(c) If any award holiday falls within a worker's period of annual leave there shall be added to that period one (1) day on which he shall be deemed to have worked for each such holiday observed.

(d) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(e) Except as hereinafter provided a period of two (2) consecutive weeks' leave on ordinary wages as prescribed shall be allowed annually to a worker by the Trust after a period of twelve (12) months' continuous service.

(f) Subject to subclause (i) of this clause if a worker after one (1) month's continuous service in any twelve (12) monthly qualifying period lawfully leaves his employment or his employment is terminated by the Trust, the worker shall be paid for such proportion of the appropriate period of annual leave set out in the preceding subclause as the number of completed months of his service in that qualifying period bears to the full qualifying period of twelve (12) months.

(g) Where the Trust closes down any of its sections either wholly or partially over Christmas and New Year for the purpose of annual leave, workers employed in such sections with less than a full year's leave due will only be entitled to payment during such period for the amount of leave due to them.

(h) Workers shall be paid for annual leave at their classified rates of pay when such annual leave is taken. Provided that if within two (2) weeks before such annual leave is taken the worker is acting in a higher capacity and has been so acting for a period of not less than two (2) months continuously, the annual leave shall be paid for at the rate applicable to such higher capacity position.

(i) A worker who is dismissed for serious and wilful misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of subclause (f) of this clause.

11.—Apprentices.

(a) The employment of apprentices shall be governed by the Apprenticeship Regulations, 1953, which are deemed to be embodied in and form part of this Award.

(b) Apprentices may be taken to the following trades or callings, namely: Electrical Fitting, Fitting and/or Turning, Motor Mechanics, First Class Welding, Blacksmithing and Battery Fitting.

12.—Shop Stewards.

Subject to the recognition of properly constituted authority, shop stewards to be appointed by the Union shall be recognised by the Trust.

13.—Maximum Rate.

Notwithstanding anything contained in this Award to the contrary, no time of duty whatsoever shall be required to be paid for more than double time rate.

14.—Hours.

(a) The ordinary working hours shall not exceed forty (40) in any one week nor eight (8) in any one day.

(b) (i) Except as hereinafter provided, the ordinary hours shall be worked in five days, Monday to Friday inclusive and except in the case of shift workers, between the hours of 7 a.m. and 5 p.m.

(ii) At running depots the ordinary hours shall be worked in five days, Monday to Friday inclusive, and except as hereinafter provided, or in the case of shift workers, shall be worked between the hours of 7 a.m. and 5 p.m. Provided that in order to meet traffic requirements workers other than shift workers may be required to commence day work not earlier than 6 a.m. or to finish such work not later than 5.30 p.m.

(iii) Work performed before 1 a.m. Saturday shall be deemed to be part of the Friday shift.

(c) Meal interval shall not exceed one (1) hour.

(d) Where shifts are worked these shall rotate as far as practicable.

15.—Guaranteed Week.

(a) All workers shall be guaranteed a full week's work, but if during any period by reason of any action on the part of any section of the Trust's workers, or for any cause beyond the control of the Trust it is unable to carry on either wholly or partially the complete running of buses, workshops or other normal operations, the Trust shall be entitled to employ only such workers (if any) it considers can be usefully employed and for such hours as it considers necessary, and during such period no worker shall be entitled to payment except for work actually performed provided that workers who are required to attend for work and do so attend as required on any day, shall be paid a minimum of one (1) day's pay at ordinary rates.

(b) Any worker stood down in accordance with the foregoing provision shall not lose any sick leave credit or other rights or privileges to which such worker would ordinarily be entitled under this Award, provided such a worker resumes work as required after such stand down and provided

further that this provision does not entitle a worker to payment for any holiday occurring during such period of stand down.

16.—Overtime.

(a) Except as hereinafter provided, all time worked outside the ordinary hours of duty on any day shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) Overtime on shift work shall be based on the rate payable for shift work.

(c) All time worked on Sundays shall be paid for at the rate of double time.

(d) (i) Rest Period after Overtime.—When overtime is necessary, it shall, wherever reasonably practicable, be so arranged that workers have at least eight (8) consecutive hours off duty between the work of successive days.

(ii) A worker who works so much overtime between the termination of his ordinary work on one day and the commencement of his ordinary work on the next day that he has not at least eight (8) consecutive hours off duty between those times shall, subject to this subclause, be released after completion of such overtime until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.

(iii) If on the instructions of the Trust, such a worker resumes or continues work without having had such eight (8) consecutive hours off duty, he shall be paid at double rates until he is released from duty for such period and he shall then be entitled to be absent until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.

(e) The Trust may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(f) When a worker is recalled to work after leaving the job he shall be paid for at least two (2) hours at overtime rates. Provided that the worker shall not be obliged to work for the two (2) hours if the job for which he has been recalled has been completed in less time.

(g) All time worked by any worker during his meal interval in excess of fifteen minutes shall be paid for at overtime rates and such rates shall continue until the worker is able to have a meal.

(h) When a worker is required to hold himself in readiness for a call to work after ordinary hours, he shall be paid at ordinary rates for the time he so holds himself in readiness.

(i) (i) A worker required to work overtime for more than two (2) hours, without being notified on the previous day or earlier that he will be so required to work, shall be supplied with a meal by the Trust or paid five shillings (5s.) for a meal.

(ii) If the amount of overtime required to be worked necessitates a second or subsequent meal, the Trust shall, unless it has notified the workers concerned on the previous day or earlier that such second or subsequent meal will also be required, provide such meals or pay an amount of three shillings and fourpence (3s. 4d.) for each such second or subsequent meal.

(iii) No such payments need be made to workers living in the same locality as their workshops who can reasonably return home for such meals.

(iv) If a worker in consequence of receiving such notice has provided himself with a meal or meals and is not required to work overtime, or is required to work less overtime than notified, he shall be paid the amounts above prescribed in respect of the meals not then required.

17.—Shift Work.

(a) The Trust may, if it so desires, work any part of its establishment on shifts, but before doing so shall give notice of its intention to the Union.

(b) Where any particular work is carried out on shifts other than day shift and less than five consecutive afternoon shifts are worked on that work, then workers employed on such afternoon shifts shall be paid at overtime rates. The sequence of work shall not be deemed to be broken by reason of the fact that work is not carried out on a Saturday or Sunday or on any holiday.

(c) Any worker employed on an afternoon shift shall be paid five per cent., in addition to his ordinary rate.

18.—Preference.

(a) Preference of employment shall be given to suitable members of the Unions parties to this Award. Provided that any worker or applicant for employment who furnishes proof that he is a financial member of any other registered industrial union of workers shall, subject to the provisions hereinafter contained, be given equal preference.

(b) Any worker or applicant for employment who is not a member of any Union party to this Award or of any other registered industrial union of workers, shall within fourteen (14) days of commencing employment under this Award apply in accordance with its rules to become a member of an appropriate union party to this Award, and any worker who is not a member of any union party to this Award but is a member of another registered industrial union of workers shall, within fourteen (14) days from the expiration of his then current membership with such other union, apply to become a member of an appropriate union party to this Award.

(c) The provisions of this clause shall not debar from employment or continuance in employment any applicant for employment or any worker whose application to become a member of an appropriate union party to this Award has been refused by such union without reasonable cause, unless and until such refusal is withdrawn.

(d) Any worker or applicant for employment who becomes a member of any union, a party to this Award, shall continue his financial membership of such union in accordance with its rules, while he continues to be employed under this Award.

(e) The Trust shall within fourteen (14) days of being advised in writing by any Union party to this Award of the breach by a worker of the provisions of this clause determine the employment of any worker who fails to comply with the provisions of this clause unless such breach is remedied by the worker concerned within such fourteen (14) days. Any dispute as to whether a worker has committed a breach of this clause may be referred to a Board of Reference by either the Trust or the Union concerned.

(f) The provisions of this clause shall not apply to any worker who objects on the grounds of conscientious religious belief to being a member of an industrial union of workers, so long as such worker, from time to time, pays to a charitable organisation nominated by the Court an amount equivalent to the subscription and levies prescribed by the rules of the appropriate union to be paid by members of that Union.

(g) Should any dispute arise as to the conscientious religious beliefs of any worker or applicant for employment the same shall be referred to a Board of Reference appointed under the Award.

19.—Board of Reference.

(a) The Court appoints for the purpose of the Award a Board or Boards of Reference. Each Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties. There are assigned to each such Board, in the event of no agreement being arrived at between the parties to the Award, the functions of—

(i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award or any of them;

- (ii) deciding any other matter that the Court may refer to such Board from time to time.

(b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

20.—Special Rates and Provisions.

(a) Leading Hands.—A leading hand placed in charge of—

- (i) not less than three (3) and not more than ten (10) other workers shall be paid at the rate of nineteen shillings (19s.) per week extra;
- (ii) more than ten (10) and not more than twenty (20) other workers shall be paid at the rate of thirty-eight shillings and sixpence (38s. 6d.) per week extra;
- (iii) more than twenty (20) other workers, shall be paid at the rate of fifty-seven shillings and sixpence (57s. 6d.) per week extra.

(b) Height Money.—Workers engaged in the erection of steel frame buildings, bridges and gasometers at a height of fifty feet (50 ft.) or more above the nearest horizontal plane shall be paid at the rate of two shillings (2s.) per day extra.

(c) Dirt Money.—Three pence (3d.) per hour extra shall be paid to workers when engaged on work of an unusually dirty nature, where clothes are necessarily unduly soiled or injured or boots are unduly injured by the nature of the work done.

(b) A tradesman not employed as a first-class welder, who in addition to his employment as such is also required to do welding, shall be entitled to receive one shilling and fourpence (1s. 4d.) per day in addition to his ordinary rates of pay whilst so engaged. A worker entitled to payment under this paragraph shall not be entitled to claim extra pay for welding under the higher duties clause of this Award.

(e) (i) The employer shall have available a sufficient supply of protective equipment (as, for example, hand screens, goggles, glasses, gloves, aprons, leggings and gum boots) for use by his workers when engaged on work for which some protective equipment is reasonably necessary. It shall be a defence to an employer charged with a breach of this subclause if he proves he was unable to obtain either the item of equipment the subject of the charge or a suitable substitute.

(ii) The Trust may require a worker to sign an acknowledgment on receipt of any article of protective clothing or equipment and he shall return same to the Trust when he has finished using it or on leaving its employment.

(iii) No worker to whom clothing or equipment has been issued under paragraph (ii) hereof shall lend another worker any such article of protective clothing or equipment issued to such first-mentioned worker, and if the same are lent both the lender and the borrower shall be deemed guilty of wilful misconduct.

(iv) Before goggles, glasses or gloves or any such substitutes which have been used by a worker are re-issued by the employer to another worker, they shall be effectively sterilised.

(v) During the time any article of protective clothing or equipment is on issue to a worker he shall be responsible for any loss or damage thereof, fair wear and tear attributable to ordinary use excepted.

(f) Confined Space.—Eightpence (8d.) per hour extra shall be paid to workers when working in "confined space," which means: A compartment or space the dimensions of which necessitate a worker working in a stooped or otherwise cramped position, or without proper ventilation.

(g) Except where otherwise expressly provided, not more than one of the foregoing allowances or extra rates shall be paid at any one time and where more than one allowance or extra rate applies only the highest shall be paid.

21.—Under-rate Workers.

(a) Any worker who, by reason of old age or infirmity is unable to earn the minimum wage, may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the Trust.

(b) In the event of no agreement being arrived at the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

22.—Complaints and Charges against Workers.

(a) When any complaint as to the conduct of any worker is received by the Trust or when any officer of the Trust charges any worker with any misconduct or breach of duty the officer of the Trust responsible for dealing with such complaint or charge shall first cause to be made a preliminary investigation of the circumstances. If as a result of such investigation the officer concerned is of the opinion that such complaint or charge may be true and is not so trivial a nature as not to warrant any action, he shall require the worker concerned to attend before him to explain the incident or circumstances relating to the complaint or charge.

(b) Any worker required under the provisions of subclause (a) to explain the incident or circumstances relating to a complaint or charge may, if he so desires, be accompanied by an official of the Union of which he is a member.

(c) The officer dealing with the complaint or charge shall give to the worker full particulars of the complaint or charge and, if in his opinion, it is of so serious a nature as likely if proved true to result in the dismissal of the worker shall also give to the worker the name and address of the person making the complaint or charge and, in any case before coming to any final decision on the matter, shall allow the worker (if desired) reasonable time to bring before such officer any other worker or member of the public who may have any knowledge of the facts.

(d) Any worker aggrieved by a decision of the officer dealing with a complaint or charge shall have the opportunity to bring all the facts relating thereto before the Chairman of the Trust and in so doing may have the assistance of an official of the Union of which he is a member.

(e) No record prejudicial to a worker shall be made on his conduct record card unless the provisions of this clause have first been complied with.

23.—Right of Entry.

Accredited representatives of the applicant Unions desiring to enter premises of the Trust must first make application to the responsible officers of the section, stating the nature of their business.

24.—Passes.

Each worker shall be issued with a pass to be available over all routes operated by the Trust and subject to such conditions as may be prescribed from time to time by the Trust.

25.—Long Service Leave.

The conditions relating to long service leave for full time Government wages employees generally as in force as at the date of this Award and as may be amended from time to time shall apply to all workers employed under the provisions of this Award.

26.—Payment of Wages.

Wages shall be paid weekly.

27.—Rates of Wages.

The minimum rates of wages payable to workers covered by this Award shall be as follows:—

Between Hospital Employees' Industrial Union of Workers, W.A., Applicant, and Home of Peace (Incorporated), Respondent.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement an Award of the Court: Now, therefore, the Court pursuant to Section 65 of the Industrial Arbitration Act, 1912-1952 and all other powers therein enabling it hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court:—

Memorandum of Agreement.

(Note.—Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

1.—Title.

This Award shall be known as the "Nursing Assistants' (Home of Peace) Award," and replaces Award No. 28 of 1956.

3.—Scope.

This Award shall apply to Nursing Assistants and Nursing Aides, employed by the Home of Peace (Incorporated).

4.—Term.

The term of this Award shall be for a period of three (3) years as from the beginning of the first pay period commencing after the date hereof.

5.—Area.

This Award shall have effect over the area occupied by the Home of Peace (Incorporated).

6.—Definitions.

(a) The term "Nursing Assistant" shall mean and include a female person other than a registered nurse or trainee as defined by Award No. 19 of 1958 who is employed in assisting in nursing duties and/or giving attention and care to the sick, aged and infirm persons, or to the care and attention of children in hospitals.

(b) The term "Nursing Aide" shall be a female person as defined by the Nurses Registration Act, who is employed in nursing duties and/or giving

attention and care to the sick, aged and infirm persons, or to the care and attention of children in hospitals.

(c) "Adult" shall mean a person of not less than 19 years of age.

(d) "Union" shall mean the Hospital Employees' Industrial Union of Workers, W.A.

7.—Hours.

Forty hours exclusive of meal times shall constitute a week's work and shall be worked on any five (5) days of the week. Provided that eighty (80) hours may be worked in ten (10) days each fortnight at the option of the employer.

8.—Overtime.

(a) All time worked in excess of the ordinary working time shall be paid for at the rate of time and a half for the first eight (8) hours and double time thereafter or, if the employer and the employee so agree, time off in lieu thereof shall be granted at the convenience of the hospital: Provided, however, that such time off shall be in unbroken periods according to each period of overtime worked; and also provided that the overtime is made up within twenty-eight (28) days from the time when it becomes due, except where it applies to the change over from night to day duty, or day duty to night duty.

(b) Less than thirty (30) minutes' overtime for a week or a fortnight, as the case may be, shall not be paid for.

(c) For the purpose of calculating the overtime rate, board and lodging assessed in accordance with clause 18 shall be added to the prescribed cash wage of junior workers.

(d) No overtime shall be paid for unless such overtime was worked by direction of the management of the hospital.

9.—Annual Leave.

(a) Every worker covered by this Award, where not otherwise provided for, shall be entitled to four weeks' leave on full pay for each twelve (12) months' service.

(b) A worker with more than one month's service, who may resign or be dismissed, shall be entitled to pay for annual leave pro rata up to the time of her leaving the service in such proportion as her period of employment bears to the number of days in the year.

(c) In addition to her salary, the worker on leave shall, where board and lodging allowance as prescribed by clause 18 is not included in the salary, be entitled to receive such allowance for the period of her leave.

(d) Every worker shall receive at least seven (7) days' previous notice of the commencement of her leave.

(e) (i) Leave shall be paid for in advance at the rate of salary the worker is receiving at the time of taking such leave.

(ii) Leave shall be given as soon as practicable after falling due. The leave of a nurse assistant shall not accumulate except with the consent of the nurse assistant, and in no case shall it accumulate for more than two (2) years.

(f) Any worker who is dismissed for misconduct or who illegally severs her contract of service, shall not be entitled to the benefits of the provisions of this clause.

10.—Sick Leave.

(a) In the case of illness, provided a satisfactory medical certificate is furnished, full pay shall be allowed as follows:—

Workers with less than six (6) months' service—Nil.

Workers with six (6) months' and less than one (1) year's service—14 days.

Workers with one (1) year's service and less than two (2) year's service—28 days.

Workers with two (2) years' service and over—42 days.

Such sick leave shall be granted in one or more periods, but the aggregate amount of leave on pay shall be as provided.

(b) The total sick leave in any one triennial period shall not exceed forty-two (42) days; the triennial period to be the three (3) years preceding the date of illness for which leave is claimed.

(c) No payment for sick leave shall be made when the illness is due to the worker's own misconduct, or to an accident met with off duty.

(d) Sick leave, if granted, will only be recognised provided a medical certificate be placed in the hands of the Hospital Secretary within forty-eight (48) hours of the rostered time for commencement of duty.

(e) The foregoing paragraphs of this clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(f) If the absence exceeds one week, the employment shall be deemed to have terminated after the expiration of the first week's absence, without prejudice to the worker's rights under the other paragraphs of this clause.

11.—Dismissals.

(a) No worker shall be dismissed (except for misconduct) unless she has received fourteen (14) days' previous notice of her dismissal, or pay for such period in lieu thereof.

(b) No worker shall, without the consent of her employer, resign without first having given fourteen (14) days' previous notice of her intention to do so; and in the absence of such notice the employer may withhold pay up to the amount of fourteen (14) days' wages.

(c) This clause shall not apply to casual workers.

12.—Laundry and Uniforms.

(a) Any worker required to wear a uniform shall be supplied free of cost with such uniform by the employer.

(b) Any clothing forming part of a uniform shall be laundered at the employer's expense.

13.—Rosters.

A roster of the working hours shall be exhibited in such place as it may conveniently and readily be seen by each worker concerned. The roster shall be posted not less than forty-eight (48) hours preceding the day on which the roster commences. The roster shall be available to the Union Secretary for inspection at all reasonable times. Rosters may be altered at any time if the hospital exigencies render any alteration necessary.

14.—Time and Wages Record.

(a) A time book shall be open for inspection at all reasonable times by the Union Secretary or his nominee, appointed in writing under the seal of the Union. Each worker must record in such book the exact time on which she starts and finishes duty on each day and also time booked off for meals.

(b) The salary sheets shall, upon reasonable notice being given, be open for inspection at the office of the employer concerned by the Union Secretary or his nominee appointed as aforesaid.

(c) Any system of automatic recording by means of a machine shall be deemed a compliance with the provisions of subclause (a) so far as the particulars actually recorded are concerned.

15.—Interviews.

The Union Secretary, with the employer's permission, may be entitled to interview members of the Union on the employer's premises at reasonable times.

16.—Notices.

If the Union so requests, a copy of this Award shall be posted on a board of reasonable size in a place where it may be conveniently and readily seen by every worker concerned. The Union Secretary may also post thereon such other notices relating to Union matters as are reasonable.

17.—Present Salaries and Privileges.

Nothing herein contained shall entitle an employer to reduce the salary of any worker who at the date of this Award is being paid a higher rate of salary than the minimum prescribed for her class of work.

A worker shall not be deprived of any privileges relating to her employment enjoyed by her at the date hereof, except such as are dealt with in the Award, in which case the Award provisions shall apply.

18.—Living Allowances.

(a) Where board and/or lodging is provided for a worker the employer shall be entitled to deduct in respect to each worker the following amounts:—

- (i) For full board an amount equal to 18.5 per cent of the male basic wage.
- (ii) For lodging an amount equal to seven (7) per cent. of the male basic wage.

(b) Where workers are provided with meals by the employer a deduction shall be made at the rate of one twenty-first (1/21st) of the value for board for each meal provided.

(c) The board and lodging allowances prescribed by this clause shall vary proportionately with the rise or fall in the basic wage.

19.—Casual Workers.

A nursing assistant engaged for a period of not more than two (2) weeks shall be deemed to be a casual worker and be paid ten per cent (10%) over the rates specified in this Award.

If a casual worker is still required at the end of two (2) weeks she may be re-engaged as a casual with payment as aforesaid for another two (2) weeks, after which she shall become permanent.

20.—Other Provisions.

Where workers leave the hospital for accumulated days off, in excess of four (4) days, they shall be allowed pro rata board allowance as prescribed by clause 18 hereof: Provided that such allowance will only be paid when application for payment has been made by the worker prior to leaving the hospital.

21.—Board of Reference.

(a) The Court hereby appoints for the purpose of this Award a Board of Reference.

(b) The Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties.

(c) There are assigned to such Board, in the event of no agreement being arrived at between the parties to the Award, the functions of:—

- (i) adjusting any matters of difference which may arise between the parties from time to time except such as involve interpretation of the provisions of the Award or any of them;
 - (ii) deciding any other matter that the Court may refer to such Board from time to time.
- (d) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

22.—Wages.

(a) Wages shall be paid at least fortnightly.

(a) On entering the employ of the Home of Peace, each worker shall provide the management with a certificate wherein shall be shown the date of birth, and the total amount of experience served with other employers as a nursing assistant, and such certificate shall be signed by the worker.

(b) In the event of any of the particulars shown on the certificates being incorrect, the worker shall have no claim against the employer for underpayment of wages.

(c) On leaving the service of the employer the worker shall be given a certificate wherein shall be shown the length of service with the employer.

Clause 19.—Overtime and Sunday Work.

1.—Overtime.

Delete sub-clause (b) (i), (ii) and (iii), and substitute in lieu thereof the following:—

- (b) (i) When a worker without being notified on the previous day is required to work overtime for more than one (1) hour after his usual knockoff time, he shall be provided with any meal required or shall be paid five shillings (5s.) in lieu thereof.

- (ii) An employee working overtime shall be allowed a meal time of twenty (20) minutes without loss of pay after each four (4) hours of overtime if the employee continues work after such meal time and where the employee has not been notified the day before that he will be required for overtime he shall be paid meal allowance of three shillings and sixpence (3s. 6d.) for each such meal time, provided that a shift worker working overtime shall not leave the job until he is relieved.
- (iii) Where a worker has been notified the previous day to work overtime which necessitates the provision of a meal or meals and has provided a meal or meals and is not required to work overtime or is required to work less than the amount advised, he shall be paid three shillings and sixpence (3s. 6d.) for each meal supplied and which is surplus.

Delete sub-clause (d) and substitute in lieu thereof the following:—

- (d) A worker recalled to work overtime after leaving his employer's premises and who returns to his home on completion of such overtime work, shall be paid a minimum of three (3) hours ordinary pay, or at overtime rates for the time actually worked, whichever is the greater; and in such circumstances time reasonably spent in getting to and from work shall be regarded as time worked at ordinary rates. The worker shall not be obliged to work for the three (3) hours if the job for which he has been brought on has been completed in less time.

Delete sub-clause (e) and substitute in lieu thereof the following:—

- (e) (i) Rest period after overtime. When overtime work is necessary it shall, wherever reasonably practicable, be so arranged that workers have at least eight (8) consecutive hours off duty between the work of successive days.
- (ii) A day worker (other than a casual worker) who works so much overtime between the termination of his ordinary work on one day and the commencement of his ordinary work on the next day that he has not at least eight (8) consecutive hours off duty between those times shall, subject to this sub-clause, be released after completion of such overtime until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.
- (iii) If, on the instructions of his employer, such a worker resumes or continues work without having such eight (8) consecutive hours off duty, he shall be paid at double rates until he is released from duty for such period and he shall then be entitled to be absent until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.

INDUSTRIAL AGREEMENT.

No. 1 of 1961.

(Registered 23rd January, 1961.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1952, this 21st day of December, 1960, between West Australian Gold Mining Clerks' Association, Industrial Union of Workers (hereinafter called "the Union"), of the one part, and the Lake View and Star Limited (hereinafter called "the employer") of the other part, witnesseth that, for the considerations hereinafter appearing, the parties hereto mutually covenant and agree the one with the other that

- (g) Allowances.—The employer shall be entitled to deduct from the salary of the worker an amount assessed by agreement with the worker as the value of accommodation, power, water, fuel and any other items supplied by the employer.

(h) Casual Workers.—Any worker dismissed through no fault of his own before the expiration of one week of his employment shall be considered casual and shall receive ten per cent. (10%) above the rate specified for the work performed.

(i) No Reduction.—In any case where the effect of the Order of the Court of the 11th of May, 1960, would be to reduce—

(a) the secondary wage payable to a worker in any classification; or

(b) the total wage payable to any junior worker;

such workers shall be entitled to receive a total secondary wage and such junior workers shall be entitled to receive a total wage in each case equal to the amount of the secondary wage or total wage respectively payable under this award immediately preceding the date of that Order.

3. Delete the "Rise and Fall" Clause inserted on the 30th day of January, 1960, in Application No. 77 (79) of 1960.
