#### WATER BOARDS ACT, 1904-1954.

# Schedule.

#### By-laws.

1. The by-laws made by the Busselton Water Board under the provisions of the Water Boards Act, 1904 (as amended), published in the Government Gazette on the 6th June, 1952, and amended by notices published in the Government Gazettes of 22nd May, 1953, and 29th October, 1959, are referred to in these by-laws as the principal by-laws.

- 2. Paragraph 2 of Schedule 1 to the principal by-laws is amended:-
  - (a) By substituting for subparagraph (c) a subparagraph as follows:—
    (c) Road Board Purposes—One shilling and sixpence (1s. 6d.) per 1,000 gallons.
  - (b) By substituting for subparagraph (d) a subparagraph as follows:—

     (d) Sporting Bodies—One shilling and sixpence (1s. 6d.) per 1,000 gallons.
  - (c) By substituting for subparagraph (f) a subparagraph as follows:—

     (f) School Purposes—One shilling and sixpence (1s. 6d.) per 1,000 gallons.

The by-laws set out in the above Schedule were passed by a resolution of the Busselton Water Board at a duly convened meeting of the Board held on the 16th day of January, 1961.

### MUNICIPAL CORPORATIONS ACT, 1906-1959. Municipality of Albany.

Amendment to By-law No. 19-(Zoning).

L.G.D. 462/59.

IN pursuance of the powers contained in the Municipal Corporations Act, 1906-1959, the Mayor and Councillors of the Municipality of Albany, hereby order that By-law No. 19, Land Use (Zoning), which was published in the *Government Gazette* on 19th July, 1956, be amended as follows:—

Fifth Schedule—Light Industrial Area, Class B—add new subclause as set out here under:—

(e) All that section of land contained within an area bounded by Vine Street, Lockyer Avenue and Stead Road, provided lots 1, 2 and 3 fronting Lockyer Avenue shall be restricted to light industry and showrooms and any building erected thereon shall be constructed of brick, concrete or other similar materials for the first 20 feet from the Lockyer Avenue frontage, provided further, that a building line is hereby established at a distance of 15 links from the Stead Road frontage.

## MUNICIPAL CORPORATIONS ACT, 1906-1959. Municipality of Albany.

Amendment to By-law No. 19-(Zoning).

IN pursuance of the powers contained in the Municipal Corporations Act, 1906-1959, the Mayor and Councillors of the Municipality of Albany, hereby order that By-law No. 19, Land Use (Zoning), which was published in the Government Gazette on 19th July, 1956, be amended as follows:—

- Eighth Schedule—Business Areas—Add new clause (i):
  - (i) All that area contained within Lots 134, 135, 136 and 1, 2 and 3 of Plantagenet Location 177, corner North and Chester Pass Roads, provided the land is consolidated into one lot and contained in one certificate of title.

# Regulations.

Citation.

1. These regulations may be cited as the Anzac Day Act Regulations, 1961.

Interpretation.

2. In these regulations unless the context requires otherwise-"Anzac Day" means the twenty-fifth day of April; "race meeting" and "sports" have the same meanings as those expressions respectively have in the Anzac

Day Act, 1960; "the Act" means the Licensing Act, 1911, as amended.

Licensee of temporary license may apply for occasional license.

race meeting or sports is held or conducted on Anzac Day when that day is not a Sunday. Period for which occasional license to be granted.

3.

The period for which an occasional license is granted in respect of premises situated at a race meeting or any sports held or conducted on Anzac Day shall be specified in the license, but no such period shall commence before the hour of one o'clock in the afternoon, or continue after the hour of ten o'clock in the evening, of that day.

5. An occasional license granted in respect of premises situated at a race meeting or any sports held or conducted on Anzac Day shall, during the period specified in the license, exempt the licensee from the provisions of the Act relating to the closing of licensed premises on that day.
