al 1. In these regulations the Totalisator Agency Board Betting ons. Regulations, 1961, published in the *Government Gazette* on the 8th February, 1961, are referred to as the principal regulations.

Reg. 34 amended.

2. Regulation 34 of the principal regulations is amended by adding after paragraph (b) of subregulation (6) the following paragraph:—

(c) Notwithstanding the provisions of paragraph (a) of this subregulation, the dividend declared for a bet of five shillings (5s.) shall not in any case be of a lesser amount than five shillings (5s.).

Reg. 36 amended. (1a) Notwithstanding the provisions of subregulation (1) of this regulation, the totalisator pool dividend for a a bet of five shillings (5s.) declared by the Board pursuant to that subregulation shall not in any case be of a lesser amount than five shillings (5s.).


A By-law of the Municipality of the City of Perth made under the provisions of the Municipal Corporations Act, 1906-1959, and the City of Perth Act, 1925-1956, and numbered 66, for the Provision of New Building Lines.


IN pursuance of the powers in that behalf contained in the Municipal Corporations Act, 1906-1959, and the City of Perth Act, 1925-1956, the Lord Mayor and Councillors of the City of Perth hereby prescribe a new building line on the north side of Rutland Avenue for its full length from Great Eastern Highway to Kew Street as shown on the plans in the schedule hereto.
















