WHEREAS under section 2 of the Native Welfare Act, 1905-1960, "Native Institution" means and includes any mission, reformatory, orphanage, school, home, station, reserve, or other institutions for the benefit, protection or care of the native inhabitants of the State declared by proclamation to be a Native Institution for the purpose of this Act: Now, therefore, I, the said Lieutenant-Governor and Administrated the said Lieutenant of the said Lieute trator, hereby declare Warramboo House, Yalgoo, Onslow Native Hostel, Onslow, Kyarra Hostel, Cue, to be Institutions within the meaning of the said section.

WHEREAS it is enacted by subsection (2) of section 4 of the Totalisator Agency Board Betting Act, 1960, that the Governor may on the recommendation of the Minister and the Board, from time

to time, and at any time, by Proclamation declare any portion or portions of the State to be a totalisator agency region for the purposes of that Act; and whereas the Minister and the Board have recommended that the land described in the schedules hereunder be declared totalisator agency regions for those purposes: Now, therefore I, the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council, do hereby declare that the land described in the schedules hereunder shall be totalisator agency regions for the purposes of the Totalisator Agency Roard Betting Act 1960 in the case of the Agency Board Betting Act, 1960, in the case of the land described in the First Schedule, as from and including the 7th day of August, 1961; and, in the case of the land described in the Second Schedule, as from and including the 14th day of August,

# First Schedule.

(a) All that portion of land comprising the area bounded by lines starting in East Fremantle at the point where an imaginary line in prolongation westerly of the northern boundary of Bolton Street meets the high-water mark of the left bank of the Swan River; thence along an imaginary line drawn in a south-westerly direction to the point of the intersection of the northern boundary of Riverside Road with an imaginary line in prolongation northerly of the eastern boundary of Hubble Street; thence along that imaginary line in a southerly direction across all streets meeting the same and in the same direction along the eastern boundary of Hubble Street across all streets meeting the same to the point where it meets the northern boundary of Marmion Street; thence along that northern boundary in an easterly direction across all streets meeting the same to the point where it meets the western boundary of Silas Street; thence along that western boundary in a northerly direction across George Street to the point where it meets the southern boundary of Canning Highway; thence across Canning Highway in a northerly direction to the point where its northern boundary

meets the western boundary of Preston Point Road; thence along that western boundary in a northerly direction across all streets meeting the same to the point of its intersection with the northern boundary of Bolton Street; thence along that northern boundary in a westerly direction across all streets meeting the same and thence along the imaginary line in prolongation westerly thereof to the starting point.

(b) All that portion of land comprising the area bounded by lines starting in Cannington at the point of intersection of the south-western boundary of the railway reserve of the railway between Perth and Cannington with the south-eastern boundary of Wharf Street; thence along that south-eastern boundary in a south-westerly direction across all streets meeting the same and continuing in the same direction along an imaginary line in prolongation of that south-eastern boundary to the point where that imaginary line meets the high-water mark of the right bank of the Canning River; thence along that high-water mark in a general south-easterly direction to the point of its intersection with the north-western boundary of Nicholson Road; thence along that north-western boundary in a north-easterly direction across all streets meeting the same to the point where it meets the south-western boundary of Cannington Terrace; thence along an imaginary line across Cannington Terrace at right angles to that south-western boundary to the point where that imaginary line meets the south-western boundary of the railway reserve hereinbefore mentioned; thence along that south-western boundary in a north-western boundary in a north-western boundary in a north-westerly direction to the starting point.

#### Second Schedule.

(b) All that portion of land comprising the area bounded by lines starting in Victoria Park at the point where an imaginary line in prolongation north-easterly of the north-western boundary of Miller Street meets the south-western boundary of the railway reserve of the railway between Perth and Carlisle; thence along that imaginary line in the same direction across that railway reserve to the point where that imaginary line meets the south-western boundary of Rutland Avenue; thence in a north-easterly direction along an imaginary line in prolongation south-westerly of the north-western boundary of Roberts Street

across Rutland Avenue to the point where that imaginary line meets that north-western boundary and extending along that boundary in the same direction across all streets meeting the same to the point where it meets the south-western boundary of Acton Avenue; thence across Acton Avenue in a north-easterly direction to the point where its north-eastern boundary meets the north-western boundary of Esther Street; thence along that north-western boundary in a north-easterly direction across all streets meeting the same to the point where it meets the south-western boundary of Hardey Road; thence across Hardey Road in a north-easterly direction to the point where its north-eastern boundary meets the north-western boundary of Belvidere Street; thence along that north-western boundary in a north-easterly direction across all streets meeting the same to the point of its intersection with the south-wesern boundary of Epsom Avenue; hence along that southwestern boundary in general north-westerly and northerly directions across all streets meeting the same to the point of its junction with the the same to the point of its junction with the northern boundary of Ascot Street; thence along an imaginary line in a northerly direction at right angles to that boundary to the point where that imaginary line meets the high-water mark of the right bank of the Swan River; thence along that high-water mark in general westerly, south-westerly, southerly, south-westerly, and westerly directions to the point where westerly and westerly directions to the point where it meets an imaginary line drawn in prolongation north-easterly of the point where an imaginary line in prolongation north-westerly of the north-eastern boundary of Orrong Road meets the highwater mark of the left bank of the Swan River; thence along that imaginary line in a south-westerly direction to the point where it meets the south-western boundary of the railway reserve of the railway hereinbefore mentioned and thence along that south-western boundary in a general south-easterly direction to the starting point.
