Health Act, 1911-1960.

### ORDER IN COUNCIL.

WHEREAS it is provided in section 161 (C) of the Health Act, 1911-1960, that the provisions of Division 3 of Part V of the said Act shall operate in certain districts which the Governor may declare by Order in Council to be districts within which the provisions of the said Division 3 of Part V shall apply: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, with the advice of Executive Council, hereby declares that the provisions of Division 3 of Part V of the Health Act, 1911-1960, shall operate and have effect in the City of South Perth.

Land Act, 1933-1960.

### ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1960, it is, *inter alia*, made lawful for the Governor by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

Corres. No. 1767/33.—That Reserve No. 21204 (Kalannie Lot 1) should, subject as aforesaid, be granted in fee simple to The Country Women's Association of Western Australia (Incorporated) in trust for the purpose of a "Rest Room Site (C.W.A.)."

Corres. No. 2359/61.—That Reserve No. 26078 (Nelson Location 12599) should, subject as aforesaid, be granted in fee simple to the Pemberton Country Club (Inc.) in trust for the purpose of a "Site for Club and Club Premises."

Now, therefore, His Excellency the Lieutenant-Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall be granted in fee simple to the abovementioned bodies to be held in trust for the aforesaid purposes, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

#### Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1960.

#### ORDER IN COUNCIL.

#### M.W.S. 1118/60.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1960, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

#### Metropolitan Water Supply.

#### City of Perth—Floreat Park.

Twenty-one-inch Water Main in Brookdale Street.

The construction of a 21-inch diameter water main (length about 5,720 feet).

The above main to be complete with valves and all necessary apparatus.

The above works are shown in red on Plan M.W.S.S. & D.D., W.A. No. 8487.

the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Water Supply.

City of Perth.

Bold Park Reservoir.

Forty-two-inch Diameter Outlet Main.

The construction of a forty-two (42) inch diameter outlet water main complete with valves and all necessary apparatus.

The above works are shown on Plan M.W.S.S. & D.D., W.A. No. 8583.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1960.

#### ORDER IN COUNCIL.

M.W.S. 2390/60.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1960, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Yokine Drainage.

(a) Three (3) compensating basins numbered Y1, Y2 and Y3.

(b) Three (3) pumping stations, each consisting of a brick and tile house and a reinforced concrete well.

(c) Reinforced concrete rising mains of 18 inch, 15 inch, 12 inch and 10 inch diameter, together with all other apparatus connected therewith.

The above works are shown on Plan M.W.S.S. & D.D., W.A. No. 8612.

Local Government Act, 1960.

#### ORDER IN COUNCIL.

L.G. 578/61.

WHEREAS it is enacted, *inter alia*, by subsection (1) of section 433A of the Local Government Act, 1960, that the Governor may make and publish in the *Gazette* uniform general by-laws for all or any portion of the purposes for which by-laws may be made by a Council under Part XV of the Act and may by order declare that all or any such uniform general by-laws as are specified in the

order shall apply to the whole or any portion of a district so specified; and whereas by an Order in Council so made on the 21st day of June, 1961, and published in the *Government Gazette* on the 23rd June, 1961, the Lieutenant-Governor and Administrator did thereby make the uniform general by-laws set out in the First Schedule thereto and declare that those by-laws should have the force of law on and after the 1st day of July, 1961, in each municipal district specified in the Second Schedule to the Order in Council; and whereas it is desired that the said by-laws should apply to the districts set out hereunder: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council, and in exercise of the power conferred by the Local Government Act, 1960, doth hereby declare that the uniform general by-laws made pursuant to the provisions of paragraph (a) of subsection (1) of section 433A of the Local Government Act, 1960, on the 21st day of June, 1961, and published in the *Government Gazette* on the 23rd day of June, 1961, shall apply to the districts and portions of a district specified in the First Schedule hereto to the extent specified in the Second Schedule hereto.

Workers' Compensation Act, 1912-1960.

#### ORDER IN COUNCIL.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1960, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under the Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability the Governor may by Order in Council exempt such employer from the operation of the said section; and whereas Midland Railway Company of Western Australia Limited of Midland Junction Western Australia, being an employer within the meaning of the Act and having made application in accordance with the Act and the regulations made thereunder for exemption from the operation of section 13, has satisfied the Minister that it has established a fund for insurance against its liability to pay compensation under the Act to all workers employed by it, and has deposited at the Treasury a security, to wit, a bond for ten thousand pounds charged with all payments to become due under the liability: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby exempt Midland Railway Company of Western Australia Limited from the operation of section 13 of the Workers' Compensation Act, 1912-1960 until and including the 7th day of August, 1963.

## Workers' Compensation Act, 1912-1960.

## ORDER IN COUNCIL.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1960, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under the Act to all workers employed by him, but that if an employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer from the operation of the said section; and whereas Millars' Timber and Trading Company Limited, of St. George's Terrace, Perth, Western Australia, being an employer within the meaning of section 13, has in accordance with the regulations, duly made application that it be exempted from the operation of the section and has proved to the satisfaction of the Minister that it has established a fund for insurance against the liability to pay compensation under the Act to all workers employed by it and has deposited at the Treasury securities, to wit, the sum of ten thousand pounds (£10,000) charged with all payments to become due from the Company under the liability: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act doth exempt Millars' Timber and Trading Company Limited, as such employer aforesaid from the operation of section 13 of the Workers' Compensation Act, 1912-1960 until and including the 15th day of September, 1963.

Proposed Loan of £8,000.

## ORDER IN COUNCIL.

P.W.W.S. 6/39.

WHEREAS by the Water Boards Act, 1904-1954, a Water Board may, with the approval of the Governor, borrow money for the construction of works for the storage, distribution and supply of water: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, with the advice and consent of the Executive Council, hereby approves, under the provisions of section 113 of the Water Boards Act, 1904-1954, of the Busselton Water Board borrowing the sum of eight thousand pounds (£8,000) for a period of fifteen years, repayable by thirty (30) half-yearly instalments with interest at the rate of five pounds seventeen shillings and sixpence (£5 17s. 6d.) per cent. per annum for the work approved by Order in Council dated the 5th July, 1961, and published in the *Government Gazette* on the 14th July, 1961, subject to the said works being commenced not later than the 1st day of February, 1962.

## Companies Act, 1943-1960.

## ORDER IN COUNCIL.

WHEREAS it is enacted by subsection (1) of section 28 of the Companies Act, 1943-1960, that no company shall be registered by a name which, *inter alia*, is identical with that by which a firm is registered and is carrying on business under the Business Names Act, 1942-1946, or, in the opinion of the Registrar of Companies, so nearly resembles that name as to be calculated to deceive; and whereas it is provided, *inter alia*, in proviso (a) to subsection (7) of that section that where in the opinion of the Governor (on being satisfied

that it would be inequitable or unreasonable to require any company formed or incorporated outside Western Australia to which Part XI of the Act applies to change its name, style, title or designation before complying with the requirements of such Part) it is in the circumstances of the particular case expedient, the Governor may authorise the Registrar to accept for filing the documents and particulars specified in subsection (1) of section 329 of the Act; and whereas registration under Part XI of the Act of a company incorporated in the State of New South Wales by the name of Philco Australia Pty. Limited, was refused by the Registrar on the ground that in his opinion that name so nearly resembles the name by which a firm (namely, Philco Cycles) is already registered and carrying on business under the Business Names Act, 1942-1946, as to be calculated to deceive; and whereas His Excellency the Lieutenant-Governor and Administrator is satisfied that it would be inequitable or unreasonable to require Philco Australia Pty. Limited to change its name before complying with the requirements of Part XI of the Act and is of the opinion that the circumstances of the case render it expedient: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council and in exercise of the powers conferred upon him by proviso (a) to subsection (7) of section 28 of the Companies Act, 1943-1960, doth hereby authorise the Registrar of Companies to accept for filing from Philco Australia Pty. Limited the documents and particulars specified in subsection (1) of section 329 of the Act.
