Shire of Sandstone. Wards and Membership. ORDER IN COUNCIL.

L.G. 1242/52.

WHEREAS under the provisions of the Local Government Act, 1960, the Sandstone Shire Council is divided into three Wards known as the Sandstone Ward, Country Ward and Youanmi Ward respectively, and there are allocated to the district seven members, one being allocated to the Sandstone Ward, five to the Country Ward and one to the Youanmi Ward; and whereas the Governor is empowered by sub-section (2) of paragraph 12 of the Local Government Act, 1960, and in particular by paragraph (g) thereof, to abolish wholly or in part Wards existing in a district and is further empowered by sub-section (4) of section 12 of the said Act to give such directions as he thinks necessary in order to give effect to an alteration in the number of Wards; and whereas the Sandstone Shire Council has, in accordance with sub-section (2) of section 12, submitted a petition to His Excellency the Governor praying that the Youanmi Ward should be abolished and that the member

be added to the list of members representing the Country Ward; and whereas it is considered expedient to grant the petition of the Council: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council, doth hereby—

- (a) abolish the Youanmi Ward of the Sandstone Shire Council;
- (b) declare that the number of members to represent the Country Ward shall be increased to six;
- (c) declare that the member at present representing the Youanmi Ward shall continue as a member of the Council representing the Country Ward and shall continue in office as a member of the Council until he vacates his office in accordance with the provisions of the Act, without there being any need for an election as a result of the abolition of the Youanmi Ward.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 30 of 1960.

Between Coastal Aerated Water and Cordial Manufacturers Employees Industrial Union of Workers, Applicant, and Coca-Cola Bottlers (Perth) Pty. Ltd. and others as per schedule attached, Respondents.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the said reference of industrial dispute was remitted by the

Court to the Conciliation Commissioner, whereas the parties subsequently met and conmatters in difference, and whereas the parties have this day appeared before the Conciliation Commissioner by their respective representatives and requested the Conciliation Commissioner to and requested the Conciliation Commissioner to make the said Agreement an Award of the Court: Now, therefore, the Conciliation Commissioner, pursuant to Section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling him, hereby declare the memorandum hereunder written to have the same effect as and be deemed an Award of the Court.

(Note,—Wherever the word "Award" occurs herein, it shall be taken to mean and include "Agreement".)

1.—Title.

This Award shall be known as the "Aerated Water Manufacturing Industry Award" and replaces No. 3 of 1953 as amended.

3.—Scope.

This Award shall apply to workers employed in the industry of cordial and aerated water manufacturing. Provided that it shall not apply to workers bound by the Transport Workers' (General) Award No. 9 of 1956, as amended.

4.—Area.

This Award shall have effect over that portion of the State known as the South-West Land Divi-

5.—Term.

The term of this Award shall be for a period of three (3) years commencing as from the beginning of the first pay period commencing after the date

6.—Contract of Service.

- (a) After being continuously employed for a period of three (3) calendar months the contract of service shall be by the week and shall be term-inated by one week's notice on either side or by the payment or forfeiture of one week's pay as the
- (b) In other cases the contract of service shall be by the day and shall be terminated by one day's notice, on either side, or by the payment or for-feiture of one day's pay, as the case may be.
- (c) Notwithstanding anything contained in this clause an employer shall be entitled to summarily dismiss a worker for misconduct or dereliction of duty.
- (d) Any worker who, having given or been given notice as aforesaid, absents himself from work during such period without reasonable cause (proof

of which shall lie on him) shall be deemed to have abandoned his employment and shall not be entitled to payment for work done by him within that period.

7.—Breakdowns.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike, by the union or unions affiliated with it, or by any other association or union, or through the breakdown of the employer's machinery, or any stoppage of work from any cause which the employer cannot reasonably prevent.

-Hours.

- (a) The ordinary working hours shall not exceed forty (40) in any one week and shall be worked in five days between Monday to Friday inclusive.
- (b) For workers other than loaders and/or drivers and/or shift workers, the ordinary hours of duty shall be worked between the hours of 7 a.m. and 6 p.m.
- (c) A meal break of a period agreed upon between the majority of the workers and the employer at each factory shall be allowed between the hours of 11 a.m. and 2 p.m. on Monday to Friday, inclusive. In default of such agreement the meal break shall be not more than one (1) hour nor less than forty-five minutes to be taken within the aforementioned period.
- (d) Where a shift commences at or after 11 p.m. then the whole shift shall be paid for at the rate which applies to the major portion of the shift.
- (e) Where the ordinary shift of a shift worker finishes by 8 a.m. Saturday, such hours on the Saturday shall be regarded as ordinary hours of employment and shall not be subject to overtime rates.

9.—Overtime.

- (a) For all work done beyond the hours of duty on any day, and for work done on Saturday, payment shall be made at the rate of time and a half for the first four (4) hours and double time there-
- (b) All work performed on Sundays or the holidays prescribed in clause 17 (a) (i) hereof shall be paid for at the rate of double time.
- (c) A worker required to work overtime for more than two (2) hours, without being notified on the previous day or earlier that he will be so required to work, shall be supplied with a meal by the employer or paid five shillings (5s.) for a meal.

If the amount of overtime required to be worked necessitates a second or subsequent meal, the employer shall, unless he has notified the workers concerned on the previous day or earlier that such second or subsequent meal will also be required, provide such meals or pay an amount of three shillings and fourpence (3s. 4d.) for each such second or subsequent meal.

No such payments need be made to workers living in the same locality as their workshops who can reasonably return home for such meals.

If a worker in consequence of receiving such notice has provided himself with a meal or meals and is not required to work overtime, or is required to work less overtime than notified, he shall be paid the amounts above prescribed in respect of the meals not then required.

- (d) Notwithstanding anything contained in this Award:-
 - (i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirements.
 - (ii) No organisation, party to this Award, or worker or workers covered by this Award shall in any way, whether directly or in-directly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.
- (e) In the calculation of overtime rates each day shall stand alone.

11.—Female Employment.

- (a) Females shall not be employed on any work which involves the lifting of weights in excess of thirty (30) 1b.
- (b) If necessary to keep the clothing dry and required by the worker, rubber aprons shall be provided by the employer, and if lost by the worker or not returned to the employer on the termination of the employment, the cost of same may be deducted from the employee's wages.

12.-Shift Work.

For all work performed on any shift other than day shift, payment shall be made at the rate of five per cent. (5%) for afternoon shift and ten per cent. (10%) for night shift, in addition to the rate prescribed in clause 10 hereof.

13.—Payment of Wages.

All wages shall be paid weekly.

14.—Higher Duties.

A worker who is required to do work which is entitled to a higher rate under this Award than that which he usually performs shall be entitled to payment at the higher rate whilst so employed.

15.—Under-rate Workers.

- (a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.
- (b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.
- (c) After application has been made to the Board and pending the Board's decision, the worker shall be entitled to work for the employer at the proposed lesser rate.

16.—Absence Through Sickness.

- (a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one (1) week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker's compensation under the Workers' Compensation Act.
- (b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident wherever sustained arising out of his own wilful default, or for sickness arising out of his own wilful default.
- (c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.
- (d) Sick leave shall accumulate from year to year so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year. Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

 (e) Notwithstanding the provisions of subclause
- (e) Notwithstanding the provisions of subclause (c) hereof, a worker who has already been allowed paid sick leave on one occasion, may be required by the employer, in the event of any further absence in the same year, to produce a medical certificate stating that he was unable to attend for duty on account of personal ill-health, and until

- such certificate is made available to the employer, shall not be entitled to sick pay for the period of such absence.
- (f) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay, or time spent on holidays or annual leave as prescribed by this Award, shall not count for the purpose of determining his right to sick leave.

17.—Holidays and Annual Leave.

(a) Holidays.

- (i) The following days or the days observed in lieu shall, subject to clause 9 hereof, be allowed as holidays without deduction of pay, namely:—New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day and Boxing Day; provided that another day may be taken as a holiday by arrangement between the parties in lieu of any of the days named in the subclause.
- (ii) Where Christmas Day or New Year's Day falls on a Saturday or a Sunday such holiday shall be observed on the next succeeding Monday and where Boxing Day falls on a Sunday such holiday shall be observed on the next succeeding Tuesday; in each such case the substituted day shall be deemed a holiday without deduction of pay in lieu of the day for which it is substituted.
- (iii) On any public holiday not prescribed as a holiday under this Award, the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done, ordinary rates of pay shall apply.

(b) Annual Leave.

- (i) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.
- (ii) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.
- (iii) If after one (1) month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth (1/6th) of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.
- (iv) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award, shall not count for the purpose of determining his right to annual leave.
- (v) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (b) (iii) of this clause, to such annual leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers of such employer he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(c) General.

- (i) A worker who is justifiably dismissed for misconduct shall not be entitled to the benefit of the provisions of this clause.
- (ii) The provisions of this clause shall not apply to workers employed for less than one week.
- (iii) (a) Any worker absenting himself without just cause from work on the whole or any portion of the working day preceding, or on the whole or any portion of the working day succeeding a holiday provided for herein, shall not be entitled to payment for such holiday.
- (b) "Just cause," for the purpose of this clause, shall mean as approved by the employer or, in default thereof, by a Board of Reference.

(iv) In special circumstances and by mutual consent of the employer the worker and the Union ${\bf r}$ annual leave shall be taken in not more than two periods.

18.—Record.

- (a) The employer shall keep a record showing:
 - (i) The name of each worker.
 - (ii) The nature of his work.
- (iii) The starting and finishing times on each day.
- (iv) The total hours worked.
- (v) The wages and overtime paid.
- (b) Each worker shall be required to sign the record on receipt of his wages.
- (c) The time and wages record shall be open for inspection by a duly accredited official of the Union, during the usual office hours, at the employer's office or other convenient place, and he shall be allowed to take extracts therefrom. Provided that if for any reason the record be not available when the official calls to inspect it, it shall be made available for inspection within twenty-four (24) hours either at the employer's office or other convenient place.

19.—Proportion of Juniors.

(a) The number of junior workers employed in any factory shall not be such as to exceed the proportion of one (1) junior to each four (4) or fraction of four (4) adult workers (excluding drivers) in receipt of the minimum rates herein-before prescribed for workers other than junior workers.

Notwithstanding the provisions of the preceding subclause, it shall be permissible for each driver, if the employer considers it necessary, to have one junior male worker to assist him.

(b) The number of junior drivers shall not be such as to exceed the proportion of one (1) junior driver to each five (5) adult drivers.

20.—Junior Worker's Certificate.

Junior workers, upon being engaged, shall furnish the employer with a certificate containing the following particulars:-

- (i) Name in full.
- (ii) Age and date of birth.

No worker shall have any claim upon an employer for additional pay in the event of the age of the worker being wrongly stated either on the certificate or, if no such certificate is furnished, verbally to the employer. If any junior worker shall wilfully mis-state his age either verbally to the employer or in the certificate, he alone shall be guilty of a breach of this Award, and in the be guilty of a breach of this Award, and in the event of a worker having received a higher rate than that to which he was entitled, he shall make restitution to the employer.

21.—Posting of Award.

The Union, party to this Award, shall be permitted to post a copy of this Award in the lunch room, or in the absence of a lunch room in some other position in the factory where it shall be visible and open to the inspection of the worker.

22.—Board of Reference.

- (a) The Court may appoint for the purpose of this Award a Board of Reference, which shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. The said Board shall have assigned to it in the event of no agreement being arrived at between event of no agreement being arrived at between the parties to the dispute, the functions of—
 - (i) adjusting any matters of difference which may arise from time to time except such as involve interpretation of the provisions of this Award or any of them;
 - (ii) dealing with any other matter which the Court may refer to the Board from time time to time.
- (b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions perscribed in the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

23.—Wet Places.

Workers required to consistently work in places where rubber boots are necessary shall, if they so request, be supplied with same by the employer, and if lost by the worker or not returned to the employer on the termination of the employment, the cost of the same may be deducted from the employee's wages.

24.-No Reduction.

Nothing in this Award shall entitle an employer to reduce the wage of any worker who at the date of this Award was being paid a higher rate of wage than the minimum prescribed for his class of work.

25.—Long Service Leave.

(a) Right to Leave.

A worker shall as herein provided be entitled to leave with pay in respect of long service.

(b) Long Service.

- (1) The long service which shall entitle a worker to such leave shall, subject as herein provided, be continuous service with one and the same employer.
- (2) Such service shall include service prior to the first day of April, 1958, if it continued until such time but only to the extent of the last 20 completed years of continuous service.
- (3) (i) Where a business has, whether before or after the first day of April, 1958, been transmitted from an employer (herein called "the transmittor") to another employer (herein called "the transmittee") and a worker who at the time of such transmission was an employee of the transmittor in that business becomes an employee of the transmittee—the period of the continuous service which the worker has had with the transmittor (including any such service with any prior transmittor) shall be deemed to be service of the worker with the transmittee.
- (ii) In this subclause "transmission" includes transfer, conveyance, assignment or succession whether voluntary or by agreement or by operation of law and "transmitted" has a corresponding meaning.
 - (4) Such service shall include-
 - (a) Any period of absence from duty on any annual leave or long service leave.
 - (b) Any period of absence from duty necessitated by sickness of or injury to the worker but only to the extent of fifteen working days in any year of his employment.
 - (c) Any period following any termination of the employment by the employer if such termination has been made merely with. the intention of avoiding obligations hereunder in respect of long service leave or obligations under any award in respect of annual leave.
 - (d) Any period during which the service of the worker was or is interrupted by ser-
 - (i) as a member of the Naval, Military or Air Forces of the Commonwealth of Australia other than as a member of the British Commonwealth Occupation Forces in Japan and other than as a member of the Permanent Forces of the Common-wealth of Australia except in the circumstances referred to in section 31 (2) of the Defence Act, 1903-1956, and except in Korea or Malaya after June 26, 1950;
 - (ii) as a member of the Civil Construction Corps established under t National Security Act, 1939-1946;
 - (iii) in any of the Armed Forces under the National Service Act, 1951 (as amended).

Provided that the worker as soon as reasonably resumed or resumes employment with the employer by whom he was employed immediately before the commencement of such service.

- (5) Service shall be deemed to be continuous notwithstanding—
 - (a) the transmission of a business as referred to in paragraph (3) hereof;
 - (b) any interruption of a class referred to in paragraph (4) hereof irrespective of the duration thereof;
 - (c) any absence from duty authorised by the employer;
 - (d) any standing-down of a worker in accordance with the provisions of an Award, Industrial Agreement, Order or Determination under either Commonwealth or State law;
 - (e) any absence from duty arising directly or indirectly from an industrial dispute if the worker returns to work in accordance with the terms of settlement of the dispute;
 - (f) any termination of the employment by the employer on any ground other than slackness of trade if the worker be reemployed by the same employer within a period not exceeding two months from the date of such termination;
 - (g) any termination of the employment by the employer on the ground of slackness of trade if the worker is re-employed by the same employer within a period not exceeding six months from the date of such termination;
 - (h) any reasonable absence of the worker on legitimate union business in respect of which he has requested and been refused leave;
 - (i) any absence from duty after the coming into operation of this clause by reason of any cause not specified in this clause unless the employer during the absence or within fourteen days of the termination of the absence notifies the worker in writing that such absence will be regarded as having broken the continuity of service, which notice may be given by delivery to the worker personally or by posting it by registered mail to his last recorded address, in which case it shall be deemed to have reached him in due course of post.

Provided that the period of any absence from duty or the period of any interruption referred to in placita (c) to (i) inclusive of this paragraph shall not (except as set out in paragraph (4) hereof) count as service.

(c) Period of Leave.

- (1) The leave to which a worker shall be entitled or deemed to be entitled shall be as provided in this subclause.
- (2) Where a worker has completed at least 20 years' service the amount of leave shall be—
 - (a) in respect of 20 years' service so completed—13 weeks' leave;
 - (b) in respect of each 10 years' service completed after such 20 years—six and a half week's leave.
- (3) Where a worker has completed at least 15 years' service since its commencement and his employment is terminated—
 - (a) by his death;
 - (b) in any circumstances otherwise than by the employer for serious misconduct;

the amount of leave shall be-

- (i) if such determination takes place before the worker has become entitled to leave under placitum (a) of paragraph (2) hereof such proportion of 13 weeks' leave as the number of completed years of such service bears to 20 years;
- (ii) if such termination takes place after the worker has become entitled to leave under placitum (a) of paragraph (2) hereof the leave due under such placitum and in addition such proportion of 13 weeks' leave as the number of completed years of such service after the accrual of such entitlement bears to 20 years.

- (4) Where a worker has completed at least 10 years' service but less than 15 years' service since its commencement and his employment is terminated....
 - (i) by his death; or
 - (ii) by the employer for any reason other than serious misconduct; or
 - (iii) by the worker on account of sickness of or injury to the worker or domestic or other pressing necessity where such sickness or injury or necessity is of such a nature as to justify or in the event of a dispute is in the opinion of the Special Board of Reference, of such a nature as to justify such termination;

the amount of leave shall be such proportion of 13 weeks' leave as the number of completed years of such service bears to 20 years.

(5) In the cases to which paragraphs (3) and (4) hereof apply the worker shall be deemed to have been entitled to and to have commenced leave immediately prior to such termination.

(d) Payment for Period of Leave.

- (1) A worker shall subject to paragraph (3) hereof, be entitled to be paid for each week of leave to which he has become entitled or is deemed to have become entitled the ordinary time rate of pay applicable to him at the date he commences such leave;
- (2) Such ordinary time rate of pay shall be the rate applicable to him for the standard weekly hours which are prescribed by this award, but in the case of casuals and part-time workers shall be the ordinary time rate for the number of hours usually worked up to but not exceeding the prescribed standard;
- (3) Where by agreement between the employer and the worker the commencement of the leave to which the worker is entitled or any portion thereof is postponed to meet the convenience of the worker, the rate of payment for such leave shall be at the ordinary time rate of pay applicable to him at the date of accrual or, if so agreed, at the ordinary time rate of pay applicable at the date he commences such leave;
 - (4) The ordinary time rate of pay-
 - (a) shall include any deductions from wages for board and/or lodging or the like which is not provided and taken during the period of leave;
 - (b) shall not include shift premiums, overtime, penalty rates, commissions, bonuses, allowances or the like.
- (5) In the case of workers employed on piece or bonus work or any other system of payment by results payment shall be at ordinary time rates.

(e) Taking Leave.

- (1) In a case to which paragraph (2) of subclause (c) applies:—
 - (a) Leave shall be granted and taken as soon as reasonably practicable after the right thereto accrues due or at such time or times as may be agreed between the employer and the worker or in the absence of such agreement at such time or times as may be determined by the Special Board of Reference, having regard to the needs of the employer's establishment and the worker's circumstances.
 - (b) Except where the time for taking leave is agreed to by the employer and the worker or determined by the Special Board of Reference the employer shall give to a a worker at least one month's notice of the date from which his leave is to be taken.
 - (c) Leave may be granted and taken in one continuous period or if the employer and the worker so agree in not more than three separate periods in respect of the first 13 weeks' entitlement and in not more than two separate periods in respect of any subsequent period of entitlement.

- (d) Any leave shall be inclusive of any public holidays specified in this award occurring during the period when the leave is taken but shall not be inclusive of any annual leave.
- (e) Payment shall be made in one of the following ways:—
 - (i) In full before the worker goes on leave;
 - (ii) at the same time as his wages would have been paid to him if the worker had remained at work, in which case payment shall, if the worker in writing so requires, be made by cheque posted to an address specified by the worker; or
 - (iii) in any other way agreed between the employer and the worker.
- (f) No worker shall, during any period when he is on leave, engage in any employment for hire or reward in substitution for the employment from which he is on leave, and if a worker breaches this provision he shall thereupon forfeit his right to leave hereunder in respect of the unexpired period of leave upon which he has entered, and the employer shall be entitled to withold any further payment in respect of the period and to reclaim any payments already made on account of such period of leave.
- (2) In a case to which paragraph (3) or paragraph (4) of subclause (c) applies and in any case in which the employment of the worker who has become entitled to leave hereunder is terminated before such leave is taken or fully taken the employer shall, upon termination of his employment otherwise than by death pay to the worker, and upon termination of employment by death pay to the personal representative of the worker upon request by the personal representative, a sum equivalent to the amount which would have been payable in respect of the period of leave to which he is entitled or deemed to have been entitled and which would have been taken but for such termination. Such payment shall be deemed to have satisfied the obligation of the employer in respect of leave hereunder.
 - (f) Granting Leave in Advance and Benefits to be Brought into Account.
- (1) Any employer may by agreement with a worker allow leave to such a worker before the right thereto has accrued due, but where leave is taken in such a case the worker shall not become entitled to any further leave hereunder in respect of any period until after the expiration of the period in respect of which such leave had been taken before it accrued due.
- (2) Where leave has been granted to a worker pursuant to the preceding paragraph before the right thereto has accrued due, and the employment subsequently is terminated, the employer may deduct from whatever remuneration is payable upon the termination of the employment a proportionate amount on the basis of 13 weeks for twenty years' service in respect of any period for which the worker has been granted long service leave to which he was not at the date of termination of his employment or prior thereto entitled.
- (3) Any leave in the nature of long service leave or payment in lieu thereof under a State Law or a long service leave scheme not under the provisions hereof granted to a worker by his employer in respect of any period of service with the employer shall be taken into account whether the same is granted before or after the coming into operation hereof and shall be deemed to have been leave taken and granted hereunder in the case of leave with pay to the extent of the period of such leave and in the case of payment in lieu thereof to the extent of a period of leave with pay equivalent to the amount of the payment and to be satisfaction to the extent thereof of the entitlement of the worker hereunder.

- (g) Records to be Kept.
- (1) Each employer shall during the employment and for a period of 12 months thereafter, or in the case of termination by death of the worker a period of three years thereafter, keep a record from which can be readily ascertained the name of each worker and his occupation, the date of the commencement of his employment and his entitlement to long service leave and any leave which may have been granted to him or in respect of which payment may have been made hereunder.
- (2) Such record shall be open for inspection in the manner and circumstances prescribed by this award with respect to the time and wages record.
 - (h) Special Board of Reference.
- (1) There shall be constituted a Special Board of Reference for the purpose hereof to which all disputes and matters arising hereunder shall be referred and the Board shall determine all such disputes and matters.
- (2) There shall be assigned to such Board the functions of—
 - (a) the settlement of disputes on any matters arising hereunder;
 - (b) the determination of such matters as are specifically assigned to it hereunder.
- (3) The Board of Reference shall consist of one representative or substitute therefor nominated from time to time by the Western Australian Employers' Federation (Incorporated) and one representative or substitute nominated from time to time by the West Australian Trade Unions Industrial Council (A.L.P.) together with a chairman to be mutually agreed upon by the organisations named in this paragraph.

(i) State Law.

- (1) The provisions of any State law to the extent to which they have before the coming into operation hereof conferred an accrued right on a worker to be granted a period of long service leave in respect of a completed period of 20 or more years' service or employment or an accrued right on a worker or his personal representative to payment in respect of long service leave shall not be affected hereby and shall not be deemed to be inconsistent with the provisions hereof.
- (2) The entitlement of any such worker to leave in respect of a period of service with the employer completed after the period in respect of which the long service leave referred to in paragraph (1) hereof accrued due shall be in accordance herewith.
- (3) Subject to paragraphs (1) and (2) hereof, the entitlement to leave hereunder shall be in substitution for and satisfaction of any long service leave to which the worker may be entitled in respect of employment of the worker by the employer.
- (4) An employer who under any State law with regard to long service leave is exempted from the provisions of that law as at the first day of April, 1958, shall in respect of the workers covered by such exemption be exempt from the provisions hereof.

(j) Exemptions.

The Special Board of Reference may subject to such conditions as it thinks fit exempt any employer from the provisions hereof in respect of its employees where there is an existing or prospective long service leave scheme which, in its opinion is, viewed as a whole, more favourable for the whole of the employees of that employer than the provisions hereof.

(k) Liberty to Apply.

Liberty is granted to any party to this award to apply to the Court at any time for an appropriate variation of this clause if any of the terms and conditions operating under the code of Long Service Leave being negotiated between the Australian Council of Trade Unions and Federal Employers' Organisations is varied in any way.

No. 1 of 1961) made pursuant to the provisions of Part X of the Industrial Arbitration Act, 1912-1952, this third day of August, 1961, between the Civil Service Association of Western Australia (Incorporated) (hereinafter referred to as the "Association") of the one part and the Public Service Commissioner of Western Australia (hereinafter referred to as of Western Australia (hereinafter referred to as the "Commissioner") of the other part, withesseth as follows:-

Whereas the parties hereto being the parties to an Agreement (P.S.C. No. 1 of 1959) dated the 24th an Agreement (P.S.C. No. 1 of 1959) dated the 24th day of March, 1959 and published in the Government Gazette (No. 31) dated 17th day of April, 1959 (hereinafter referred to as the "principal Agreement") as amended by Public Service Salaries Agreement Amendment, 1960, (P.S.C. No. 1 of 1960) dated 23rd day of March, 1960, and published in the Government Gazette (No. 46) of the 3rd Tune, 1960, have mutually agreed that the principal June, 1960, have mutually agreed that the principal Agreement as amended shall be and the same is hereby varied in the manner following, that is to say:-

1. Clause 18—Female Officers—Drafting Assistants.

Delete the proviso to subclause (a) and insert the following in lieu thereof:-

Provided that an officer shall not proceed beyond a margin of £226 per annum unless she-

 (i) has completed and passed an efficiency examination in the appropriate group of subjects of the Technical Education Division of the Education Department, herein listed:

> Engineering Drafting-Elementary Drawing; Mechanical Drawing I; Qualifying Maths D; or Such other subjects of equivalent

standard as may be approved by the Public Service Commissioner.

Architectural Drafting-Freehand Drawing; Building Construction I; Qualifying Maths D.

Cartographic Drafting-Plan Drawing I; Cartographic Reproduction of Maps and Plans I; Qualifying Maths D; or

(ii) has completed six years of continuous service as a Drafting Assistant after attaining the age of 21 years.

- 2. Delete the existing subclauses (b) and (c) and insert the following subclauses:-
 - (b) Subject to a satisfactory report from the Permanent Head concerning the officer's conduct, diligence and efficiency, an officer who completes and passes the prescribed efficiency examination before reaching a salary margin of £251 per annum, shall be paid an allowance of £25 per annum, provided that such allowance shall convert to salary and cease when a salary margin of £251 per annum is reached.
 - (c) An officer who is over the age of 21 years on appointment may be appointed at a minimum rate of pay based on years of service and not on age.
 - (d) An officer who has completed not less than 20 years of continuous permanent service shall be paid an allowance of £30 per annum, provided the Permanent Head certifies as to the good conduct, diligence and efficiency of the officer.

2.—Date of Operation.

It is agreed by the parties hereto that the amendments referred to in this amending Agreement shall be and are effective on and from the 1st day of January, 1961.

- (a) For workers specified in this subclause the week's work shall consist of forty (40) hours to be worked eight (8) hours per day Monday to Friday inclusive:
 - (i) Mental Hospitals.—Laundry, Garden and Maintenance staff other than Handyman, Heathcote.
 - (ii) Royal Perth, Princess Margaret, Fre-mantle and King Edward Memorial Hos-pitals.—Laboratory Attendants.

Provided that when Laboratory Attendants are periodically required to work on Saturday, the time so worked up to 12 noon may at the discretion of the employer be included in the working week of forty (40) hours.

- (b) The hours of the following workers shall remain substantially as at present:—
 - Farm Attendants, Mental Hospital.— These workers shall in every seven (7) consecutive days be granted two (2) full days off duty.
 - (ii) Lazaret Attendants, Wooroloo.—There shall be no fixed hours of duty for these workers but they shall receive two days off in each week. These days may accumulate to a maximum of eight (8) days off in each four (4) weeks.
- (c) (i) For all other workers the working hours shall be— $\,$

Forty (40) hours per week worked on any five days of the week.

Eighty (80) hours per fortnight worked on any ten days of each fortnight; or

At Wooroloo.—One hundred and sixty hours (160) hours per four (4) weeks to be worked in twenty consecutive days;

at the option of the employer, rostered in accordance with Clause 8 of this Award.

- (ii) Subject to (iii) hereof and excepting the Butcher's Shop no alteration to the hours basis as at present being worked at Wooroloo shall be made during the currency of the Award.
- (iii) Leave to apply to amend this clause is reserved to either party.
- (d) There shall be no fixed hours of duty in hospitals where the daily average of occupied beds does not exceed four (4). The daily average of beds occupied will be calculated on the actual inpatient days only. Out-patients and babies will not be included.
- 8. Rosters.—Delete subclause (a) and insert in lieu thereof the following:— $\,$
 - (a) The ordinary hours of duty prescribed in sub-clause (c) of clause 6 of this award shall be set out in a roster which shall be posted in a convenient place where it can be readily seen by the workers concerned, setting out the time each worker starts and finishes each shift and also each break in the shift, together with the days each worker is booked off duty.
- 1. (a) In the case of rostered workers overtime shall mean all time worked—
 - (i) beyond the spread of shift prescribed in Clause 7; and/or
 - (ii) outside of or in excess of the rostered hours.
- (b) In the case of all other workers, overtime shall mean all work performed outside of or in excess of the usual working hours of such worker.
- (c) Overtime shall be paid for at the following

Wooroloo and Mental Hospitals.—Time and a half for the first four (4) hours and double time thereafter.

All Other Hospitals.—Time and a half for the first two (2) hours and double time thereafter.

Provided that in lieu of payment time off equivalent to the time worked may be granted when overtime is occasioned through the failure of another worker to report for duty except where a full additional shift is required when overtime rates shall apply.

(d) In the computation of overtime each day shall stand alone.

INDUSTRIAL AGREEMENT.

No. 13 of 1961.

(Registered 4th September, 1961.)

THIS agreement, made pursuant to the provisions of the Industrial Arbitration Act, 1912-1952, of Western Australia, this 31st day of August, 1961, between the West Australian Local Government Officers' Association Union of Workers (hereinafter called "the Association") of the one part and the Town of Kalgoorlie (hereinafter called "the Local Authority") of the other part, witnesseth that for Authority") of the other part, witnesseth that for the consideration hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:-

1.—Title.

This Agreement shall be known as the Town of Kalgoorlie Officers' Agreement, 1961.

2.—Arrangement.

3.—Area.

This Agreement shall extend over and include the boundaries of the Town of Kalgoorlie and any premises or land upon which any undertakings of the local authority are being carried on.

-Scope.

This Agreement shall apply to all officers in the employment of the Town of Kalgoorlie but shall not include health inspectors.

5.—Definitions.

"Officer" shall mean an employee eligible to be a member of the Association.

"Permanent Officer" for the purpose of this Agreement is one who is appointed by resolution of the local authority and is given notice of such appointment in writing under the hand of the Town Clerk.

"Town Clerk" shall mean the person appointed to that position in accordance with the Local Government Act, 1960.

"Local Authority" shall mean the Town of Kalgoorlie.

"Association" shall mean the West Australian Local Government Officers' Association, Union of Workers, Perth.

"Engineer" shall mean an officer of the Local Authority (excepting a works supervisor) who is required to prepare estimates and/or specifications and/or to set out, supervise or control and/or inspect the outside work of the Local Authority.

"Works Supervisor" shall mean an officer who supervises, directs and controls outside work.

"Foreman" shall mean an officer other than engineer who supervises work under the direction of an engineer or works supervisor.

"Senior Typiste" shall mean an officer employed as a typiste who is over the age of 21 years.

6.—Resignations and Dismissals.

Terms of Employment.—Subject to the provisions of the relevant Act or Acts for the time being in force, the following provisions shall apply:—

- (a) An officer being a Town Clerk, Engineer, Works Supervisor, Town Treasurer, Pool Manager, Traffic Inspector, Head Gardener, Electrical Engineer or Foreman shall not without the approval of the Local Authority resign from his position until the expiration of one month's notice in writing of his intention to do so. All other officers to be required to give one week's notice.
- (b) One month's notice shall be given by the Local Authority to an officer whose services are no longer required; provided that this subclause shall not apply to cases of summary dismissal for misconduct.
- (c) Temporary Officers.—One (1) week's notice on either side shall be required to terminate a contract of service except where a temporary officer is engaged for a specified period or job.

7.—Hours of Duty.

- (a) Except as provided in subclauses (b) and (c) the hours of duty shall be from 9 a.m. to 5 p.m. on Monday to Friday both inclusive with a break of one hour for lunch between 12 noon and 2 p.m.
- (b) The hours mentioned in subclause (a) may be varied by agreement between the Local Authority and the Association and where the duties appertaining to any officer cannot be efficiently carried out within the prescribed hours then in default of such agreement the hours of work shall be determined by the Board of Reference. Provided, however, that the officer or officers concerned shall not be required to work (except subject to the provisions of the next following clause) a greater number of hours than those included in the hours specified in the said subclause (a).
- (c) The hours of duty of the Stores Clerk, Foreman and Overseers who exercise control over non-clerical workers shall be the same as those of the men over who they exercise control.
- (d) The Caretaker shall work such hours as his duties require provided that such hours shall not exceed forty-four (44) per week without payment of overtime.

8.—Holidays.

The following holidays shall be granted and paid for, namely:—The days observed as New Year's Day, Australia Day, Good Friday, Easter Monday, Labour Day, Anzac Day, State Foundation Day, Goldfields Cup Day, Queen's Birthday, Christmas Day, Boxing Day and any other days that may be proclaimed as a public holiday in the Municipality or may be proclaimed as a holiday for persons employed in the Public Service or under the Public Service Act of the Government of Western Australia. When an officer at the direction of the Local Authority works on any of the prescribed holidays he shall have the equivalent time added to his annual leave. This accumulation is limited to five (5) days in one year.

9.—Annual Leave.

- (a) After the completion of each year of continuous service all officers shall be entitled to and shall take a minimum of three weeks' annual recreation leave (exclusive of intervening holidays) on full pay. The leave shall be taken at a time mutually convenient to the officer and the Local Authority at any time within six (6) months of its becoming due.
- (b) An officer not completing one year's service shall be granted pay in lieu of holidays in proportion to his length of service.
- (c) At least fourteen (14) days' notice shall be given to an officer by the Local Authority before requiring him to take annual leave.

10.-Long Service Leave.

- (a) All officers of the Local Authority shall after each period of ten (10) years' continuous service as permanent full-time officers thereof be entitled to three (3) months' long service leave to be taken at the convenience of the Local Authority.
- (b) In calculating the length of service of any present officer for the purposes of this clause the following shall be deemed to be continuous service as a permanent full-time officer of the Local Authority:—
 - Continuous service with the Local Authority as a permanent officer immediately prior to the date hereof and after the 1st day of January, 1936.
 - (ii) In the case of an officer employed by the Local Authority on a permanent full-time basis immediately prior to entering thereon continuous full-time service with the Armed Forces of the Commonwealth of Australia between the 3rd day of September, 1939, and the 3rd day of March, 1947.
- (c) Absence on account of sickness shall not be deemed a break in the continuity of service and periods of absence on account of sickness up to but not exceeding three (3) months' duration in any one (1) year shall be included in the period of service.
- (d) Officers due to take long service leave shall be paid their salary for the period thereof at the rate equivalent to the average rate of pay over the preceding twelve (12) months.
- (e) Any officer leaving the service of the Local Authority on account of sickness or retrenchment or for any other cause which the Local Authority in its discretion thinks reasonable after three (3) years' or more continuous service as a permanent full-time officer since the date of the commencement of service or since the date on which such officer last became entitled to long service leave hereunder as the case may be and the personal representatives of any deceased officer who dies after a period of service as aforesaid shall be entitled to be paid at the rate hereinbefore provided for such proportion of three (3) months as such period of service as aforesaid bears to ten (10) years.
- (f) Long service leave shall be considered as a special period of recuperation after a lengthy term of service with a view to fitting the officer for a further term and during such leave no officer shall undertake any form of employment for hire or reward. Any contravention of the stipulation in this subclause contained shall entitle the Local Authority to dismiss the officer from its service forthwith.

11.—Overtime.

- (a) Except as provided in paragraph (b) all work done outside the hours specified in clause 7 hereof shall be paid for at the rate of time and a half for the first two (2) hours and double time thereafter.
- (b) Executive officers and heads of departments shall receive overtime as specified in paragraph (a) only for work of a special nature in excess of their normal duties.
- (c) Where an officer other than a departmental head or executive officer is required to be on duty on any of the holidays mentioned in clause 8 or on Saturdays or Sundays he shall be paid at the rate of double time.
- (d) A minimum of two (2) hours shall be paid when overtime is worked.
 - 12.—Minimum Salary of an Officer Acting in a Higher Grade or in a Dual or Multiple Capacity.

When an officer—

(a) performs the duties of a position of a grade higher for a period of not less than one month than that to which he is appointed, he shall be paid whilst performing the duties of such position the salary awarded to such position. In the event

of the absence of a departmental head, this paragraph shall apply to all classified officers who would be called upon as a matter of course to perform work of a higher grade;

- (b) carries out the duties of or occupies a dual office he shall be paid the salary pertain-ing to the higher office;
- (c) carries out the duties of or occupies more than two (2) positions he shall be paid in addition to the salary prescribed by sub-clauses (a) and (b) hereof ten per centum of the salary of each of the other positions occupied whether the salary for such other position or positions is prescribed by this or another Agreement.

13.—Sick Leave.

In the event of absence from duty on account of personal sickness all officers shall be entitled to Ten (10) days' full pay for each year of service with a maximum of sixty (60) days on production of a medical certificate that such leave is necessary.

14.—Travelling Expenses.

(a) The Local Authority will pay to its officers all reasonable travelling and hotel expenses incurred by an officer in the discharge of his duties on production of the necessary vouchers.

The method and mode of travelling or the vehicle to be supplied shall be mutually arranged between the Local Authority and the officer concerned; provided, however, that nothing herein contained shall impose an obligation on any officer to provide a method of conveyance at his own expense nor shall it be a condition precedent to the appointment of an officer that he shall provide a conveyance at his own expense.

- (b) When by arrangements the officer supplies his own conveyance there shall be added to his expenses the amount equal to fair rental value for the vehicle and an adequate amount for running costs.
- (c) If the parties cannot agree upon any question arising under subclauses (a) and (b) hereof the matter may be referred for settlement by either party concerned to the Board of Reference.
 - 15.—Preference to Seniority on Promotion.

Whenever a vacancy occurs in any office preference to fill such vacancy may be given to the senior officer of that department regard being had to his efficiency and long service.

16.—Board of Reference.

- (a) The Court may appoint for the purpose of the Agreement a Board or Boards of Reference. Each Board shall consist of a chairman and two (2) other representatives one to be nominated by each of the parties as prescribed by the regulations to the Industrial Arbitration Act, 1912-1952. There are assigned to each such Board in the event of no agreement being arrived at between the parties to this Agreement the functions of-
 - (i) adjusting any matters of difference which may arise between the parties from time to time except such as involve interpreta-tions of the whole and/or any of the provisions of the Agreement;
 - (ii) classifying and fixing wages rates and conditions for any occupation or calling not specifically mentioned in the Agreement;
 - (iii) deciding any other matter that the Court may refer to such Board from time to time.
- (b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Agreement.

17.—Term.

The term of this Agreement shall be for a period of three years.

18.—Salaries.
