HEALTH ACT, 1911-1960.

HIS Excellency the Governor in Executive Council, acting under the provisions of the Health Act, 1911-1960, has been pleased to make the regulations set out in the schedule hereunder.

Schedule.

Regulations.

- 1. In these regulations the Sewerage and Drainage Fixtures and Fittings Regulations, 1959, published in the *Government Gazette* on the 15th September, 1959, and amended from time to time thereafter, by notices published in the *Government Gazette* are referred to as the principal regulations.
- 2. The principal regulations are amended by adding the following regulation:— $\,$
 - 10. (1) Every apparatus for the bacteriolytic treatment of sewage, soak well, or leach drain shall be fitted with a cover made of concrete.
 - (2) A cover mentioned in subregulation (1) of this regulation shall be not less than two inches thick, and shall be reinforced in accordance with Standards Association of Australia Standard A 84 (1st Edition 1958), Table No. 2—No. 606 steel mesh.
 - (3) A person who manufactures for sale any article intended for use as a cover for an apparatus for the bacteriolytic treatment of sewage, soak well or leach drain shall, before the article is sold, mark the article with his name, or a distinguishing brand.
 - (4) A person shall not mark any article to which this regulation refers with a distinguishing brand, unless that brand shall first have been approved by, and recorded at the office of, the Commissioner.
