WHEREAS it is enacted by section 2 of the Church of England in Australia Constitution Act, 1960, that the Act shall come into operation on a day to be fixed by Proclamation, being a day appointed in accordance with section sixty-eight of the Constitution and the said Act: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council, do hereby proclaim that the Church of England in Australia Constitution Act, 1960, shall come into operation on the 1st day of January, 1962, being the day appointed in accordance with section sixty-eight of the Constitution and the said Act.

WHEREAS it is enacted by section 1A of the Bank Holidays Act, 1884-1961, that the Governor may, by Proclamation, declare that as from a day specified in the Proclamation, Saturday—

- (a) shall be a bank holiday; and
- (b) shall be kept as a close holiday in and by all banks in the State;

and whereas it is further enacted by that section, that such a Proclamation shall not be made until the Governor is satisfied that arrangements which will operate generally throughout the State have been made and will be carried out for keeping all banks in the State open for business until five o'clock in the afternoon of every Friday that is not a bank holiday: Now, therefore I, the Governor, being satisfied that the above arrangements have been made, and acting with the advice and consent of the Executive Council, do hereby declare that as from the date of publication of this Proclamation in the *Government Gazette*, Saturday—

- (a) shall be a bank holiday; and
- (b) shall be kept as a close holiday in and by all banks in the State.

WHEREAS it is enacted by section 115 of the Factories and Shops Act, 1920-1959, that during every Christmas Day, New Year's Day, Good Friday, Anzac Day and Easter Monday, and any other day that the Governor may, by Proclamation, declare to be a public holiday to be observed under the said Act, all shops (except those mentioned in the Fourth Schedule and registered small shops) and warehouses shall be closed: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, do by this Proclamation declare that Tuesday, the 26th day of December, 1961, shall be observed as a public holiday under the Factories and Shops Act, 1920-1959, throughout the State, with the intent that on the said day all shops (except those mentioned in the Fourth Schedule to the said Act and registered small shops) and warehouses throughout the State shall be closed.

WHEREAS it is enacted by subsection (1) of section 5 of the Stock Diseases Act, 1895-1960, that in any case where he deems it necessary for

the purpose of preventing the introduction or dissemination of disease into or in the State, the Governor may, from time to time by Proclamation, prohibit or put restrictions on the introduction into the State from any other State of the Commonwealth specified in the Proclamation of any infected stock or stock suspected to be infected for such specified period as may appear to him necessary or expedient for the purpose; and whereas a disease known as "Swine Fever," being a disease to which swine are subject, has been found in swine in the State of New South Wales and it is suspected that swine in other States of the Commonwealth may also be infected with that disease; and whereas the Governor deems it necessary for the purposes of preventing the introduction or dissemination of that disease into or in the State to prohibit the introduction into this State of any swine and of any carcase of any swine or portion thereof from the States hereinafter specified: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council, do hereby prohibit for the period of six months commencing on and including the 1st day of December, 1961, the introduction into this State of any swine and of any carcase of any swine or portion thereof from any of the States of Victoria, Queensland, Tasmania and South Australia.

WHEREAS it is enacted by subsection (1) of section 5 of the Stock Diseases Act, 1895-1960, that, in any case where he deems it necessary for the purpose of preventing the introduction or dissemination of disease into or in the State, the Governor may, from time to time by Proclamation, prohibit or put restrictions on the introduction into the State from any other State of the Commonwealth specified in the Proclamation of any infected stock or stock suspected to be infected for such specified period as may appear to him necessary or expedient for the purpose; and whereas it is also enacted by subsection (2) of that section that the Governor may, by Proclamation, vary or revoke any Proclamation so made under that section; and whereas, by a Proclamation made on the 17th day of May, 1961, and published in the *Government Gazette* on the 19th day of May, 1961, the Lieutenant-Governor and Administrator did prohibit until the 30th day of November, 1961, the introduction into this State of any swine or any carcase of any swine or portion thereof from the State of New South Wales; and whereas it is deemed desirable and expedient to vary that Proclamation by extending the period of prohibition specified therein: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council, do hereby vary the Proclamation made on the 17th day of May, 1961, by extending until and including the 31st day of May, 1962, the period for which the introduction into the State of any swine and of any carcase of any swine or portion thereof from the State of New South Wales is prohibited.

ORDER IN COUNCIL.

L.G. 578/61.

WHEREAS it is enacted, *inter alia*, by subsection (1) of section 433A of the Local Government Act, 1960, that the Governor may make and publish in the *Gazette* uniform general by-laws for all or any portion of the purposes for which by-laws may be made by a Council under Part XV of the Act and may by order declare that all or any such uniform general by-laws as are specified in the order shall apply to the whole or any portion of a district so specified; and whereas by an Order in Council so made on the 21st day of June, 1961, and published in the *Government Gazette* on the 23rd June, 1961, the Lieutenant-Governor and Administrator did thereby make the uniform general by-laws set out in the First Schedule thereto and declare that those by-laws should have the force of law on and after the 1st day of July, 1961, in each municipal district specified in the Second Schedule to the Order in Council; and whereas it is desired that the said by-laws should apply to the district set out hereunder: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, and in exercise of the power conferred by the Local Government Act, 1960, doth hereby declare that the uniform general by-laws made pursuant to the provisions of paragraph (a) of subsection (1) of section 433A of the Local Government Act, 1960, on the 21st day of June, 1961, and published in the *Government Gazette* on the 23rd day of June, 1961, shall apply to the district specified in the First Schedule hereto to the extent specified in the Second Schedule hereto.

Bulk Handling Act, 1935-1961.

ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by section 26A of the Bulk Handling Act, 1935-1961, that from and after the date on which the management and control of the business of the Co-operative Bulk Handling Limited, defined in that Act as the Company, shall be handed over to the growers, as defined in the Act, in terms of a deed of trust as so defined, there shall, subject to the proviso mentioned in subsection (2) of the section, be paid to the Company by every holder of a warrant, as so defined, on surrendering the same to the Company, in respect of all wheat delivered to it a toll of fourpence per bushel or such lesser toll as the Governor may from time to time fix by Order in Council; and whereas such management and control was handed over on the 28th day of October, 1943: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council in exercise of the power in that behalf conferred upon him by the section, doth hereby fix such toll at twopence per bushel as from the 16th day of November, 1961, until further order.

Between the Operative Painters and Decorators' Industrial Union of Workers, Perth, Applicant, and Lake View and Star Limited, Respondent.

HAVING heard Mr. J. G. White on behalf of the applicant and Mr. D. E. Cort on behalf of the respondent, the Court, in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1952, doth hereby order and declare that the Painters' (Gold Mining) Award, No. 28A of 1946, as amended and consolidated, be and the same is hereby further amended in the following manner:—

Clause 7—Wages.—Delete subclause (h) and substitute the following:—

(h) Tool Allowance.—In addition to the above an allowance at the rate of one shilling and ninepence (1s. 9d.) per week shall be paid to painters and to third, fourth and fifth year apprentices.

Clause 9—Hours.—Delete the second paragraph of subclause (c) of this clause.

Clause 16—Special Rates and Provisions:

Subclause (1)—Boat Type and Swinging Scaffolds.—Delete the words, figures and symbols "one shilling and three pence (1s. 3d.) per day" in the third and fourth lines of paragraph (a) and substitute "sixpence (6d.) per hour."

Subclause (2)—Spray Painting.—

(a) Insert the words "head covering" after the word "overalls" in the third line of paragraph (b).

(b) Delete the words, figures and symbols "one shilling and threepence (1s. 3d.)" in the seventh and eighth lines of paragraph (c) and substitute "one shilling and sixpence (1s. 6d.)."

Subclause (12)—Excessive Dirty Work.—

(a) Delete the word "Excessive" in the heading of the subclause and substitute "Excessively."

(b) Delete the word, figure and symbol "fourpence (4d.)" in the fourth and fifth lines and substitute "sixpence (6d.)."

After subclause (12) add a new subclause (13) as follows:—

(13) Work on Winder Drums or Head Frame Wheels.—Workers engaged on work on winder drums or head frame wheels shall be paid an additional payment of sixpence (6d.) per hour, with a minimum additional payment of two shillings (2s.) in any one day.

Clause 22—Definitions.—Delete this clause and substitute the following:—

22.—Definitions.

"Painter" means—

(a) a worker who applies paint or any other preparation used for preservative or decorative purposes—

(i) to any building or structure of any kind or to any fabricated unit forming or intended to form part of any building or structure, or

(ii) to any machinery or plant

(b) and includes any worker engaged in the hanging of wallpapers or substitutes therefor or in glazing, graining, gilding, decorating, applying plastic relief or putty glazing

(c) and also includes any worker who strips off old wallpapers or who removes old paint or varnish or who is engaged in the preparation of any work for painting or of any materials required for the trade

(d) and also includes any worker engaged in signwriting;

Provided that nothing in this definition shall prevent—

(a) a brush hand working under the provisions of the Australian Workers' Union Award, No. 11 of 1946, from doing rough painting (or rough preparation therefor) of any building or structure other than a cottage, office, change room, workshop or storeroom, when it is intended that such a building or structure shall be only roughly painted with not more than one coat of paint; or rough painting of any plant;

(b) a carpenter or joiner or an apprentice to either of those trades from applying one coat of primer to any joinery intended to form part of a building; or

(c) a worker of the appropriate classification under the Australian Workers' Union Award, No. 11 of 1946, from doing rough painting (with not more than one coat) of any machinery or other iron work.
