WHEREAS by a Proclamation dated the 30th day of November, 1961, that portion of the land comprised in Pastoral Lease 394/929, described in the First Schedule hereto was, in exercise of the power conferred by section 109 of the Land Act, 1933-1960, resumed for the purpose of a "Town-site"; and whereas it is desirable that the portion of land comprised in Pastoral Lease 394/929 described in the Second Schedule hereto should be resumed for the said purpose in lieu of the land described in the First Schedule: Now, therefore I, Sir Charles Henry Gairdner, Governor as aforesaid, with the advice and consent of the Executive Council, do hereby revoke the recited Proclamation of the 30th day of November, 1961, and do by this my Proclamation resume that portion of the said Pastoral Lease 394/929, which is described in the Second Schedule hereto for the purpose aforesaid.

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1960, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any

municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of sub-leasing; and whereas it is deemed expedient that Reserve No. 26132 (Swan Location 7366) should vest in and be held by the Shire of Perth in trust for the purpose of a Bowling Club Site and Bowling Club Premises: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Shire of Perth in trust for a Bowling Club Site and Bowling Club Premises with power to the said Shire of Perth, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding twenty-one (21) years from the date of the lease.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1960, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient as follows:—

Corr. 94/11.—That Reserve No. 19312 (Cockburn Sound Locations 798 and 1972) should vest in and be held by the Shire of Mandurah in trust for the purpose of Recreation.

ORDER IN COUNCIL.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—

Country Areas Water Supply Act, 1947-1960.
Goldfields and Agricultural Country Water Area.
Kalamunda Rating Zone—Extensions.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Country Areas Water Supply Act, 1947-1960, that the Governor may, by Order in Council, alter or extend the boundaries of a Rating Zone: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby alter and extend the boundaries of the Kalamunda Rating Zone by adding and excising thereto the land described in the schedule hereto.

Schedule.

Extensions to Kalamunda Rating Zone.

(a) All that portion of land bounded by lines starting at a point on the present Kalamunda Rating Zone boundary situate at the south-eastern corner of Swan Location 1298 and extending northerly and westerly along boundaries of that location to the south-eastern side of road No. 3504; thence generally north-easterly along that side to its intersection with the north-eastern boundary of location 1763; thence south-easterly, 24 chains 29 and seven-tenths links along that boundary to the western side of a one-chain strip, being a former railway reserve as shown on Land Titles Office Plan 3230; thence generally northerly, north-easterly and easterly along that side to the north-western corner of lot 265 of Helena Location 20a, as shown on Land Titles Office Plan 4634; thence east-south-easterly and generally southerly along the northern and eastern boundaries of that lot and the eastern boundaries of lot 266 to the southern corner of the lastmentioned lot and onwards to the northern boundary of Swan Location 2639, a point on the present Kalamunda Rating Zone boundary, and thence generally north-westerly, southerly and south-westerly along that boundary to the starting point, as shown bordered green on Drawing No. 1 of Plan P.W.D., W.A. 39189.

(b) All that portion of land bounded by lines starting at a point on the present Kalamunda Rating Zone boundary situate on the northern boundary of Canning Location 570 at its intersection with the former boundary of the Canning Reservoir Water Reserve and extending generally
