Regulations.

Principal 1. In these regulations the Totalisator Agency Board Betting Regulations, 1961, published in the Government Gazette on the 8th February, 1961, and amended from time to time thereafter by notices published in the Government Gazette are referred to as the principal regulations.

Reg. 34B added.

2. The principal regulations are amended by adding after regulation 34A a regulation as follows:-

> 34B. All bets in respect of horse races conducted on race courses outside the State lodged with and received by or on behalf of the Board shall be so lodged and received subject to the condition that at any time prior to the running of any such horse race the Board may in its sole discretion decide that the bets in respect of that horse race are made with and received by or on behalf of the Board or are placed by the Board in a totalisator pool conducted by it on that horse race.

CITY OF PERTH PARKING FACILITIES ACT, 1956-1961.

HIS Excellency the Governor in Executive Council, acting pursuant to the provisions of the City of Perth Parking Facilities Act, 1956-1961, has been pleased to confirm the amendments to by-law 60 made under that Act, which amendments were made with the approval of the Minister for Transport by order of the Council of the City of Perth dated the 5th February, 1962, and set forth in the schedule hereunder.

City of Perth Parking Facilities Act, 1956-1961.

THE CITY OF PERTH.

By-law No. 60—Care, Control and Management of Parking Facilities—Amendment.

IN pursuance of the powers conferred by the said Act the Council of the City of Perth with the approval of the Minister orders that by-law No. 60 be amended as follows:—

- 1. That clause 12 thereof be repealed and the following be substituted therefor:—
 - 12. Where a parking stall is marked with the symbol "M/C" such stall is reserved for the parking of motor bicycles and bicycles and no person shall stand in any part of that stall any vehicle other than a motor bicycle to which no side-car or side-box is attached or a bicycle but such motor bicycle or bicycle may be parked in such stall without payment of any fee.
- 2. That clause 15 thereof be amended by adding after the last word thereof the words:—

or, in the case of a vehicle in No. 6 Parking Station, to the cashier at the City Parking Office.

- 3. That clause 25 thereof be amended by inserting after the last word thereof the words:
 - provided that this clause shall not prevent the parking of a motor bicycle and a bicycle together in a stall marked "M/C" if the bicycle shall be parked in accordance with clause 27A hereof.
- 4. That clause 30 thereof be amended by inserting after the last word thereof the words:—

provided that this clause shall not apply to a motor bicycle and a bicycle parked in a stall marked "M/C" if the bicycle shall be parked in accordance with clause 27A hereof.

- 5. That a new clause, to be numbered 27A, be inserted after clause 27 hereof as follows:—
 - 27A. No person shall stand or permit to stand any bicycle in a parking stall other than in a stall marked "M/C" and elsewhere in such stall than against the curb.
 - 6. That the Second Schedule thereto be amended by-
 - (a) inserting at the end of paragraph 1 thereof the following:—
 No. 6 Parking Station—situated at No. 152 Wellington Street
 - (b) inserting at the end of paragraph 2 thereof the following:-
 - (c) A weekly period is between 7 a.m. on a Monday and 12 noon on the following Saturday;
 - (c) inserting at the end of paragraph 3 thereof the following:-
 - (e) In No. 6 Parking Station-

For a weekly period (or any part of a week) 5s.
