FACTORIES AND SHOPS ACT, 1920-1959.

THE SPRAY PAINTING REGULATIONS, 1928

(Published in the Government Gazette on the 21st December, 1928, and incorporating the amendments published in the Government Gazette on the 13th October, 1939, the 10th January, 1941, and the 3rd May, 1955, and reprinted pursuant to the provisions of the Reprinting of Regulations Act, 1954.)

Reprinted pursuant to the Reprinting of Regulations Act, 1954, by authority of the Minister dated, 9th May, 1962.

THE SPRAY PAINTING REGULATIONS, 1928.

These Regulations may be cited as "The Spray Painting 1. Regulations, 1928.'

Reg. 1A. 1A. In these regulations "Spray Painting" shall mean the Added by G.G. 10/1/41, splication to any vehicle or article by spraying of lead paint, p. 38. silica paint, or any enamel, vitreous enamel, lacquer or other material having a nitrocellulose and/or inflammable liquid content.

2. In every factory in which vehicles or other articles are painted by the spraying process, there shall be provided to the satisfaction of the inspector, a suitable booth or cubicle within which such vehicles or other articles shall be sprayed.

Such booth or cubicle shall be of sufficient size to accommodate the vehicle or other articles to be sprayed, and to permit of the spray operator using the spraying apparatus with a reasonable degree of comfort and so that he shall not be exposed to dust and fumes.

Reg. 4. The internal walls and ceilings of every booth or cubicle Amended by 4. The internal walls and ceilings of every booth or cubicle G.G. 10/1/41, shall be constructed of smooth impervious non-combustible and ...36. non-inflammable materials and shall be free of any obstruction so as to permit of its being easily and effectively washed down and cleansed when required.

> 5. Every booth and paint shop shall be provided with a floor of hard and smooth material so constructed as to facilitate easy cleansing. Such floor shall be cleansed by washing or hosing upon the completion of each day's work.

Reg. 6. 6. Every booth or cubicle shall be fitted with an exhaust ran-Substituted by G.G. 10/1/41, the inspector, and be capable of producing and maintaining within p. 37. the booth a minimum air movement of not less than 100 linear feet per minute during which spraying operations are carried on.

7. There shall be fitted to every booth or cubicle in which an exhaust fan is operated, a metal tube or duct into which all vapours, fumes or dust extracted by such fans shall be discharged.

8. Such tube or duct shall be carried to the external air to a height exceeding the height of the eaves of the factory and of any adjacent building, or as the inspector directs, and shall be of a diameter and construction to be approved by the inspector.

9. The occupier shall provide for the use of every spray operator a suitable respirator of a type to be approved by the inspector. Such respirator shall be cleansed daily and be maintained in a clean and efficient condition, and when not in use shall be kept under cover in a place not within the booth or cubicle.

10. The occupier shall also provide a supply of clean water, soap and clean towels for the use of operators.

11. Overalls shall be thoroughly washed and cleansed at intervals of not less than one week and shall be kept in a closed locker or receptacle without the booth or paint shop when not in use.

Reg. 11A. 11A. (1) Subject to subregulation (2) of this regulation no Added by G.G. 3/5/55, person shall use or cause to be used heating or pre-heating equip-p 798. ment for spray painting unless the equipment has been first ment for spray painting unless the equipment has been first approved in writing by the Chief Inspector of Factories.

(2) Where the heating or pre-heating equipment for spray painting is electrically heated, before the Chief Inspector of Factories so approves, the owner or person using the equipment

shall produce to the Chief Inspector a written certificate from an inspector appointed under the Electricity Act, 1945, certifying that the owner or person using the equipment has complied with the regulations made under the Electricity Act, 1945, which are applicable to the equipment.

Reg. 12. 12. No occupier of a factory shall instal therein a paint G.G. 10/1/41, spraying apparatus without first having submitted to the Chief p. 37. Inspector of Factories for approval plans and specifications of the Inspector of Factories for approval plans and specifications of the booth or cubicle within which it is intended to operate such apparatus, and no such booth or cubicle shall be erected or altered in any factory unless and until the plan and specifications referred to have been approved by the Chief Inspector, and every booth or cubicle shall be constructed in accordance with the plan and specification so approved.

Reg. 13. 13. It shall be an offence for any paint-spraying to be carried G.G. 10/1/41, on elsewhere than within the booth or cubicle except with the p. 37. approval of the Chief Inspector of Factories.

14. Every operator of paint-spraying apparatus shall wear suitable overalls and head coverings during the whole working period, and shall use the respirator provided by the employer.

15. Every painter shall carefully clean and wash his hands, arms and face on ceasing work and shall abstain from smoking, eating or drinking in or near the booth or in any room wherein painting is being done. "Painting" for the purpose of this regulation means painting either by brush or by spraying.

16. Operators shall not paint by spraying at right angles to a flat surface, and shall not test the sprayer by spraying promiscuously about the room or booth.

17. A copy of these regulations shall be exhibited in a con-spicuous place in every factory in which vehicles or other articles are painted by the spraying process. Such copy of the regulations shall be maintained in a legible condition.

Reg. 18. 18. (1) Any person who contravenes or neglects, refuses or by G.G. fails to comply with any provision contained in these regulations 10/1/41, shall be guilty of an offence, and shall be liable to a penalty not p. 37. exceeding five nounds exceeding five pounds.

(2) The minimum penalty which may be imposed upon any person convicted of any offence against these regulations shall be— (i) On a first conviction-Two pounds; and

(ii) On a second or subsequent conviction-Five pounds.

FACTORIES AND SHOPS ACT, 1920-1959.

THE ELECTRIC ACCUMULATOR REGULATIONS, 1931

(Published in the Govenment Gazette on the 6th November, 1931, and incorporating the amendments published in the Government Gazette on the 13th October, 1939, and reprinted pursuant to the provisions of the Reprinting of Regulations Act, 1954.)

THE ELECTRIC ACCUMULATOR REGULATIONS, 1931.

1. These Regulations may be cited as "The Electric Accumulator Regulations, 1931," and shall have application to those factories or parts thereof in which electric accumulators are manufactured or repaired.

Provided that these regulations shall not apply to the manufacture or repair of electric accumulators or parts thereof not containing lead or any compound accumulator forming part of a stationary battery.

Reg. 2. Amended by G.G. 13/10/39, p. 1788. 2. In these regulations, subject to the context—

"lead process" means the melting of lead or any other material containing lead, casting, pasting, lead burning, or any other work, including trimming, or any other abrading or cutting of pasted plates, involving the use, movement, or manipulation of, or contact with, any oxide of lead;

"manipulation of raw oxide of lead" means any lead process involving any manipulation or movement of raw oxide of lead other than its conveyance in a receptacle or by means of an implement from one operation to another;

and where any term which is defined in the Factories and Shops Act, 1920-1937,¹ is used in these regulations, such term shall have the same meaning as that given to it in the Factories and Shops Act, 1920-1959.

Duties.

3. It shall be the duty of the occupier to observe Part I of these regulations.

It shall be the duty of every person employed to observe Part II of these regulations.

Part I.—Duties of Occupiers.

4. Each of the following processes shall be carried on in such a manner and under such conditions as to secure effectual separation from one another and from any other process:—

- (a) Manipulation of raw oxide of lead.
 - (b) Pasting.
 - (c) Drying of pasted plates.

(d) Formation with lead burning ("Tacking").

(e) Melting down of pasted plates.

5. In every room in which a lead process is carried on there shall be at least 500 cubic feet of air space for each person employed therein, and in computing this air space no height over 12 feet shall be taken into account.

7. In every pasting room the distance between the centre of the working position of any paster and that of the paster working nearest to him shall not be less than five feet.

8. The floor of every room in which a lead process is carried on shall be—

- (a) of cement or similar material, so as to be smooth and impervious to water;
- (b) maintained in sound condition;
- (c) kept free from materials, plant, or other obstruction not required for or produced in the process carried on in the room;
 - and in all such rooms other than grid-castings, shops shall be—
- (d) cleansed throughout daily after being thoroughly sprayed with water at a time when no other work is being carried on in the room;
 - and in grid-casting shops shall be—
- (e) cleansed throughout daily;
 - and, in addition, where manipulation of raw oxide of lead or pasting is carried on, shall be—
- (f) kept constantly moist while work is being done;
- (g) provided with suitable and adequate arrangements for drainage;
- (h) thoroughly washed daily by means of a hosepipe.
- 9. The work benches at which any lead process is carried on l
 - (a) have a smooth surface and be maintained in sound condition;
 - (b) be kept free from all material or plant not required for or produced in the process carried on thereat;
 - and all such work benches other than those in gridcastings shops shall—
 - (c) be cleansed daily, either after being thoroughly damped or by means of a suction-cleaning apparatus at a time when no other work is being carried on thereat;
 - and all such work-benches in grid-casting shops shall—
 - (d) be cleansed daily;

shall-

- and every work-bench used for pasting shall-
- (e) be covered throughout with sheet metal or other impervious material;
- (f) be provided with raised edges;
- (g) be kept constantly moist while pasting is being carried on.

10. The following processes shall not be carried on without the use of an efficient exhaust draught:—

- (a) Melting of lead or materials containing lead.
- (b) Manipulation of raw oxide of lead, unless done in an enclosed apparatus so as to prevent the escape of dust into the workroom.
- (c) Pasting.
- (d) Trimming, brushing, filing, or any other abrading or cutting of pasted plates giving rise to dust.
- (e) Lead burning, other than-
 - (i) "tacking" in the formation room;
 - (ii) chemical burning for the making of lead linings for cell cases necessarily carried on in such a manner that the application of efficient exhaust is impracticable.

Such exhaust draught shall be effected by appliances approved by the Chief Inspector of Factories, and shall operate on the dust or fume given off as nearly as may be at its point of origin, so as to prevent it entering the air of any room in which persons work.

Provided that, at pots containing molten lead, the exhaust draught may be effected by natural means, but, if so effected, shall not be deemed to be efficient unless it produces through the working opening over the pot an average air velocity measured across the plane of the opening of at least 120 linear feet per minute.

11. The products of combustion produced in the heating of any melting pot shall not be allowed to escape into a room in which persons work.

12. A suitable receptacle with tightly-fitting cover shall be provided and used for dross as it is removed from every melting pot.

Such receptacle shall be kept covered while in the workroom, except when dross is being deposited therein.

13. In every workroom there shall be provided a suitable covered receptacle, in which shall be deposited old plates and waste material.

14. The racks or shelves provided in any drying room shall not be more than eight feet from the floor nor more than two feet in width.

Provided that, as regards racks or shelves set or drawn from both sides, the total width shall not exceed four feet.

Such racks or shelves shall be cleansed only after being thoroughly damped, unless an efficient suction-cleaning apparatus is used for this purpose.

15. A Health Register, containing the names of all persons employed in a lead process, shall be kept in a form approved by the Chief Inspector of Factories, and, where any employee is absent from work for three days owing to supposed lead poisoning, the name, address, age, date of cessation from work, duration of absence shall be entered by the employer in the Health Register.

The Health Register kept in pursuance of this regulation shall, upon demand being made by an Inspector of Factories at reasonable times, be produced for examination.

16. The occupier shall, within 24 hours of any entry being made in the Health Register, notify in writing to the Chief Inspector of Factories that such entry has been made.

17. Protective clothing shall be provided and maintained in good repair for all persons employed in—

(a) manipulating of raw oxide of lead;

(b) pasting;

(c) the formation room.

Such protective clothing shall consist of an overall, an apron made of material impervious to water, and clogs or other suitable footwear; and, also, as regards persons employed in the manipulation of raw oxide of lead or in pasting, head covering.

The overalls and head coverings provided for the persons employed in the manipulation of raw oxide of lead or in pasting shall be washed or renewed weekly.

18. There shall be provided and maintained for the use of all persons employed in a lead process—

- (a) a cloakroom for clothing put off during working hours. Such accommodation shall be separate from any mess room.
- (b) Separate and suitable arrangements for the storage of protective clothing provided under regulation 17.

19. There shall be provided and maintained in a cleanly state and in good repair for the use of all persons employed in a lead process-

(a) Lavatory, under cover, with either—

- (i) a trough with a smooth impervious surface fitted with a waste pipe, without plug, and of sufficient length to allow of at least two feet for every five such persons employed at any one time, and having a constant supply of warm water, from taps or jets above the trough at intervals of not more than two feet; or
- (ii) at least one lavatory basin for every five such persons employed at any one time, fitted with a waste pipe and plug, and having either a constant supply of hot and cold water or warm water laid on, or (if a constant supply of heated water be not reasonably practicable) a constant supply of cold water laid on, and a supply of hot water always at hand when required by such persons for use; and

a sufficient supply of clean towels made of suitable material renewed daily; which supply in the case of pasters and persons employed in the manipulation of raw oxide of lead, shall include a separate marked towel for each such worker; and

a sufficient supply of soap or other cleansing material and of nail brushes.

(b) There shall, in addition, be provided means of washing in close proximity to the rooms in which manipulation of raw oxide of lead or pasting is carried on, if required by notice in writing from the Chief Inspector of Factories.

20. Sufficient bath or shower-bath accommodation shall be provided for all persons engaged in the manipulation of raw oxide of lead, or in pasting, with hot and cold water laid on, and a sufficient supply of soap and clean towels.

Part II.—Duties of Persons Employed.

21. (a) Every person employed in a lead process shall deposit in the cloakroom provided in pursuance of regulation 18 (a) all clothing put off during working hours.

(b) Every person employed in the manipulation of raw oxide of lead, in pasting, or in the formation room, shall wear the protective clothing provided under regulation 17. The protective clothing, when not being worn, shall be deposited in the place provided under Regulation 18 (b).

22. No person shall introduce, keep, prepare, or partake of any food or drink, nor make use of tobacco in any place in which a lead process is carried on.

23. Every person employed in a lead process shall, before partaking of food or drink, or making use of tobacco, or leaving the premises, wash the hands, and every such person employed in the manipulation of raw oxide of lead or in pasting shall, in addition, wash the face.

24. Every person, when drossing, shall immediately deposit the dross in the receptacle provided under Regulation 12.

25. Every person employed in a lead process shall make full and proper use of the appliances provided for any of the purposes of these regulations.

26. Every person employed in a factory in which a lead process is carried on shall, whenever required so to do, submit to an examination by the Commissioner of Public Health or some duly qualified medical practitioner appointed by him. 27. Every person employed in a factory in which a lead process is carried on, and who suffers from any symptoms which lead him to believe that he has contracted poisoning of any kind, shall forthwith notify the occupier as to such symptoms, and the occupier shall record such notification in the Health Register.

28. No person shall misuse, or, without the concurrence of the occupier or manager, in any way interfere with any appliance provided in pursuance of these regulations.

Posting of Regulations.

29. A copy of these regulations shall be exhibited in a conspicuous place in every factory in which electric accumulators are manufactured or repaired. Such copy of regulations shall be maintained in a legible condition.

Penalty.

30. The penalty for a breach of the terms of any of these regulations shall be a sum not exceeding $\pounds 5$.

THE FACTORIES (POISONOUS SUBSTANCES) REGULATIONS, 1932

(Published in the Government Gazette on the 28th October, 1932, and incorporating the amendments published in the Government Gazette on the 13th October, 1939, and reprinted pursuant to the provisions of the Reprinting of Regulations Act, 1954.)

THE FACTORIES (POISONOUS SUBSTANCES) REGULATIONS, 1932.

1. These regulations may be cited as the Factories (Poisonous Substances) Regulations, 1932.

2. These regulations are divided into Parts as follows:----

Part I.--Regulations 3 and 4-General.

Part II.—Regulation 5—Factories in which arsenic or arsenical compounds are used or manufactured.

 Part III.—Regulation 6—Factories in which lead or poisonous compounds of lead are used or manufactured.
 Part IV.—Regulations 7 and 8—Miscellaneous.

Part I.—General.

Reg. 3. Amended by G.G. 13/10/39, p. 1788. 3. In every factory where lead or arsenic, or any poisonous compound of lead or of arsenic is used or manufactured, the following provisions shall apply and be observed, namely:---

- (1) The occupier shall provide and maintain clean and in good order, repair, and condition for the use of all persons employed or remaining on, in, or about the factory—
 - (a) a lavatory, under cover, with a sufficient supply of clean towels, to be renewed daily, and of soap and nail brushes, and fitted either—
 - (i) with a trough with a smooth impervious surface, fitted with a wastepipe without plug, and of such length as to allow at least two feet for every five persons employed in the factory at any one time, and having a constant supply of warm water from taps or jets above the trough at intervals of not more than two feet; or
 - (ii) with at least one lavatory basin for every five persons employed in the factory at any one time, fitted with a waste-pipe and plug, and having a constant supply of hot and cold water or warm water laid on to each basin;

\$

- (b) a suitable and adequate meal room which is—
 - (i) sufficiently ventilated and separated from any workroom adjoining the same by a wall or partition extending from floor to ceiling without having any door, window, or other opening therein; and
 - (ii) furnished with sufficient tables and chairs or benches with back rests, and with adequate means and appliances for warming food and for boiling water;
- (c) a suitable room for the accommodation and changing of clothing put off by employees during working hours, which shall be adjacent to the place where washing and bathing facilities are provided, and which shall be separated from but may adjoin the meal room, and which shall contain at least six square feet of floor space for each person employed at any one time, and adequate arrangements for drying wet clothes: Provided that—
 - (i) if hooks or pegs are provided for hanging clothes, there shall be at least two hooks or pegs for each employee set at least eighteen inches apart; and
 - (ii) if lockers are provided, there shall be at least one locker for each employee, and such locker shall be at least five feet high, one foot six inches wide and one foot deep, ventilated at top and bottom, and approved of by the Chief Inspector of Factories;
- (d) adequate and sufficient facilities and appliances, appoved by an inspector, to enable persons employed and remaining on, in, or about the factory to wash their mouths.
- (2) The occupier shall allow each person employed or remaining on, in, or about the factory at least ten minutes before each meal and before the end of each day's work, in addition to the time allowed for regular meal times, for the purpose of washing himself.
- (3) Where a meal room, cloak room, baths, and sanitary conveniences are required to be provided in the factory, either under the provisions of the Factories and Shops Act, 1920-1959, or these regulations, the occupier shall, if the Chief Inspector of Factories so requires, cause such rooms, baths, and conveniences, and any furniture, fittings, and appliances contained therein or used in connection therewith to be placed under the charge of a responsible person and to be maintained in a clean condition.
- (4) The occupier shall cause the floors of the factory to be cleaned daily after being thoroughly dampened.
- (5) The occupier shall not permit any person to partake of a meal in, on, or about the factory, except in the meal room provided for that purpose.
- (6) The occupier shall keep or cause to be kept at the factory a book, to be called "The Health Register," in accordance with the Form No. 1 in the Appendix to these regulations, for the purpose of recording therein particulars concerning every person who becomes

poisoned or otherwise affected as the result of his occupation whilst employed in, on, or about the factory, and shall enter in such book the following particulars:---

- (a) The name and address of every person employed in, on, or about the factory; and
- (b) particulars of every notification of symptoms of poisoning or other affection by any of such employees; and
- (c) the date of such notification.
- (7) Every person employed in, on, or about the factory who is suffering from any symptoms which may lead him to believe that he has contracted poisoning of any kind shall forthwith notify the occupier of such symptoms.
- (8) Every person employed in, on, or about the factory shall, whenever required so to do by the occupier, or the Commissioner of Public Health, or by an inspector, submit to an examination by the Commissioner of Public Health or some duly qualified medical practitioner appointed by the said Commissioner. Such examination shall take place at intervals of not longer than one calendar month, and shall be conducted at the expense of the occupier, who shall be liable for and shall pay to the person conducting every such examination the fee or charge payable in respect thereof on demand.
- (9) The Commissioner or medical practitioner who has conducted any such examination as aforesaid may order the suspension from employment of any person examined by him; and no person whose suspension from employment has been so ordered shall work or be employed in the factory without the approval in writing of the Commissioner of Public Health, or of the medical practitioner who examined such employee.

4. The occupier of any factory shall forthwith send written notice, in accordance with Form No. 2 in the Appendix to these regulations, to the nearest inspector whenever it comes to his knowledge that any employee is suffering from lead or arsenical poisoning.

Part II.—Factories in Which Arsenic or Arsenical Compounds are Used or Manufactured.

5. In every factory where arsenic or any arsenical compounds are used or manufactured, the provisions of Part I. of these regulations, and, in addition thereto, the following provisions, shall apply and be observed, namely:—

- (1) The occupier shall provide and maintain clean and in good order, repair, and condition for the use of persons employed in, on, or about the factory—
 - (a) sufficient and suitable shower-bath accommodation, with hot water laid on; and
 - (b) sufficient and suitable overalls, under-clothing, head coverings, and clean respirators, to the satisfaction of the Inspector, and shall cause the employees to wear the same during working hours;
 - (c) sufficient and suitable change rooms, to the satisfaction of an Inspector, so arranged that clothing worn by employees during working hours in, on, or about the factory shall not be changed or stored in the same room as clothing worn by such employees outside the factory.
- (2) The occupier shall cause all clothing worn by employees during working hours to be collected and thoroughly washed daily.

(3) Every person engaged in-

- (a) condensation chambers; or(b) flues; or

 - (c) setting or drawing furnaces; or
 (d) feeding screw conveyors; or
 (e) handling or packing arsenic or any poisonous compound of arsenic,

or in any other work involving exposure to dust of any arsenic or poisonous compound of arsenic shall, while so engaged, wear an overall suit, suitable underclothing, headcovering, and respirator.

Part III.—Factories in which Lead or any Poisonous Compound of Lead is Used or Manufactured.

6. In every factory in which lead, or any white lead, red lead, litharge, or any other compound of lead is used or manufactured, the provisions of Part I of these regulations, and, in addition thereto, the following provisions, save and except as otherwise hereinafter provided, shall apply and be observed:

- (1) The occupier shall provide and maintain clean and in good order, repair, and condition for the use of persons employed in, on, or about the factory---
 - (a) a sufficient and suitable bath accommodation (douche or other) with hot water laid on, unless the water supply and appliances for washing provided in accordance with subparagraph (a) of paragraph (1) of regulation three of these regulations are so arranged that a warm douche for the face, neck and arms can be taken;
 - (b) sufficient and suitable overalls, head coverings, and respirators, to the satisfaction of an Inspector; and shall cause the employees to wear the same during working hours;
 - (c) a suitable place set apart for the purpose outside the factory building and approved by an Inspector for the storage of overalls, head coverings and respirators when not being used.
- (2) The occupier shall cause all overalls, head coverings, and respirators to be collected at the end of each day's work and stored in the place set apart for that purpose.
- (3) The occupier shall cause all overalls, head coverings, and respirators which have been used by employees engaged in setting or drawing stoves to be thoroughly washed daily, and all overalls, head coverings, and respirators used by other employees to be thoroughly washed at least once in every week.
- (4) Every person engaged in-
 - (a) white beds; or
 - (b) emptying chambers; or
 - (c) rollers, washbecks, or grinding; or
 (d) setting or drawing stoves; or

 - (e) packing; or

 - (f) paint mixing; or(g) handling dry lead compounds,

or in any other work involving exposure to dust of any lead compounds shall, whilst so engaged, wear an overall suit and head covering.

- (5) Every person engaged in-
 - (a) emptying white beds; or(b) emptying chambers; or

 - (c) dry grinding; or
 (d) packing dry lead compounds; or
 (e) handling dry lead compounds; or

 - (f) entering a chamber used for the condensation or recovery of lead compounds,

shall, whilst so engaged, wear a respirator in addition to an overall suit and head covering: Provided that the provisions of this regulation shall not apply to factories used in or in connection with the following classes of business, namely:—

- (a) Printing and type-setting;
- (b) paint shops;
- (c) plumbing and sheet metal works;
- (d) potteries;
- (e) tile works;
- (f) engineering and electrical appliance factories; or
- (g) brass and other metal foundries.

Part IV.-Miscellaneous.

7. A copy of these regulations shall be exhibited in a conspicuous place in every factory in which lead or arsenic or any poisonous compound of lead or arsenic is used or manufactured, and shall at all times be maintained in a clean and legible condition.

8. Any person who is by act or omission guilty of or party or privy to any breach of these Regulations shall be liable on summary conviction to a penalty not exceeding Five pounds.

FACTORIES AND SHOPS ACT (GENERAL) REGULATIONS, 1939.

These regulations may be cited as the Factories and Shops Act (General) Regulations, 1939.

2. These regulations are divided into Parts, as follows:-

Part I.--Regulation 3-Preliminary.

Part II.—Regulation 4—Appointment of Inspectors. Part III.—Regulation 5-12—Registration of Factories. Part IV.—Regulation 13-17—Regulation of Factories and Factory Work.

Part V.-Regulation 18-38-Provisions relating to Health, Sanitation, and Safety.

Part VI.-Regulation 39-Special provisions relating to certain Trades.

Part VII.--Regulation 40-49-Closing of Shops.

VIII.—Regulation 50-51—Provisions relating Part to Employment of Assistants in Shops.

Part IX .-- Regulation 52-53-Registration of Shops and Warehouses.

Part X.-Regulation 54-Miscellaneous.

Part I.—Preliminary.

3. In these regulations, unless the contrary intention appears, the term "the Act" means the Factories and Shops Act, 1920-1959, as reprinted under the Amendments Incorporation Act, 1938, and any Acts amending the same, and terms which are defined in the Act when used in these regulations shall have the same meanings as those given to such terms by the Act.

Part II.—Appointment of Inspectors.

Reg. 4. Amended by G.G. 10/1/47, p. 61.

4. Every applicant for the position of inspector of factories shall produce satisfactory evidence of character and reliability and shall have passed an examination to the satisfaction of the examiners appointed by the Minister, showing that he or she possesses the following qualifications, namely:—

(a) a fair standard of general education, including a sound knowledge of the rules of arithmetic up to and including square root and decimal fractions;

- (b) a sound knowledge of the Act and these regulations and of the Industrial Arbitration Act, 1912-1961, and any amendment thereto and the regulations thereunder;
- (c) a sound knowledge of the subject matter of the following text books—
 - (1) Hope, Hanna and Stallybrass "Industrial Hygiene and Medicine," 1923 edition (excluding pages 278 to 463 and 520-552, inclusive).
 - (2) Randerson "Australian Sanitary Engineering Practice," 1935 edition (excluding chapters 12, 13 and 14).

Part III.—Registration of Factories.

5. (1) An application for registration of any building, premises, or place as a factory shall be lodged with the Chief Inspector in the Form 1 in the Appendix A to these regulations.

(2) The applicant must fill in truthfully and accurately the particulars required to be filled in by the applicant in the Form 1 in Appendix A to these regulations and in the Certificate of Registration attached to that form.

6. If and whenever the Chief Inspector, pursuant to paragraph (a) of subsection (2) of section 20 of the Act, forbids the use of any premises registered as a factory for the purpose for which they are used, or intended to be used, he shall serve a notice on the occupier of the said premises in the Form 2 in the Appendix A to these regulations.

7. Every requisition of an inspector pursuant to paragraph (b) of subsection (2) of section 20 of the Act to an applicant for registration of premises as a factory shall be made in the Form 3 in the Appendix A to these regulations.

8. A notice of appeal against the requisition of an inspector pursuant to paragraph (4) of section 21 of the Act shall be in the Form 4 in the Appendix A to these regulations, and shall be served on the clerk of the local court nearest to the place where the factory, shop, or warehouse is situated, and on the inspector, within 14 days after service of such requisition.

9. Upon receipt of such notice the clerk of the said court shall fix a date for the hearing of the appeal, and set the case down for hearing on such date, and shall cause a notice of the day of hearing to be sent to the parties in the Form 5 in the Appendix A to these regulations.

10. A notice pursuant to section 22 of the Act given by the Minister to the owner of premises registered as a factory which require any structural alterations or building additions that he will regard such owner for the purpose of making such alterations or additions as the occupier thereof, shall be in the Form 6 in the Appendix A to these regulations.

Reg. 12. Amended by G.G. 30/6/59, p. 1769. 11. (1) The Chief Inspector shall keep a register of factories wherein he shall cause to be entered particulars of every registration effected by him.

(2) The register may be kept by the Chief Inspector in the Form 7 in Appendix A to these regulations or by filing the application forms in the Form 1 in the Appendix A to these regulations as a register.

12. The occupier of every factory registered under the Act shall, on or before the 31st day of January in each year, send to the Chief Inspector, together with the prescribed fee, an application for re-registration of such factory, in the Form 1 in the Appendix A to these regulations.

Part IV.-Regulation of Factories and Factory Work.

13. The record of the employees of a factory required to be kept pursuant to paragraph (a) of section 27 of the Act shall be kept in the Form 9 in the Appendix A to these regulations, or in such other form as the Chief Inspector may approve of in writing.

Such record shall be kept at the factory and shall be entered up daily.

14. A notice by the occupier of a factory pursuant to paragraphs (a) and (c) of section 37 of the Act of having availed himself of the provisions of sections 33, 35, or 36 of the Act, and specifying the names of the workers to whom the extension of the working hours applied, and the period of such extension, shall be sent to the Chief Inspector within twenty-four hours after the commencement of the extra working, in the Form 10 in the Appendix A to these regulations.

15. The industries specified in Appendix B to these regulations shall be special industries for the purposes of section 36 of the Act.

16. The record required by section 42 of the Act to be kept by the occupier of a factory who lets out or gives out work of any description in connection with textile or shoddy material to be done by any person elsewhere than in a factory, shall be kept in the Form 11 in the Appendix A to these regulations.

17. Application for registration as an outside worker pursuant to section 44 of the Act shall be lodged with the Chief Inspector in the Form 12 in the Appendix A to these regulations.

Part V.—Provisions Relating to Health, Sanitation, and Safety.

Cubic Reserved Space. (Sections 61 (b) and 133 (e)).

18. Every factory, shop, or warehouse, and every portion thereof, shall contain such cubic reserved space as shall be determined by the Chief Inspector: Provided always, that such reserved space shall not be less than 350 cubic feet for each person employed therein (exclusive of the space occupied by goods, cases, furniture, and fittings). When gas is used as an illuminant, 350 cubic feet of air space shall be deducted for each light.

In the calculation of cubic space the maximum height taken shall be 14 feet.

Lighting.

Reg. 18A. Added by G.G. 12/10/45, p. 989.

18A. Where after the commencement of this regulation provision is made in any building used as a factory, shop or warehouse for the interior illumination of such building by natural light such provision shall be such as is in conformity with the Australian Standard Code for the interior illumination of buildings by natural light as from time to time declared and published by the Standards Association of Australia.

18B. Where after the commencement of this regulation—

- (a) any artificial lighting system is installed in any factory, shop or warehouse for the interior illumination of the building; or
- (b) any artificial lighting system already installed in any factory, shop or warehouse for the interior illumination of the building is altered or extended,

such lighting system shall be so installed, or so altered and extended, as the case may be, so as to be in conformity with the Australian Standard Code for the interior illumination of buildings by artificial light as from time to time declared and published by the Standards Association of Australia.

Ventilation.

Reg. 19. Amended by G.G. 12/10/45, p. 989 19. (a) If a system of mechanical ventilation approved by the inspector is not installed and properly utilised, each workroom shall be provided with means of ventilation by openings other than windows or doors, for the inlet and outlet of air, in the proportion (except where otherwise expressly provided) of not less than 12 square inches of inlet openings and 12 square inches of outlet openings for each person employed in such workroom, such space to be calculated exclusive of all bars, ornamentation, or other obstruction thereto. Such inlet openings shall be provided at the height of about 7 feet from the floor level by tubes, shafts, or hoppers in the external walls, external doors, or external windows, and shall be kept permanently open; and such outlet openings as close to the ceiling thereof as may be practicable, or else in the ceiling; and in the latter case, there shall be connected with each such opening an open tube or shaft having a transverse area equal to that required, and leading through and above the roof of the building, and having its upper end terminating in a cowl or other similar contrivance.

(b) The provisions of this regulation shall not, unless considered necessary by the inspector, apply to a work-room in which there is a fireplace with chimney and a window made to open, and in which not more than four persons are employed.

Proper means for outlet ventilation shall be provided for all stairwells.

(c) Notwithstanding anything to the contrary contained in either paragraph (a) or paragraph (b) of this regulation the provisions made in every factory, shop or warehouse after the commencement of this paragraph for the ventilation thereof shall be such as shall in every respect conform with the Australian Standard Code for the ventilation of buildings as from time to time declared and published by the Standards Association of Australia.

Heating Appliances.

20. (a) Means and appliances for efficiently warming the factory shall be provided, when such means and appliances are considered necessary by the inspector.

(b) The provisions of paragraph (a) of this regulation shall, if required in writing by the Chief Inspector of Factories, be complied with in the case of any building registered at any time as a factory.

21. Except in the case of an electric heater, every heating appliance in every workroom, whether used for the warming of such room or in connection with the work carried on therein, shall be provided with a flue at least four inches in diameter, and extending to the outer air to a point at least eight feet above the appliance.

Lavatories (Section 75).

22. In every factory, shop, or warehouse there shall be provided proper lavatory accommodation to the satisfaction of the inspector. Such accommodation shall consist of wash basins, with sufficient water supply, and fitted with trapped waste pipe or pipes connected with a drain. The basins shall not be fewer in number than one to twenty persons employed, and shall be situated under cover and be convenient of access.

In factories, shops or warehouses in which the majority of those employed or engaged are to be of one sex and not more than two are to be of the other sex, separate and distinct closet accommodation for the persons of different sexes shall not be required if in the opinion of the Chief Inspector the same is suitably provided in adjoining or adjacent premises.

· · · · ·

23. (a) In every factory, shop or warehouse which is connected with any system of sewerage there shall be provided sanitary conveniences for the use of the persons employed or engaged, in accordance with the following scale and conditions:—

Water Closets	Proportion of Pans to Female Employees	Proportion of Pans to Male Employees
When the number of em- ployees does not exceed 100	One to twenty	One to twenty-five
When such number exceeds 100 but does not exceed 200	One to twenty-five	One to thirty
When such number exceeds 200	One to twenty-five	One to forty

(b) Closets for different sexes shall not adjoin each other, unless separated by a wall of brick, stone, or concrete of approved thickness.

(c) The door of every external closet shall be properly screened at least 6 feet high, and reaching to the ground, and, if required, a screen shall be fixed to prevent the closet being visible from overlooking windows.

(d) Any closet for the use of females shall have a separate entrance behind such screen, and such entrance shall not be within 12 feet from the entrance of any closet intended for the use of males.

(e) In every factory, shop, or warehouse in which more than twelve males are employed, urinal accommodation shall be provided in the proportion of one stall to each 30 employees.

24. (a) In every factory, shop or warehouse which is not connected with an approved system of sewerage, there shall be provided sanitary conveniences for the use of the persons employed or engaged, in accordance with the following scale and conditions:—

Earth or Pan Closets	Proportion of Pans to Female Employees	
When the number of em- ployees does not exceed 100	One to ten	One to fifteen
Where such number exceeds 100 but does not exceed 200	One to fifteen	One to twenty
Where such number exceeds 200	One to fifteen	One to thirty

(b) In every factory, shop, or warehouse, subject to this regulation and in which more than six males are employed, suitable and sufficient urinal accommodation shall be provided to the satisfaction of the inspector.

(c) The provisions of paragraphs (b), (c), and (d) of regulation No. 23 shall apply in like manner to every factory, shop or ware-house to which this regulation applies.

Fire Escape (Section 80, par. (2)).

25. The following requirements regarding means of escape shall be complied with in all factories, provided that places that have been registered and occupied as factories prior to the coming into

(a) There shall be provided for every floor of a factory above the ground floor a primary and an alternative escape in case of fire. These shall be so constructed and situated as to allow of each escape being readily and safely accessible to and usable by all of the persons who may be accommodated on the different parts of every floor so that, should exit by one escape become obstructed by fire or smoke, exit by the other shall be instantly available and safely accessible and usable.

(b) The main traffic internal stairway for each floor above the ground floor in every factory shall be deemed to be the primary escape in case of fire.

(c) The alternative escape shall, wherever practicable, be an external stair, any windows in close proximity to which shall have metal frames and sashes and be glazed with wire rolled plate glass. Wherever it is impraticable to build an external stair, it shall be an internal stair completely fire-isolated, situated as far as possible from lifts or other stairs, and having direct communication with the outer air.

(d) Provided that, for any buildings situated within any municipality or road district, other means of escape which do not comply with all the requirements of these regulations may be accepted, if the building surveyor or engineer of such municipality or road district, or the chief officer, W.A. Fire Brigades' Board, certifies in writing that, in his opinion, full compliance is impracticable, unsuitable, or unnecessary and that the other means of escape (specified in the certificate) are at least as safe and effective.

Stairs and Landings.

26. All stairs and landings shall be constructed of fire-resisting materials with—

- (a) straight flights, with half-space or quarter-space landings at intervals of not more than sixteen nor less than two risers;
- (b) a securely fixed continuous hand rail on one side at a vertical height of not less than two feet ten inches above the nosing of the tread, and not less than three feet above the landing where the stairway is three feet four inches or less in width, and two such continuous handrails (one on each side) where the stairway is over three feet four inches in width; balusters or mid-rails shall be provided to every open side of every unenclosed stair;
- (c) a clear headway throughout of not less than six feet six inches;
- (d) steps of uniform dimensions throughout, with strongly secured treads, not less than 10 inches, exclusive of nosing, and risers of not more than 7 inches;
- (e) the underside of stairs lines, except where risers are fitted;
- (f) a landing at each floor of the same width as the stair, with a fire resisting self-closing door, not less than six feet six inches high, of the same width as the landing, and opening outwards, so as not to obstruct the landing. Such door shall be fitted with such fastenings as the Chief Inspector may direct to be provided;
- (g) a width of stair not less than two feet eight inches when the floor area is not more than one thousand square feet; three feet four inches where the floor area

is more than one thousand and not more than two thousand square feet, and thereafter in accordance with the following scale:—

Area of Each Floor in Square Feet		Total Width of Stairs or Exits
2,000 to 4,000 4,000 to 6,000 6,000 to 8,000 8,000 to 10,000 Over 10,000		 4 ft. 2 in. 5 ft. 0 in. 5 ft. 10 in. 6 ft. 8 in. An additional 10 in. in width for every 2,000 square feet of additional floor area

- (h) All exit doors shall be so arranged as to be readily visible, and no obstructions in the form of partitions or other erections interfering with access or visibility shall be permitted.
- (i) Every fire escape staircase, whether internal or external, and whether erected before or after the coming into operation of this regulation, shall be maintained and kept in good and substantial repair and fit for use to the satisfaction of the inspector.
- (j) All walls and partitions enclosing any stair shall be of fire-resisting material. Fire isolated stairs shall be enclosed by reinforced concrete walls, not less than 4 inches thick, or by terra cotta walls not less than 6 inches thick, or by brick, stone, or concrete walls not less than 9 inches thick.

Fire Extinction.

27. (1) The following or other appliances, if approved of as equally effective by the Chief Inspector, shall be provided:—

- (a) In factories in which more than 25 persons are employed—iron pipes, not less than 3 inches in diameter, conducting water from a street water main to within the building, with taps with $2\frac{1}{2}$ inches outlet, fitted with fire brigade standard hose cocks and hoses of the same dimensions and of such numbers and in such positions as may be approved by the Chief Inspector.
- (b) In factories in which not more than 25 persons are employed, the iron pipes shall be not less than 3 inches in diameter, with taps with 2½ inches outlet fitted, with fire brigade standard hose cocks and hoses of the same dimensions and of such numbers and in such positions as may be approved by the Chief Inspector. Provided that, when in respect to any such factory the Chief Officer of Western Australian Fire Brigades Board has certified in writing that the occupier has provided sufficient and suitable fire-extinguishing appliances to the satisfaction of such Chief Officer, the occupier shall not also be required to provide iron water pipes, taps, standard hose and cocks, and hose as herein specified.
- (c) In every factory which is subject to this regulation, there shall be provided to the satisfaction of the Chief Inspector a sufficient number of chemical fireextinguishers, each of which having a fluid capacity of two gallons shall be provided for every 1,600 square feet of floor space in the factory.

(2) Arrangements satisfactory to the Chief Inspector shall be made for all appliances to be maintained in an effective condition. Every occupier who has entered into an agreement or arrangement with the W.A. Fire Brigades Board for the supervision and maintenance of fire-extinguishing appliances provided under these regulations shall, so long as such agreement or arrangement is in operation, be deemed to have complied with this regulation.

28. No person shall smoke or carry a lighted cigar, cigarette, pipe, or match or any naked light within or into any room or enclosed space, or any cellar or basement, or any part of any premises used as a factory in which any explosive or highly combustible or inflammable material is manufactured or stored.

29. A conspicuous notice comprising the words "Smoking strictly prohibited" shall be posted in a conspicuous position in each part of the factory to which the preceding paragraph applies.

Egress Space.

30. The amount of egress space from the ground floor which shall be provided for any factory occupied by not more than twentyfive persons shall not be less than two feet eight inches: if occupied by more than twenty-five persons, but not exceeding one hundred persons, it shall be not less than three feet four inches. If occupied by a greater number of persons, the egress space shall be increased at the rate of 20 inches for every additional 100 or fraction of 100 persons.

Where the amount of egress space required on the ground floor exceeds five feet, at least two separate doorways, placed as far apart as practicable, shall be provided. No doorway or gateway shall be less than two feet eight inches wide and six feet six inches high in the clear.

Internal approaches to Doorways.

31. No aisle may be less than two feet eight inches wide. The aggregate width of aisles, passages, or gangways is to be at least as wide as the stairways or doorways to which they lead.

Doors and Gateways.

32. Doors and gates forming exits from a factory shall, if so required by the Chief Inspector, be hung to open outwards towards the nearest road, street, or right-of-way, or to open both inwards and outwards.

33. No door or gate shall be hung so as to open immediately on to a flight of steps, or to obstruct, when open, any exit.

34. No door or gate shall during the working hours of the factory be secured with fastenings other than such as will allow such door or gate to be readily opened from the inside without a key.

35. No door or gate across a passage shall have any other fastening except such as will allow the door to be readily opened from each side without a key and is approved by the Chief Inspector. Knobs and handles of all bolts and locks must be firmly secured.

36. No door to a fire-isolated stairway shall during the working hours of the factory be-

(a) kept open for a longer time than is necessary for the passage of persons or goods;

(b) prevented from closing by wedges or other means.

Provided that, where approved self-closing hardwood doors not less than two inches thick or other approved fire-resisting doors are fitted inside fire underwriters' doors, and are kept closed in accordance with the requirements of paragraphs (a) and (b) hereof, such fire underwriters' doors may be kept open by means of an approved fusible link, but not otherwise.

Such self-closing hardwood or other approved door may be glazed: Provided that the glazing substance employed is fire-resisting and that the glazed area does not exceed 30 per cent. of the total area of such doors. Prohibition of Employment during Structural Alterations. (Section 82.)

37. A notice pursuant to section 82 of the Act shall be in the Form 13 in the Appendix A to these regulations.

First Aid Appliances. (Section 88.)

38. In every factory where power-driven machinery is used in any process whatsoever, and in every factory where ten or more persons are employed, the occupier shall, if required by an inspector, provide and keep a suitable case or locker, placed in a position approved by the inspector, such case or locker to be equipped and supplied with the following articles, namely:-

- 1 bottle antiseptic solution.
 - 1 dozen bandages (assorted sizes).

 - 2 ounces castor oil. 2 ounces tincture iodine.
 - 1 pint picric acid solution. Formula: $1\frac{1}{2}$ teaspoons powdered picric acid, 3 ounces absolute alcohol, 2 pints distilled water.
 - 1 jar carbolised petrolatum.
 - 6 ounces sal volatile.
 - 4 ounces absorbent cotton wool.

4 small packets absorbent lint.

- 2 packets sterilised plain gauze, 3 in. 1 reel adhesive plaster, 2 in.
- 1 packet safety pins.
- 1 pair scissors.
- 1 (only) tourniquet.
- 1 pair tweezers.
- 1 (only) glass measure. 2 (only) small enamel bowls.
- 1 (only) eye dropper. 1 First Aid Manual.
- 1 pair rubber gloves.

Part VI.—Special Provisions Relating to Certain Trades.

Stamping Furniture (Section 92).

39. All furniture, other than second-hand furniture, which is sold, exposed, or offered for sale, either by wholesale or retail, shall be stamped in the manner set forth herunder:-

- (a) Every stamp on furniture which is made of wood, or of which wood forms the principal part, shall be of indelible permanent ink or stain, or impression, and shall be of legible type, and the lettering on such stamp shall be in bold-faced sans serif-capital letters of not less than eight points face measurement.
- (b) Every article of furniture which is manufactured from metal, reeds, rattan, cane, or seagrass shall be deemed to be stamped in accordance with the Act if each such article has appended thereto a label of metal, wood, or other substantial material on which is stamped, em-bossed, or printed the required words, the lettering of which shall be in bold-faced sans serif-capital letters of not less than eight points face measurement.
- (c) Such label shall be nailed, riveted, screwed, tacked, or attached by other suitable means, firmly secured to or let into such articles in workmanlike manner, and, so far as reasonably possible, in a way that will not permit of the label or stamp being easily rubbed off, obliter-ated, or detached in the handling of such articles.
- (d) Of the methods of stamping referred to in paragraph (c) of this regulation, the one used in any particular case shall be the one most fitting to be used to secure permanency, having regard to the composition of the label required to be used, and the nature, composition, size, shape, or other characteristics of the particular article of furniture.

Part VII.—Closing of Shops.

Registration of Small Shops (Section 103).

40. Every application to register a small shop shall be made in the Form 14 in the Appendix A to these regulations.

41. Every certificate of registration of a small shop shall be in the Form 15 in the Appendix A to these regulations.

(3A) Where Division 2 of the respective Parts of the Appendix is amended by substituting from time to time a new Division 2 then that Division 2 so substituted shall operate from the date of commencement of the first period of time referred to therein.

(4) The respective days on which those shops are so permitted and required to open respectively, are hereby prescribed to be those shown in Division 2 of each of the respective Parts of the Appendix opposite the respective descriptions of the shops, and are referred to in this regulation and the Appendix as the "rostered extraordinary trading period."

(5) The respective times during extraordinary trading hours when those shops are so permitted and required to open are hereby prescribed to be those shown in Division 3 of each of the respective Parts of the Appendix and are referred to in this regulation and the Appendix as "extraordinary trading times."

(6) The requisites which the shopkeepers of those shops are required under subsection (7) of section one hundred of the Act to sell are hereby prescribed under paragraph (b) of subsection (5) of that section to be—

(a) fuel;

(b) oil;

(c) lubricants;

(d) tyres;

(e) batteries;

(f) distilled water; and

(g) such other requisites as the shopkeeper has in stock at the shop.

(7) Where any of the days in any rostered extraordinary trading period is Christmas Day, Good Friday, or Anzac Day, a shopkeeper of a shop in a zone shall keep his shop closed during the whole of that day, but for the purpose of preserving uniformity in each rostered extraordinary trading period, the hours during which, but for this subregulation, he would have been permitted and required to keep the shop open for the sale of requisites during extraordinary trading times, shall be deemed to be included in that rostered extraordinary trading period as if, in fact, the shop had so been open during those times.

(8) Where a shopkeeper intends to cease to carry on business of selling any requisites prescribed by subregulation (6) of this regulation at a shop described in Division 2 of any of the Parts of the Appendix, he shall, within fourteen days before so ceasing,

give written notice, signed by him, of the intention and the day of the intended cessation to sell such requisites, to the Chief Inspector of Factories.

Penalty £5.

(9) Where a shopkeeper of a shop in a zone omits for any reason, whether because of damage to, or destruction of, his shop, or otherwise, to keep his shop open for the sale of requisites for the whole or part of any extraordinary trading times in any rostered extraordinary trading period as required by this regulation, the omission does not affect the liability of any shopkeeper of any other shop in the zone to keep his shop open for the sale of requisites for any extraordinary trading times in any rostered extra-ordinary trading period during which he is required to do so by this regulation, and during which he would do so in compliance with the requirements of this regulation were there no such omission.

(10) This regulation takes effect and has the force of law on and from the 13th day of January, 1958, on which day regulation 41A, the subheading to that regulation, and Form 15A prescribed by that regulation, all of which were published in the Gazette on the 26th day of January, 1940, are hereby revoked.

Presiding Officer and Assistant Presiding Officer—£2: Providing that presiding officers and assistant presiding officers required to assist at the scrutiny and count of votes shall be paid for such services at the rate of three shillings and sixpence (3s. 6d.) per hour.

No transport or meal allowance shall be paid to any officer aforesaid in respect of the day of a poll, but, if approved by the Chief Inspector of Factories, any expense necessarily incurred by an officer for transport on the day of the poll may be recouped to such officer.

The Minister may in special cases approve of the abovementioned fees being increased to coincide with those paid under the regulations under the Electoral Act, 1907-1959 as amended, for State Parliamentary elections.

Articles Deemed to be Appropriate to Exempted Shops and Articles Exempted. (Sections 106 and 112.)

Reg. 48. Amended by G.G. 30/8/60, p. 2634. 48. The following schedule of articles shall be deemed to be appropriate to the class of business specified hereunder:—

- "Newsagents, stationers and booksellers' shops"—All kinds of books, whether printed or blank, stationery, including all kinds of writing materials, postal materials, Christmas and other cards, cardboard, paper of all kinds, india-rubber stamps, gum, stationery baskets, sealing wax, school bags, photo albums, sheet music, books of music, account books (all sizes), paper, school books, ink, indiarubber bands, pencil (including ornamental pencils), paper clips, erasers, rulers, red tape, children's books, novels, magazines, newspapers, copy books, exercise books, twine, school slates, visiting and plain cards, scrapbooks and scraps, Catholic and English prayer books, bibles, birthday cards, blotting paper, foolscap, wrapping papers, ink bottles, drawing books, music paper, manuscript music books, blotting and writing pads, postage and duty stamps, writing desks, pen racks and paper transfers.
- "Railway book stall"—All those articles hereinbefore described as being appropriate to newsagents, stationers and booksellers' shops, with the addition of confectionery.
- "Confectioners' shops"—All kinds of sweets, pastry, biscuits, fancy bread, cakes, all non-alcoholic beverages, ice, icecream, cooked meat, tea, coffee and coffee essences, cocoa, sugar, condensed and powdered milk, prepared invalid and infants' food, analgesic tablets or powders for which doctors' prescriptions are not necessary, prepared breakfast cereals, cigarettes, tobacco and cigarette papers and matches.
- "Fruit and vegetable shops and refreshment shops"—All kinds of fresh or dried fruits, and cut flowers; all vegetables fresh and dried, including onions and potatoes, all non-alcoholic beverages, ice, icecream, butter, cheese, margarine, eggs, tea, coffee and coffee essences, cocoa, sugar, condensed and powdered milk, prepared invalid and infants' foods, analgesic tablets or powders for which doctors' prescriptions are not necessary, prepared breakfast cereals, cigarettes, tobacco and cigarette papers and matches.
- "Tobacconists' shops"—Tobacco pipes, tobacco, cigars, cigarettes, snuff and snuff boxes, tobacco pouches, matches, match boxes, cigar, cigarette and pipe cases, cigar and cigarette holders and cutters, pocket cigarette making machines, pocket knives, hairdresser's scissors and hair clippers, razors, razor blades, shaving brushes, shaving soap, bay rum, brilliantine, face cream, shaving cream, florida water, combs, hair brushes, hair oils, talcum or other face powders, razor strops, shaving mugs, and walking sticks.
- "Restaurants, and fish and oyster shops"—Game and poultry, fresh, cured or cooked fish, or shell fish, but not tinned fish, all kinds of cooked foodstuffs other than tinned or bottled foods. All kinds of non-alcoholic beverages—and butter, cheese, margarine, and eggs.
- "Premises in respect of which a publican's general license, wayside house license, Australian wine and beer license, Australian wine license, Railway refreshment room license or hotel license has been or may hereafter be granted":—Tobacco and cigars, cigarettes and other articles made of tobacco.

- "Chemists' and druggists' shops"—All kinds of medicinal preparations, drugs, patent medicines, and chemicals, surgical, medical, and chemical appliances, instruments and apparatus, disinfectants, antiseptics, and vermin destroyers, prepared food for invalids and children, feeding cups and bottles, toilet requisites, such as sponges, brushes, soaps, powders, cosmetics and perfumery, bay rum, brilliantine, face cream, shaving cream, florida water, combs, hair brushes, hair oils, talcum or other face powders, sprays, puffs, manicuring appliances, and cases or boxes for same.
- "A business in favour of which the provisions of section 111 and subsection (1) of section 112 have been suspended"—Kerosene."

Substantial Partitions for Mixed Businesses.

(Section 113.)

49. In the case of shops, where two or more descriptions of businesses are carried on in different parts of the same premises such parts shall be deemed to be separated from each other by a substantial partition, if any, if the following conditions are complied with, namely:—

- (1) If the several businesses are respectively carried on in entirely distinct and separate buildings.
- (2) If the parts are separated from each other by **a** permanent partition, and, when the partition is pierced by a door, if, at the closing hour the door is closed and locked, and the key removed.
- (3) Close roller-shutters made of wood, iron, or other substantial material approved by the inspector may be used as a partition to separate the parts if at the closing hour they are securely fastened by lock or padlock, and the key removed.
- (4) Movable shutters of wood, iron, or other substantial material approved by the inspector may be used as a partition to separate the parts if when put up at the closing hour they are securely fastened by a horizontal bar, which is padlocked, and if the key thereof is removed.
- (5) Framed glass may be used as a partition to separate the parts if at the closing hour the goods contained behind the glass partition and the glass doors or frames are closed and locked, and if the key thereof is removed.
- (6) Windows boxed in with wood or glass may be used as a partition to separate the parts if at the closing hour the door of the compartment is locked, and if the key thereof is removed.
- (7) Movable shutters of not greater than 1½ inch mesh wire framed in wood or iron may be used as a separation: Provided they are securely locked to the approval of the inspector, and that the key thereof is removed: Provided further, that if netting of greater mesh than 1 inch be used, such netting shall be made of wire not lighter than 14 s.w. gauge.
- (8) Movable wooden lattice shutters of not greater than $1\frac{1}{2}$ inch mesh, securely fastened to wooden frames, may be used as a separation, provided they are securely locked, to the approval of the inspector, and that the key thereof is removed.

Part VIII.—Provisions relating to the Employment of Assistants in Shops.

Employment during Extended Hours.

(Section 119.)

50. Every notification by the occupier of a shop to the Chief Inspector that such occupier has availed himself of the provisions of section 118 shall be in the Form 19 in the Appendix A to these regulations.

Records to be Kept.

(Section 128.)

51. The form of a record to be kept by the occupier of a shop shall be the same as that prescribed for a factory in regulation 13 of these regulations.

Part IX.—Registration of Shops and Warehouses. (Section 132.)

52. An application to the Chief Inspector of Factories by the occupier of a shop or warehouse for registration or re-registration or renewal of registration thereof, pursuant to section 132 of the Act, shall be in accordance with Form 1 in the Appendix A to these regulations.

Part X.—Miscellaneous. (Section 158.)

(Sconon 190.)

54. (1) Any person who contravenes or neglects, refuses, or fails to comply with any provision of these regulations shall be guilty of an offence.

(2) Unless otherwise prescribed any person guilty of an offence against these regulations shall be liable upon conviction to a penalty not exceeding $\pounds 5$.

"Warehouse" means any building, premises, or place in or from which goods are sold, offered for sale, or distributed by wholesale only.

If the factory is first occupied by the present occupier after the 30th June of the current year, half fee only is payable.



SUPERPHOSPHATE INDUSTRY REGULATIONS, 1948.

1. These regulations may be cited as the Superphosphate Industry Regulations, 1948.

Safety Code for Removal of Superphosphate Dumps by Manual Labour.

2. A worker shall not approach the overhanging face of any superphosphate dump in a factory except a face not more than six feet high formed by the boom of a dump excavator.

3. A worker in a factory shall not under-cut by handwork or drill into a very steep face of any superphosphate dump more than six feet high.

4. Walls of any superphosphate dump in a factory shall be brought down from the top in sections not greater than six feet high.

BENZENE REGULATIONS, 1955

(Published in the *Government Gazette* on the 30th December, 1955, and reprinted pursuant to the provisions of the Reprinting of Regulations Act, 1954.)

Reprinted pursuant to the Reprinting of Regulations Act, 1954, by authority of the Minister dated, 9th May, 1962.

BENZENE REGULATIONS, 1955.

 $1. \$ These regulations may be cited as the Benzene Regulations, 1955.

 $2.\ \mbox{In these regulations unless inconsistent with the context or subject matter}\hfill \mbox{---}$

"benzene" means the chemical compound benzene, sometimes known as benzol or benzole, and having the chemical formula C_6 H₆ or any liquid containing more than 97 per cent. of this chemical constituent;

"medical practitioner" means a legally qualified medical practitioner registered under the Medical Act, 1894-1961.

"distant breathing air mask" means an arrangement of face mask equipped with the necessary valves and fitted with a hose connected in such a way and of such a length that the distal end of the hose is placed in fresh air uncontaminated by benzene;

"positive pressure air mask" means an arrangement of face mask or hood and a hose connected thereto through which fresh air is supplied to the wearer by a compressed air cylinder or compressor;

"oxygen mask" means an arrangement of a face mask or hood and a hose connected thereto through which oxygen is supplied to the wearer by a cylinder of compressed oxygen.

3. (1) Where a liquid or other substance consisting of benzene or containing in excess of five parts per centum by weight of benzene is used in any process or occupation in any factory, the person by whose authority the process or occupation is carried on shall display or cause to be displayed in a conspicuous position and in the vicinity of the process a poster containing the information set out in the First Schedule to these regulations.

(2) Where the Inspector is satisfied that the position of a poster displayed pursuant to paragraph (1) of this regulation is not sufficiently conspicuous or not sufficiently near to the process he may order that the poster be displayed in such other position as the Inspector may order.

4. (1) Subject to the provisions of subregulation (2) of this regulation the occupier of a factory shall not permit the use of any liquid or other substance consisting of benzene or containing benzene in excess of five parts per centum by weight in any container holding more than six fluid ounces of the liquid or other substance unless the container has displayed on it in a legible manner the following:—

(a) The appropriate symbol adopted by the Medical Industries Committee, I.L.O.

- (b) The name and address of the seller.
- (c) The amount of benzene present in the liquid or other substance, expressed as parts per centum by weight.
- (d) The word "Danger" in bold-faced sans serif capital letters which shall be of not less than 18 points for a container of less than 1 gallon capacity and of not less than 72 points for a container of 1 gallon or more capacity.
- (e) The information set out in the Second Schedule to these regulations.

(2) Where such liquid or other substance is to be used as a motor fuel only and contains less than 20 parts per centum by weight of benzene such container may have displayed on it instead in a legible manner the following:—

- (a) The appropriate symbol adopted by the Medical Industries Committee of the International Labour Organisation.
- (b) The name and address of the seller.
- (c) The words "Dangers of Benzene (benzol)" in boldfaced sans-serif capital letters of not less than 18 points face measurement.
- (d) The warning matter as set out in the Third Schedule to these regulations.

5. A person shall not use any liquid containing more than one part per centum by weight of benzene for the purpose of spray painting except in accordance with the provisions of The Spray Painting Regulations, 1928.

6. (1) Every person employed in, on or about a factory shall, whenever required so to do by the occupier of the factory or the Commissioner of Public Health, or by the Chief Inspector of Factories, submit to an examination by the Commissioner of Public Health or some duly qualified medical practitioner appointed by the Commissioner.

(2) The examination shall take place at intervals as directed by the Commissioner of Public Health or a duly qualified medical practitioner.

7. The Commissioner or the medical practitioner who conducts an examination in accordance with regulation 6 of these regulations may order the suspension from employment in any process involving the use of benzene of any person examined by him; and no person whose suspension from employment has been so ordered shall work or be employed in a factory without the approval in writing of the Commissioner of Public Health, or of the medical practitioner who examined the employee.

8. Unless the air in any vat or other container which has contained benzene has been proved by appropriate test to contain less than 30 parts per million of benzene by volume, a person shall not be permitted to enter such vat, tank or container unless he is wearing a distant breathing air mask or a positive pressure air mask or an oxygen mask and has attached a safety belt and rope, and is attended by another person who remains outside the vat, tank or container, throughout the period in which he remains in the vat, tank or container.

9. The occupier of any factory or part thereof wherein there is used benzene shall not cause or allow concentrations of benzene in excess of 30 volumes of gas or vapor per million volumes of air to be present in the air in any factory or part of a factory.

10. Subject to regulation 11 of these regulations, the occupier of a factory shall provide to the satisfaction of the Inspector fans or other efficient appliances to carry off and render harmless any concentration of benzene greater than that mentioned in regulation q 11. Where the occupier is authorised to do so in writing by the Chief Inspector, the occupier of a factory in lieu of installing fans or other appliances as required by regulation 10 shall provide respirators, distant breathing apparatus or positive pressure air masks for use by all persons likely to inhale a concentration of benzene greater than that mentioned in regulation 9.

12. Every person so provided with personal equipment as described in regulation 11 shall use the apparatus at all times whilst exposed to a concentration of benzene greater than that mentioned in regulation 9.

13. (1) A copy of these regulations shall be exhibited in a conspicuous place in every factory in which benzene is used in any manner.

 $\ensuremath{(2)}$ The copy of the regulations shall be maintained in a legible condition.

14. The penalty for non-observance of these regulations shall be in accordance with section 151 of the Factories and Shops Act, 1920-1959.

First Schedule.

Dangers of Benzene (Benzol).

Benzene liquid is highly infiammable.

Benzene readily vaporises and the vapour is explosive over a wide range of concentrations with air.

Smoking or the presence of any naked flame, spark or heating element in the vicinity of benzene or benzene vapour is dangerous.

Benzene is poisonous.

The liquid may be absorbed through the skin and cause poisoning.

The vapour if breathed in large quantities may be immediately fatal. Chronic poisoning may arise from exposure to repeated small doses of vapour or contact of the skin with the liquid. Chronic poisoning may prove fatal years after contact.

Prevention and Treatment:

Do not breathe the vapour. If skin is contaminated with the liquid, wash it off. Do not wear garments soaked with benzene.

If a person collapses while in contact with vapour remove to fresh air and call a doctor. If breathing stops, give artificial respiration.

If proper precautions are taken in handling benzene it is unlikely to cause illness.

If at any time you feel persistently unwell, consult a doctor and inform him that you have been in contact with benzene.

Second Schedule.

Inhalation of low concentrations for prolonged periods may cause serious illness and may even be fatal.

Third Schedule.

Danger of Benzene (Benzol).

This fuel contains benzene and is to be used as a motor spirit only. Its use for other purposes such as dry cleaning, degreasing, etc., may endanger health.

Fourth Schedule.

Method of Analysis.

Determination of Benzene in Liquid or Other Substance.

Reagents Required:---

- Nitro-sulphuric acid—equal parts of concentrated sulphuric acid (sp. gr. 1.84) and fuming nitric acid (sp. gr. 1.49-1.50).
- Chromic acid solution-saturated.
- Sodium hydroxide solution-40 per cent.

Alcohol—95 per cent.

Butanone (methyl ethyl ketone).

Ether (diethyl ether).

Petroleum ether (benzene-free).

Preliminary Procedure:---

- (a) Remove the solvent from a known weight (W) of commercial product (e.g., rubber, cement, millinery stiffiner, etc.) by steam distillation into an erlenmeyer flask immersed in ice. Transfer distillate to separating funnel and run off aqueous layer.
- (b) Fractionally distil the solvent so obtained and collect the fraction between 70° and 95° C. Measure the volume of this fraction (v).
- (c) Where the sample is a solvent, take a known weight (W) and fractionally distil, collecting the fraction between 75° and 95° C. Measure the volume of this fraction (v).

Determination:----

- (a) Accurately measure 0.10 ml of the fraction and transfer to a thoroughly dry test tube immersed in a beaker of water at 20° C.
- (b) Add slowly 2.0 ml of nitro-sulphuric acid at the rate of about one drop every two seconds. Immediately add one drop of chromic acid solution.
- (c) Stand in water bath for ten minutes, remove and add 25 ml distilled water.
- (d) When cold, transfer contents to separating funnel, extract nitrated product with 25 ml ether, wash ether extract, with two 25 ml lots of water and discard aqueous layers.
- (e) Transfer ether extract to 100 ml volumetric flask and make to mark with alcohol.
- (f) Place a 10 ml aliquot in a test tube, add 1 ml butanone and two drops sodium hydroxide solution, shake and allow to stand.
- (g) After standing 20 minutes in the dark at room temperature, measure the intensity of crimson colour produced from the m-dini-trobenzene by use of a suitable photoelectric colorimeter and colour filter with maximum transmission at 550 millimicrons (e.g., Spekker Photoelectric Absorptiometer and Ilford Yellowish-Green Filter 605). If the colour intensity is too strong for accurate measurement, repeat from paragraph (6) with a smaller aliquot, diluted to 10 ml with alcohol.
- (h) Using colorimeter reading, determine benzene content
 (B) of the fraction as per cent. vol./vol. from graph in "standardisation" below.

Standardisation:-

Prepare benzene solutions in benzene-free petroleum ether containing 0.5, 1.0, 1.5, 2.0, 2.5 and 3.0 per cent. benzene (vol./vol.) respectively. Treat 0.10 ml of each of these solutions exactly as under "Determination" above. Graph colorimeter readings against percentage of benzene.

Calculation:---

(1) Percentage of benzene (wt./wt.) in sample is calculated thus-

FOUNDRY REGULATIONS, 1957.

Part I.—Preliminary.

1. (1) These regulations may be cited as the Foundry Regulations, 1957.

(2) These regulations shall not be construed as affecting the provisions of any other regulations made under the Factories and Shops Act, 1920, as amended.

2. These regulations are divided into Parts and Divisions as follows:—

Part I.-Preliminary.

Part IV.—General.

Interpretation.

- 3. In these regulations, unless the context otherwise requires-
 - "blasting" means the cleaning or smoothing of castings by a jet of abrasive propelled by a blast of compressed air or steam or by a hydraulic blast; and the verb "to blast" and its inflexions and derivatives have correlative meanings;
 - "Blasting chamber" means room or place in which blasting operations are carried out by persons who are inside the room or place;

"blasting enclosure" means chamber, barrel, cabinet or other receptacle or enclosure in which blasting is carried out, and includes a blasting chamber;

- "foundry" means part or parts of a factory in which foundry operations are carried on;
- "occupier" means occupier (within the meaning of the Act) of a factory in which foundry operations are carried on;
- "the Act" means the Factories and Shops Act, 1920, as amended.

Part II.—Special Measures to be Taken for Securing the Safety and Health of Persons Employed in Connection with Foundry or Blasting Operations.

Division 1.—Safety Measures.

Storage of Equipment and Materials.

4. The occupier shall store and keep stored in a safe and orderly manner, and in such a position in the factory as to cause no interference with the safety or free movement of persons employed therein or of materials or equipment, all the equipment pertaining to its foundry, if any, when the materials and equipment are not in use.

Gangways and Passageways.

5. (1) The occupier shall provide for the use of employees engaged in foundry operations clearly defined main gangways in each room of the foundry.

(2) Where persons are required to transport, whether by hand or otherwise, molten metal to or from one point within a foundry to another, the occupier shall provide in addition to main gangways, such passageways or pouring aisles as the Chief Inspector of Factories thinks sufficient to enable those persons to proceed to and from those points in safety.

(3) The occupier shall maintain or cause to be maintained all main gangways, passageways and pouring aisles at a uniform level and shall keep them or cause them to be kept clear of materials, stock or any articles or matter which obstructs or prevents the safe use of those main gangways, passageways or pouring aisles.

Floors.

6. (1) An occupier shall not permit or cause any part of the factory to be used as a foundry unless the floors of that part (except any portion of that part where molten metal is poured or carried), are firm, durable and have a level surface.

(2) An occupier shall not permit or cause any part of the factory to be used as a place where molten metal is poured or carried, unless he constantly maintains the floors of that place at a uniform level.

Furnace Areas.

7. (1) No person shall in any foundry carry on moulding or casting operations within 10 feet of any part of a furnace or of any part of a receiver used in connection with a furnace while the furnace is in use.

(2) The person in charge of a foundry shall contantly maintain or cause to be constantly maintained at a uniform level a safe operating area which he shall also cause to be kept clear of materials, stock and articles or matter which obstruct or prevent the safe use of that area.

Cupola Charging Platforms.

8. (1) The occupier shall not permit or cause a cupola charging platform to be used in a foundry pertaining to the factory unless---

- (a) the platform is of sufficient dimensions to permit safe and unimpeded handling of raw materials by furnace men; and
- (b) the floors of the platform are constructed of heavy timber or steel plate, and where steel plate is used, the plate is firmly fixed to the decking; and

- (c) the floors of the platform are
 - (i) of sufficient strength to support any load they are required to bear;
 - (ii) surrounded by a wall of sound construction, of a height not less than 2 feet 6 inches above the floor, so as to prevent objects falling from the platform; and
 - (iii) maintained in a level and safe condition;

and

(d) a properly constructed access stair or ramp is provided to give access to the platform and which stair or ramp is fitted with hand-rails,

(2) The occupier shall cause the working area of a cupola charging platform to be covered by a roof, and the platform to be adequately ventilated.

Pits and Deep Moulds.

9. (1) Where a pot furnace in a foundry is provided below ground level, the occupier of the factory in which the foundry is carried on shall ensure that the pit is covered by a strong and substantial grating at the point at which metal is removed from the furnace.

(2) (a) Where in a foundry a pouring pit is used the occupier shall ensure that the pouring pit is constructed, and of such dimensions as are ordinarily sufficient, to leave a distance of at least one foot between all the sides of the pit and any part of a ladle or anything attached to a ladle placed therein.

(b) In this subregulation "pouring pit" means a pouring pit in which a ladle is placed while receiving molten metal from a furnace.

Ladles.

- 10. (1) No person shall use or cause to be used in a foundry
 - (a) a ladle of a holding capacity of 10 hundredweight or more unless it is fitted with a safety worm gear or other equivalent safety device to regulate its position; or
 - (b) any other type of ladle which is not carried by hand unless it is fitted with safety clips.

(2) No person shall lift or move by hand or be required or permitted to lift or move by hand—

- (a) when using a single-handed ladle, a weight greater than 60 pounds; or
- (b) when using a double-handled ladle, a weight greater than a weight calculated on the basis of 84 pounds per person operating the ladle.

(3) The occupier shall regularly inspect or cause to be inspected all parts of every ladle used in a foundry pertaining to the factory and shall maintain them or cause them to be maintained in good order and condition.

(4) No person shall use for heating or drying ladles inside a foundry any open coal, coke or wood fires unless adequate measures have been taken to prevent fumes or other impurities from entering or remaining in the atmosphere of the foundry during working hours.

Work Under Suspended Castings, Etc.

11. No person shall work or be permitted or required to work in a foundry under any moulding boxes, cores, or castings unless the boxes, cores or castings are securely supported on a trestle or on a support of a similar kind.

Moulds or Chills for Spare Metal.

12. The occupier shall provide for use in operations carried on in the factory sufficient moulds or chills into which spare metal may be poured.

Division 2.—Health Measures (General).

Ventilation and Temperature Control.

13. An occupier shall, where practicable, provide adequate ventilation for all cooling racks and all fixed sources of heat such as furnaces and core ovens, by means of suitably designed hoods with flues extending to the open air at a point above the eaves of the foundry pertaining to the factory.

Mould Drying.

14. Where moulds are dried inside a foundry during working hours, the occupier shall—

- (a) cause adequate measures to be taken to prevent fumes or other impurities from entering, or remaining in, the atmosphere of the foundry; and
- (b) cause all kettles to be prepared outside the foundry and ensure that they are not used in position until a clear fire is burning.

Division 3.—Health Measures (Dust Control).

Blasting, Enclosures.

15. (1) A person shall not carry out blasting except in a blasting enclosure.

(2) A person shall not use a blasting enclosure for any purpose other than blasting, carrying out work which is immediately incidental to blasting, and the cleaning, maintenance and repair of the enclosure and of plant and appliances situated in the enclosure.

(3) The person using or operating a blasting enclosure shall keep closed or cause to be kept closed every door or opening of the blasting enclosure while blasting is being carried out therein.

(4) The occupier of a factory provided with a blasting enclosure shall constantly maintain the enclosure in good order and condition, and shall take all practical measures to prevent dust escaping from the enclosure and from any apparatus used in connection with the enclosure into the atmosphere in any room.

(5) (a) The occupier shall provide and maintain in efficient working order and for use in connection with any blasting enclosure, an efficient apparatus for separating any abrasive which has been used in blasting apparatus from dust or particles of other materials arising from blasting.

(b) No person shall introduce into blasting apparatus any abrasive which has been so used until it has been effectively separated by means of the separating apparatus.

(6) The occupier shall provide and maintain in efficient working order and for use in connection with any blasting enclosure, an efficient ventilating plant to extract by mechanical means dust within the enclosure and to remove and dispose of the dust so that it will not escape into the amosphere in any room.

(7) Where a bag or other dust filtering or settling device is used for filtering dust extracted from a blasting enclosure, the person in charge of the enclosure shall, if the bag or other device is situated in a room, cause it to be completely separated from that room in an enclosure ventilated to the open air, unless the bag or device is so constructed as effectively to prevent the escape of air from it into the room. (8) (a) The occupier shall provide for any ventilating plant referred to in subregulation (6) of this regulation suitable and efficient dust arrestors for the purpose of collecting dust from the exhaust air, and from the cleaning process in the recovery of the abrasive, and the dust so collected shall be removed and disposed of by the occupier at regular intervals so as to ensure the proper functioning of the blasting equipment.

(b) The dust arrestors referred to in this subregulation must be of such a capacity as not to require emptying more than once daily.

(9) The occupier and the persons using or operating a blasting enclosure shall keep or cause to be kept in continuous operation the ventilating plant referred to in subregulation (6) of this regulation whenever the blasting enclosure is in use, whether the blasting is actually being carried out therein or not, and in the case of a blasting chamber, they shall also keep the plant or cause the plant to be kept in operation when any person is inside the chamber for the purpose of cleaning or carrying out repairs inside the chamber.

(10) No person shall open a door of a blasting enclosure until a reasonable time has elapsed after the blast has been turned off.

Blasting-Helmets and Protective Clothing.

16. (1) The occupier shall provide and maintain in good order sufficient positive pressure helmets for the use of all persons who are employed in a blasting chamber on blasting or cleaning work.

(2) A person for whose use a positive pressure helmet is so provided shall wear it while he is in the chamber and shall not remove it until he is outside the chamber.

(3) The occupier shall provide that the air supplied to a positive pressure helmet, before reaching the helmet, passes in the following order through—

- (a) a filter to remove dust, oil and other contaminants;
 - (b) a conditioner which will deliver the air at room temperature; and
 - (c) a condensate trap fitted with a drain cock, to remove any condensed liquid.

and shall also make provision that the condensate trap and filter are cleaned daily.

(4) (a) The occupier shall cause each helmet to bear a distinguishing mark indicating the person by whom it is intended to be used.

(b) No person shall wear or be required or allowed to wear a helmet which does not bear his distinguishing mark, or a helmet which has been worn by another person and which has not since been thoroughly cleaned.

(c) The occupier shall cause each protective helmet when in use, to be supplied with air at the rate of not less than 6 cubic feet per minute.

(5) The occupier shall provide for the use of all persons while engaged in blasting in a blasting chamber, suitable gauntlets and overall suits.

Blasting—Advisory Leafiets.

17. (1) The occupier shall exhibit or cause to be exhibited conspicuously near every blasting enclosure appurtenant to the factory an advisory leafiet issued by the Chief Inspector of Factories relating to the safety and other precautions to be taken by persons employed in or in connection with blasting.

(2) The advisory leaflet referred to in this regulation shall be deemed not to be conspicuously exhibited as required by sub-regulation (1) of this regulation unless it is clearly legible at all times by persons employed in or in connection with blasting.

Part III.—Facilities for Washing.

18. The occupier shall provide for every foundry appurtenant to the factory an adequate number of basins and showers with hot and cold water for use by persons employed in the foundry.

Part IV.—General.

19. (1) A person engaged in foundry or blasting operations in a factory shall wear the protective clothing and use the protective devices and equipment prescribed and provided for his use by or under these regulations.

(2) Where a person engaged in a foundry or blasting operations in a factory discovers any defect in any protective clothing, or any protective device or equipment so prescribed and provided for his use, he shall without delay report the defect to the occupier of the factory or to the person apparently in charge of the foundry or blasting operations, as the case may be.

20. (1) An employee shall not so leave any materials or equipment in any main gangways, passageways or pouring aisles or in any place in a foundry as to obstruct the safe use of any part of the foundry or cause interference with the safety or obstruct the free movement of persons in the foundry.

(2) An employee shall, after using any foundry materials or equipment, store or place the same in a safe, orderly and tidy manner in such place or places as are provided for the storing or placing of those materials or that equipment.

Penalties.

21. A person who commits a breach of any provision of these regulations commits an offence and on conviction in a court of summary jurisdiction is liable to a penalty not exceeding five pounds.

FACTORIES AND SHOPS ACT, 1920-1959.

WELDING AND CUTTING REGULATIONS, 1957

(Published in the Government Gazette on the 15th October, 1957, and reprinted and published in the Government Gazette on the 3rd July, 1958, and further reprinted pursuant to the provisions of the Reprinting of Regulations Act, 1954.)

Reprinted pursuant to the Reprinting of Regulations Act, 1954, by authority of the Minister dated, 9th May, 1962.

WELDING AND CUTTING REGULATIONS, 1957.

Part I.—Preliminary.

1. These regulations may be cited as the Welding and Cutting Regulations, 1957, and shall apply to factories or parts of factories where gas welding and cutting, electric arc welding and cutting and resistance welding are carried on, but shall not affect any process or operation being carried on in those factories or parts of facttories to which process or operation the Electric Accumulator Regulations, 1931, or the Factories (Poisonous Substances) Regulations, 1932, apply.

2. In these regulations subject to the context-

- "confined space" means a boiler, tank, vessel, drum, barrel, receiver or other similar enclosed space;
- "distant breathing air mask" means an arrangement of face mask equipped with the necessary valves and fitted with a hose connected in such a way and of such a length that the distal end of the hose is placed in fresh air;

"positive pressure air mask" means an arrangement of face mask or hood and a hose connected to the face mask or hood through which fresh air is supplied to the wearer by a compressed air cylinder or compressor;

"welder" means any person engaged in gas welding or cutting, electric arc welding or cutting, or resistance welding.

3. These regulations are divided into parts as follows:-

Part I.—Preliminary, Regulations 1-3.

Part II.-Gas Welding and Cutting, Regulations 4-9.

- Part III.—Electric Arc Welding and Cutting, Regulations 10-13.
- Part IV.-Resistance Welding, Regulations 14-15.

Part V.—General, Regulations 16-24.

Part II.—Gas Welding and Cutting.

4. A person employed or engaged in a factory shall not under any circumstance introduce oxygen into a confined space for the purpose of ventilation.

5. A person employed or engaged in a factory shall not use oxygen to dust or dry clothing or work or as a substitute for compressed air.

6. A person working with or handling oxygen equipment in a factory shall at all times keep such equipment free of grease and oil.

7. Where a person is carrying on welding or cutting operations in a confined space in a factory, the occupier or the factory shall—

- (a) station a person outside the confined space whose duty it is to keep the welder or cutter under observation; and
- (b) shall place the necessary gas cylinders and generators in charge of the person so stationed.

8. When a welder enters a confined space in a factory through a manhole or opening, the occupier of the factory shall arrange that the manhole or opening is kept clear while the welder is in the confined space and that effective means are provided for quickly removing him in case of emergency and that lifelines of cotton or nylon not more than $\frac{1}{2}$ in. or less than $\frac{3}{2}$ in. diameter be provided for this purpose.

9. Where a person welding or cutting in a confined space leaves the work for a period of ten minutes or more, he shall remove all hand pieces, torches or gas lines from the confined space and make sure that there can be no escape of oxygen or acetylene in the confined space.

Part III.—Electric Arc Welding and Cutting.

10. A person employed or engaged in welding in a confined space in a factory shall use a fully insulated electrode holder.

11. Where a person is carrying on electric arc welding or cutting operations in a confined space in a factory, the occupier of the factory shall—

- (a) station a person outside the confined space whose duty it is to keep the welder or cutter under observation; and
- (b) shall place the necessary gas cylinders and generators in charge of the person so stationed.

12. When a welder enters a confined space in a factory through a manhole or opening, the occupier of the factory shall arrange that the manhole or opening is kept clear while the welder is in the confined space and that effective means are provided for quickly removing him in case of emergency and that lifelines of cotton or nylon not more than $\frac{1}{2}$ in. or less than $\frac{3}{8}$ in. diameter be provided for this purpose.

13. The occupier of a place where electric arc welding or cutting is carried on shall arrange that all electric arc welding or cutting or similar operations shall be screened by screens approved by the Chief Inspector of Factories and provided by the occupier to prevent the dangerous effects of stray radiation to persons employed in the vicinity of the operation.

Part IV.—Resistance Welding.

14. To prevent injury to a person engaged in welding operations in a factory, the occupier of the factory shall provide adequate shields on all moving parts of resistance welding equipment whether mechanically, pneumatically or electrically operated.

15. In a factory where welding operations are carried on, the occupier of the factory shall provide face shields which shall be used by a person employed as a welder to protect his face and neck when engaged on resistance welding operations in which the welder is exposed to possible injury.

Part V.—General.

16. In any factory where welding is carried on, goggles, shields and helmets, fitted with filter lenses to the specifications declared and published from time to time by the Standards Association of Australia, shall be provided by the occupier of the factory and shall be used by persons engaged in welding. 17. Before welding or cutting is carried on in any factory on containers, drums, barrels or tanks, the occupier of the factory shall arrange for tests to be made to establish that there is no danger of fire or explosion.

18. (1) In any factory where a person is engaged in welding or cutting lead or cadmium or their alloys or in welding or cutting lead painted iron or steel, or lead or cadmium coated or plated iron or steel or fiame treatment of lead painted surfaces, or where lead, mercury or cadmium or their compounds are present or where welding operations are carried on in a confined space, the occupier of the factory shall provide local exhaust ventilation to supply each welder with a minimum rate of 350 cubic feet of air per minute.

2. In any factory where local exhaust ventilation cannot be so provided, a distant breathing apparatus or positive pressure air mask shall be provided by the occupier of the factory and used by the welder.

19. (1) Where welding is carried on in any factory, the occupier of the factory shall display or cause to be displayed in a conspicuous position and in the vicinity of the place where the welding is carried on a poster containing the information set out in the schedule of these regulations.

(2) Where an Inspector is satisfied that the position of the poster referred to in subregulation (1) of this regulation is not sufficiently conspicuous or not sufficiently near to the process, he may order that the poster be displayed in a position to his satisfaction, and the occupier of the factory shall comply with that order.

20. The occupier of a factory shall provide for the use of welders, fire resistant gauntlets, gloves and suitable aprons, in addition to goggles, shields and helmets, referred to in regulation 16 of these regulations, and any other equipment prescribed by these regulations.

21. In any factory every welder shall use the protective equipment provided under regulation 20 of these regulations.

22. In every factory to which these regulations are applicable the occupier of the factory shall provide adequate equipment for the prevention and extinction of fire.

23. (1) A copy of these regulations shall be exhibited by the occupier of every factory in a conspicuous place in the factory or part of the factory in which welding or cutting operations are carried on.

(2) The copy of the regulations shall be maintained by the occupier of every factory in a legible condition.

24. A person who commits a breach of any of these regulations commits an offence. Penalty: Five pounds.

Schedule.

SAFETY IN WELDING.

Reg. 19.

Welding is not a hazardous occupation when simple and obvious precautions are taken. It is therefore recommended that all interested make themselves familiar with the Welding and Cutting Regulations, 1957, and the suggestions in this notice and relevant publications of Standards Association of Australia.

Cylinders should be handled with care.

Cylinders should be marked with the name of gas contained therein.

Acetylene should always be referred to by its proper name, "acetylene," and not the word "gas."

Oxygen should always be referred to by its proper name, "oxygen," and not the word "air."

Calcium carbide must be stored where it cannot contact water. In case of fire, water or foam extinguishers must not be used.

Acetylene generators must be only used, cleaned, recharged in a place with ample ventilation away from any source of ignition and where smoking is prohibited. A generator must not be altered to allow it to operate at pressures or production rates higher than for which it was designed.

Acetylene cylinders should be stored and used in an upright position.

Woollen outer clothing is preferable to cotton.

Low cut shoes should not be worn.

Trousers should not have cuffs.

Sleeves and collars should be kept buttoned to prevent lodgment of sparks.

Non-conducting impervious mats will reduce the risk of shock in electric arc or resistance welding.

Prior to entering a confined space, the air should be tested for contamination or oxygen enrichment.

All persons concerned should be instructed in the correct and most efficient use of the fire fighting equipment available.

· . .
