WHEREAS it is enacted by section 115 of the Factories and Shops Act, 1920-1959, that the expression "Public Holiday" shall mean certain days therein specified and any other day declared by Proclamation to be a public holiday for the purposes of the said Act: Now, therefore I, the said Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, do hereby proclaim and declare that Saturday, the 13th day of October, 1962, from eight o'clock in the forenoon to one o'clock in the afternoon, shall be a public holiday within the Toodyay Shop District for the purpose of section 115 of the Factories and Shops Act, 1920-1959, and all shops (except those mentioned in the Fourth Schedule) and warehouses shall be closed.

AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, this 20th day of June, 1962, the following Order in Council was authorised to be issued:—

Business Names Act, 1942-1946.

## ORDER IN COUNCIL.

WHEREAS it is enacted by subsection (1) of section 24 of the Business Names Act, 1942-1946, that notwithstanding anything in any Act no firm, individual, or corporation required to register under Part II of the Act shall use a business name, and no business name shall be registered which, *inter alia*, includes the word "Imperial" or any word which, in the opinion of the Registrar, suggests, or is calculated to suggest the patronage of Her Majesty or any member of the Royal Family or Government support or patronage, unless the Governor by order published in the *Government Gazette* consents to the use of such word in the said business name; and whereas it is provided in subsection (2) of the section that the consent of the Governor, as provided for in subsection (1) of that section, shall not be granted in any case if, in the opinion of the Governor, the use of any word mentioned in the said subsection in a business name by the firm, individual, or corporation using or

proposing to use the same would imply or be likely to convey the impression that such firm, individual, or corporation is or will be wholly or partly authorised or supported by or connected with Her Majesty's Government in any part of Her Majesty's Dominions; and whereas a corporation required to register under Part II of the Act namely W. Angliss & Co. (Australia) Proprietary Limited, has made application in writing to the Registrar for the consent of the Governor under subsection (1) of that section; and whereas in the opinion of the Lieutenant-Governor the use of the word "Imperial" by W. Angliss & Co. (Australia) Proprietary Limited in a business name would not imply or be likely to convey the impression that such corporation is or will be wholly or partly authorised or supported by or connected with Her Majesty's Government in any part of Her Majesty's Dominions: Now, therefore, His Excellency the Lieutenant Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 24 of the Act, doth hereby consent to the use by W. Angliss & Co. (Australia) Proprietary Limited of the word, "Imperial" in a business name.

## Land Act, 1933-1960.

## ORDERS IN COUNCIL

WHEREAS by section 33 of the Land Act, 1933-1960, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

Corres. 2475/53.—That Reserve No. 24502 (Kwinana Lot M710) should, subject as aforesaid be granted in fee simple to The Salvation Army (Western Australia) Property Trust to be held in trust for the purpose of a "Church Site (Salvation Army)."

Corres. 5438/48.—That Reserve No. 25922 (Forest Location 26) should, subject as aforesaid be granted in fee simple to the Royal Flying Doctor Service of Australia (Western Australian Section) Incorporated to be held in trust for the purpose of a "Radio Receiving Station Site."

Now, therefore, His Excellency the Lieutenant-Governor by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall be granted in fee simple to the abovementioned bodies to be held in trust for the aforesaid purposes, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

#### Local Government Act, 1960.

##### ORDERS IN COUNCIL

WHEREAS by section 288 of the Local Government Act, 1960, it shall be lawful for the Governor, on request of the Council by notice in the *Government Gazette* to declare any land reserved, or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control and management of a Council, or land comprised in a private street, constructed and maintained to the satisfaction of a Council, as a public street, and if the Council thinks fit, that the Governor shall declare the width of the carriage way and foot-paths of the public street; and whereas the Councils mentioned in the schedule hereunder have requested that certain lands named and described in the schedule which have been reserved for streets within the said Councils be declared public streets: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be public streets, and such lands shall, from the date of this order, be absolutely dedicated to the public as streets within the meaning of any law now or hereafter in force.
