Licensing Act, 1911-1962. PROCLAMATION

WHEREAS it is enacted (inter alia) by subsection (1) of section 122 of the Licensing Act, 1911-1962, that no licensee shall have or keep his licensed premises open for the sale of liquor, or sell any liquor or permit or suffer any liquor to be drunk or consumed in or upon his licensed premises, upon any Sunday, except under the authority of an airby subsection (2) of that section, that the provisions of the section shall not prohibit the sale of liquor to, or the consumption of liquor by, any person on a Sunday, not being Anzac Day or Christmas Day, on premises which are the subject of a publican's general license, an hotel license, or a wayside-house license, and are at least twenty miles distant from the Town Hall in Perth when measured by the shortest road route or are situate on Rottnest Island, if the liquor is sold and consumed between the hours of 12 noon and 1 p.m. or the hours of 5 p.m. and 6 p.m.; and whereas it is enacted by the proviso to paragraph (c) of the subsection lastmentioned that the Governor may, on the recommendation of the Licensing Court, by Proclamation from time to time extend, reduce or vary the hours hereinbefore mentioned in any

licensing district or part of a district within the Goldfields District, and that the hours so extended, reduced or varied shall in that licensing district or part of a district thereupon have effect; and whereas by a Proclamation made on the 9th day of January, 1962, and published in the Government Gazette on the 12th day of January, 1962, the Governor did, inter alia, extend and vary those hours in the case of the licensing district of Yilgarn, to the hours between the hours of 10.30 a.m. and 12.30 p.m. and 3 p.m. and 6 p.m.; and whereas the Licensing Court has recom-mended to me, the Governor, that the hours as extended and varied in the case of the licensing district of Vilenry by the soid Broalengetion should district of Yilgarn by the said Proclamation should be further varied: Now, therefore I, the Governor, on the recommendation of the Licensing Court, and with the advice and consent of the Executive Council, do hereby vary, in the case of the licensing dis-trict of Yilgarn, the hours referred to in subparagraph (ii) of paragraph (c) of subsection (2) of section 122 of the Licensing Act, 1911-1962, as extended and varied by the Proclamation made on the 9th day of January, 1962, and published in the Government Gazette on the 12th day of January, 1962, to the hours between the hours of 10.30 a.m. and 12.30 p.m. and of 3.30 p.m. and 6.30 p.m.

Fauna Protection Act, 1950-1954. PROCLAMATION

IN pursuance of the provisions of section 14 of the Fauna Protection Act, 1950-1954, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby declare as follows:-

- (1) That the period from five o'clock in the forenoon of January 1, 1963, until five o'clock in the forenoon of January 1, 1968, shall be an open season in respect of those species of wild ducks specified in the schedule hereto in those parts of the State which lie within the boundaries of the Kimberley, North-West and Eastern Divisions, as defined in section 28 of the Land Act, 1933.
- (2) That a person shall not take any wild duck or the egg of any wild duck for the purpose of keeping it in captivity, or for the purpose of aviculture, or for the purpose of sale.
- (3) That a person shall not sell any wild duck.
- (4) That a person shall not take any wild duck by any means other than a shotgun provided that this restriction shall not prohibit a person who is a native within the meaning of the Native Welfare Act, 1905-1954, from using any native artifact in the taking of wild ducks.

Marsh; thence east by south to the summit of Roy Hill; thence south by west to Sur-vey Station AN (conjoined) 172; thence westerly to Survey Station B101 on the east branch erly to Survey Station B101 on the east branch of Turee Creek; thence in a westerly direction along the said branch and Turee Creek pro-per to its junction with the north-eastern boundary of the Ashburton Goldfield; thence north by west to Trig Station 10; thence north westerly to the summit of Mt. Wall; thence westerly to the summit of Mt. de Courcey; thence due north about 129 miles along the eastern boundary of the Ashburton Goldfield to the sea coast; thence generally north-easterly along the sea coast to the starting point, and including all islands off the coast. coast.

The area bounded by lines commencing at a point, on the right bank at the mouth of the Yule River, on the north-western coast of Western Australia being the north-eastern corner of the West Pilbara Goldfield; thence north-easterly along the sea coast to south parallel of latitude 19 deg. 30 min. being the most western corner of the West Kimberley Goldfield; thence east along the south parallel of latitude 19 deg. 30 min. to its junction with the 126th Meridian being the western boundary of the Kimberley Goldfield; thence south along the western boundary of the Kimberley Gold-field to its south-western corner; thence west along the Tropic of Capricorn (23 deg. $27\frac{1}{2}$ min.) to the No. 1 Rabbit Proof Fence; thence northerly along the said fence to the 630-mile post: thence westerly to Survey Station AN (conjoined) 172; thence north by east to the summit of Roy Hill; thence west by north to the summit of Mt. Marsh; thence northwesterly to Survey Station V23; thence north-erly to the summit of Mt. Francisco; thence north by west to the summit of Mt. Berghaus; thence north-westerly to the starting point and including all islands off the coast.

- (a) alter the boundaries of the existing wards of the district of the Shire of Mount Magnet so that the wards shall be as described in the schedule hereto;
- (b) direct that the number of offices of Councillor assigned to the municipality shall be varied in respect of the wards by increasing the number of Councillors representing the Town Ward from four to five and decreasing the number of members representing the Country Ward from five to four;
- (c) direct that all members at present in office for the Country Ward shall go out of office on the 25th day of May, 1963, and that an election shall be held on that day for returning four members for the Country Ward and one additional member for the Town Ward.

Report of Inquiry by the Medical Board of Western Australia.

BY a notice dated the 8th day of November, 1962, duly served upon Kevin Owen McRae Fitzpatrick (hereinafter called the Medical Practitioner), the Medical Board of Western Australia (hereinafter called the Board) instituted of its own motion an inquiry in accordance with the Medical Act into certain allegations against the Medical Practitioner that he had been guilty of drunkenness frequently and at short intervals of time and guilty of improper conduct in a professional respect, particulars of which allegations were appended to the notice.

In accordance with the notice, the inquiry was commenced on the 13th December, 1962; it was continued on the 10th January, 1963, and concluded on the 8th February, 1963, and at such inquiry the Board was represented by Mr. G. G. Hammond and the Medical Practitioner was represented by Mr. Frank Downing, Q.C. All evidence led at the inquiry was given on oath or affirmation by the witnesses called.

At the conclusion of the evidence the Board reserved its decision.

On the 8th February, 1963, the Board resolved its finding and penalty pursuant to the inquiry as follows:—

- Finding: In the opinion of this Board there is a preponderence of evidence to establish that the Medical Practitioner has been guilty of improper conduct in a professional respect within the meaning of the provisions of section 13 of the Medical Act, 1894-1961, and in that respect the allegations contained in the complaint have been substantiated. The Medical Board therefore finds in relation to the said inquiry and complaint that the Medical Practitioner has been guilty of improper conduct in a professional respect.
- Penalty: As a result of the foregoing finding, it was resolved that the name of Kevin Owen McRae Fitzpatrick be suspended from the Register of Medical Practitioners for a period of six months commencing on and including the 1st day of March, 1963.
