PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Major-General Sir Douglas
TO WIT, } Anthony Kendrew, Knight Commander of the
DOUGLAS ANTHONY } Most Distinguished Order of Saint Michael and
KENDREW, } Saint George, Companion of the Most Honour-

Governor in and over the State of Western
Australia and its Dependencies in the Com-
monwealth of Australia.

WHEREAS it is enacted by section 11 of the Native Welfare Act, 1905-1960, that the Governor may by Proclamation declare any Crown lands to be Reserves for Natives and abolish any reserve so declared; and whereas by a Proclamation issued under the Native Welfare Act, 1905-1960, and published in the *Government Gazette* on the 20th December, 1935, the Governor declared an area at Wyndham more particularly described as Reserve 21453 and defined in the schedule to such Proclamation to be a Reserve for Natives; and whereas it is now deemed desirable and expedient to abolish the said reserve: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council and in exercise of the power in that behalf conferred by section 11 of the Native Welfare Act, 1905-1960, do hereby abolish the Reserve for Natives as declared and described and defined in the hereinbeforementioned Proclamation published in the *Government Gazette* on the 20th December, 1935, as aforesaid.

And where as it is deemed desirable that a Reserve for Natives should be declared at Wyndham: Now, therefore I, the said Governor, with the advice of the Executive Council, do hereby declare all that portion of land, containing approximately 4 acres 2 roods 3 perches being Wyndham Lot 1033 to be a Reserve for Natives (Reserve No. 27020).

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1962, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient that Reserve No. 26979 (Roebourne Lots 407 to 413 inclusive) should vest in and be held by the Minister for Native Welfare in trust for the purpose of Native Housing: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Minister for Native Welfare in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

(1) The ordinary hours of duty shall not exceed forty (40) per week and, except as prescribed in subclause (2) of this clause, shall be worked either—

(a) in five straight shifts of eight (8) hours each, exclusive of meal breaks, on each day from Monday to Friday, inclusive, between the hours of 7 a.m. and 6 p.m.; or

(b) in five straight shifts each of not more than eight (8) hours, exclusive of meal breaks, on each day from Monday to Friday, inclusive, between the hours of 7 a.m. and 6 p.m. and a further shift of not more than four (4) and not less than two (2) hours on Saturday between the hours of 7 a.m. and 1 p.m.

Provided that in respect of work north of the 27th parallel of latitude, the starting and finishing times of the foregoing spread of hours may be varied by agreement between the employer and the worker so long as the length of such spread shall not be increased.

(2) The ordinary hours of workers—

(a) engaged in connection with the transport of fish, fruit, vegetables, livestock, cordials or of pastrycooks' products, or in ice-carting, ice-loading, parcel express carting, or newspaper delivering or mail delivering, or in the milk, cream, ice cream or dairy produce industries; or

(b) engaged in driving over distances in excess of two hundred miles in a complete journey (but only in respect of that journey);

shall not exceed eight (8) hours in any one day nor forty (40) hours in any one week and shall not be spread over more than six (6) days of the week and shall, except for workers employed in wholesale delivery of milk, be worked in continuous shifts, except for meal breaks.

(e) In Clause 12 (Overtime):—

(i) Delete subclause (1) and substitute:—

(1) Subject to subclause (4) of this clause, all time worked—

(a) outside the ordinary hours of work prescribed for any day in clause 9 hereof; or

(b) outside the ordinary hours of work prescribed for any week by clause 9 hereof but which time would not be outside the ordinary hours for any day;

shall stand alone and be paid for at the rate of time and a half for the first four (4) hours and double time thereafter in addition to the ordinary weekly wage. Provided that all overtime worked on Sundays shall be paid for at the rate of double time and provided further that the penalty rates prescribed in clauses 10 and 11 shall not be regarded as part of the ordinary rate for calculating overtime.

(ii) In subclause (2) delete the word and figure in brackets "two (2)" and in line 4 substitute the word and figure in brackets "three (3)".

(f) In Clause 14 (Time and Wages Record):—

(i) Add at the end of subclause (1) the following:—

Provided that an employer may at his option in lieu of a time record provide a mechanical clock for the purpose of recording any of the aforementioned information.

(ii) Delete subclause (2) and substitute:—

(2) The secretary of the Union or any other person authorised in writing by him shall be at liberty to inspect such record at least once a week at the place where such record is kept or at some other convenient place.

(g) In Clause 15 (Meals):—

(i) In subclause (3) delete the word, "workers" in line 2 and substitute the words, "a worker" and delete the words, "their work-shops" in lines 2 and 3 and substitute the words, "his place of work".

(ii) Delete subclause (5) and substitute:—

(5) Every worker, other than those to whom subclause (2) of clause 9 refers, shall be allowed each day a meal break of not less than thirty (30) minutes nor more than one (1) hour, to commence at any time between the end of the third and the end of the fifth hour of the day's employment and every worker to whom subclause (2) of clause 9 refers, except workers employed in delivering milk to consumers or to the holders of milk shop or milk store licences outside the areas defined in Sixth Schedule to the Milk Act Regulations No. 7, shall be allowed a meal break of not less than thirty (30) minutes nor more than one (1) hour at some time during each working day.

(h) In Clause 17 (Annual Leave) insert the words and figure in brackets, "of subclause (4)" before the word, "of" in the last line of paragraph (a) of subclause (6).

(i) In Clause 21 (Board and Lodging) delete the words, "to provide his own accommodation in the way of" in line 5 of subclause (3) and substitute the words, "to live in a".

Kelly on behalf of various Ministers of the Crown in the right of the State and various Crown instrumentalities, and other representatives for other industrial unions and employers, determined that various Awards and Industrial Agreements be amended: Now therefore, the Court, in pursuance of the powers conferred on it by section 61 of the Industrial Arbitration Act, 1912-1961, doth hereby order—

That the Metal Trades (Timber Industry) Award, No. 15 of 1954, be and the same is hereby amended in the terms of the attached schedule.

Delete Clause 7—Holidays and insert in lieu thereof the following:—

7.—Holidays.

(a) (i) The following days, or the days observed in lieu shall, subject to clause 6, be allowed as holidays without deduction of pay, namely: New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day and Boxing Day. Provided that another day may be taken as a holiday by arrangement between the parties, in lieu of any of the days named in the subclause. Subject to another day being allowed in lieu of Sovereign's Birthday at any particular mill by agreement between the Union and the employer concerned.

(ii) Where Christmas Day or New Year's Day falls on a Saturday or a Sunday, such holiday shall be observed on the next succeeding Monday and where Boxing Day falls on a Sunday or a Monday such holiday shall be observed on the next succeeding Tuesday; in each such case the substituted day shall be deemed a holiday without deduction of pay in lieu of the day for which it is substituted.

(b) On any public holiday not prescribed as a holiday under this Award, the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done, ordinary rates of pay shall apply.

(c) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with that employer, but where a worker completes that twelve months' continuous service on or after the 30th November, 1963, he shall be allowed three (3) consecutive weeks' leave instead of the two (2) consecutive weeks' leave prescribed herein.

(d) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day, being an ordinary working day, for each such holiday observed as aforesaid.

(e) After one (1) month's continuous service in any qualifying twelve-monthly period a worker whose employment terminates shall be paid, in respect of each completed month of continuous service in that qualifying period—

(i) One-sixth ($\frac{1}{6}$) of a week's pay at his ordinary rate of wage if he leaves his employment before the 30th November, 1963, and one-quarter ($\frac{1}{4}$) of a week's pay at his ordinary rate of wage if he leaves his employment on or after that date;

(ii) One-quarter ($\frac{1}{4}$) of a week's pay at his ordinary rate of wage if his employment is terminated by the employer through no fault of the worker after 1st November, 1963, and one-sixth ($\frac{1}{6}$) of a week's pay at his ordinary rate of wage if his employment is so terminated on or before that date.

(f) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay, or time spent on holidays or annual leave as prescribed by this Award, shall not count for the purpose of determining his right to annual leave.

(g) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (e) or subclause (k) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers, he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(h) (i) A worker who is justifiably dismissed for misconduct shall not be entitled to the benefit of the provisions of this clause.

(ii) In special circumstances and by mutual consent of the employer, the worker and the Union concerned, annual leave may be taken in not more than two (2) periods.

(i) The provisions of this clause shall not apply to casual workers.

(j) Notwithstanding anything else herein contained an employer who observes a Christmas closedown for the purpose of granting annual leave may require a worker to take his annual leave in not more than two (2) periods but neither of such periods shall be less than one (1) week.

(k) In the area outside a radius of fourteen (14) miles from the General Post Office, Perth, the following provisions shall apply until midnight, 6th January, 1964:—

(i) Subclause (a) hereof shall not apply except in the case of Anzac Day, Labour Day, New Year's Day 1964, and Sovereign's Birthday, subject to another day being allowed in lieu of Sovereign's Birthday at any particular mill by agreement between the Union and the employer concerned.

(ii) Subclause (c) hereof shall not apply but except as hereinafter provided a period of two (2) consecutive weeks' leave at Christmas time and also the day immediately preceding Good Friday, Good Friday and the week immediately succeeding such days, with payment of ordinary wages as prescribed, shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer, but where a worker completes that twelve months' continuous service on or after

the 30th November, 1963, he shall be allowed during 1964 a further week's leave with payment of ordinary wages as prescribed.

(iii) Subclause (e) hereof shall not apply but if after one (1) month's continuous service in any qualifying twelve-monthly period a worker whose employment terminates shall be paid, in respect of each completed month of continuous service in that qualifying period—

(a) eleven and one-third ($11\frac{1}{3}$) hours' pay at his ordinary rate of wage if he leaves his employment before the 30th November, 1963, and fourteen and two-thirds ($14\frac{2}{3}$) hours' pay at his ordinary rate of wage if he leaves his employment on or after that date;

(b) fourteen and two-thirds ($14\frac{2}{3}$) hours' pay at his ordinary rate of wage if his employment is terminated by the employer through no fault of the worker after 1st November, 1963, and eleven and one-third ($11\frac{1}{3}$) hours' pay at his ordinary rate of wage if his employment is so terminated on or before that date.

(iv) Workers engaged on essential work during the period or periods referred to in paragraph (ii) hereof, shall be allowed equivalent time off at such time as may be mutually agreed upon between the employer and the worker.

(v) In all other respects, the provisions of this clause shall apply.

- (ii) one-quarter ($\frac{1}{4}$) of a week's pay at his ordinary rate of wage if his employment is terminated by the employer through no fault of the worker after 18th October, 1963, and one-sixth ($\frac{1}{6}$) of a week's pay at his ordinary rate of wage if his employment is so terminated on or before that date.

That the Dairy Factory Workers' Award, No. 23A of 1959, be and the same is hereby amended in the terms of the attached schedule.

1. Delete subclauses (d), (e) and (k) of clause 13 and insert in lieu thereof the following:—

13.—Annual Leave and Holidays.

(d) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with that employer, but where a worker completes that twelve months' continuous service on or after the 30th November, 1963, he shall be allowed three (3) consecutive weeks' leave instead of the two (2) consecutive weeks' leave prescribed herein.

(e) After one (1) month's continuous service in any qualifying twelve-monthly period a worker whose employment terminates shall be paid, in respect of each completed month of continuous service in that qualifying period—

- (i) one-sixth ($\frac{1}{6}$) of a week's pay at his ordinary rate of wage if he leaves his employment before the 30th November, 1963, and one-quarter ($\frac{1}{4}$) of a week's pay at his ordinary rate of wage if he leaves his employment on or after that date;
- (ii) one-quarter ($\frac{1}{4}$) of a week's pay at his ordinary rate of wage if his employment is terminated by the employer through no fault of the worker after 8th November, 1963, and one-sixth ($\frac{1}{6}$) of a week's pay at his ordinary rate of wage if his employment is so terminated on or before that date.

(k) Notwithstanding the foregoing, the following provisions shall apply to all milk treatment plants situated within a 15-mile radius of the G.P.O., Perth:

- (i) Except as hereinafter provided, a period of four (4) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with that employer, but where a worker completes that twelve months' continuous service on or after the 30th November, 1963, he shall be allowed five (5) consecutive weeks' leave instead of the four (4) consecutive weeks' leave prescribed herein.
- (ii) After one (1) month's continuous service in any qualifying twelve-monthly period a worker whose employment terminates shall be paid, in respect of each completed month of continuous service in that qualifying period—

(a) one-third ($\frac{1}{3}$) of a week's pay at his ordinary rate of wage if he leaves his employment before 30th November, 1963, and five-twelfths ($\frac{5}{12}$) of a week's pay at his ordinary rate of wage if he leaves his employment on or after that date;

(b) five-twelfths ($\frac{5}{12}$) of a week's pay at his ordinary wage if his employment is terminated by the employer through no fault of the worker after 8th November, 1963, and one-third ($\frac{1}{3}$) of a week's pay at his ordinary rate of wage if his employment is so terminated on or before that date.

(iii) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(iv) (1) A worker who is justifiably dismissed for misconduct shall not be entitled to the benefit of the provisions of this clause.

(2) In special circumstances and by mutual consent of the employer, the worker and the Union concerned, annual leave may be taken in not more than two periods.

(v) The provisions of this clause shall not apply to casual workers.

2. Add a new subclause (1) as follows:—

(1) Notwithstanding anything else herein contained, an employer who observes a Christmas closedown for the purpose of granting annual leave may require a worker to take his annual leave in not more than two (2) periods but neither of such periods shall be less than one (1) week.

INDUSTRIAL AGREEMENT.

No. 32 of 1963.

(Registered 18th October, 1963.)

THIS agreement, made in pursuance of the Industrial Arbitration Act, 1912-1961, this 17th day of October, 1963, between the West Australian Plumbers and Sheet Metal Workers' Industrial Union of Workers and the West Australian Plumbers and Sheet Metal Workers' Industrial Union of Workers (Fremantle Branch) (hereinafter called the "union"), of the one part, and the Hon. Minister for Works (hereinafter called the "employer"), of the other part, witnesseth that, for the considerations hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:—

1.—Title.

This agreement shall be known as the "Sheet Metal Workers (State Engineering Works) Agreement, 1963."

2.—Arrangement.

3.—Term.

This agreement shall operate for a period of twelve (12) months from the date hereof.

4.—Area.

This agreement shall apply to all workers employed in the Sheet Metal Industry under the direct control of the Management of the State Engineering Works.

5.—Scope.

This agreement shall apply to workers employed to work in all classes of sheet metal and its substitutes, the manufacture of metal furniture and the manufacture and repairs of circulating radiators.

6.—Definitions.

- (1) "Sheet Metal" means sheets of metal ten (10) gauge or lighter.
- (2) "Sheet Metal Worker—First Class" shall mean a worker required—
 - (a) to work from blue prints, drawings, or measurements (whichever is required of him) for completed articles, and to make the articles throughout; or
 - (b) to do work, the ability to do which involves the ability to do the work specified in (a).

The expression "blue prints" drawings or measurements mean blue prints, drawings or measurements furnished by the customer to the employer for the purpose of specifying the nature and/or dimensions of the articles ordered, or part thereof, or blue prints, drawings, or measurements of a similar nature; but the expression does not include drawings, sketches, or measurements supplied to the individual workman for the purpose of assisting such workman to understand the nature of and to carry out the work required of him.

(3) "Sheet Metal Worker—2nd Class" shall mean a tinsmith or sheet metal worker employed, except as above, in manufacturing or partly manufacturing articles out of any class of sheet metal of ten (10) gauge or lighter, and including wire work in connection with such articles.

(4) "Sheet Metal Welder—1st Class" means a worker using electric arc or acetylene, petrol or coal gas blow pipe on any work other than—

- (a) cutting scrap metal; or
- (b) welding with the aid of jigs; or
- (c) operations specifically mentioned as being the work of a second and third class welder in the definitions of those terms hereunder.

(5) "Sheet Metal Welder—Second class" means a worker who—

- (a) welds with the aid of jigs; or
- (b) operates automatic welding machines for the setting up of which he is not responsible (other than machines mentioned in the definition of "Sheet Metal Welder—3rd Class"); or
- (c) operates a profile cutting or a straight line cutting machine.

(6) "Sheet Metal Welder—3rd class" means a worker who uses any of the foregoing types of welding apparatus in tacking preparatory to the completion of work by any other worker.

(7) "Process Worker" means a worker engaged on repetition work on any automatic, semi-automatic, or single-purpose machine, or any machine fitted with jigs, gauges, or other tools rendering operations mechanical or in the assembling of parts of mechanical appliances or other metallic articles so made, or any repetitive hand processes.

(8) "Casual Worker" means a worker engaged to work for less than five (5) consecutive days.

7.—Higher Duties.

(1) A worker engaged for more than one-half ($\frac{1}{2}$) of one (1) day or shift on duties carrying a higher rate than his ordinary classification shall be paid the higher rate for such day or shift; if employed for one-half ($\frac{1}{2}$) or less than half ($\frac{1}{2}$) of one (1) day or shift, he shall be paid the higher rate for the time actually worked. Provided, however, that acting time of less than twenty (20) minutes in any one day or shift shall not be counted.

(2) Should any worker be required to perform work in a lower grade, his wage shall not be reduced whilst employed in such capacity.

8.—Contract of Service.

(1) The contract of service shall be by the week and shall be terminable by one (1) week's notice on either side or by the payment or forfeiture, as the case may be, of a week's wages in lieu of such notice.

(2) The employer shall be under no obligation to pay for any day not worked on which the worker is required to present himself for duty, except such absence from work is due to illness and comes within the provisions of clause 22, or such absence is on account of holidays to which the worker is entitled under the provisions of this agreement.

(3) This clause does not affect the right to dismiss for misconduct and in such case wages shall be paid up to the time of dismissal only.

(4) When a worker is discharged before the usual pay day, he shall be paid his wages when he ceases work, or it shall be forwarded to his address the day after by registered post, at the employer's risk, unless the worker desires to collect at the office.

(5) The employer shall be entitled to deduct payment for any day or portion of a day on which the worker cannot be usefully employed because of a strike by the Union, or by any other association or union associated with it, or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.

9.—Annual Leave.

(1) Except as hereinafter provided, a period of two (2) consecutive weeks leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with that employer, but where a worker completes that twelve months continuous service on or after the 30th November, 1963, he shall be allowed three (3) consecutive weeks leave instead of the two (2) consecutive weeks leave prescribed herein.

(2) After one (1) month's continuous service in any qualifying twelve monthly period a worker whose employment terminates shall be paid, in respect of each completed month of continuous service in that qualifying period—

- (i) one-sixth ($\frac{1}{6}$) of a week's pay at his ordinary rate of wage if he leaves his employment before the 30th November, 1963, and one-quarter ($\frac{1}{4}$) of a week's pay at his ordinary rate of wage if he leaves his employment on or after that date;
- (ii) One-quarter ($\frac{1}{4}$) of a week's pay at his ordinary rate of wage if his employment is terminated by the employer through no fault of the worker after 29th August, 1963, and one-sixth ($\frac{1}{6}$) of a week's pay at his ordinary rate of wage if his employment is so terminated on or before that date.

(3) Any worker who may resign or be dismissed from the service for any cause, other than for peculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service: Provided always that if the worker has been dismissed for peculation or theft, no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(4) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(5) "Ordinary wages" for the purpose of subclause (1) hereof shall mean the rate of wage the worker has received for the greatest proportion of the calendar month prior to his taking the leave.

(6) (a) Subject to paragraph (b), when computing the annual leave due under this clause, no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays: Provided that no deductions shall be made for any approved period a worker is absent from duty through sickness with or without pay, unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

(b) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six (6) months only of any such period shall count as service for the purpose of computing annual leave.

(7) When work is closed down for the purpose of allowing annual leave to be taken, workers with less than a full year's service shall only be entitled to payments during such period for the

number of days leave due to them: Provided that nothing herein contained shall deprive the employer of his right to retain such workers at work during the close-down period as may be essential.

(8) A worker may be rostered off and granted annual leave with payment of ordinary wages as prescribed prior to his having completed a period of twelve (12) months' continuous service, in which case should the services of such worker terminate or be terminated prior to the completion of twelve (12) months' continuous service, the said worker shall refund to the employer the difference between the amount received by him for wages in respect of the period of his annual leave and the amount which would have accrued to him by reason of the length of his service up to the date of the termination of his services.

(9) The provisions of this clause shall not apply to casual workers.

10.—Public Holidays.

(1) (a) The following days or the days observed in lieu shall, subject to subclause (2) hereof, be allowed as holidays without deduction of pay, namely: New Year's Day, Australia Day (26th January), Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day and Boxing Day. Provided that another day may be taken as a holiday by arrangement between the parties in lieu of any of the days named in the subclause.

(b) Where Christmas Day or New Year's Day falls on a Saturday or a Sunday, such holiday shall be observed on the next succeeding Monday and where Boxing Day falls on a Sunday or a Monday such holiday shall be observed on the next succeeding Tuesday; in each such case the substituted day shall be deemed a holiday without deduction of pay in lieu of the day for which it is substituted.

(2) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day, he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(3) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker is on duty or is available on the working day immediately preceding a holiday, or resumes duty or is available on the working day following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

(4) A casual worker shall not be entitled to payment for any holiday referred to in this subclause.

11.—Apprentices.

(1) The employment of apprentices shall be governed by the provisions of the Apprenticeship Regulations made under the Industrial Arbitration Act and dated 2nd November, 1953.

(2) Apprentices shall be allowed in the trade of Sheet Metal Work 1st Class.

12.—Shop Stewards.

Subject to the recognition of properly constituted authority, shop stewards, to be appointed by the Union, shall be recognised by the management. The management shall be notified in writing by the Union of the stewards appointed.

13.—Hours of Duty.

(1) (a) The week's work shall consist of forty (40) hours and shall be worked in five (5) days, Monday to Friday inclusive, of eight (8) hours each day.

(b) The hours specified in paragraph (a) of this subclause shall be worked between 7 a.m. and 5.30 p.m.

(2) A meal interval shall not exceed one (1) hour.

(3) (a) Subject to the provisions hereinafter contained, a rest period of seven (7) minutes from the time of ceasing to the time of resumption of work shall be allowed each morning.

(b) This interval shall be counted as time off duty without deduction of pay and shall be arranged at a time and in a manner to suit the convenience of the employer. Morning tea may be taken by employees during this interval, but the period of seven (7) minutes shall not be exceeded under any circumstances. Upon proof of breach by any employee of any provision hereinbefore expressed or implied, the Court may grant the employer concerned exemption from liability to allow the rest period aforesaid.

(4) (a) The employer may require any worker to work reasonable overtime at overtime rates, and such worker shall work overtime in accordance with such requirements.

(b) The Union or worker, or workers covered by this Agreement shall not in any way, whether directly or indirectly, be party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

(c) This subclause shall remain in operation until otherwise determined by the Court.

14.—Overtime and Sunday Time.

(1) (a) All time worked in excess of or outside of the usual working hours shall be paid at the rate of time and a half for the first four (4) hours after the usual stopping time and double time thereafter: Provided that all work after 10 p.m. on Monday to Friday inclusive shall be paid at the rate of double time up to the usual starting time: Provided also that workers called upon to start work within an hour and a half of the usual starting time shall be paid at the rate of time and a half until the usual starting time.

(b) Where work is done on Saturdays the worker shall be paid at the rate of time and a half for the first four (4) hours and double time thereafter, but all work done after 5 p.m. on Saturdays shall be paid for at the rate of double time.

(2) When an employee is required for overtime duty in excess of one hour after the usual ceasing time without being notified the previous day, he shall be supplied with any meal required or be paid five shillings (5s.) for such meal. This subclause shall not apply to workers residing within a radius of one-half mile of the works.

Workers required to start work at 12 midnight until 6.30 a.m., and ordered back to work at 8 a.m. the same day, shall be paid three shillings and sixpence (3s. 6d.) for breakfast.

(3) All time worked during the usual meal time by any worker shall be paid at overtime rates, and such rates shall continue until the worker knocks off for his meal.

(4) A worker called back after completing a day's work, or called out on a Saturday or Sunday, shall be paid a minimum of two (2) hours at overtime rates, but if he is called out more than once within any period of two (2) hours of a call, he shall not be entitled to any further payment for time worked within the period of two (2) hours from the time when he commenced work in response to his first call.

(5) For all work done on Sunday, double time shall be paid with a minimum of two (2) hours.

15.—Fares and Travelling.

(1) Country work:—

(a) When a worker is instructed to proceed on duty from the place where he is then or is usually employed, the employer shall pay all fares, including sleeper and a proper allowance at current rates for all necessary meals and board and lodging. Fares shall be second class, except where travelling by coastal boat, when saloon fares shall be paid, and shall include return fares on completion of job or after twelve (12) months on job.

(b) A worker travelling to work away from or returning to his usual place of employment shall be paid for the actual travelling time in his ordinary working hours, and, in addition thereto, his actual travelling time outside his ordinary working hours, shall be paid at ordinary rates up to a maximum of eight (8) hours in any one (1) day.

Sunday travelling time shall be paid for at the same rates and on the same conditions as on week days.

(c) In respect of a worker who is provided with a sleeping berth in a passenger train, travelling time shall not count between 10 p.m. and 7 a.m.: Provided that this shall not operate to reduce the wages earned and travelling time when paid for below eight (8) hours in any one (1) day.

(2) Other than country work:—

A worker residing in the suburban area who is required to start work at some place other than his usual workshop or place of employment shall, if the time taken in travelling from his place of residence to the job and return exceeds the time normally taken in travelling from his usual place or residence to his usual workshop or place of employment and return, be paid for such excess travelling time at ordinary rates; and if the fares actually and reasonably incurred in such travelling exceed the fares normally paid by the worker in travelling from his place of residence and return, the employer shall pay the amount by which such fares exceed those usually paid for travelling to and from his usual workshop or place of employment.

16.—District Allowance.

(1) In addition to the wages prescribed in clause 21 hereof, allowances shall be paid at the rates set out below, to the workers employed in the following areas:—

(2) The above allowances cover a week, whether of five (5), six (6) or seven (7) days. For periods of less than five (5) days, one-seventh of the above shall be payable for each day or part thereof: Provided, however, that workers who have worked at least one-half of a week shall be given the benefit of Sunday in the calculation of district allowances.

(3) Workers living in messes provided by the employer shall be paid half the rates prescribed in subclause (1).

17.—Preference.

Preference of employment shall be given to financial members of the Union: Provided that the employer shall be under no obligation to communicate with the Union officers to ascertain whether a member is financial.

18.—Board of Reference.

The Court appoints for the purpose of the Agreement a Board of Reference. The Board shall consist of a chairman and two (2) other representatives nominated by the parties. There shall be assigned to such Board in the event of no agreement being arrived at between the parties to the Agreement the functions of—

- (a) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of this Agreement;
- (b) deciding any other matter that the Court may refer to the Board from time to time.

19.—Right of Entry.

On notifying the officer in charge, any officer of the Union, authorised in writing by the President and Secretary of such Union, shall have the right to enter any place or premises during ordinary working hours wherein members of such Union covered by this Agreement are engaged, for the purpose of conversing with or interviewing the workers in such place or premises.

Provided that such officer shall not hamper or otherwise hinder the workers in the carrying out of their work. The officer in charge shall determine whether workers are being hampered or hindered in their work.

20.—Notice Boards.

A notice board shall be provided by the employer on all jobs where, in the opinion of the officer in charge, it is considered that notices are essential to meet the convenience of the Union concerned.

22.—Sick Leave.

(1) (a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth of a week's pay for each completed month of service.

(b) The liability of the employer shall in no case exceed one (1) week's wages during each calendar year in respect of each worker, but the sick leave herein provided shall be allowed to accumulate, and any portion unused in any year may be availed of in the next or any succeeding year.

(c) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(2) The clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act, 1912-1961.

(3) No worker shall be entitled to the benefit of this clause unless he produces proof satisfactory to his employer or his representative of sickness but the employer shall not be entitled to a medical certificate unless the absence is for three (3) consecutive working days or more.

(4) No payment shall be made for any absence due to the worker's own fault, neglect or misconduct.

23.—Long Service Leave.

The conditions applying to Government wages employees generally shall apply to workers covered by this Agreement.

24.—Leading Hands.

"Leading Hand" means any tradesman placed in charge of three (3) or more other workers. A leading hand shall be paid such extra rate as hereinafter prescribed:—

- (a) When in charge of not less than three (3) and not more than ten (10) other workers, shall be paid twenty-one shillings (21s.) per week extra.
- (b) When in charge of more than ten (10) and not more than twenty (20) other workers, shall be paid forty-two shillings and sixpence (42s. 6d.) per week extra.
- (c) When in charge of more than twenty (20) other workers, shall be paid sixty-three shillings and sixpence (63s. 6d.) per week extra.

25.—Special Rates and Provisions.

(1) Height Money: Workers employed at a height of 50 feet or more above the nearest horizontal plane shall be paid an allowance of 1s. 8d. per day, provided that the above allowance may be paid where the work is at a height of less than 50 feet but more than 25 feet above the nearest horizontal plane if the officer in charge so agrees or, failing agreement, if so determined by a Board of Reference.

(2) An allowance of fourpence (4d.) per hour shall be paid on work of an exceptionally dirty nature where clothes are necessarily unduly soiled or injured by the nature of the work done.

(3) Confined Space: Sixpence (6d.) per hour extra shall be paid to any worker working in any place the dimensions of which necessitate the worker working in an unusually stooped or otherwise cramped position, or where confinement within a limited space is productive of unusual discomfort.

(4) Wet Work: Any worker working in water over his boots or if gum boots are supplied over the gum boots, shall be paid one shilling and fourpence (1s. 4d.) per day extra.

(5) Ship Repair Work: Any worker engaged in repair work on board ships shall be paid an allowance of five shillings (5s.) per day for each day on which he is so engaged.

(6) Ramset Guns: Workers using Ramset guns or other explosive tools shall, while using such tools, be paid one penny-halfpenny (1½d.) per hour in addition to the prescribed rate.

(7) Except where otherwise expressly provided, not more than one of the foregoing allowances or extra rates shall be paid at any one time and where more than one allowance or extra rate applies, only the highest shall be paid, but this shall not operate so as to prevent the payment of the allowance prescribed for ship repair work in addition to the extra rate prescribed in subclause (3) (but only if the employer and the worker agree that the degree of discomfort is so exceptional as to warrant the payment of this extra rate in addition to the allowance for ship repair work).

(8) Protective Equipment:

- (a) The employer shall have available a sufficient supply of protective equipment (as for example hand screens, goggles, glasses, gloves, aprons, leggings, gum boots and oilskins) for use by workers when engaged on work for which some protective equipment is reasonably necessary.
- (b) Every worker shall sign an acknowledgment on receipt thereof but such equipment shall at all times remain the property of the employer.
- (c) During the time the same are on issue to the worker he shall be responsible for any loss or damage thereto, fair wear and tear attributable to ordinary use excepted.
- (d) No worker shall lend another worker any protective equipment issued to such first-mentioned worker, and if the same are lent both the lender and the borrower shall be deemed guilty of wilful misconduct.
- (e) Before any protective equipment which has been used by a worker is re-issued by the employer to another worker it shall, where necessary, be effectively sterilised.

(9) First class sheet metal workers and apprentices shall be supplied by the employer with all necessary tools of trade.

26.—Payment of Wages.

(1) Workers shall be paid weekly where practicable.

(2) When a worker is discharged before the usual pay day he shall be paid his wages when he ceases work or it shall be forwarded to his address within seven (7) days by registered post at the employer's risk.

(3) When a worker leaves his employment before the usual pay day he shall on giving notice of his intention to leave not later than starting time be paid his full wages on the day he leaves or it shall be forwarded to his address within seven (7) days by registered post at the employer's risk.

27.—Record Book.

The wages sheets of the department shall be open for inspection at head office by the Secretary of the Union upon reasonable notice being given of his desire to inspect same.
