WHEREAS it is enacted (*inter alia*) by subsection (1) of section 122 of the Licensing Act, 1911-1963, that no licensee shall have or keep his licensed premises open for the sale of liquor, or sell any liquor or permit or suffer any liquor to be drunk or consumed in or upon his licensed premises, upon any Sunday, except under the authority of an airport license; and whereas it is enacted (*inter alia*) by subsection (2) of that section, that the provisions of the section shall not prohibit the sale of liquor to, or the consumption of liquor by, any person on a Sunday, not being Anzac Day or Christmas Day, on premises which are the subject of a publican's general license, a limited hotel license, a canteen license, or a wayside-house license, and are at least twenty miles distant from the Town Hall in Perth when measured by the shortest road route or are situate on Rottnest Island, if the liquor is sold and consumed between the hours of 12 noon and 1 p.m. or the hours of 5 p.m. and 6 p.m.; and whereas it is enacted by the proviso to paragraph (c) of the subsection lastmentioned that the Governor may, on the recommendation of the Licensing Court, by Proclamation, from time to time extend, reduce or vary the hours hereinbefore mentioned in any licensing district or part of a district within the Goldfields District, and that the hours so extended, reduced or varied shall in that licensing district or part of a district thereupon have effect; and whereas by a Proclamation made on the 9th day of January, 1962, and published in the *Government Gazette* on the 12th day of January, 1962, the Governor did, *inter alia*, extend and vary those hours in the case of the licensing district of Ravensthorpe, to the hours between the hours of 10.30 a.m. and 12.30 p.m. and 3 p.m. and 6 p.m.;

and whereas the Licensing Court has recommended to me, the Governor, that the hours in part of the licensing district of Roe, (formerly known as the licensing district of Ravensthorpe) as extended and varied by the said Proclamation, should be further varied: Now, therefore I, the Governor, on the recommendation of the Licensing Court, and with the advice and consent of the Executive Council, do hereby vary, in the case of part of the licensing district of Roe (formerly known as the licensing district of Ravensthorpe) namely, the site of the Port Hotel, Hopetoun, the hours referred to in subparagraph (ii) of paragraph (c) of subsection (2) of section 122 of the Licensing Act, 1911-1963, as extended and varied by the Proclamation made on the 9th day of January, 1962, and published in the *Government Gazette* on the 12th day of January, 1962, to the hours between the hours of 11 a.m. and 1 p.m. and of 4.30 p.m. and 7.30 p.m.

liquor or permit or suffer any liquor to be drunk or consumed in or upon his licensed premises, upon any Sunday, except under the authority of an airport license; and whereas it is enacted (*inter alia*) by subsection (2) of that section, that the provisions of the section shall not prohibit the sale of liquor to, or the consumption of liquor by, any person on a Sunday, not being Anzac Day or Christmas Day, on premises which are the subject of a publican's general license, a limited hotel license, a canteen license or a wayside-house license, and are at least twenty miles distant from the Town Hall in Perth when measured by the shortest road route or are situate on Rottnest Island, if the liquor is sold and consumed between the hours of 12 noon and 1 p.m. or the hours of 5 p.m. and 6 p.m.; and whereas it is enacted by the proviso to paragraph (c) of the subsection lastmentioned that the Governor may, on the recommendation of the Licensing Court, by Proclamation, from time to time extend, reduce or vary the hours hereinbeforementioned in any licensing district or part of a district within the Goldfields District and that the hours so extended, reduced or varied shall in that licensing district or part of a district thereupon have effect; and whereas the Licensing Court has recommended to me, the Governor that the hours hereinbeforementioned should be extended and varied in the manner hereinafter appearing in respect of part of the licensing district of Gascoyne, namely the site of the North West Radio Station situate at North West Cape: Now, therefore I, the Governor, on the recommendation of the Licensing Court and with the advice and consent of the Executive Council, do hereby extend and vary the hours referred to in subparagraph (ii) of paragraph (c) of subsection (2) of section 122 of the Licensing Act, 1911-1963, in the case of part of the licensing district of Gascoyne, namely the site of the North West Radio Station situate at North West Cape, which premises are the subject of a canteen license under that Act, to the hours between the hours of 10.30 a.m. and 12.30 p.m., of 3 p.m. and 6 p.m., and of 8 p.m. and 10 p.m.

AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, this 13th day of February, 1964, the following Orders in Council were authorised to be issued:—

Health Act, 1911-1962.

ORDER IN COUNCIL.

P.H.D. 915/63.

WHEREAS it is enacted (*inter alia*) by section 22 of the Health Act, 1911-1962, that the Governor may place any area of land outside a municipal district under the jurisdiction of the Council of

such municipal district, for the purposes of that Act, and such area shall for all purposes of that Act be deemed to be within the municipal district while so placed under that jurisdiction and the Governor may remove the area of land from that jurisdiction and from that district; and whereas the areas of land described in the first schedule to this Order in Council, being land outside the municipal district of the Town of York, have for the purposes of the said Act been placed under the jurisdiction of the Council of that municipal district and are for all the purposes of the said Act deemed to be within that municipal district; and whereas it is deemed expedient to remove those areas of land from that jurisdiction and from that district; and whereas it is desired and deemed expedient to place the area of land described in the second schedule to this Order in Council, being land outside the municipal district of the Town of York, under the jurisdiction of the Council of that municipal district for the purposes of the said Act and that such area be deemed for all the purposes of the said Act to be within that municipal district while so placed under that jurisdiction: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council and in exercise of the powers conferred by the said Health Act, 1911-1962, doth hereby—

- (a) remove the areas of land described in the first schedule to this Order in Council from the jurisdiction of the Council of the municipal district of the Town of York and from that district; and
- (b) place the area of land described in the second schedule to this Order in Council under the jurisdiction of the Council of the municipal district of the Town of York, for the purposes of the said Act.

First Schedule.

1. All that portion of Avon Location Y, containing about 10 acres, bounded on the northern side by Gwambygne Lot 46, on the eastward by the foreshore of the Avon River, on the southward by part of lot 48 and a public road, and on the westward by the eastern boundary of lot 47.

3. All that portion of Avon Location Y 17 lying south-eastward of road number 663.

Health Act, 1911-1962.

ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by section 19 of the Health Act, 1911-1962, that the Governor may, by Order in Council, constitute any portion of the State, not being a municipal district, a health district, with such boundaries and by such name as may be specified in the order: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 19 of the said Act, doth hereby declare all that portion of the State comprised in the municipal district of the Shire of Exmouth, to be a health district, and for the purposes of the said Act to be known as the "Exmouth Health District."

Fire Brigades Act, 1942-1963.

ORDER IN COUNCIL.

WHEREAS it is enacted by subsection (1) of section 5 of the Fire Brigades Act, 1942-1963, that, subject to the provisions of subsection (2) of that section, the municipal and road districts and parts

thereof constituted as fire districts prior to the coming into operation of the Fire Brigades Act Amendment Act, 1959, as set out in the second schedule to the Act, are for the purposes of the Act fire districts under the respective names as set out in that schedule; and whereas it is further enacted, *inter alia*, by subsection (2) of that section that for the purposes of the Act the Governor may from time to time, by Order in Council, adjust the boundaries of a fire district: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby adjust the boundaries of the Northam Fire District as set forth in Part IV of the second schedule to the Act by substituting for the Municipal District of Northam referred to in that Part IV of such schedule that portion of the Municipal District of the Town of Northam set forth in the schedule to this Order in Council.
