#### ORDER IN COUNCIL.

P.W. 1060/58 "A."

WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in Arthur Frank Amey: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby vests in Arthur Frank Amey the appointment of foremen and all other persons employed on such works at a daily rate of wage.

#### ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such Order and with power of sub-leasing; and whereas it is deemed expedient as follows:—

Corres. 6401/97.—That Reserve No. 5751 (Tammin Agricultural Area Lot 75) should vest in and be held by the Shire of Tammin in trust for the purpose of Recreation.

Corres. 2455/19.—That Reserve No. 27145 (Avon Location 20588 should vest in and be held by the Shire of Kellerberrin in trust for the purpose of Recreation (Water Sports Area).

Corres. 2324/59.—That Reserve No. 27147 at Northam should vest in and be held by the Town of Northam in trust for the purpose of Recreation and Drainage.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall vest in and be held by the abovementioned bodies in trust for the the purposes aforesaid with power to the said bodies, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserves for any term not exceeding 21 years from the date of the lease.

#### ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall be granted in fee simple to the abovementioned bodies to be held in trust for the aforesaid purposes, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

ORDER IN COUNCIL.

WHEREAS by section 4 of the Water Supply, Sewerage, and Drainage Act, 1912-1950, it is provided, *inter alia*, that all water works, sewerage, drainage, and irrigation works constructed by the Government and declared by the Governor to be subject to any of the Acts mentioned in the schedule to that Act shall vest in the Minister for Water Supply, Sewerage, and Drainage on behalf of Her Majesty unless and until those works are vested in a board; and whereas the Government by the Honourable Minister for Works has constructed water works being Limeburner's Creek Pipehead and Gravity Main in the Albany Country Water Area on the land delineated on Plan P.W.D., W.A. 40746, and thereon shown in red; and whereas, by Order in Council dated the 3rd September, 1957, and published in the *Government Gazette* on the 13th September, 1957, the Albany Water Area was constituted a Country Water Area under the name or designation "Albany Country Water Area" with effect on the 1st day of November, 1957; and whereas it is deemed expedient that the water works constructed as hereinbefore mentioned be declared to be subject to the Country Areas Water Supply Act, 1947-1960: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council and acting in pursuance of section 4 of the Water Supply, Sewerage, and Drainage Act, 1912-1950, doth hereby declare the water works being Limeburner's Creek Pipehead and Gravity Main constructed by the Government in the Albany Country Water Area on the land delineated on Plan P.W.D., W.A. 40746, and thereon shown in red, to be subject to the Country Areas Water Supply Act, 1947-1960, being an Act mentioned in the schedule to the Water Supply, Sewerage and Drainage Act, 1912-1950.

ORDER IN COUNCIL.

P.W.W.S. 842/61 "B."

WHEREAS it is enacted under section 8 of the Country Areas Water Supply Act, 1947-1960, that the Governor may, by Order in Council, alter or extend the boundaries of a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby extend the boundaries of the Great Southern Towns Country Water Area to include the area as defined in the schedules hereunder, and assign the name of "Great Southern Towns Country Water Area" thereto.

the northern boundary of location 7102, a point on the present southern boundary of the Great Southern Towns Country Water Area, and extending southerly, westerly and northerly along boundaries of location 253 aforesaid to the south-eastern corner of the northern severance of location 3989; thence generally north-westerly along the southern boundaries of that severance and west-north-westerly along the southern boundaries of locations 552, 553, 1636, 554, 1342 and 556 to a point situate in prolongation northerly of the eastern boundary of location 7318; thence southerly and westerly to and along boundaries of that location to the south-eastern corner of location 557; thence westerly and north-westerly along boundaries of that location to a point situate in prolongation easterly of the southern boundary of lot D3 of part of location 257 as shown on Certificate of Title Volume 1085, folio 924; thence westerly and generally north-westerly to and along boundaries of the eastern severance of that lot and onwards to the southern boundary of location 433; thence westerly along the southern boundaries of that location and location 432 to the south-western corner of the lastmentioned location; thence generally north-westerly along the western boundaries of that location and locations 588 and 536 to a point situate in prolongation easterly of the southern boundary of Broomehill Suburban Lot 416; thence westerly to and along the southern boundaries of that lot and lots 415, 400 and 399 to the south-western corner of the lastmentioned lot; thence northerly along the western boundaries of that lot and lots 398, 397 and 396 and onwards to the south-western corner of lot 395; thence westerly to and along the southern boundaries of lots 391, 386, 385 and 384 to the south-western corner of the lastmentioned lot; thence northerly along the western boundaries of that lot and lots 382, 381 and 378 to the south-western corner of lot 377; thence westerly to and along the southern boundary of location 1237 to the eastern boundary of part of lot E10 of location 256; thence southerly, generally westerly and generally northerly along boundaries of that part of lot E10 to a point situate in prolongation easterly of the southern boundary of location 1142; thence westerly and generally northerly to and along boundaries of that location to a point situate in prolongation easterly of the southern boundary of Reserve 1701; thence westerly to and along that boundary and the southern boundaries of location 1279, 8342 and 204 to the south-western corner of the lastmentioned location; thence northerly along the western boundary of that location and onwards to a southern boundary of location 1279 aforesaid; thence westerly and northerly along boundaries of that location and onwards to a southern boundary of lot 3 of location 256 as shown on Land Titles Office Plan 5239, a point on the present southern boundary of the Great Southern Towns Country Water Area aforesaid, and thence generally east-south-easterly along that boundary to the starting point, as shown in red on Plan P.W.D., W.A. 40877.

location and easterly and southerly along boundaries of location 1354 and onwards to the northern boundary of location 5739; thence north-easterly along the northern boundaries of that location and location 4928 to the north-eastern corner of the lastmentioned location; thence southerly along the eastern boundary of that location and onwards to the northern boundary of location 3716; thence easterly and southerly along boundaries of that location to the north-western corner of location 2046; thence easterly and southerly along boundaries of that location and onwards to the northern boundary of location 2043; thence easterly and southerly along boundaries of that location and southerly along the eastern boundary of location 2044 to the northern boundary of location 2045; thence easterly along the northern boundary of that location and easterly and southerly along boundaries of location 1675 to the north-eastern corner of location 226; thence southerly along the eastern boundary of that location to the north-western corner of location 292; thence easterly and southerly along boundaries of that location and onwards to the northern boundary of Gnowangerup Townsite; thence generally westerly and southerly along that boundary to a point situate in prolongation easterly of the southern boundary of location 2356, a point on the present northern boundary of the Great Southern Towns Country Water Area aforesaid, and thence generally north-westerly along that boundary to the starting point, as shown in red on Plan P.W.D., W.A. 40877.
