MINE WORKERS' RELIEF ACT, 1932-1961.

### REGULATIONS

MINE WORKERS' RELIEF ACT, 1932-1961.  
REGULATIONS.

1. These regulations may be referred to as the Mine Workers' Relief Regulations.

1A. In these regulations unless the context requires otherwise—  
"Mines Medical Officer" means a medical officer appointed for the purposes of the Act under section 7 of the Act;  
"the Act" means the Mine Workers' Relief Act, 1932 (as amended);

words and expressions used in these regulations have when so used the same respective meanings as are given to them in and for the purposes of the Act.

2. The certificate of appointment mentioned in section 7 of the Act shall be in the Form "A" in the First Schedule hereto.

3. The Mines Medical Officer, when requiring any person occupied or employed in mining operations to submit himself for examination for symptoms of silicosis or tuberculosis shall do so by notice in Form "B" in the First Schedule hereto.

4. (1) The certificate to be supplied to a person pursuant to subsection (3) of section 8 of the Act shall be in the Form "C" or "C1" in the First Schedule hereto.

(2) After every medical examination or re-examination of any person under the provisions of the Act, the Mines Medical Officer shall issue to that person a notice in the Form "D1" in the First Schedule hereto.

5. Within seven (7) days of the completion of examination of the mine workers employed on or in any mine, or persons engaged in prospecting, the Mines Medical Officer shall furnish a report in writing to the Minister stating the name, address, laboratory number and the date of examination of any such person found to be suffering from—

- (a) Tuberculosis without silicosis;
- (b) Silicosis with tuberculosis;
- (c) Silicosis in the advanced stage;

together with a medical certificate in the Form "D" in the First Schedule hereto in each case, except in the case of a person found to be suffering from tuberculosis without silicosis in the second year of his leaving the industry, when the medical certificate shall be in the Form "D2" in such schedule.

- (d) The name and address and laboratory number of any such person found to be suffering from silicosis in the early stage.
- (e) The number of men free from the diseases mentioned in the Act.

6. (1) The Minister shall, on receipt of a report in the Form "D" in the First Schedule hereto from the Mines Medical Officer under the provisions of section 13, subsection 1, serve upon the person named therein in Form "E" or "F" in the First Schedule hereto, and upon the employer of such person a notice in the Form "G" or "H" in the First Schedule hereto, as the case may be.

Where the said person is suffering from tuberculosis without silicosis, the Minister shall also on receipt of the said report serve upon him a notice in Form "E1" in the said First Schedule hereto.

(2) On receipt of a report from the Mines Medical Officer in the Form "D2" in the First Schedule hereto and of an appeal in the Form "K" in that schedule from the person named in such report, the Minister shall, if he is satisfied that the tuberculous condition of that person resulted from his employment in the mining industry and after verifying the correctness of the date stated by that person in his appeal as being the date on which he was last employed as a mine worker, serve upon that person a notice in the Form "E" in the First Schedule hereto.

(3) If after having received the report and appeal referred to in subregulation (2) of this regulation the Minister is not satisfied that the tuberculous condition of the person named in that report resulted from his employment in the mining industry, the Minister shall, after verifying the correctness of the date stated by that person in his appeal as being the date on which he was last employed as a mine worker, refer the appeal to a Medical Board for a determination.

7. The Minister shall, on receipt of a report under section 16, subsection 1, send notice to the person therein named in Form "T" or "J" in the First Schedule hereto, as the case may be.

8. (1) Every appeal under section 14 of the Act shall—

- (a) be in the Form "K" in the First Schedule hereto;
- (b) be lodged in duplicate with the Superintendent, Mine Workers' Relief Act, Mines Department at Perth within thirty days of the issue by the Mines Medical Officer to the appellant of the notice referred to in subregulation (2) of regulation 4 of these regulations;
- (c) be accompanied by that notice and by a certificate in writing supplied by a duly qualified medical practitioner; and
- (d) contain the name and address of the qualified medical practitioner nominated by the appellant as a member of the Medical Board.

(2) Each appellant shall state in his appeal the date on which he ceased work as a mine worker and the name of the employer by whom he was last so employed, or if he is still so employed the name of his employer, or where the appellant was a prospector admitted as a contributor to the Mine Workers' Relief Fund, the date on which he ceased to be engaged in *bona fide* full time prospecting, or that he is still so engaged.

(3) The Superintendent, Mine Workers' Relief Act, shall give to the appellant notice in writing of the date fixed by the Medical Board for hearing the appeal and the place where the appeal is to be heard at least fourteen days prior to the date so fixed, unless the appellant consents in writing filed with the Superintendent to a lesser period of notice.

(4) The certificate of the decision of the Medical Board on an appeal and its determination (if any) made under paragraph (b) of subsection (4) of section 14 of the Act shall be in the form "L" in the First Schedule hereto.

(5) The Minister shall give notice to the appellant of the decision and determination of the Medical Board in the Form "Li" in the First Schedule hereto, and shall also—

- (a) where the appeal was made under paragraph (a) of subsection (4) of section 14 of the Act, serve on the appellant such of the Forms referred to in subregulation (1) of regulation 6 and in regulation 7 of these regulations as are appropriate and necessary in the case, and otherwise act and cause such acts to be done as though the decision were one made and reported by the Mines Medical Officer; or
- (b) where the appeal was made under paragraph (b) of that subsection (4) and the certificate of the determination of the Medical Board reports that the tuberculous

condition of the appellant resulted from his employment in the mining industry or from his being engaged in prospecting, serve on the appellant a notice in the Form "E" in the First Schedule hereto, and otherwise act and cause such acts to be done as though the tuberculous condition of the appellant had been diagnosed and reported by the Mines Medical Officer during the operations of the appellant in the mining industry or within one year after his having ceased such operations.

(6) An appeal which is not lodged in accordance with the provisions of section 14 of the Act or which does not comply with the requirements of this regulation shall lapse.

(7) No costs shall be payable by or be awarded against an appellant in respect of an appeal under section 14 of the Act, except that—

- (a) where a person appeals on similar grounds more than once in any period of twelve months; or
- (b) where in the opinion of the Minister the appeal is frivolous,

the Minister may require the appellant before his appeal will be proceeded with to lodge with the Superintendent, Mine Workers' Relief Act, a sum specified by the Minister to meet the costs of the appeal which sum shall in the event of the appellant not succeeding in his appeal be forfeited to the Crown.

12. Every mine worker shall contribute to the fund three shillings and sixpence per pay when the pay is fortnightly, or half-monthly, and seven shillings per pay when the pay is monthly.

Provided that, when the pay is fortnightly and when three pay days occur in any one calendar month, every mine worker shall be exempt from making a contribution to the fund on the occasion of the third pay day in such month.

13. Prior to the 15th day of February, 1933, and the 15th day of February in every succeeding year, the names of persons nominated as candidates for the office of Member of the Mine Workers' Relief Board shall be lodged with the Secretary of the Board. Nominations shall be in writing, signed by the person nominated and also by his proposer and seconder. The proposer and seconder must be employers, in the case of candidates for elections as employers' representative, and mine workers, in the case of candidates for election as mine workers' representative, and in every case must be persons who are entitled to vote at the election.

14. (1) If the number of candidates nominated by the mine workers exceeds the vacancy or number of vacancies or prospective vacancies amongst the mine workers' representatives of the Mine Workers' Relief Board, the Secretary shall cause ballot papers to be printed containing in alphabetical order all the names of the candidates and the Secretary shall in the case of mine workers post to the employers a sufficient number of such ballot papers according to the number of contributing mine workers employed on the mine of the employer and such employer shall cause a ballot to be taken on any date that may be suitable to the employer between

the 7th and 20th days of April, inclusive, of all contributing mine workers engaged on the mine of the employer on that day. A mine worker when voting shall mark the ballot paper in accordance with regulation 16A of these regulations and shall then place the ballot paper in a sealed box to be kept by the employer for this purpose, and at the close of the poll the employer shall forthwith send or hand the box, with the seal still unbroken, to the Secretary.

(2) The Secretary shall also cause ballot papers to be distributed one to each of those persons who are not mine workers but are contributors to the fund and as such are entitled to vote pursuant to paragraph (b) of section 31 of the Act, in sufficient time to enable the contributor to mark the ballot paper and return it to the Secretary on or before the 19th April. Each contributor when voting shall mark the ballot paper in accordance with regulation 16A of these regulations and shall then place it in the envelope supplied for that purpose by the Secretary and marked "Ballot Paper" and close and seal the envelope. The contributor shall then place that envelope marked "Ballot Paper," together with his name and address, in another envelope and post or deliver it to the Secretary so that it is received by him on or before the 19th April.

If the number of candidates nominated by the employers exceeds the vacancy or number of vacancies or prospective vacancies of employer representatives on the Mine Workers' Relief Board, the Secretary shall cause ballot papers to be printed containing in alphabetical order all the names of the candidates and shall send one of such ballot papers to each employer with an envelope marked "Ballot Paper." Each employer when voting shall mark the ballot paper in accordance with regulation 16A of these regulations, and then place the ballot paper in the envelope marked "Ballot Paper," and close it. The envelope marked "Ballot Paper" shall then be placed together with a statement in writing of the name and address of the employer in another envelope addressed, stamped and posted or delivered to the Secretary on or before the 19th April.

16A. (1) Voting shall be by means of a preferential ballot.

(2) When only one candidate is to be elected and there are not more than two candidates, the elector shall mark his vote on the ballot paper by placing the numeral 1 opposite the name of the candidate for whom he votes.

(3) When only one candidate is to be elected and there are more than two candidates, the elector shall mark his vote on the ballot paper by placing the numeral 1 opposite the name of the candidate for whom he votes as his first preference and he shall give contingent votes for all remaining candidates by placing the numerals 2, 3 and so on (as the case requires) opposite their names, so as to indicate by such numerical sequence the order of his preference.

(4) When two candidates are to be elected, the elector shall mark his vote on the ballot paper by placing the numeral 1 opposite the name of the candidate for whom he votes as his first preference and the numeral 2 opposite the name of the candidate for whom he votes as his second preference and he shall give contingent votes for all the remaining candidates by placing the numerals 3, 4 and so on (as the case requires) opposite their names so as to indicate by such numerical sequence the order of his preference.

16B. (1) Where any mine worker or employer be, or intends to be absent from the district on the dates appointed for the ballot, he may, prior to such dates, vote as an absent voter at the office of the Secretary, but before being issued with a ballot paper shall make a statutory declaration to the effect that he is qualified to vote and will not be within the district under conditions which would permit of him voting; and that if he is permitted to vote as an absent voter shall not vote elsewhere in connection with the ballot.

(2) Upon the ballot paper being issued the voter shall mark his vote thereon in accordance with Regulation 16A and then place the ballot paper in an envelope marked "Ballot Paper" and fasten and seal it and return it to the Secretary who shall forthwith deposit the envelope in a sealed ballot box, which shall not be opened until the close of the ballot.

17. The Secretary shall act as Returning Officer, and in the event of the nominations not exceeding the number of vacancies the Returning Officer shall forthwith declare those nominated duly elected. In the event of the nominations exceeding the number of vacancies, the Secretary as such Returning Officer shall forthwith fix a day as soon as possible after the 20th day of April for counting the votes in the presence of the Scrutineers or a quorum of the same.

18. If an election shall take place as provided for under regulations 14 and 16 of these regulations the Returning Officer shall conduct the election, and count the votes, in the manner prescribed by these regulations and on the completion of the counting of the votes, forthwith declare in writing the result of the election. Such declaration as to the result of the election shall be final and conclusive.

18A. Except as otherwise provided in these regulations the method of conducting the election and the count of the votes shall be the same as that prescribed under the Electoral Act, 1907 and its amendments, for the conduct of an election and the counting of votes taken at an election of members of the Legislative Assembly. Provided that—

- (a) when two candidates are to be elected the count of the votes shall proceed until one candidate has received an absolute majority, when he shall be declared elected. The first elected candidate shall then be eliminated from the count, and to proceed with the election of the second candidate all the ballot papers, including those which have been set aside as exhausted, shall be brought into operation and again sorted into first preference votes. The first preference votes of the eliminated successful candidate shall be distributed according to the second preference markings shown thereon to the remainder of the candidates, and when added to their respective first preference votes shall constitute the first count for the second candidate. The procedure from then on shall be the same as in the counting of votes for the election of one candidate.
- (b) Votes shall not be deemed to be informal except in the case hereinafter mentioned.

18B. (1) A ballot paper shall be informal—

- (a) if it is not initialled by the Returning Officer, or Presiding Officer;
- (b) if, subject as hereinafter provided, it is marked in any other manner than that prescribed in regulation 16A of these regulations; or
- (c) if it has upon it any mark or writing which, in the opinion of the Returning Officer, will enable any person to identify the voter; or
- (d) if it does not indicate the elector's vote or if, when there are more than two candidates, it is not marked as prescribed by these regulations so as to indicate by numerical sequence the elector's preference as regards all candidates; provided that if numerals in arithmetical sequence are placed opposite the names of all the candidates but one, the next following numeral shall be deemed to be placed opposite the name of the remaining candidate.

(2) A ballot paper shall not be informal for any reason other than the reasons mentioned in subregulation (1) of this regulation, but shall be given effect to according to the elector's intention so far as his intention is clear and in particular when only one candidate is to be elected and there are only two candidates a ballot paper shall not be informal by reason only of the elector having indicated his vote or first preference by a cross instead of the numeral 1.

19. The Mine Workers' Relief Board shall nominate two persons as Scrutineers and the Minister for Mines a third one to assist the Returning Officer—two Scrutineers shall be a quorum. No member or candidate for membership of the Mine Workers' Relief Board shall act as a Scrutineer.

20. The Secretary shall post the result of every election in his office and publish the same in the *Government Gazette*.

21. On an election of Mine Workers' representatives on the Mine Workers' Relief Board each mine worker shall have one vote.

22. On the election of employers' representatives on the Mine Workers' Relief Board each employer shall have one vote for every mine worker in respect of whom he contributes to the fund under the Act up to five. He shall have an additional vote for every additional five mine workers up to fifty, and an additional vote for every ten beyond the first fifty. The attorney of an employer may vote in his name.

23. When any extraordinary vacancy shall occur among the elected members of the Mine Workers' Relief Board, an extraordinary election shall be held to fill such vacancy in accordance with the provisions of regulations 14 or 16 as the case may require, with such modification as regards dates as the circumstances may necessitate. Every such election shall be held within three months of the vacancy arising.

24. The Minister may authorise alterations in detail as may be deemed necessary by him.

25. Any person voting who is not entitled to vote, or voting more than once at the same election, shall be guilty of a breach of the Regulations and shall be liable to a penalty of not more than Ten pounds for each offence.

26. The Returning Officer and any scrutineers appointed to attend at contested elections of Mine Workers' representative or employers' representative on the Mine Workers' Relief Board will be allowed the following fees:—

Persons appointed under the provisions of the Public Service Act, 1904, are authorised to receive and retain such fees as are provided for their use under this Regulation, in accordance with the procedure adopted in the Public Service.

Remuneration of Members of the Board.

27. Each member of the Mine Workers' Relief Board shall be paid out of the fund a fee not exceeding £2 2s. for each Board meeting he shall attend, but no member shall during any one year of office receive more than £100 for such fees.

Travelling Expenses of Members of the Board.

27A. Subject to the approval of the Board, whenever the Chairman or any other member of the Mine Workers' Relief Board has necessarily to travel for the purposes of the performance of his functions, or the carrying out of his duties as such Chairman or member, he shall be entitled to and be paid out of the fund a travelling expenses allowance at the rate of fifteen shillings per day, and *pro rata* for part of a day, plus such taxi hire, railway fare, and railway sleeping berth charges as are actually incurred.

#### Meetings of the Board.

28. The Mine Workers' Relief Board may meet for the despatch of business, adjourn, and otherwise regulate their meetings as they may think fit, and three members of the Board shall be a quorum. The Chairman or two members of the Board may at any time, and the Secretary shall, upon the request in writing of the Chairman or two members of the Board, summon a meeting of the Board. Notice of every meeting of the Board stating the general particulars of all business to be considered at such meeting shall be sent by post to each member of the Board at least three days before such meeting unless urgent circumstances require shorter notice, but the proceedings of any meeting shall not be invalidated by any irregularity in respect of such notice, or by reason of any business being considered, which is not comprised in such general particulars.

29. The minutes of resolutions and proceedings of the Board shall be entered in ink in a minute book to be kept for that purpose, and the minutes of every meeting of the Board shall be read at the next or any subsequent meeting thereof, and if found correct shall be signed by the Chairman of such meeting.

41. Any person desiring to contribute to the fund as a mine worker under paragraph (a) or (b) of subsection (1) of section 57 of the Act shall make application to the Secretary of the Mine Workers' Relief Board in the Form "Y" or "Z" in the First Schedule hereto, as the case may be, and annex thereto a certificate from the Mines Medical Officer in the form "Z4" or "Z5" in the said Schedule, as the case may be, that he is free from—

- (a) the diseases mentioned in subregulation (1) of regulation 251 of The Mines Regulation Act Regulations made under the Mines Regulation Act, 1946, and is in other respects physically fit for work as a mine worker; or
- (b) the diseases mentioned in subregulation (1) of regulation 251 of The Mines Regulation Act Regulations made

under the Mines Regulation Act, 1946, with the exception of silicosis in the early stage, and is in other respects physically fit for work as a mine worker.

Provided that:—

- (1) If any prospector is prospecting at a place so far distant from Kalgoorlie that it would cause him unreasonable delay and expense to obtain a certificate from the Mines Medical Officer, the Board may accept the certificate of the legally qualified medical practitioner residing nearest to him, conditionally that he obtains the necessary certificate from the Mines Medical Officer within twelve months of the date of his application, or such further time as the Board may allow; and
- (2) if any prospector has obtained a certificate from a medical practitioner as provided in paragraph (1) of this proviso, and thereafter is medically examined by the Mines Medical Officer and found to be suffering from any of the diseases mentioned in subregulation (1) of regulation 251 of the Mines Regulation Act Regulations made under the Mines Regulation Act, 1946, and its amendments, and was in the opinion of the Mines Medical Officer suffering from the said disease or diseases at the time when he previously obtained that certificate from a medical practitioner, the Board may revoke such permission and refund the total amount of contributions paid into the Fund by the prospector.

This proviso shall not be construed as applying to any prospector who at the date he obtained a certificate of a medical practitioner in accordance with paragraph (1) of this proviso was only suffering from silicosis in the early stage and had for a period or periods amounting in the aggregate to five years been personally engaged in prospecting in Western Australia.

A mine worker, or prospector who has been permitted to contribute to the Mine Workers' Relief Fund, may appeal against the diagnosis made by the Mines Medical Officer by giving notice thereof to the Superintendent, Mine Workers' Relief Act, Mines Department, Perth, within 30 days of the date of this notice. Such an appeal is required to be accompanied by this form and a certificate by a duly qualified medical practitioner given in support of the appeal, and the appellant must nominate a duly qualified medical practitioner who has agreed to represent him on a medical board which will be constituted to hear his appeal.

2. Also, a person found to be suffering from tuberculosis without silicosis in the second year of his leaving the industry may likewise appeal for a determination by a medical board that his tuberculous condition resulted from his employment in the mining industry or resulted from his being engaged in prospecting, and if the board constituted to consider the appeal shall so determine, or, in the case of a mine worker, if the Minister is prepared to concede the appeal without reference to a board, such person's case may then be considered under the provisions of section 13 or section 57, dependent upon whether the appellant was a mine worker or prospector.

3. Appeal forms are obtainable from the Superintendent, Mine Workers' Relief Act, Mines Department, Perth; the Mines Medical Officer, State X-ray Laboratory at Kalgoorlie, and the Secretary of the Mine Workers' Relief Fund, Maritana Street, Kalgoorlie.
