ORDER IN COUNCIL.

P.W. 1060/58.

WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in Robert Anthony Cameron, and that the power vested in George Keith Thompson should be revoked: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby vests in Robert Anthony Cameron the appointment of foremen and all other persons employed on such works at a daily rate of wage; and doth hereby revoke the power vested in George Keith Thompson.

Corres. 3057/63.—That Reserve No. 27180 (Meekatharra Lots 259, 260 and 270) should vest in and be held by the Minister for Native Welfare in trust for the purpose of Native Housing.

Corres. 2257/62.—That Reserve No. 27181 (Jerramungup Lot 133) should vest in and be held by the Shire of Gnowangerup in trust for the purpose of a Municipal Depot Site.

Corres. 1427/63.—That Class "A" Reserve No. 27184 (Mount Barker Lot 577) should vest in and be held by the Shire of Plantagenet in trust for the purpose of Vehicle Parking.

Corres. 1808/16.—That Reserve No. 27187 (Korbel Lot 38) should vest in and be held by Messrs. Alfred Wallace Miller, Harold James Clark and William Thomas Osborne in trust for the purpose of Hall Site.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserves shall vest in and be held by the abovementioned bodies and persons in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

#### Land Act, 1933-1963.

#### ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined

in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

#### Land Act, 1933-1963.

#### ORDERS IN COUNCIL.

WHEREAS by section 34 of the Land Act, 1933-1963, it is made lawful for the Governor, by Order in Council, without issuing any deed or grant, to place any reserve under the control of any municipality, road board, or other person or persons, as a board of management, and to empower such Board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon or other use thereof, and for other purposes, such by-laws to be approved by the Governor and published in the *Government Gazette*; and whereas it is deemed expedient as follows:—

Corres. 1426/63.—That Class "A" Reserve No. 27183 for the purpose of Conservation and Propagation of Timber at Mount Barker should be placed under the control of the Shire of Plantagenet as a Board of Management.

Corres. 1428/63.—That Class "A" Reserve No. 27185 for the purpose of a Green Belt at Mount Barker should be placed under the control of the Shire of Plantagenet as a Board of Management.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned reserves under the control of the abovementioned bodies as Boards of Management, and doth empower such Boards to make, repeal, or alter by-laws for the control and management of the said reserves; for prescribing fees for depasturing thereon or other use thereof; for directing the manner in which such fees shall be imposed, paid, collected and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof and £2 a day for a continuing breach, but not more than £20 in the aggregate.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1962.

#### ORDER IN COUNCIL.

M.W.S. 488743/64.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1962, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Mounts Bay Main Drain Outlet Extension, consisting of reinforced concrete pipe drains of 72-inch and 78-inch diameter together with all things necessary for the undertaking, as shown on Plan W.M.S.S. & D.D., W.A. No. 9040.

This Order in Council shall take effect from the 8th day of May, 1964.

Water Supply, Sewerage and Drainage Act, 1912-1950.

#### ORDER IN COUNCIL.

WHEREAS by section 4 of the Water Supply, Sewerage and Drainage Act, 1912-1950, it is provided, *inter alia*, that all water works, sewerage, drainage, and irrigation works constructed by the Government and declared by the Governor to be subject to any of the Acts mentioned in the schedule to that Act shall vest in the Minister for Water Supply, Sewerage, and Drainage on behalf of Her Majesty unless and until those works are vested in a board; and whereas the Government by the Honourable Minister for Works has constructed headworks, service tank, supply main and reticulation works being Watheroo Water Supply in the Watheroo Country Water Area on the land delineated on Plan P.W.D., W.A. 40700, and thereon shown in green; and whereas, by Order in Council dated the 4th July, 1962, and published in the *Government Gazette* on the 13th July, 1962, the Watheroo Country Water Area was constituted a Country Water Area under the name or designation "Watheroo Country Water Area" with effect on the 13th day of July, 1962; and whereas, by Order in Council dated the 27th November, 1963, and published in the *Government Gazette* on the 6th December, 1963, the boundaries of the said Watheroo Country Water Area were extended; and whereas it is deemed expedient that the water works constructed as hereinbefore mentioned be declared to be subject to the Country Areas Water Supply Act, 1947-1960: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council and acting in pursuance of section 4 of the Water Supply, Sewerage and Drainage Act, 1912-1950, doth hereby declare the water works being Watheroo Water Supply constructed by the Government in the Watheroo Country Water Area on the land delineated on Plan P.W.D., W.A. 40700, and thereon shown in green, to be subject to the Country Areas Water Supply Act, 1947-1960, being an Act mentioned in the schedule to the Water Supply, Sewerage, and Drainage Act, 1912-1950.

WHEREAS by section 4 of the Water Supply, Sewerage and Drainage Act, 1912-1950, it is provided, *inter alia*, that all water works, sewerage, drainage, and irrigation works constructed by the Government and declared by the Governor to be subject to any of the Acts mentioned in the schedule to that Act shall vest in the Minister for Water Supply, Sewerage and Drainage on behalf of Her Majesty unless and until those works are vested in a board; and whereas the Government, by the Honourable Minister for Works has constructed irrigation works being Ord Irrigation in the Ord Irrigation District on the land delineated on Plan P.W.D., W.A. 40922 and thereon shown in pink and blue; and whereas, by Order in Council dated the 4th July, 1962, and published in the *Government Gazette* on the 13th July, 1962, the Ord Irrigation District was constituted an Irrigation District under the name or designation "Ord Irrigation District"; and whereas it is deemed expedient that the irrigation works constructed as hereinbefore mentioned be declared to be subject to the Rights in Water and Irrigation Act, 1914-1962: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council and acting in pursuance of section 4 of the Water Supply, Sewerage and Drainage Act, 1912-1950, doth hereby declare the irrigation works being Ord Irrigation constructed by the Government in the Ord Irrigation District on the land delineated on Plan P.W.D., W.A. 40922, and thereon shown in pink and blue, to be subject to the Rights in Water and Irrigation Act, 1914-1962, being an Act mentioned in the schedule to the Water Supply, Sewerage and Drainage Act, 1912-1950.

## Local Government Act, 1960.

## ORDER IN COUNCIL.

L.G. 523/61.

WHEREAS it is enacted by section 433A of the Local Government Act, 1960, that the Governor may (*inter alia*) make and publish in the *Gazette* uniform general by-laws for all or any of the purposes for which by-laws may be made by a Council under Part XV of that Act and, by order, declare that all or any such uniform general by-laws as are specified in the order shall apply to the whole or any portion of a district so specified; and whereas the Governor has so made and published the uniform general by-laws hereinafter in this order appearing: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid, doth hereby declare that—

- (1) the uniform general by-laws published in the *Government Gazette* on the 16th April, 1964, apply to—
  - (a) the municipal district of the shire of Swan-Guildford, less that portion of the district shown as for "Rural Development" on the Metropolitan Regional Plan;
  - (b) the whole of each of the municipal districts set out in the First Schedule hereto; and
  - (c) those portions specified, in each of the districts set out, in the Second Schedule.

- The cities of Perth, Fremantle, Subiaco, Nedlands and South Perth.
- The towns of Albany, Boulder, Bunbury, Carnarvon, Claremont, Cottesloe, East Fremantle, Geraldton, Kalgoorlie, Melville, Midland, Mosman Park, Narrogin, Northam and York.
- The shires of Armadale-Kelmscott, Bal- ingup, Bassendean, Bayswater, Belmont, Beverley, Busseton, Canning, Capel, Cockburn, Collie, Cranbrook, Dardanup, Denmark, Dundas, Gosnells, Harvey, Kwinana, Mandurah, Mundaring, Murray, Northam, Northampton, Peppermint Grove, Perth, Rockingham, Serpentine-Jarrahdale, Wanneroo and Waroona.

- The shire of Ashburton, the townsites of Onslow.
- The shire of Augusta-Margaret River, the townsites of Augusta, Cowaramup, Margaret River and Witchcliffe.
- The shire of Bridgetown, the townsites of Bridgetown.

- The shire of Bruce Rock, the townsites of Ardath, Babakin, Belka, Bruce Rock, Kwolyin and Shackleton.
