Health Act, 1911-1962.

ORDER IN COUNCIL.

WHEREAS in accordance with section 60 of the Health Act, 1911-1962, His Excellency the Governor has received details of a plan for the installation of a sewer within the townsite of Wyalkatchem as marked in green on the plan at page 1 of P.H.D. File 95/64, and is satisfied that the scheme is formulated in accordance with the provisions of the Health Act, 1911-1962, and that the cost and provisions for repayment justify the undertaking, and that the works, if carried out in the manner designed, will be of benefit to that portion of the district which the works are intended to serve: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby order that the Shire of Wyalkatchem, being the local authority for the district, be empowered to undertake the construction of the said works.

Child Welfare Act, 1947-1962.

Land Act, 1933-1963.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of subleasing; and whereas it is deemed expedient as follows:—

Corres. 4828/30.—That Reserve No. 900 (near Jarrahdale) should vest in and be held by the Shire of Serpentine-Jarrahdale in trust for the purpose of Camping.

Corres. 4434/55.—That Reserve No. 25650 (Rockingham Lot 646) should vest in and be held by the Shire of Rockingham in trust for the purpose of a Kindergarten Site.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall vest in and be held by the abovementioned bodies in trust for the aforesaid purposes, with power to the said bodies, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserves for any term not exceeding 21 years from the date of the lease.

Land Act, 1933-1963.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall be granted in fee simple to the abovementioned bodies, to be held in trust for the aforesaid purposes, subject to the conditions that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

Forests Act, 1918-1954. ORDER IN COUNCIL.

F.D. 701/63, L. and S. 3983/27.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament the Governor, on a resolution being passed by both houses that such proposal be carried out, shall by Order in Council revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the 30th day of October, 1963, for the revocation in part of the dedication of Crown lands as State Forest; and whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown land as State Forest No. 22 by excising that portion of such State Forest as is described in the schedule hereto.

SUPREME COURT RULES.
Order 62, Rule 3.
