WHEREAS it is enacted by section 12 of the Weights and Measures Act, 1915-1958, that the Governor may cause such new denominations of standards as may appear to him to be required in addition to those thereinbefore in that Act mentioned to be provided and deposited in the Treasury, and that such new denominations of standards when proclaimed by the Governor in the *Gazette* shall be standard weights and measures of Western Australia; and whereas it appears to the Governor that new denominations of the standards of weight, namely metric standards of measurement of mass, are required to be provided in addition to those referred to and the Governor has caused such new denominations of standards to be deposited in the Treasury: Now, therefore I, the Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby declare that new denominations of standards comprising the metric standards of measurement of mass set forth in the schedule hereunder are provided in addition to the standards mentioned as aforesaid in the Weights and Measures Act, 1915-1958, and have been deposited in the Treasury, and that such new denominations of standards shall be standard weights and measures of Western Australia.

Land Act, 1933-1963.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid: And whereas it is deemed expedient, as follows:—

Corres. 4318/54.—That Reserve No. 24110 (Geraldton Lot 1387) should, subject as aforesaid be granted in fee simple to The Australian Pensioners League Western Australian Division (Incorporated) to be held in trust for Homes for Aged People.

Corres. 7827/13.—That Reserve No. 27252 (Jitarning Lot 71) should, subject as aforesaid, be granted in fee simple to The Country Women's Association of Western Australia (Inc.) to be held in trust for the purpose of a Rest Room Site (C.W.A.).

Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall be granted in fee simple to the abovementioned bodies to be held in trust for the aforesaid purposes, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

ORDER IN COUNCIL.

Corres. 4828/30.

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of sub-leasing; and whereas it is deemed expedient that Reserve No. 990 (near Jarrahdale) should vest in and be held by the Shire of Serpentine-Jarrahdale in trust for the purpose of Camping: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by the Shire of Serpentine-Jarrahdale in trust for Camping with power to the said Shire of Serpentine-Jarrahdale, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding 21 years from the date of the lease.

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient that Class "A" Reserve No. 27250 (Cottesloe Lot 328) should vest in and be held by the City of Nedlands in trust for the purpose of Recreation: Now therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by the City of Nedlands in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act and to the condition that any buildings erected on the said reserve shall not exceed fifteen (15) feet in height.

ORDER IN COUNCIL.

F.D. 1231/62, L. & S. 1665/58.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown Land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the 8th day of November, 1962, for the revocation in part of the dedication of Crown Lands as State Forest; and whereas after such proposal had been laid before Parliament a resolution was passed by both Houses

that such proposal should be carried out: Now, therefore, His Excellency the Lieutenant-Governor with the advice and consent of the Executive Council doth hereby revoke in part the dedication of Crown land as State Forest No. 25 by excising that portion of such State Forest as is described in the Schedule hereto.

Forests 615/63, Lands 496/64.

WHEREAS by the Forests Act, 1918-1954, it is provided that the Governor may, by Order in Council, declare any Crown lands as Timber Reserves within the meaning and for the purposes of that Act: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council doth hereby declare that the land described in the schedule hereto shall be set apart as Timber Reserve No. 163/25 within the meaning and for the purposes of the said Act.

ORDER IN COUNCIL.

P.W.W.S. 317/64.

WHEREAS by the Country Areas Water Supply Act, 1947-1960, it is provided that before undertaking the construction of water works, the Minister shall submit plans, descriptions, books of

reference and estimates of the proposed works to the Governor for approval; and that if they are approved, the Governor may forthwith, by Order in Council empower the Minister to undertake the construction of the proposed works: Now, therefore, His Excellency the Lieutenant-Governor, with the advice of the Executive Council, hereby approves of the plans, descriptions, books of reference and estimates marked on Plan P.W.D., W.A. 40964, for the construction of the Australind Water Supply which was duly submitted for approval, and hereby empowers the Minister to undertake the construction of the said works.

Metropolitan Water Supply, Sewerage and
Drainage Act, 1909-1963.

ORDER IN COUNCIL.

P.W.W.S. 1059/61, M.W.S. 60891/55.

WHEREAS by section 8 of the Country Areas Water Supply Act, 1947-1960, and by section 7 of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1963, it is enacted that the Governor may, by Order in Council, from time to time alter or extend the boundaries of a country water area and of the Metropolitan Water, Sewerage and Drainage Area, or of any District thereof; and whereas it is desirable to alter the boundaries of the said areas and of the Metropolitan Water and Sewerage District, as hereinafter described: Now, therefore, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Acts, doth hereby order and declare as follows:—

That the boundaries of the Goldfields and Agricultural Country Water Area are hereby altered by excising therefrom, and that the boundaries of the Metropolitan Water, Sewerage and Drainage Area and of the Metropolitan Water and Sewerage District are hereby extended by adding thereto, the land described in the Schedule hereto.

Schedule.

All that portion of land bounded by lines starting from the north-eastern corner of Canning Location 390, a point on the present boundary of the Metropolitan Water, Sewerage and Drainage Area and the Metropolitan Water and Sewerage District, and extending easterly along the prolongation of the northern boundary of that location to the western boundary of location 673; thence generally northerly, easterly and southerly along boundaries of that location to the north-western corner of location 363; thence easterly and southerly along boundaries of that location to the north-western corner of location 797; thence easterly along the northern boundaries of that location and locations 796, 795 and 794 and southerly along the eastern boundary of the lastmentioned location to the north-western corner of location 793; thence easterly along the northern boundary of that location to its north-eastern corner, a point on the Helena River Reservoir Watershed Boundary as shown on Lands and Surveys Department Resumption Plan 245; thence generally south-easterly along that boundary to the 129-mile Post; thence 83 degrees 54 minutes, 5 chains 55 and seven-tenth links along that boundary to a point on the boundary of the Metropolitan Water, Sewerage and Drainage Area and the Metropolitan Water and Sewerage District aforesaid and thence generally north-westerly and generally northerly along that boundary to the starting point, being the land delineated and shown coloured red on Plan P.W.D., W.A. No. 41143 and on Plan M.W.S.S. & D.D., W.A. No. 9069.

This Order in Council shall take effect from the 1st day of July, 1964.

Shires of Perenjori and Dalwallinu.

Alteration and Adjustment of Boundaries—
Severance and Annexation.

ORDER IN COUNCIL.

L.G. 3091/52.

WHEREAS it is provided in paragraph (f) of subsection (2) of section 12 of the Local Government Act, 1960, that the Governor upon the presentation of a petition under the common seal of the districts concerned may alter and adjust the boundaries to adjoining districts; and whereas it is further provided in subsection (3) of the said section that the Governor may sever from a district a portion of the district and annex the portion to another district which the portion adjoins; and whereas the Municipalities of the Shires of Perenjori and Dalwallinu have presented a joint petition praying that the boundaries of the two districts shall be altered and adjusted by severing from the district of the Shire of Perenjori and annexing to the district of the Shire of Dalwallinu the area set out in the schedule hereunder; and whereas it is considered expedient that the prayer of the petition should be granted: Now, therefore, His Excellency the Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, doth hereby alter and adjust the boundaries of the Shires of Perenjori and Dalwallinu by severing from the district of the Shire of Perenjori and annexing to the district of the Shire of Dalwallinu to form part of the North East Ward of the Dalwallinu district, that area shown in the schedule hereto.

Transfer of Territory from the district of the Shire of Perenjori to the district of the Shire of Dalwallinu.

All that portion of land bounded by lines starting from the southernmost south-western corner of Ninghan Location 416, a point on the present boundary of the Shire of Dalwallinu, and extending generally north-westerly, generally north-easterly and generally westerly along western boundaries of that location and location 415 to the northernmost south-western corner of the lastmentioned location; thence west to the eastern shore of Mongers Lake; thence generally north-westerly along that shore to a point situate in prolongation westerly of the southern boundary of location 418; thence easterly along that prolongation to the south-western corner of that location; thence generally northerly along the western boundaries of that location and location 419 to the north-western corner of the lastmentioned location; thence easterly and southerly along boundaries of that location to the southernmost south-western corner of Pastoral Lease 392/483; thence easterly along a southern boundary of that lease to the north-western corner of Pastoral Lease 392/601, a point on the present boundary of the Shire of Dalwallinu aforesaid, and thence southerly and westerly along that boundary to the starting point. and New Zealand Bank Limited of St. George's Terrace, Perth, being an employer within the meaning of the section has duly, in accordance with the Act and the regulations made thereunder, made application for exemption from the operation of the section, and has satisfied the Minister that it has established a fund for insurance against the said liability, and has deposited at the Treasury a security, to wit, a bond for five thousand pounds (£5,000) charged with all payments to become due under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby exempt the Australia and New Zealand Bank Limited from the operation of section 13 of the Workers' Compensation Act, 1912-1963, for a period expiring on the 20th day of June, 1966.
