and in exercise of the powers vested in me as aforesaid,
do by this instrument under the Public Seal of the
State constitute and appoint you the said Sir John

upon the said absence to be my Deputy, and in
that capacity to exercise, perform and execute for

and on my behalf, as such Governor, all the powers
and authorities vested in me by the said Letters
Patent.

Railways (Cue-Big Bell and Other Railways) Discontinuance Act, 1960.

WHEREAS it is enacted, *inter alia*, by section 2 of the Railways (Cue-Big Bell and other Railways) Discontinuance Act, 1960, that the Act shall come into operation on a day to be fixed by Proclamation, and that it shall not be necessary to proclaim that the whole of the Act shall commence on one day, but the several sections and paragraphs of the Act may be proclaimed to commence on such days as are respectively fixed by Proclamation; and whereas it is enacted by section 3 of the Act that on and after the commencement of that section the line of railway as authorised by and constructed under the Cue-Big Bell Railway Act, 1936 (Act No. 5 of 1936), shall cease to be operated until the Governor otherwise declares; and whereas it is enacted by section 4 of the Act that on and after the commencement of that section the line of railway as authorised by and constructed under the Meekatharra-Wiluna Railway Act, 1927 (Act No. 32 of 1927), shall cease to be operated until the Governor otherwise declares; and whereas it is desired that each of sections 3 and 4 of the Act shall commence: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council, do hereby fix the day on which this Proclamation is published in the *Government Gazette* as the day on which each of sections 3 and 4 of the Railways (Cue-Big Bell and other Railways) Discontinuance Act, 1960, shall commence.

(a) by adding to that Schedule the following items:—

Methyl-Phenidate.

Monoamine Oxidase Inhibitors; and

(b) by adding to the item, "B/Aminopropylbenzene", in that Schedule, the passage, "(except Methoxyphenamine)".

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of sub-leasing; and whereas it is deemed expedient that Reserve No. 25948 (Dundas Location 197) should vest in and be held by the Shire of Dundas in trust for the purpose of Recreation (Motor Racing): Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserve shall vest in and be held by the Shire of Dundas in trust for Recreation (Motor Racing) with power to the said Shire of Dundas, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding 21 years from the date of the lease.

WHEREAS it is enacted, under section 8 of the Country Areas Water Supply Act, 1947-1960, that the Governor may, by Order in Council, constitute a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council doth hereby constitute the Boyanup Country Water Area as defined in the schedule hereunder and assign the name of "Boyanup Country Water Area" thereto.

Schedule.

Boyanup Country Water Area.

All that portion of land bounded by lines starting from the north-western corner of Boyanup A.A. Lot 35 and extending easterly along the northern boundary of that lot to the north-western corner of Boyanup Town Lot 99, a point on the boundary of Boyanup Townsite; thence easterly along that boundary to the left bank of the Preston River; thence easterly to a point on the western side of the South-Western Highway situate in prolongation westerly of the southern boundary of Boyanup A.A. Lot 280, a point on the boundary of Boyanup Townsite aforesaid; thence

Eaton Rating Zone and Australind Rating Zone.

ORDER IN COUNCIL.

P.W.W.S. 734/62.

WHEREAS it is enacted, under section 10 of the Country Areas Water Supply Act, 1947-1960, that the Governor may, by Order in Council, constitute a Rating Zone in a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby constitute within the Eaton Country Water Area the Eaton Rating Zone as defined in Schedule "A" hereunder, and assign the name of "Eaton Rating Zone" thereto, and the Australind Rating Zone as defined in Schedule "B" hereunder, and assign the name of "Australind Rating Zone" thereto.

Eaton Rating Zone.

All that portion of land being the whole of the land contained within the boundaries of the Eaton Townsite together with all that portion of land bounded by lines starting from the North-Western corner of Collie A.A. Lot 45, a point on the present boundary of the Eaton Country Water Area, and extending 325 degrees to the shore of Leschenault Inlet, a point on the present boundary of the Eaton Country Water Area aforesaid, and thence generally northerly, generally south-easterly and southerly along that boundary to the starting point.
