## Town Planning and Development Act, 1928-1961.

### SHIRE OF MANJIMUP.

#### Town Planning Scheme No. 3.

THIS Town Planning Scheme is prepared by the Manjimup Shire Council under the provisions of the Town Planning and Development Act, 1928-1959, primarily for the purpose of zoning and classifying land within the Shire of Manjimup and regulating development thereon, but also includes other matters authorised by the enabling Act.

#### PART I.—PRELIMINARY.

1. The Scheme is known as "Shire of Manjimup Town Planning Scheme No. 3", hereinafter called "the Scheme", and shall come into operation on the publication thereof in the *Government Gazette*.

2. The Town Planning Scheme for Manjimup Townsite which was published in the *Government Gazette* on the 25th day of March, 1938, and subsequently from time to time amended, is hereby revoked and this Scheme substituted therefore.

3. This Scheme shall apply to the whole of the land within the Manjimup Townsite and more particularly the whole of the land bordered by a broken black line on the Scheme plans.

4. The responsible authority for enforcing the observance of this Scheme is the Manjimup Shire Council.

5. This Planning Scheme is divided into the following Parts and Schedules:—

Part I.—Preliminary.

Part II.—Zoning.

Part III.—Non-conforming Use of Land.

Part IV.—Special Provisions as to Certain Zones and Uses.

Part V.—Building Alignments.

Part VI.—General.

Schedules:

First—Land Use Map (Annotated Map No. 1).

Second—Planning Scheme Map (Annotated Map No. 2).

6. Interpretation.—In this Scheme, unless the context otherwise indicates, the following terms shall have the following meaning set against them hereunder respectively:—

#### Definitions.

"Act" means the Town Planning and Development Act, 1928, and any amendment or re-enactment thereof.

"Allotment" or "lot" bears the same meaning as in the Town Planning and Development Act, 1928, and any amendment thereto.

"Approved date" means the date on which notice of the approval of the Planning Scheme is published in the *Government Gazette*.

"Boarding house" and "lodging house" bear the same meanings as in the Health Act.

"Building" means any structure, whether fixed or otherwise, permanent or temporary, which is roofed or wholly or partially enclosed by walls. Fences erected on surveyed boundaries are excluded.

"Building line" means the line between which and any public place or public reserve a building may not be erected except by or under the authority of an Act.

"Building set-back" means a line inside an allotment of land at a specified distance from the frontage or building line, which line is designed and fixed to locate the position of a building on that allotment.

"Car Park" means a site or building used primarily for the parking of motor vehicles other than tractors, articulated vehicles and caravans, whether a public or private park, but not including parts of the public highway used for parking or a taxi rank.

"Caravan Park" means an area which is set aside for the parking of caravans in conformity with the provisions of the Health Act, 1911-1959, and the Local Government Act, 1960, and any amendments thereto.

"Central Area" means that portion of the Manjimup Townsite which is shown bounded by a thick black line on the Zoning Plan and is described as follows:—

From the south-eastern corner of Bath and Mount Streets in an easterly direction to the corner of Mount and Rose Streets thence northerly along Rose Street to the northern boundary of the Police Reserve; thence easterly along the northern boundary of the Police Reserve continuing to the W.A. Government Railway; thence generally in a southerly direction along the railway to the northern boundary of Lock Street; thence westerly along Lock Street to the south-eastern corner of lot 549; thence northward along the right-of-way to the south-eastern corner of lot 144; thence along the southern boundary of lot 144 to Bath Street; thence northerly along Bath Street to the point of origin.

"Drive-in theatre" means an open air cinema with provision for more than 75% (seventy-five per centum) of the audience or spectators to view the entertainment while seated in motor vehicles.

"Duplex house" means a single-storey building comprising two tenements, but so designed as to have the appearance of a single dwelling house.

"Dwelling house" means a building used or designed or adapted for use as a single tenement. The term includes such outbuildings as are ordinarily used therewith.

"Existing use" means a use of a building or land for the purpose for which it was lawfully used immediately before the approved date.

"Extractive Industry" includes the extraction of sand, gravel, clay, turf, soil, rock, stone or similar substances from the land, and when carried out on the same land or land adjacent thereto, the treatment of such materials.

"Frontage" means the boundary line between a site and the street upon which such site abuts, and where the site abuts on more than one street, then the boundary line between the site and the street to which any building that may be erected thereon fronts.

"General Industry" means any industry which is not a light industry or a special industry or an extractive industry.

"Home occupation" means an occupation carried on within a dwelling or the curtilage of a dwelling which—

- (a) does not cause injury to, or prejudicially affect, the amenity of the neighbourhood including (without limiting the generality of the foregoing) injury or prejudicial affection due to the emission of noise, vibration, smell, fumes, smoke, vapour, steam, soot, ash, dust, grit, oil, waste water, or waste products;
- (b) does not entail the employment of any person not a member of the occupier's family, except in the case of horticulture and the professions;
- (c) does not occupy an area greater than 200 square feet, except in the case of a medical practitioner, a dentist, or a masseur, or where used for horticulture, or a kindergarten.
- (d) does not require the provision of any essential service main of a greater capacity than normally required in the zone in which it is located;
- (e) is restricted in advertisement to a sign not exceeding two (2) square feet in area.

"Hotel" means premises in respect of which there is granted a publican's general licence or a hotel licence under the Licensing Act, 1911, as amended or re-enacted.

"Industry" means the carrying-out of any process for or incidental to—

- (a) the making, altering, repairing or ornamentation, painting, furnishing, cleaning, washing, packing, canning or adapting for sale, or breaking up or demolition of any article; and
- (b) the winning, processing or treatment of minerals; and
- (c) the generation of electricity or the production of gas; and

(d) the manufacture of edible goods for human or animal consumption;

being a process carried on in the course of trade or business for gain, other than operations connected with—

- (i) the carrying out of agriculture;
- (ii) site works on buildings, works or land; and
- (iii) in the case of the manufacture of goods referred to in subparagraph (d) above, the preparation on the premises of a shop of food for sale,

and includes, when carried out on land upon which the process is carried out, and in connection with that process, the storage of goods, any work of administration or accounting, the sale of goods resulting from the process and the use of land for the amenity or persons engaged in the process.

“Land” includes buildings and structures thereon.

“Light Industry” means an industry, not being an Extractive Industry or a Special Industry, in which the processes carried on, the materials and machinery used, and the transportation of materials, goods and commodities to and from the premises will not cause injury to or prejudicially affect the amenity of the locality by reason of the emission of noise, vibration, smell, fumes, smoke, vapour, steam, soot, ash, dust, waste water, waste products, grit, oil or otherwise.

“Liquid fuel depot” means a site, not being a petrol filling station, a service station or motor repair station, used for the storage in bulk and the distribution of liquid fuels.

“Motel” has the same meaning as it has in the Local Government Model By-laws (Motels) No. 3, made under the powers conferred by the Local Government Act, 1960 (as amended).

“Motor Repair Station” means business premises for the supply of liquid fuels, lubricants, accessories and parts for motor vehicles, tractors and engines, and the carrying out of repairs to an extent which can no longer be considered “minor”; i.e., its income is related to this side of the business rather than the profit of petrol and oil sales, and includes panel beating, chassis straightening and spray painting.

“Non-conforming use” means such use of land or building which, had it been commenced after the approved date, would be a contravention of the provisions of this Scheme, and “non-conforming user” has a corresponding meaning.

“Noxious Trade” means an offensive trade within the meaning of the Health Act, 1911-1959, and any amendment thereto, but excludes fish shops and dry-cleaning establishments.

“Owner” in relation to any land includes the Crown and every person who, jointly or severally, whether at law or in equity—

- (a) is entitled to the land for any estate in fee simple in possession; or
- (b) is a person to whom the Crown has lawfully contracted to grant the fee-simple of the land; or
- (c) is a lessee or licensee from the Crown; or
- (d) is entitled to receive or is in receipt of, or, if the lands were let to a tenant, would be entitled to receive the rents and profits thereof, whether as a beneficial owner, trustee, mortgagee in possession, or otherwise.

“Petrol Filling Station” means business premises designed or used principally for supplying liquid fuels for motor vehicles and the supplying of lubricants, parts and accessories for motor vehicles, but in which no industry is carried on.

“Professional office or room” means any building constructed or used for the purpose of his professions by an accountant, architect, artist, author, barrister, chiropodist, dentist, doctor, engineer, masseur, nurse, physiotherapist, quantity surveyor, solicitor, teacher (other than a dancing teacher or a music teacher), town planner, veterinary surgeon, or for other occupation of a similar nature as determined by resolution of the responsible authority.

“Public building” means a building that may suitably form part of a civic or neighbourhood centre.

“Residential flat” or “flat” means a separate tenement used for living purposes in a building containing two or more such tenements other than a building forming part of an attached pair or terrace of dwelling houses.

“Service station” means business premises for the supply of liquid fuels, lubricants, accessories and parts for motor vehicles, and the carrying out of service and minor repairs to motor vehicles, tractors and engines, but does not include panel beating, spray painting or motor engineering works.

“Shop” means any permanent roofed building, constructed and used for retail sales, in which the maximum part of the street frontage is used for the display of goods for sale, and which is not used by, or in association with, any industry, office, service station, used car dealer, warehouse or wholesaler.

- "Site" means an area of specified dimensions occupied, or to be occupied, by one building and its accessory buildings, and includes in every case the curtilage of the building.
- "Special industry" means an industry in which the processes involved constitute a noxious or offensive trade as defined in this Scheme.
- "Street alignment" in relation to either side of a street means the line or lines forming the boundary between the street and the lands abutting on that side of the street.
- "Subdivision" means the division of a parcel of land into two or more lots or parcels for the purpose of transfer or ownership or building development whether a new street is involved or not, and "subdivided", "subdivide" or "re-subdivide" has a corresponding meaning.
- "Tenement" means a building or part of a building used, or designed or adapted for use, as self-contained living quarters for a single family.
- "Trade display" means the controlled and moderate display of goods for advertisement, as approved by the responsible authority.
- "Wayside stall" means a structure used for the sale of produce alongside a road or highway but not on the road reserve.
- "Zone" means a portion of the area shown on the Zoning Plan by distinctive colouring, hatching or edging for the purpose of indicating the restrictions imposed by the Planning Scheme on the erection and use of buildings and/or the use of land.
- "Zoning plan" means a plan of Manjimup Townsite, which plan has—
- been divided into zones for various primary uses;
  - such zones denoted by different colours for different primary uses;
  - been signed by the President and Shire Clerk of the Manjimup Shire Council for identification and dated 20th July, 1964.
- The Zoning Plan and this regulation shall be read in conjunction with each other, and the Zoning Plan shall form part of this regulation.
- "Zoning table" means a reference table referred to in clause 10 hereof.

## PART II—ZONING.

7. The Scheme area is divided into ten (10) types of zones. These types of zones are set out hereunder, together with the colours by which they are represented on the Zoning Plan:—

Zone.	Colour.
A. Residential	Red-brown.
B. Commercial "A"	Blue.
C. Commercial "B"	Blue with dark blue border.
D. Light Industrial	Purple border with purple vertical hatching.
E. General Industrial	Purple.
F. Civic, Cultural and Educational	Yellow-green with red border.
G. Special Site Zone	White with red border with the particular special use marked on each site.
H. Rural	Yellow.
I. Railway	Grey.
J. Open Space Reserve	Green.

The above zones and their corresponding colours are shown in the key which is attached to the Zoning Plan.

8. Subject to Part IV of this Scheme, no building shall be erected and no land or building shall be used or adapted for use for any other purpose than a purpose permitted in the zone in which such land or building is situated provided that—

- land which is not built on may be used for a purpose for which a building could be erected and used on such land under the Scheme or for any purpose directly ancillary to such building;
- land in any zone may be used for the purpose of a private garden.

9. Certain uses of land in the townsite are controlled. These controlled uses are known as "Use Classes" and are classified as follows:—

- Use Class 1—Residential flats.
- Use Class 2—Dwelling houses.
- Use Class 3—Boarding houses, hostels, lodging houses, unlicensed hotels, residential clubs.
- Use Class 4—Home occupations, but always subject to an annual permit from the responsible authority.
- Use Class 5—Shops, department stores, and those uses classified under Use Class 6, where the building is designed and constructed with a majority of its frontage for shop window display and when used for the purpose of display of goods for retail sale.

- Use Class 6—Restaurants, cafes, ticket offices and bureaux, receiving offices, hairdressers, local post offices.
- Use Class 7—Show rooms in connection with retail warehousing or offices and intended for the display of goods of a bulky character.
- Use Class 8—Offices, banks, stock or produce exchanges.
- Use Class 9—Public buildings and places of assembly including churches, halls, cinemas and theatres, Government and Local Government offices and buildings, non-residential clubs, colleges, and institutions.
- Use Class 10—Special places of assembly, including athletic or sports grounds with spectator provision, racecourses or trotting tracks, stadia, showgrounds.
- Use Class 11—Petrol filling stations.
- Use Class 12—Service stations.
- Use Class 13—Motor repair stations.
- Use Class 14—Wholesale warehouses designed for the storage of goods and transaction of business other than retail business.
- Use Class 15—Storage warehouses and yards, including builder's or contractors' yards, furniture warehouses, grain silos, Government or Local Government depots and stores transit warehouses.
- Use Class 16—Light Industry.
- Use Class 17—General Industry.
- Use Class 18—Schools, residential colleges or universities.
- Use Class 19—Hospitals, sanatoria, clinics, convalescent and nursing homes.
- Use Class 20—Outdoor recreation, including public parks or gardens, playing fields, children's playgrounds, private open spaces which do not fall within other use classes.
- Use Class 21—Professional rooms or professional offices.
- Use Class 22—Liquid fuel depots.
- Use Class 23—Other buildings and uses (special sites):—  
 Airports.  
 Bus garages, stations or tram depots.  
 Caravan Parks and/or camping grounds.  
 Cemeteries.  
 Crematoria.  
 Drive-in theatres.  
 Licensed hotels.  
 Major public utility installations (water, electricity, gas, sewerage, drainage).  
 Mental homes.  
 Motels.  
 Prisons.  
 Refuse destructors and refuse disposal areas.  
 Service stations.  
 Wireless or television buildings or installations.  
 Zoological gardens.
- Use Class 24—Building or uses of land for the purpose of farming, including pastoral, agricultural and dairy farming, afforestation, market and nursery gardens, and other similar uses.
- Use Class 25—Extractive industry.
- Use Class 26—Open air displays and premises for sale of motor vehicles or other goods and equipment, but always subject to an annual permit from the responsible authority.
- Use Class 27—Wholesale markets, but always subject to an annual permit from the responsible authority.
- Use Class 28—Special industries (noxious).
- Use Class 29—Wayside stalls.
- Use Class 30—Car Parks and Taxi Parks.

10. The Zoning Table hereunder sets out—

- (a) all of the use classes itemised in clause 9, in the first vertical column the number appearing represents the use class opposite the same number in clause 9;
- (b) in the horizontal column the zones set out in clause 7;
- (c) opposite each use class indicates by use of the letters described below whether—
  - (i) the use is permitted as of right, indicated by the letter "p";
  - (ii) the use is not permitted unless approval is obtained from the responsible authority, indicated by letters "AA";
  - (iii) the use is not permitted unless such use is incidental to the predominant use and the approval of the responsible authority is obtained, indicated by the letters "IP";
  - (iv) the use is not permitted, indicated by the letter "X".

Note.—For meaning of notation see subparagraph (c) immediately above. In all cases, building development is subject to control of density, siting, etc.

11. Subject to Part III of these regulations—
- (i) land within each zone described in the top horizontal column of the Zoning Table may not be used for a controlled use (known as a use class) except as authorised by the Zoning Table;

(ii) no building in any zone shall be erected or altered and no building in any zone shall be used or adapted to be used for any purpose other than a purpose authorised by the Zoning Table.

PART III—NON-CONFORMING USE OF LAND.

12. (a) Subject to the following provisions in this Part and in Part IV of this Scheme, where, immediately before the commencing date hereof, any land was lawfully used for any purpose which does not conform to the provisions of this Scheme, such land may continue to be used or be used (as the case may be) for that purpose so long as any building or works comprised therein at such approved date is not, save with the consent of the responsible authority, enlarged, rebuilt or extended. Such consent may be refused if, in the opinion of the responsible authority, the use thereof as enlarged, rebuilt or extended is likely to cause injury to or prejudicially affect the amenity of the neighbourhood, or to increase any existing injury to, or prejudicial affection of, the neighbourhood, including, without limiting the generality of the foregoing, injury or prejudicial affection due to the emission of noises, vibration, smell, fumes, smoke, vapour, steam, soot, ash, dust, grit, oil waste, water or waste products.
- (b) For the purpose of this clause, land shall be deemed to have been used immediately before the commencing date hereof—
- (i) in the case of unused land, for the purpose for which it was last used within twelve (12) months prior to such date;

(ii) in the case of land upon which, immediately before such date, any building or works was lawfully being constructed, for the purpose for which such building or works was being constructed; and

(iii) in the case of land in respect of which a contract for the construction of any building or works which could lawfully have been constructed was entered into prior to such date, and for which a building permit has been obtained (if required) for the purpose for which such building or works was to be constructed.

13. Should any land, to which clause 12 of the regulation applies, be subdivided and sold in separate parcels, only such parcels of land upon which on the commencing date hereof, there existed substantial buildings or works, or upon which, with the consent of the responsible authority, any enlargement or extension of a building or works had been carried out, may, in pursuance of the said clause, continue to be used for a purpose not conforming with the provisions of the planning scheme.

14. Should any land, to which the provisions of clause 9 of this regulation apply, cease to be used for the purpose for which such land was used on the commencing date hereof, and be not used for that purpose for a period of twelve (12) consecutive months, or should, since such date, any building or works comprised in such land be so damaged or destroyed that the cost of restoration or replacement is greater than seventy-five per centum (75%) of the value of such building or works immediately prior to the damage to or destruction thereof, such land shall be used only in conformity with the provisions of the planning scheme.

15. Subject to the foregoing, land used for a non-conforming use may be used for any other purpose within the same use class, or for any other non-conforming use as allowed under the provisions of clause 16.

16. (a) A non-conforming use may be changed to any use higher than its own position on the ladder in clause 17 applicable to the zone in which it is being carried on.

(b) If a non-conforming use does not appear in the applicable ladder—

(i) the responsible authority shall determine the most nearly comparable use in the applicable ladder; and

(ii) the non-conforming use shall be treated as being on the same rung of the applicable ladder as the use so determined, but this provision shall not operate to enable a change to a use which does not appear on the applicable ladder.

(c) If there is no ladder indicated for any zone in which a non-conforming use is being carried on, a change can only be made to a conforming use.

18. A non-conforming use shall comply with all requirements and conditions as would pertain to the site if it were zoned for its non-conforming use.

#### PART IV—SPECIAL PROVISIONS AS TO CERTAIN ZONES AND USES.

19. In a Residential Zone, no lot shall be built on to a greater extent than one-third of the area of the lot.

20. Within a Commercial "A" or a Commercial "B" Zone—

(a) In any new subdivision of land, a rear access way is to be provided for services and off-street loading, and such rear access way shall be a minimum width of 25 links with either a turning circle or return access.

(b) A sufficient area is to be provided within each site for the loading and unloading of vehicles clear of any public road and right of way, to the satisfaction of the responsible authority. This may be either open yard or may be roofed, subject to compliance with the Building By-laws.

21. Within a Light Industrial Zone or a General Industrial Zone—

(a) No person shall stack or place any fuel or raw materials or products or by-products or waste of manufacture closer to a road or street than the building alignment.

(b) No person shall use the land between the building alignment and the road or street for any purpose other than a means of access, for parking of vehicles, for loading or for unloading of vehicles, or for lawns and gardens without the special approval of the responsible authority for trade display.

- (c) A residence on land forming part of, or adjoining, a factory occupied by a caretaker of, or an employee of, the factory, and set aside for the exclusive use of the occupants, may be allowed by resolution of the responsible authority where it is established that such residence is necessary to the proper operation of the industry.

22. Within a Rural Zone, subject to annual permission from the responsible authority, temporary structures may be erected as wayside stalls, provided that sales are restricted to those produced or grown on the site by the stall owners.

23. Site Coverage.—Within the Central Area:—

- (i) Until the townsite is provided with a deep drainage scheme for the collection and treatment of sewerage, and the site has been connected to it, the maximum amount of any site that may be built over is 90 per cent.
- (ii) A sufficient area is to be provided, within each site, for the loading and unloading of vehicles clear of any public road or right of way. This may be either open yard or may be roofed, subject to compliance with the Building By-laws. This requirement is additional to any area over which building is not permitted under paragraph (i) immediately above.
- (iii) In the case of any development of a residential nature (such as hotels, hostels, boarding or lodging houses, tenements, etc.), the maximum area of any site that may be built over is 70 per cent.

PART V—BUILDING ALIGNMENTS.

24. (a) No buildings shall be constructed closer to the frontage of the lot, or building line, if such has been gazetted, than the distances specified hereunder:—

(b) No person shall erect, or cause or permit to be erected, any building so that any portion of the building is erected closer to any road or street than the building alignment as above determined. Provided that this clause may be varied by the responsible authority in its discretion as follows:—

- (i) Where both adjoining lots are built upon and one or more of such buildings shall be nearer to the street or road than the building set-back line determined above, the responsible authority may permit a building to be erected nearer to the street or road than the building set-back line, but not nearer than the foremost portion of the rearmost building.
- (ii) The responsible authority may permit the erection of car ports (i.e., structures consisting of a roof and supports only, but with no wall sheeting of any kind).

27. (a) Not more than one dwelling or building for residential use shall be built on any one lot. This provision may be waived by resolution of the responsible authority in respect of land within the "Rural", "Special Sites", "Civic, Cultural and Educational" and "Railway" Zones when it is established by the applicant that no separate title is required in respect of the building, and that the building is required for workers on the property, or for special purposes pertaining to the permitted use.

(b) The minimum area of a lot on which a dwelling or a shop and attached dwelling may be erected is 6,000 square feet, with a minimum frontage of 50 feet.

(c) The minimum area of a subdivisional lot within a Commercial Area is 2,000 square feet, with a minimum frontage of 20 feet.

(d) No duplex house shall be erected on a lot having an area of less than 8,000 square feet, or of which the width, measured at right angles to any side, is at any point less than 66 feet.

28. Compensation.—Any person—

- (i) whose land or property is injuriously affected by the making of this Town Planning Scheme; and
- (ii) who is desirous of claiming compensation in respect thereof, shall make his claim within six (6) months from the date when notice of approval of this Scheme is published. No claim shall be entertained unless made within this period, but shall be barred.

in front of a building set-back line in cases where there is insufficient space to enable the erection of such a structure behind the set-back line prescribed.

- (iii) In cases where an area is re-zoned and/or the use and purpose of an existing building is permitted to be changed, its position in relation to the building set-back line shall not in itself prevent a permit being granted for the necessary structural alterations.

Where a street widening of an existing street has been gazetted, wither as part of this Scheme or elsewhere, such widening is an additional requirement to the building set-back line as set out in paragraph (a) above. Further, in this case, the discretionary powers referred to in subparagraph (b) (i) above are not applicable.

#### PART VI—GENERAL.

25. No building of any class shall be erected unless means of access be provided for the removal of rubbish and servicing to every separate tenement and/or shop within the building. Such means of servicing shall be provided in such a manner that every separate tenement or shop can be serviced without passing through the front entrance thereof or through any other shop or tenement.

26. No land shall be subdivided or built on until it is drained and/or filled as instructed or directed to the satisfaction of the responsible authority; and, in the case of land to be built on, provision also made for the disposal of roof water and household or trade waste, as the case may be, to the satisfaction of the responsible authority.

29. Annual Permit.—Where any use class is permitted under these regulations, subject to an annual permit from the responsible authority, an application shall be made annually by the owner or occupier as required by the responsible authority.

30. Entry to Premises.—The responsible authority may, by its Shire Clerk or other authorised officer, enter, at all reasonable times, any building or land for the purpose of ascertaining whether the provisions of the planning scheme are being observed.

31. Enforcement of Provisions.—If any person contravenes, or fails or neglects to comply with, any of the provisions of this planning scheme, the responsible authority shall, by notice in the manner set out in clause 32 hereof, order such person to discontinue forthwith any such contravention, and within thirty (30) clear days after the service of such notice to remove, pull down, take up, alter or otherwise make good any work which contravenes the scheme, or carry into effect any provisions of the scheme which are not being complied with.

32. Any notice in writing under subsection (1) of section 10 of the Town Planning and Development Act, 1928—

- (a) shall be served on the owner or owners of the land in question, or such of them as can with reasonable diligence be ascertained, either personally or by registered letter posted to their last known place of residence; and
- (b) shall describe, in general terms, the manner in which the planning scheme has been contravened; and
- (c) shall require the owner or owners, as the case may be, within thirty (30) clear days, or such other period being not less than 30 clear days, as determined by the responsible authority, after the service of such notice, to discontinue such contravention of the scheme and take such action as the responsible authority may direct to cause a compliance with the provisions of the Scheme.

33. Should the owner or owners, as the case may be, fail or refuse to comply with the notice within the time specified in the notice, the responsible authority may itself remove, pull down, take up or alter the building, work or development accordingly.

34. Any expenses incurred by the responsible authority under the provisions of clause 33 of this Scheme may be recovered from the owner or owners of the land on which the building or work was so commenced, continued or carried out as a debt due to it by the owner or owners.
