1. IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1962, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in those portions of Western Australian waters described in Schedules A, B, C and D hereto, for the term of five years from date of publication of this Proclamation in the *Government Gazette*.

2. In pursuance of the provisions of the section aforesaid, I prohibit all persons from taking any fish whatsoever by means of fishing nets in that portion of Western Australian waters described in schedule E hereto, during the periods commencing 8 o'clock in the afternoon of Thursday in each week and ending at 8 o'clock in the forenoon of the Sunday next following for a term of five years from date of publication of this Proclamation in the *Government Gazette*.

Schedule A.

All that portion of the waters of Leschenault Inlet bounded on the west by the railway bridge at Point MacLeod on the east by a line of posts extending north-north-easterly from an unnamed point on the southern shore of the inlet, situate adjacent to and north-easterly from the mouth of the Preston River, to a point on the north-western shore of the inlet situate adjacent to the northern shore of the channel connecting the inlet to the sea. Being more particularly the portion of the Leschenault Inlet delineated and shown bordered red on Department of Lands and Surveys Miscellaneous Plan 248.

Schedule B.

The whole of the waters of the Collie River and all its tributaries and all that portion of Leschenault Inlet lying within a radius of 30 chains of the northernmost extremity of Bar Island.

Schedule C.

The whole of the coastal waters in the vicinity of Bunbury known as "Hungry Hollow," being those waters lying between the Westerly extensions

of Clifton Street and Beach Road, in the Municipality of Bunbury, and within a distance measured rectangularly from the foreshore of half a mile.

Schedule D.

The whole of the waters of that part of Koom-bana Bay lying within a radius of one-quarter of a mile of the groyne adjacent to the channel connecting Leschenault Inlet with the Indian Ocean.

Schedule E.

The whole of the waters of Leschenault Inlet lying to the north of a line drawn from a point marked by a post on the southern shore of the inlet situate adjacent to and north-easterly from the mouth of the Preston River to a point marked by a post on the north-western shore of the inlet situate adjacent to the northern shore of the channel connecting the inlet to the sea.

AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 17th day of September, 1964, the following Orders in Council were authorised to be issued:—

Explosives and Dangerous Goods Act, 1961.

ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by section 14 of the Explosives and Dangerous Goods Act, 1961, that the Governor may from time to time, by Order in Council, classify explosives and declare any specified explosive to be an authorised explosive for the purposes of that Act and that the Governor shall not so classify or declare any explosive until he has defined the composition, quality and character of that explosive; but such definition in respect of the explosive is not required to be published in the Order in Council classifying that explosive; and whereas it is further enacted that an Order in

Council made under the said section may be cancelled or from time to time varied by a subsequent Order in Council; and whereas certain explosives were declared authorised explosives by an Order in Council made by the Governor on the 22nd day of July, 1964, and published in the *Government Gazette* on the 31st day of July, 1964; and whereas it is deemed expedient to vary that Order in Council in the manner hereinafter mentioned; Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by section 14 of the Explosives and Dangerous Goods Act, 1961, do hereby vary the abovementioned Order in Council by adding thereto under the heading "CLASS 3—NITRO-COMPOUND, Division 1," the explosives specified in the schedule hereunder and declare them to be authorised explosives for the purposes of the said Act, with effect from and including the day of the publication of notice of this Order in Council in the *Government Gazette*.

ORDERS IN COUNCIL.

ORDER IN COUNCIL.

Corres. 3303/60.

WHEREAS by section 33 of the Land Act, 1933-1963, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is issued for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that Reserve No. 27232 (Swan Location 7803) should, subject as aforesaid, be granted in fee simple to The Returned Sailors', Soldiers' & Airmen's Imperial League of Australia (W.A. Branch) Incorporated to be held in trust for the purpose

of a Hallsite (R.S.L.): Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall be granted in fee simple to the aforesaid body, to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

ORDER IN COUNCIL.

Corres. 1067/64 (R921).

WHEREAS by section 288 of the Local Government Act, 1960, it shall be lawful for the Governor, on request of the Council by notice in the *Government Gazette*, to declare any lands reserved, or acquired, for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control and management of a Council, or lands comprised in a private street, constructed and maintained to the satisfaction of a Council as a public street, and if the Council thinks fit, that the Governor shall declare the width of the carriage way and footpaths of the public street: and whereas the Shire of Armadale-Kelmscott has requested that certain lands named and described in the schedule hereunder, which have been reserved for a street within the Shire of Armadale-Kelmscott be declared a public street: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be a public street, and such lands shall, from the date of this order, be absolutely dedicated to the public as a street within the meaning of any law now or hereafter in force.

ORDER IN COUNCIL.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the 8th day of November, 1962, for the revocation in part of the dedication of Crown lands as State Forest; and whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby

revoke in part the dedication of Crown land as State Forest No. 25 by excising that portion of such State Forest as is described in the Schedule hereto.

Alteration and Adjustment of Boundaries.

ORDER IN COUNCIL.

L.G. 343/64.

WHEREAS it is provided in paragraph (f) of subsection (2) of section 12 of the Local Government Act, 1960, that the Governor upon the presentation of a petition under the Common Seal of the districts concerned may alter and adjust the boundaries of adjoining districts; and whereas the municipalities of the Shires of Albany and Gnowangerup have presented a joint petition praying that the boundaries of the two districts shall be altered and adjusted as set out in the schedules hereunder; and whereas it is considered expedient that the prayer of the petition should be granted: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council, doth hereby alter and adjust the boundaries of the districts of the Shires of Albany and Gnowangerup by—

- (1) Severing from the district of the Shire of Gnowangerup and annexing to the district of the Shire of Albany to form portion of the Napier Ward thereof the area shown in Schedule "A" hereto;
- (2) severing from the district of the Shire of Albany and annexing to the district of the Shire of Gnowangerup to form part of the Borden Ward thereof, the area shown in Schedule "B" hereto.

Transfer of Territories from the Shire of Gnowangerup to the Shire of Albany.

(a) All that portion of land bounded by lines starting from the western corner of Plantagenet Location 6847, a point on the present boundary of the Shire of Albany, and extending north-easterly and south-easterly along the north-western and north-eastern boundaries of that location to a point situate in prolongation westerly of the southern boundary of location 6228, a point on the present boundary of the Shire of Albany aforesaid, and thence westerly and north-westerly along that boundary to the starting point.

(b) All that portion of land bounded by lines starting from a point on the south-eastern boundary of Plantagenet Location 6846 situate in prolongation westerly of the southern boundary of location 6228, a point on the present boundary of the Shire of Albany, and extending north-easterly along that boundary of location 6846 to a point situate in prolongation north-westerly of the north-eastern boundary of location 6850; thence south-easterly to and along that boundary to a point situate in prolongation westerly of the southern boundary of location 6228 aforesaid, a point on the present boundary of the Shire of Albany aforesaid, and thence westerly along that boundary to the starting point.

Severance and Annexation of Land.

ORDER IN COUNCIL.

L.G. 912/52.

WHEREAS it is provided by paragraph (e) of subsection (1) of section 12 of the Local Government Act, 1960, that the Governor may, after effective presentation of a petition from a majority of ratepayers who occupy rateable land in a portion of a district, sever from a district a portion of a district and annex the portion to a district which the portion adjoins, but provision is also made in paragraph (i) of section (6) that the Minister may refer any question concerning the constitution or alteration of the constitution of municipalities to the Local Government Boundaries Commission for consideration and report; and whereas a petition was effectively presented by ratepayers of portion of the district of the Municipality of the Shire of Chapman Valley praying for the severance of portion of that district and its annexation to the district of the Municipality of the Shire of Geraldton-Greenough; and whereas the request of the petitioners was referred by the Minister to the Local Government Boundaries Commission appointed under the Local Government Act, 1960, and the Commission has reported that it is desirable that certain lands should be severed from the district of the Municipality of the Shire of Chapman Valley and annexed to the District of the Municipality of the Shire of Geraldton-Greenough: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council, doth hereby sever from the district of the Municipality of the Shire of Chapman Valley and annex to the district of the Municipality of the Shire of Geraldton-Greenough, the land described in the schedule hereto, and to direct that this order shall take effect as and from the 1st day of January, 1965.
