Constitution Act, 1889-1963.

ORDER IN COUNCIL.

P.W. 1060/58.

WHEREAS section 74 of the Constitution Act, 1889-1963, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Board) should be vested in Raymond Ernest Green: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby vests in Raymond Ernest Green the appointment of foremen and all other persons employed on such works at a daily rate of wage.

Fire Brigades Act, 1942-1963.

ORDER IN COUNCIL.

WHEREAS it is enacted by subsection (1) of section 5 of the Fire Brigades Act, 1942-1963, that, subject to the provisions of subsection (2) of that section, the municipal districts and parts thereof constituted as fire districts prior to the coming into operation of the Fire Brigades Act Amendment Act, 1959, as set out in the Second Schedule to the Act, are for the purposes of the Act fire districts under the respective names as set out in that Schedule; and whereas it is further enacted, *inter alia*, by subsection (2) of that section that for the purposes of the Act the Governor may from time to time, by Order in Council, adjust the boundaries of a fire district; and whereas by an Order in Council published in the *Government Gazette* on the 30th November, 1962, the Governor did adjust the boundaries of the Kalamunda Fire District by substituting that portion of the municipal district of the Shire of Kalamunda described in the Schedule to that Order in Council; and whereas it is deemed expedient to further adjust the boundaries of that district: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby adjust the boundaries of the Kalamunda Fire District which district is referred to in column one of Part IV of the Second Schedule to the Act by substituting for the portion of the municipal district of the Shire of Kalamunda described in the schedule to the said Order in Council so published on the 30th November, 1962, the portion of the municipal district of that Shire set out in the schedule to this Order in Council.

Kalamunda Fire District.

All that portion of land bounded by lines starting from a point on the western boundary of Swan Location 2639, situate in prolongation easterly of the southern side of Jessie Street and extending southerly along that boundary to the northern side of Hill Street (Road Number 10683); thence easterly along that side to the eastern boundary of location 2639 aforesaid; thence southerly along that boundary and the western boundary of location 1473 and onwards to and along the easternmost boundary of Kalamunda Town Lot 441 (Reserve 27154) to the south-eastern corner of that lot; thence south-westerly to the westernmost corner of lot 361 (Reserve 19232); thence generally south-easterly along the north-eastern alignment of Byron Road and onwards to the southern side of Howell Road; thence easterly along the northern boundaries of Canning Locations 395 and 563 to the north-eastern corner of the lastmentioned location; thence southerly along the eastern boundary of that location and onwards to the north-eastern side of the late Upper Darling Range Railway Reserve; thence generally south-easterly along that side and the south-western side of road number 6547 to a point situate north of the intersection of the eastern side of Caladenia Road and the prolongation easterly of the northern side of Banksia Road; thence south to that intersection; thence westerly to and along the northern side of Banksia Road aforesaid and onwards to the western side of Canning Road (road number 1837); thence southerly along that side to the southern side of Glyde Road (road numbers 6852 and 7412); thence generally westerly along that side to a point situate in prolongation northerly of the eastern boundary of lot 2 of location 432 as shown on Land Titles Office Diagram 4484; thence southerly to and along that boundary and the eastern boundary of lot 5 and onwards to the southern side of Grove Road (road number 1136); thence westerly along that side to the north-western corner of location 371; thence southerly along the western boundary of that location and the eastern boundary of lot 33 of Location 634 as shown on Land Titles Office Plan 6849 and onwards to the northern boundary of Kalamunda Town Lot 143; thence westerly along that boundary and the northern boundary of lot 142 and onwards to the north-eastern corner of location 481; thence southerly along eastern boundaries of that location and location 174 and onwards to the southern side of Pomeroy Road (road number 1949); thence generally west-north-westerly along that side, and the south-western side of Welshpool Road (road number 2525) to a point situate in prolongation southerly of the eastern boundary of Kalamunda Town Lot 131; thence northerly to and along that boundary to the western side of Basildon Road; thence northerly, generally north-westerly and generally north-easterly along that side to the north-eastern corner of lot 81 of Kalamunda Town Lot 127 as shown on Land Titles Office Plan 7564 and onwards to the eastern corner of location 1817 (Reserve 26112); thence northerly along the eastern boundary of that location to the southern corner of lot 57 of location 579 as shown on Land Titles Office Plan 3609; thence generally north-easterly along eastern boundaries of that lot to its north-eastern corner; thence north-easterly to the eastern corner of lot 65 of locations 85 and 579 aforesaid; thence generally north-north-easterly along the western side of a one-chain road passing along the eastern boundaries of that lot and lots 66, 68, 69 and 11 to 3 inclusive of locations 241 and 579 aforesaid to the eastern corner of lot 3 aforesaid and onwards to a north-western boundary of lot 72; thence generally north-easterly and south-easterly along boundaries of that lot to the north-western boundary of lot 82; thence north-easterly and south-easterly along boundaries of that lot to its eastern corner; thence south-easterly to the northern corner of Lot 26 as shown on Land Titles Office Diagram 27651; thence south-easterly along the north-eastern boundaries of that lot and lots 35 and 40 to the north-western boundary of location 415; thence north-easterly along that boundary to a point situate in prolongation westerly of the northern boundary of part of location 177, being the subject of Land Titles Office Diagram

4797; thence easterly to and along that boundary to the eastern boundary of location 177 aforesaid; thence northerly along that boundary and the eastern boundary of Kalamunda Town Lot 178 and onwards to the southern boundary of lot 180 (Reserve 23383); thence generally westerly along that boundary and the southern boundaries of lot 179 (Reserve 24240) to the south-western corner of the lastmentioned lot; thence northerly along the western boundary of that lot and onwards to the south-eastern corner of lot 102 of location 579 as shown on Land Titles Office Plan 3609 aforesaid; thence north-westerly and north-easterly along boundaries of that lot to the south-western corner of location 259; thence northerly along the western boundaries of that location and of locations 80 and 422 to the north-western corner of the lastmentioned location; thence northerly to and along the westernmost boundary of location 929 and onwards to the southern boundary of location 244; thence westerly, northerly and easterly along boundaries of that location to the south-western corner of location 398; thence northerly along the easternmost eastern boundary of Swan Location 1394, the eastern boundary of lot 47 of Canning Location 437 as shown on Land Titles Office Plan 2551 to the southern side of Temby Avenue (road number 10666); thence westerly along that side and onwards to the western side of West Terrace (road number 1717); thence generally north-north-westerly along that side to the southern side of Norwood Road; thence westerly along that side and onwards to the north-eastern corner of lot 6 of Swan Location 1790 as shown on Land Titles Office Diagram 6097; thence generally west-north-westerly along the northern boundaries of that lot and lots 5 and 4 to a point situate in prolongation south-westerly of the north-western boundary of lot 17 of location 2082, as shown on Land Titles Office Diagram 17169; thence north-easterly to and along that boundary and the north-western boundaries of lots 16, 15, 14 and 21 and 20 as shown on Land Titles Office Diagram 19404 to the southern side of Maida Vale road (road number 2484); thence west-north-westerly along that side to the south-eastern boundary of location 1348; thence north-easterly along that boundary and onwards to a point situate in prolongation southerly of the western side of Kalamunda Road (road number 1135); thence northerly to and along that side to a point situate in prolongation westerly of the northern boundary of location 3148 (part Reserve 18689); thence easterly to and along that boundary to the north-eastern corner of that location; thence easterly to the north-western corner of location 1332; thence easterly along the northern boundaries of that location and of lot 6 of Location 1290 as shown on Land Titles Office Plan 4326 to the western boundary of location 1298; thence southerly and easterly along boundaries of that location to its south-eastern corner; thence north-easterly to the western corner of lot 34 of location 1763 as shown on Land Titles Office Plan 3491; thence north-easterly and south-easterly along boundaries of that lot and south-easterly along the north-eastern boundaries of lots 33 to 30 inclusive to the north-western boundary of Lot 26; thence north-easterly along that boundary and the north-western boundaries of lots 25 and 24 and south-easterly along the north-eastern boundary of the lastmentioned lot to its eastern corner; thence south-easterly to the northern corner of lot 23; thence north-easterly along the prolongation of the north-western boundary of that lot to a point situate west of the north-western corner of lot 2 of Kalamunda Town Lot 185 as shown on Land Titles Office Diagram 4676; thence east to the western side of William Street; thence generally north-easterly along that side and the western side of Lascelles Parade to a point situate in prolongation westerly of the southern side of Jessie Street aforesaid and thence easterly to and along that side and onwards to the starting point.

Land Act, 1933-1963.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of sub-leasing; and whereas it is deemed expedient as follows:—

Metropolitan Water Supply, Sewerage and
Drainage Act, 1909-1963.

ORDER IN COUNCIL.
