CEMETERIES ACT, 1897.

Regulations.

Expenditure of Funds.

Heading added by G.G. 12/7/57, p. 2282.

- 1. Any sum of money paid to the Trustees of any Cemetery out of moneys appropriated by Parliament shall be applied by the Trustees to such purpose as the Minister may direct.
- 2. Before making any advance, the Minister may require the Trustees to give a guarantee to his satisfaction that such moneys will be properly applied.
- 3. On the completion of the work for which any grant is made, properly acquitted vouchers for the expenditure shall be transmitted to the Minister by the Trustees.
- Any moneys so advanced shall be repayable by the Trustees to the Minister, on demand, if such moneys have not been properly applied or vouchers for the expenditure have not been duly transmitted by the Trustees to the Minister.

- Heading and 5. The fee Reg. 5 added Board shall be-by G.G. (a) Ch 5. The fees payable to the trustees of the Karrakatta Cemetery
 - (a) Chairman—a sitting fee of £4 4s. for each meeting of the Board which he attends;
 - (b) Members—a sitting fee of £3 3s. for each meeting of the Board which the member attends.

Fees Payable to the Trustees of the Fremantle Public Cemetery.

Heading and Reg. 6 added Cemetery shall be-by G.G. (a) Chair p. 3855.

- 6. The fees payable to the Trustees of the Fremantie Public
 - (a) Chairman—a sitting fee of £2 2s. for each meeting of the Board which he attends;
 - (b) Members—a sitting fee of £1 1s. for each meeting of the Board which the member attends.

Fees Payable to the Trustees of the Kalgoorlie Public Cemetery.

Heading and Reg. 7 added by G.G.

7. The fees payable to each Trustee of the Kalgoorlie Public Cemetery shall be a sitting fee of ten shillings and six pence (10s. 9/2/61, 6d.) for each ordinary meeting of the Board which he attends.
