declared and whereas by proclamation issued under the Native Welfare Act, 1963 and published in the *Government Gazette* on the 13th March, 1953, the Governor declared an area at Geraldton more particularly described as Reserve No. 23186 and defined in the Schedule to such proclamation to be a Reserve for Natives; and whereas it is now deemed desirable and expedient to abolish the said Reserve: Now, therefore I, the said Governor acting with the advice and consent of the Executive Council and in exercise of the power in that behalf conferred by section 18 of the Native Welfare Act, 1963, do hereby abolish the Reserve for Natives as declared and described and defined in the hereinbefore mentioned proclamation published in the *Government Gazette* on the 13th March, 1953, as aforesaid.

AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 16th day of December, 1964, the following Orders in Council were authorised to be issued:—

Constitution Act, 1889.

ORDER IN COUNCIL.

WHEREAS section 74 of the Constitution Act, 1889, provides, *inter alia*, that the Governor in Council may vest in heads of departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of persons employed at a weekly rate of wage in or about institutions and establishments and country offices of the Department of Native Welfare and in or about Mobile Welfare Units provided by the said Department, should be vested in John Barrett Redfern, Chief Clerk, Department of Native Welfare: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby vests in the said John Barrett Redfern, and any person appointed to act temporarily in his place, for so long as the said John Barrett Redfern holds the office aforesaid or until this power be sooner revoked, the power of appointment of persons employed at a weekly rate of wage in or about such institutions and establishments and country offices, and in or about such Mobile Welfare Units.

Child Welfare Act, 1947-1962.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 19 of the Child Welfare Act, 1947-1962, that the Governor may by Order in Council, (*inter alia*) appoint a special magistrate or special magistrates for any court or courts established under that section and may, in like manner, amend, vary or revoke any appointment made under that section; and whereas it now appears expedient that, with effect from the date hereinafter mentioned, every appointment made as aforesaid should be revoked and that the appointments of special magistrates as hereinafter appearing in this Order should be made: now, therefore, His Excellency the Governor acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid, doth, with effect from and including the 5th day of January, 1965—

- (a) revoke every appointment heretofore made pursuant to the said section; and
- (b) appoint each of the persons named in the Schedule hereto to be a special magistrate for every Children's Court heretofore established under the said section.

Land Act, 1933-1963.

ORDER IN COUNCIL.

Corres. 2792/62.

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of subleasing; and whereas it is deemed expedient that Reserve No. 27376 (Swan Location 7771) should vest in and be held by the Town of East Fremantle in trust for the purpose of a Site for a Yacht Club and Premises: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Town of East Fremantle in trust for a Site for a Yacht Club and Club Premises with power to the said Town of East Fremantle, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding 21 years from the date of the lease.

the whole or any portion of the said reserve for any term not exceeding 21 years from the date of lease, subject to the following conditions:—

- (a) any lease of this reserve shall be determined if at any time the occupier relinquishes possession of Reserve 27376 (Swan Location 7771) or fails to utilise either reserve for its respective purpose.
- (b) pedestrian public shall have the right of free access to and over the whole of location 7772 at all times.
- (c) the lessee shall keep the foreshore clean and clear of algae, rubbish and debris.

ORDER IN COUNCIL.

Forests 710/64, L. and S. 2487/62.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament the Governor, on a resolution being passed by both houses that such proposal be carried out, shall by Order in Council revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposals dated the 30th day of October, 1963, and the 28th day of October, 1964, for the revocation in part of the dedication of Crown lands as State Forest; and whereas after such proposals had been laid before Parliament resolutions were passed by both Houses that such proposals should be carried out: Now, therefore, His Excellency the Governor with the advice and consent of the Executive Council doth hereby revoke in part the dedication of Crown land as State Forest No. 38 by excising those portions of such State Forest as are described in the schedule hereto.

All that portion of Nelson Location 10924 as shown coloured green and marked (1) on L.T.O. Plan 5997, comprising an area of 18 acres 1 rood 13 perches.

All those portions of Nelson Location 3811 as shown coloured green and marked (2) on L.T.O. Plan 5997 and coloured green and marked (4) on L.T.O. Plan 5998 and comprising areas of 18 acres 3 roods, 28 perches and 6 acres 15 perches, respectively.

THE METROPOLITAN WATER SUPPLY, SEWERAGE AND DRAINAGE ACT, 1909-1963.

Metropolitan Main Drainage.

Shire of Perth.

The construction of approximately 3,900 feet of open channel, 15 inch and 36 inch diameter reinforced concrete piped drain and an excavated compensating basin together with all things necessary for the undertaking and as shown on plan M.W.S.S. and D.B., W.A. No. 9141.

This Order in Council shall take effect from the 24th day of December, 1964.

Local Government Act, 1960.

ORDERS IN COUNCIL

WHEREAS by section 288 of the Local Government Act, 1960, it shall be lawful for the Governor, on request of a Council by notice in the *Government Gazette* to declare any land reserved, or acquired, for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control and management of a Council, or land comprised in a private street, constructed and maintained to the satisfaction of a Council as a public street, and if the Council thinks fit, that the Governor shall declare the width of the carriage way and footpaths of
