IN pursuance of the provisions of section 9 of the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking by any means of capture whatsoever, the fish known as or called "crayfish" in all that portion of Western Australian waters specified in the schedule hereto for a period of five years from the date of publication of this Proclamation in the Government Gazette.

# Schedule.

The whole of the waters adjacent to Garden Island, bounded by lines commencing at Callista Point on that island, and extending one-quarter of a mile west; thence generally southerly and parallel to the foreshore to a point one-quarter of a mile west of Collins Point; thence east to Collins Point; thence generally northerly along the high water mark of Garden Island to the starting point.

IN pursuance of the provisions of section 9 of the Fisheries Act, 1905-1964, I, the Lieutenant-Governor of the State of Western Australia, by and Consent of the Evecutive with the advice and consent of the Executive Council, do hereby prohibit all persons from taking by any means of capture, other than by means of traps known as or called crayfish pots, the fish known as or called "crayfish", in all that portion of Western Australian waters specified in the schedule hereto for a period of five years from the date of publication of this Proclamation in the Government Gazette.

# ORDER IN COUNCIL.

F.D. 1231/62, L. & S. 5697/52 and 3975/14. WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall, by Order in Council, revoke such dedication.

- (c) direct that until the 22nd day of May, 1965, the Councillors shall continue to represent the electors as if elected by electors of the whole of the district instead of from wards.

# FRUIT CASES ACT AMENDMENT ACT. No. 88 of 1962.

ALL direct buyers of apples are required to be registered with the Department of Agriculture, South Perth, as from the 1st day of January, 1965. Registration fee £1.

Definitions:-

"Direct Buyer" means-

- (a) a person who during the period of two years immediately prior to the commencement of the Fruit Cases Act Amendment Act, 1962, purchased direct from a grower or growers an annual average quantity of not less than one hundred bushels of apples for the purpose of selling the same either wholesale or retail; or
- (b) a person who after the commencement of that Act purchases direct from a grower or growers an aggregate quantity of apples of not less than one hundred bushels during any period of twelve months commencing on the first day of January, for the purpose of selling the same either wholesale or retail.

"Grower" means a person by whom or on whose behalf apples are actually grown or produced for sale, and include a person who carries on the business of processing apples and a person who operates a packing shed for apples.

Every person who purchases apples direct from a grower or growers for the purpose of selling either wholesale or retail shall keep or cause to be kept a record containing the following particulars as to each purchase of apples:—

- (a) The name and address of each grower from whom the apples were purchased.
- (b) The date or dates when purchased.
- (c) The prescribed grades of the apples purchased and the quantity of each prescribed grade so purchased.
- (d) Such other particulars (if any) as may be prescribed.
