IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1964, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters specified in the schedule hereto for a period of five years from the date of publication of this Proclamation in the *Government Gazette*.

### Schedule.

All that portion of the Gascoyne River (near Carnarvon) lying south of a line drawn due east from the north-east extremity of Babbage Island and all that portion of Western Australian waters within a radius of one half of a mile of the south entrance to the Gascoyne River.

The waters of all creeks within a distance of five miles due north of the Carnarvon jetty and the waters of all creeks south of the Carnarvon jetty to the southerly bank of Oyster Creek and all those portions of Western Australian waters within a radius of one quarter of a mile of the entrances of the aforesaid creeks.

RESOLVED that the Shire of Bayswater, in pursuance of section 7 of the Town Planning and Development Act, 1928-1962, prepare the above Town Planning Scheme with reference to areas situated wholly within the Bayswater Shire and enclosed within blue borders on the plans now produced to the Bayswater Shire Council and marked and certified by the President and the Shire Clerk of the Council under their hands dated the 8th day of April, 1964, as the Control Plan and as Plan No. 1 and Plan No. 2.

**Details of Scheme.**

1. Responsible Authority.—The authority responsible for enforcing the observance of this scheme is the Shire of Bayswater (hereinafter referred to as "the Council").

2. Areas.—The Scheme shall apply to the lands contained within blue borders on the Control Plan. Portions of the said lands are also contained within blue borders on each of Sheets A, B and C of Plan No. 1 and on each of Sheets A, B and C of Plan No. 2. The said lands are hereinafter referred to as "the Area." The lands within an orange border on Sheet C are hereinafter referred to as the "Subdivided Area." The remainder of "the Area" is hereinafter referred to as the "Undeveloped" Area.

3. General Objects.—The general objects of the Scheme are:—

- (a) To improve and develop the Area to the best possible advantage.
- (b) To plan within the Area suitable roads.
- (c) To ensure the proper drainage of so much of the Area as is low-lying and to make such portion of the Area available for building purposes.
- (d) To ensure the provision of adequate drainage compensating basins.
- (e) To make provision for land to be used for public recreation, public open space and local authority purposes.
- (f) To facilitate and co-ordinate progressive subdivision and development of land within the Area.

4. Acquisition of Land.—The land within the "Subdivided Area" or so much thereof as is necessary to implement the Scheme shall be resumed or otherwise acquired by the Council.

4A. When acquired by the Council whether by purchase or resumption the lands described hereunder shall vest in the Council free of all reservations as to the use of the said lands contained in the Certificates of Title thereto and all rights and trusts in respect thereof.

Lands referred to.—Those portions of the land comprised in Certificate of Title Volume 38, folio 308, which are therein stated to be reserved for a Town Hall and to be reserved for schools respectively and coloured green on the plan on the Certificate of Title. That portion of the land comprised in Certificate of Title Volume 38, folio 309, which is therein stated to be reserved for a Church and coloured green on the plan on the Certificate of Title.

5. Works to be Carried Out.—The following works shall be carried out within the Subdivided Area:—

- (a) The Subdivided Area shall be re-surveyed in conformity with the design shown on Plan No. 2.

- (b) Those portions of the roads shown on Plan No. 1 which are no longer shown as roads on Plan No. 2 shall be closed and the land used for the purposes shown on Plan No. 2.

- (c) The land shown as roads on Plan No. 2 of which the carriageway is coloured yellow shall be constructed and drained and any necessary earthworks shall be undertaken.

- (d) Levelling, filling and grading works shall be carried out where necessary.

- (e) Drainage works will be carried out.

6. Method of Dealing with New Lots in Subdivided Area.—The lots shown on Plan No. 2 within the Subdivided Area shall be dealt with as follows:—

- (a) The new lots shown in Column No. 2 of the Schedule hereto shall be offered to the owners of the old lots on Plan No. 1 shown opposite in Column No. 1 of the Schedule. The offer shall be made on the basis that the owner shall—

- (i) pay to the Council upon the acceptance by him of the said offer the sum of money (if any) shown in Column No. 3 opposite his old lot in Column No. 1;

- (ii) accept the lot or lots so offered in full satisfaction of all claims for compensation in respect of the resumption from him of the lot on Plan No. 1 in respect of which the offer is made and otherwise in respect of the operation of this Scheme.

- (b) Lot Nos. 1, 7, 18, 27, 29, 64, 65, 72, 117, 126, 128, 154, 157, 158, 159 and 160 on Plan No. 2 (hereinafter referred to as "surplus lots") may be dealt with by the Council as hereinafter appears.

7. Offer of Lots.—The offer referred to in clause 6 hereof shall be made in writing to each of the said owners and posted by certified post to him at his address as appearing in the Rate Book of the Council and shall specify the lot on Plan No. 2 the subject of the offer and the old lot on Plan No. 1 in respect of which the offer of the replacement lot is made.

8. The offer shall state the amount of money (if any) payable by the owner on the acceptance of the offer.

9. The offer shall specify a date not being less than twenty-eight (28) days after the posting of the said offer within which the offer may be accepted.

10. The offer may be accepted by notice in writing to the Council at any time before the date specified in the said offer and if not accepted within such time shall subject to clause 32 hereof be deemed to have been rejected. No acceptance of the offer shall be deemed a valid acceptance unless all rates and taxes due by the owner in respect of land within the Area have been paid.

11. Registration of Transfers.—The Council shall cause to be prepared and sent to those owners entitled transfers in respect of each offer of a replacement lot which has been accepted by the owner in accordance with this Scheme. If an owner shall fail to complete the transfer in accordance with the Transfer of Land Act, 1893-1959, to make the payment of the amount payable by him and to return the transfer to the Council for registration within twenty-eight (28) days after having been called upon so to do by notice sent by certified post to the owner at his address last known to the Council (which notice may be served with the transfer) the Council may rescind any agreement whereby such owner is entitled to have the land the subject of the transfer transferred to him and thereupon such owner shall have a claim against the Council only for compensation for the resumption of the land in respect of which the offer of the replacement lot or lots was made and the land the subject of the transfer shall be treated as a rejected lot.

12. Rejected Lots.—If an owner does not accept an offer made to him by the Council in accordance with this Scheme or fails to complete a transfer of the said lot or make the said payment in manner aforesaid the Council may deal with the lots so affected as hereinafter appears.

13. Sale of Lots.—The Council may sell any surplus lots and any rejected lots either by public auction tender or private contract as a whole or in separate lots upon such terms and conditions as the Council shall think fit. In the event of a sale by private contract the price shall not be less than the price recommended by the Chief Valuer of the Taxation Department of Western Australia unless after submitting the land for sale by public auction or tender that price has not been obtained.

14. Overall Planning.—It is intended that as and when owners of land within the Undeveloped Area desire to develop and subdivide their land such development and subdivision shall be according to a plan which will be capable of forming part of an overall plan of subdivision and development for the Area.

15. The plan of subdivision shown in Plan No. 2 forms a basis for subdivision and development of the Area but the Council may permit alterations or variations to the plan where circumstances justify such action provided that no such alteration or variation shall be permitted if in the opinion of the Council it shall impede the subdivision and development of the Area as a whole or without the consent of the Town Planning Board.

16. An owner of land within the Undeveloped Area who desires to subdivide and develop his land either alone or in conjunction with other owners shall submit a plan of proposed subdivision to the Town Planning Board as required by the Town Planning and Development Act of Western Australia.

17. Open Space and Drainage Reserves.—It is intended that the tracts of land coloured green on Plan No. 2 be reserved for public recreation public open space and road drainage purposes.

18. It is intended that the tracts of land coloured blue on Plan No. 2 be reserved for drainage compensating basins and local authority purposes.

19. The Council may acquire the said land coloured green and the said lands coloured blue or any parts thereof by purchase or resumption or partly by one method and partly by the other.

20. Subject to clause 21 each owner of land within the Undeveloped Area shall when subdividing his land pay to the Council an amount equal to one-tenth of the value of his land at the date on which the subdivision of his land is approved by the Town Planning Board of Western Australia. If the Council so agrees the said payment may be specified wholly or in part by the transfer of land to the Council.

The said valuation shall be made on the basis that the whole of the owners land is offered for sale, taking into account that the subdivision can be approved, but not on the basis of the total of the values of the individual lots in the subdivision.

21. Certain roads in the Area have been designed as roads of a width greater than the usual width of one chain. Where an owner in accordance with the terms of this Scheme makes land available for any of the said roads, the amount of land which he makes available for such roads which is in excess of the amount of land which he would have been called upon to concede if the road had been of a width of one chain shall be valued as at the date on which the subdivision of his land has been approved by the Town Planning Board of Western Australia. The value of such land shall be deducted from the amount which such owner is required to contribute under clause 20 hereof.

22. For the purpose of clauses 20 and 21 the value of the owners' land shall be determined by the Chief Valuer of the Taxation Department of Western Australia or some person recommended by him. If the owner objects to the value so determined he may give notice of such objection to

the Council within twenty-eight days after having been informed of the said value and in that event the value shall be determined by arbitration in manner hereinafter provided.

23. So much of the land which is coloured green on Plan No. 1 which is not coloured green on Plan No. 2 is no longer required for public open space and shall subject to the consent of the Minister for Lands be transferred by the Crown to the Council free from encumbrances and free from any obligation as to its use for any specified purpose.

24. The Council shall apply the moneys received by it under clause 20 or so much thereof as is necessary for that purpose in the purchase of or the payment of compensation on the resumption of those parts of the Area which are coloured green on Plan No. 2. If the Council is or shall become the owner of any of the said areas coloured green on Plan No. 2 otherwise than in pursuance of this Scheme it may debit this Scheme with the value of such land as at the date upon which such land was made available by it for this Scheme.

25. Drainage Works.—Those portions of the Undeveloped Area which are contained within a pink border on Sheet A shall not be drained as part of this Scheme. The remainder of the Undeveloped Area is hereinafter referred to as the "Drainage Area." Each of the owners of land which is within Drainage Area shall pay to the Council the sum of thirty-five pounds (£35) for each subdivisional allotment of land in his plan of subdivision which is situated wholly within the drainage area. The said payment shall unless otherwise agreed between the owner and the Council be paid to the Council at the time his plan of subdivision shall be submitted to the Town Planning Board of Western Australia.

26. The Council shall construct or cause to be constructed drains, earthworks and carry out or cause to be carried out such other works as shall be necessary to drain and make the drainage area fit for building purposes. Such works may be carried out in stages and as and when the Council shall determine. The Council may contract with the Metropolitan Water Supply, Sewerage and Drainage Department or other authority or person to carry out the said works or any of them or any part thereof.

27. An owner of land within lands contained within a pink border on Sheet A who desires to develop and subdivide his land shall be responsible for the filling and draining of his land.

28. New Roads.—All new roads within the Undeveloped Area shall be constructed and drained by the Council at the expense of the owners of land therein in manner following. Upon the application by an owner for the approval of a plan of subdivision of his land within the Undeveloped Area the Council shall ascertain the average cost of the construction and drainage of roads within the Area at that date. Each such owner shall pay to the Council the said average cost of the construction and drainage of seventy-five (75) links of road for each allotment of land in his plan of subdivision; excluding lots already fronting existing constructed roads at date of Scheme.

29. Closure of Roads.—All surveyed roads within the Area which are shown on Plan No. 2 as roads to be closed shall be deemed to have been closed as from the date on which this Scheme shall come into operation and the land within the closed sections shall, except in the case of the lands edged brown on Plan No. 2 become part of the lot or lots shown in Plan No. 2 of which they form part and upon the subdivision of the land the fee in the road so closed with the exception of the lands edged brown shall vest in the owner of the said lot or lots of which the closed road forms part.

The lands edged brown on Plan No. 2 shall vest in the Council and the Council may sell or deal with such lands in such manner and upon such terms and conditions as it shall deem fit. The Council subject to the consent of all appropriate authorities may in anticipation of receiving payment of the whole or any portion of the moneys payable to it by reason of this Scheme raise funds by way of loan or bank overdraft for the purpose of acquisition of the Subdivided Area and of the said lands coloured green or blue and on Plan No. 2 or any of them or carrying out any of the works or making any of the payments to be carried out or made in pursuance of this Scheme or may make funds available for all or any of the said purposes.

31. The Council may enter into arrangements with the Metropolitan Water Supply, Sewerage and Drainage Department for the extension of water mains and pipes to the subdivisional area and make such payments to the Department for that purpose as it considers reasonable.

32. Powers and Authorities of Council.—In carrying out the provisions of this Scheme the Council shall have the following powers and authorities:—

- (a) To enter and inspect any land within the Area.
- (b) To enter into agreements with the owners or occupiers of any land within the Area.
- (c) To enter into agreements with purchasers or prospective purchasers or prospective occupiers of land within the Area.
- (d) To extend the time within which any offer of replacement lots may be accepted.
- (e) To extend the time within which the payments referred to in clause 6 (a) (i) shall be made.
- (f) To acquire by purchase or otherwise any land within the Area.
- (g) Resume land for roads.
- (h) Carry out any road construction, drainage, improvements or other works within the Area.
- (i) Dispose of any land not required for the purposes of the Scheme.
- (j) Enter into any agreements or arrangements with the Crown for the purposes of the Scheme.
- (k) If any owner of land within the Undeveloped Area does not proceed with the subdivision and development of his land in accordance with the terms of this Scheme and his failure to do so in the opinion of the Council will unduly delay the completion of the Scheme the Council may resume the land of such owner and proceed with the subdivision and development of the said land in accordance with the provisions of this Scheme.
- (l) In the event of the Council exercising its powers under clause (k) it shall have all the powers of an owner in the subdivision development and disposal of the said land but before selling the land so subdivided and developed it shall offer the new lots to the original owner upon his paying to the Council all costs and expenses consequent upon the resumption subdivision and development of the said land and all moneys which would have been payable by him if he had carried out such subdivision and upon his releasing the Council from all claims for compensation in respect of such resumption. The said offer shall be made in writing and if not accepted within one calendar month of the service thereof the Council may proceed with the sale of the subdivided lots. All moneys received by it from such sale shall be applied firstly in payment of all costs and expenses consequent upon such development subdivision and sale and secondly in payment of all compensation in respect of the resumption of the said land. The balance if any of such moneys

may be retained by the Council and the Council shall make good any deficit.

- (m) If the offer mentioned in clause (l) hereof be not accepted the Council may retain all or any part of the said land but if it does so it shall be responsible to pay such costs of subdivision of the said land and compensation for its resumption as are then unpaid.
- (n) The Council may resume any land within the Area for public or local authority purposes or for roads or in order to make it available for a particular use shown on Plan No. 2 without waiting until the owner thereof shall have prepared a plan of subdivision in accordance with the provisions of this Scheme and may develop the said lands and construct roads.

33. Arbitration.—Any dispute or difference between the owners as to their respective rights under this Scheme or as to the valuation of land under clause 22 hereof may be referred to the arbitration of a single arbitrator in manner provided by the Arbitration Act, 1895, or any statutory modification thereof for the time being in force and if the parties fail to agree upon any one single arbitrator he may be nominated by the Council.

34. Costs of Scheme.—The Council may pay all costs and expenses of this Scheme and the costs of any works carried out by it within the Area from moneys received by it in pursuance with the terms of the Scheme. If the moneys received by the Council are insufficient to meet the said costs and expenses the Council shall be responsible for the payment of the balance. The Council may retain any moneys coming to it by reason of the Scheme which are in excess of the amount required for the costs of the Scheme and the said works.

35. Compensation.—Claims for compensation by reason of the operation of this Scheme shall be made within six months of this Scheme coming into operation and claims for compensation on resumption of any land shall be made within six months from the issue of a notice of resumption or the date of rescission under clause 11 whichever is the later.
