ORDER IN COUNCIL.

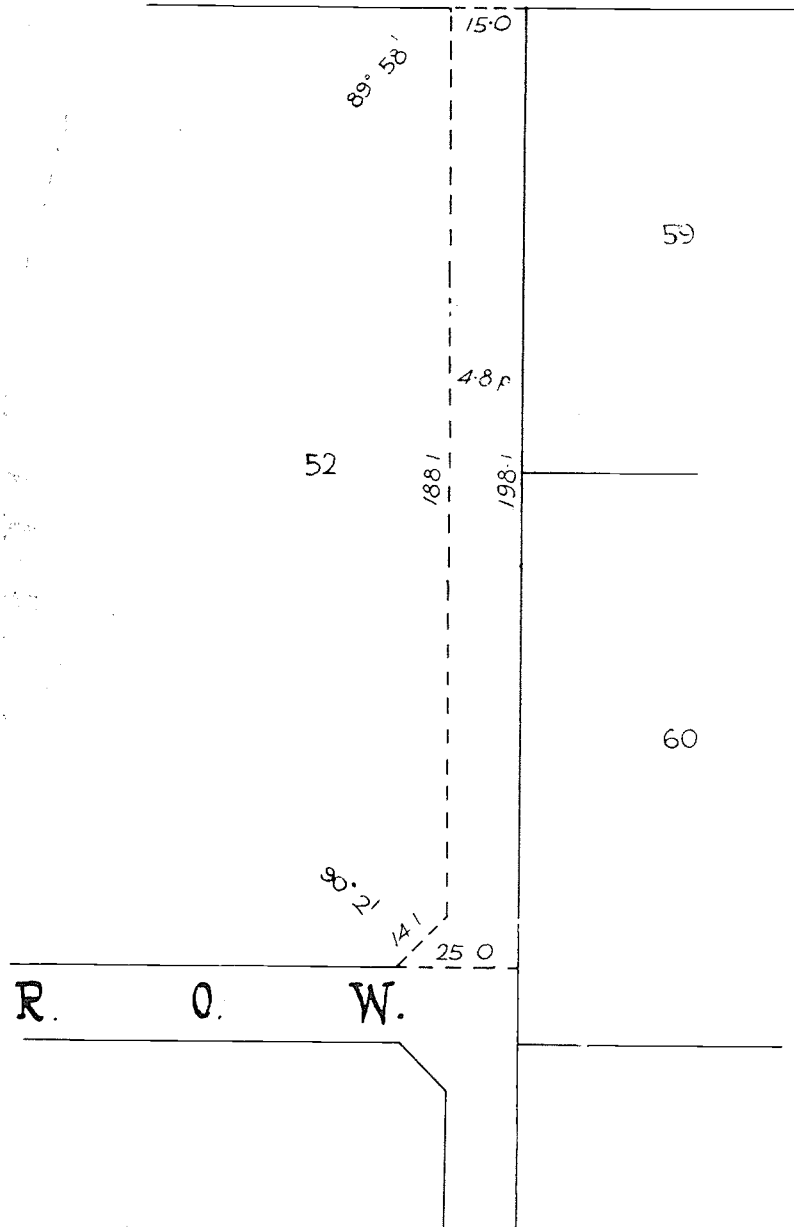
