WHEREAS the Bill for an Act to amend the Constitution Acts Amendment Act, 1899-1965, cited as the Constitution Acts Amendment Act (No. 3), 1965, (No. 105 of 1965) was on the twentieth day of December one thousand nine hundred and sixty-five reserved for the signification of Her Majesty's pleasure; and whereas at the Court at Buckingham Palace on the tenth day of March one thousand nine hundred and sixty-six the said Bill was laid before the Queen's Most Excellent Majesty in Council, and Her Majesty did then, by order, by and with the advice of Her Privy Council, declare Her Assent to the said Bill: Now, therefore, I, the said Governor, acting with the advice and

consent of the Executive Council and in exercise of the powers conferred on me by section 8 of the Interpretation Act, 1918-1962, do by this Proclamation declare that Her Majesty has assented to the said Bill.

ORDER IN COUNCIL.

L.G. 578/61.

WHEREAS it is enacted by section 433A of the Local Government Act, 1960-1964, that the Governor may (*inter alia*) make and publish in the *Government Gazette* uniform general by-laws for all or any of the purposes for which by-laws may

be made by a council under Part XV of that Act and, by order, declare that all or any such uniform general by-laws as are specified in the order together with any amendments thereof whether by way of addition, substitution or cancellation shall apply to the whole or any portion of a district so specified; and whereas the Governor has made and published uniform general by-laws namely the Uniform Building By-laws, 1965: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid, doth hereby declare that, of the Uniform Building By-laws, 1965, published in the *Government Gazette* on the 15th day of October, 1965—

- (a) the whole of each of them, with the exception of paragraph (a) of by-law 2805, applies to the whole of the municipal district of the Shire of Rockingham;
- (b) the whole of each of them applies to the municipal district of the Shire of Swan-Guildford with the exception of paragraph (a) of sub-by-law (1) of by-law 203 and sub-by-law (2) of by-law 2832 which apply only to those portions of the district which are not shown as for "Rural Development", on the Metropolitan Regional Plan;
- (c) the whole of each of them applies to the whole of each of the municipal districts set out in the first schedule hereto; and
- (d) the whole of each of them applies to those portions specified in each of the districts set out in the second schedule.
