STAMP ACT, 1921-1966.

Office of the Commissioner of Stamps, Perth, 12th January, 1967.

HIS Excellency the Governor in Executive Council, acting in pursuance of the provisions of section 120 of the Stamp Act, 1921-1966 and section 11 of the Interpretation Act, 1918-1962, has been pleased to make the regulations set forth in the Schedule hereunder.

Schedule. Regulations.

1. In these regulations the Stamp Act Regulations, 1966, Principal published in the Government Gazette on the 9th February, 1966, regulation regulations. are referred to as the principal regulations.

2. These regulations shall take effect on and from the 1st $_{\text{Commence-}}$ February, 1967. ment.

3. Regulation 3 of the principal regulations is amended by Reg.3 adding after the word "Perth", being the last word in the regula-tion, the passage, ", but all correspondence relating to the payment of stamp duty by a return shall be addressed to "The Returns Officer, Stamp Office, Perth". amended.

- 4. Regulation 4 of the principal regulations is amended-
 - (a) by revoking paragraph (b) of subregulation (3); and
 - (b) by deleting the words "followed by the letters ABC or such other letters as the Commissioner may from time to time determine" in lines two and three of paragraph (c) of subregulation (3).

5. Subregulation (5) of regulation 8 of the principal regula- Reg 9 tions is amended by deleting the words "in duplicate" in the second amended. line thereof.

Paragraphs (a) and (c) of regulation 9 of the principal Reg. 9 amended. 6. regulations are revoked.

Reg.9A added. 7. The principal regulations are amended by adding after regulation 9 the following regulation:—

9A. (1) A person to whom section 99A of the Act applies who wishes to elect to pay stamp duty under and in accordance with that section may so elect, by giving notice to the Commissioner in the form of Form P in the Schedule to these regulations.

(2) A person who elects to pay stamp duty under and in accordance with section 99A of the Act shall deliver the duly completed Form P to the Commissioner within seven days from the date thereof and shall indicate therein—

- (a) which of the categories of persons set out in the form is applicable to him;
- (b) the date from which he wishes to so elect to pay stamp duty, being a date not earlier than the date on which the Form P is signed by that person or on his behalf; and
- (c) whether the aggregate average monthly amount received by, paid to or deposited with that person, during the months preceding the date of the form is—

(i) \$50,000 or more;

- (ii) \$5,000 or more but less than \$50,000;
- (iii) \$1,000 or more but less than \$5,000; or
- (iv) less than \$1,000.

(3) The Commissioner shall send an acknowledgment of the receipt by him of any notice in the form of the Form P in the Schedule to these regulations to the person named therein as making the election referred to in the notice, and the acknowledgment shall contain—

- (a) for the purposes of section 99B of the Act, the direction of the Commissioner directing at what intervals the statement in the form of Form R in the Schedule to these regulations, is to be forwarded to the Commissioner and the period to which the initial and each such subsequent statement shall relate; and
- (b) the serial number assigned by the Commissioner to that notice and that serial number shall be quoted as a reference on all correspondence and each such statement relating to the payment of stamp duty in accordance with section 99B of the Act.

(4) A notice of election given under section 99A of the Act may be cancelled by the person who gave it, by notice sent by him to the Commissioner in the form of Form Q in the Schedule to these regulations.

(5) A notice of cancellation in the Form Q shall operate from the date specified therein as being the date it is required the notice shall operate, being a date not earlier than the date of the notice.

(6) On and from the date upon which a notice of cancellation in the Form Q operates, the person who gave the notice or on whose behalf the notice is given shall, subject to the Act, give duly stamped receipts for all amounts received by, paid to or deposited with him.

(7) A person who has made an election under section 99A of the Act shall, until the election is duly cancelled, forward to the Commissioner in accordance with the direction of the Commissioner given to him pursuant to section 99B of the Act-

(a) a statement in the form of Form R in the Schedule to these regulations relating to the period referred to therein, together with a remittance for the amount of stamp duty payable on that statement as calculated in accordance with the appropriate rate of stamp duty as prescribed in paragraph (b) of sub-section (1) of section 99B of the Act;

(b) a "nil" statement in the form of Form R where in respect of any period referred to therein no amounts have been received by, paid to or deposited with the person required to forward the statement to the Commissioner, that would require stamp duty to be paid on the statement.

Each such statement shall be forwarded to the Com-missioner within a period of fourteen days next following the termination of the period to which the statement relates.

(8) The Commissioner shall issue an official receipt in the form set out in the form of the statement of Form R in the Schedule to these regulations, for the amount of stamp duty paid on the statement.

(9) Each person who has made an election under section 99A of this Act shall keep proper records of all amounts received by, paid to or deposited with him until the time the election is duly cancelled, and those records-

- (a) shall, at all reasonable hours, be open to the inspection of the Commissioner or any person authorised in writing by him to inspect those records:
- (b) may be copied by the Commissioner or the person so authorised; and
- (c) shall be preserved by the person until a period of more than two years has elapsed from the time the amounts to which the records relate were so received, paid or deposited.

(10) For the purposes of paragraph (a) of subsection (1) of section 99B of the Act the prescribed period shall be where the average monthly amount received by, paid to or deposited with the person who has made an election under section 99A of the Act-

- (a) is \$50,000 or more—one month;
 - (b) is \$5,000 or more but less than \$50,000-three months:
 - (c) is \$1,000 or more but less than \$5,000-six months:
 - (d) is less than \$1,000-twelve months. .
