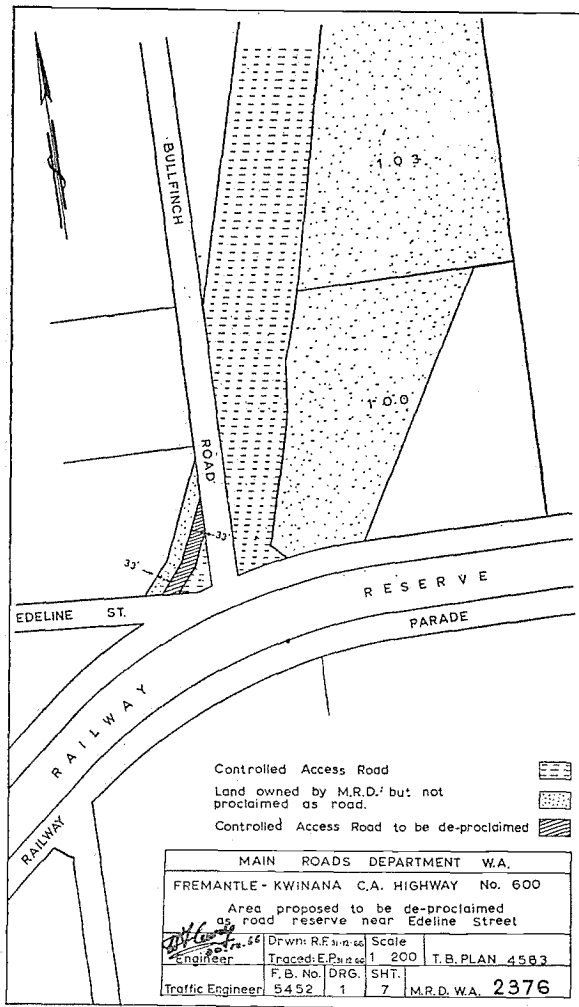

ORDER IN COUNCIL.

Corres. 1540/65.

WHEREAS by section 33 of the Land Act, 1933-1965, it is *inter alia*, made lawful for the Governor by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the conditions that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that Reserve No. 28472 (Cockburn Sound Location 2034) should, subject as aforesaid be granted in fee simple to the Shire of Mandurah, to be held in trust for the purpose of an "Administrative and Civic Centre": Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the beforementioned reserve shall be granted in fee simple to the aforesaid body,

to be held in trust for the aforesaid purpose, subject to the conditions that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

ORDERS IN COUNCIL.

WHEREAS by section 288 of the Local Government Act, 1960, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the *Government Gazette* to declare any lands reserved or acquired for use by the public or used by the public as a street, way,

public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the Councils mentioned in the schedule hereunder have requested that certain lands named and described in the said schedule, which have been reserved for streets within the said Councils, be declared public streets: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be a public streets, and such lands shall, from the date of this Order, be absolutely dedicated to the public as streets within the meaning of any law now or hereafter in force.

ORDER IN COUNCIL.

P.W.W.S. 660/47.

WHEREAS by section 12 of the Land Drainage Act, 1925-1954, the Governor may, at any time, by Order in Council, *inter alia*, excise any portion of a district, extend any district by the addition thereto of any land that has not theretofore formed part of a district and repeal, vary or amend any of the provisions of any previous order relating to any district: Now, therefore, His Excellency the Governor with the advice and the consent of the Executive Council doth hereby extend the boundaries of the Preston Drainage District as defined in the Schedules hereunder.

Extension of Preston Drainage District.

Schedule "A".

All that portion of land bounded by lines starting from a point on the Low Water Mark of the southern shore of Leschenault Inlet situate in prolongation northerly of the eastern side of King Road a point on the present boundary and extending southerly along that boundary to a point situate in prolongation northeasterly of the northwestern side of Hennessy Road (Road No. 163); thence southwesterly, northerly and again southwesterly to and along that side to the northeastern side of the Bunbury to Picton Junction Railway Reserve; thence generally northwesterly along that side to the southern side of Armitage Street; thence westerly to the southern side of Higgins Street; thence southwesterly along that side to the eastern side of Castle Street; thence northerly along that side and onwards to the northern side of Strickland Street; thence generally westerly along that side to the eastern side of Bourke Street; thence northerly along that side to the southern side of Rose Street; thence northwesterly to the intersection of the northern side of that road and the western side of Bourke Street aforesaid; thence northerly along the lastmentioned side to the northern side of Stuart Street; thence westerly along that side to the eastern side of George Street; thence northerly along that side and onwards to the northern side of Ramsay Street; thence westerly along that side to the eastern side of Zoe

Street; thence northwesterly along that side to the southeastern side of Cornwall Street; thence northeasterly along that side and onwards to the northeastern side of the Bunbury to Picton Junction Railway Reserve aforesaid; thence northwesterly along that side to the northern side of Stirling Street; thence easterly, southerly and again easterly along that side and onwards to the Low Water Mark of the southern shore of Leschenault Inlet aforesaid and thence generally easterly along that mark to the starting point as shown delineated and coloured green on Plan P.W.D., W.A. 43519, Drawing 1, Sheet 1.

Metropolitan Water Supply, Sewerage and
Drainage Act, 1909-1965.

ORDER IN COUNCIL.

M.W.B. 581911/66.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1965, it is provided that subject to the provisions of the Act, the Metropolitan Water Supply, Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Metropolitan Water Supply.

Shire of Kalamunda.

Victoria Reservoir Pumping Station.

The construction of a pumping station and the installation of pumping equipment, complete with valves and all necessary apparatus and as shown in red on plan M.W.B. 9491.

This Order in Council shall take effect from the 14th day of April, 1967.

Explosives and Dangerous Goods Act, 1961-1966.

ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by section 14 of the Explosives and Dangerous Goods Act, 1961-1966, that the Governor may from time to time by Order in Council, classify explosives and declare any specified explosive to be an authorised explosive for the purposes of that Act and that the Governor shall not so classify or declare any explosive until he has defined the composition, quality and character of that explosive; but such definition in

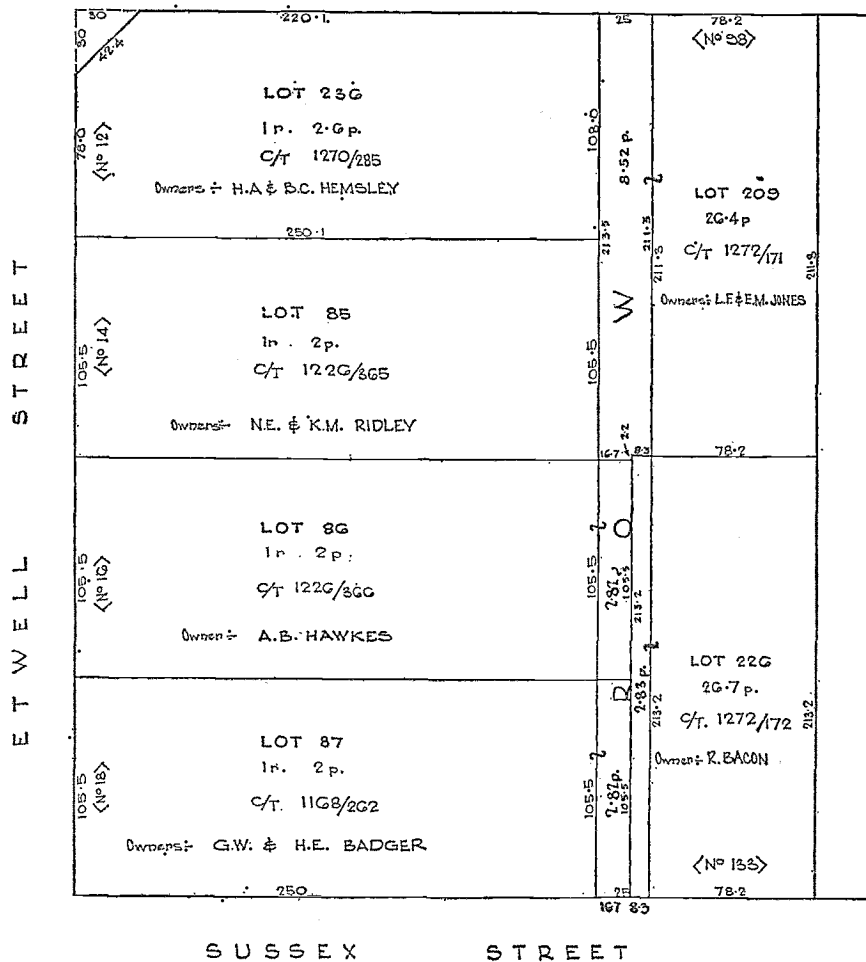
