TO HIS HONOUR JAMES HERBERT FORREST. Judge of the County Court in the State of Victoria:

I, the said Governor, acting with the advice and consent of the Executive Council, do hereby appoint you JAMES HERBERT FORREST to be a Royal Commission to enquire into and report upon, in relation to off-course betting on horse-races as concerning or affecting the Totalisator Agency Board, its staff, agents or administration

- (a) the truth, accuracy and fairness of the articles and the allegations therein which were published by the *Daily News* newspaper in its issues of the 17th, 18th, 19th and 20th April, 1967, in so far as they purport to refer to the facts or circumstances of any particular case;
- (b) the action taken by the Totalisator Agency Board in each case and whether such action was adequate and justified,

and to make such recommendations in regard thereto as the Commission may think fit. And I hereby declare that, by virtue of this Commission, you may in the execution hereof do all such acts, matters and things and exercise all such powers as a Royal Commission or the Chairman or members of a Royal Commission may lawfully do and exercise, whether under or pursuant to the Royal Commissioners' Powers Act, 1902-1956, or otherwise wise.
