WHEREAS it is enacted by subsection (1) of section 5 of the Fire Brigades Act, 1942-1966, that, subject to the provisions of that section, the municipal and road districts and parts thereof constituted as fire districts prior to the coming into operation of the Fire Brigades Act Amendment Act, 1959, as set out in the Second Schedule to the Act, are for the purposes of the Act fire districts under the respective names as set out in that schedule; and whereas it is further enacted, *inter alia*, by subsection (2) of that section that for the purposes of the Act the Governor may from time to time, by Order in Council adjust the boundaries of a fire district: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council doth hereby adjust the boundaries of the Harvey Fire District as set forth in Part IV of the Second Schedule to the Act by substituting for the Road District of Harvey referred to in that Part of such Schedule, that portion of the Municipal District of the Shire of Harvey set forth in the Schedule to this Order in Council.

- (3) Where an acknowledgment of a claim is forwarded to an elector who after the 30th June 1967 duly claims enrolment for an Electoral Province and Electoral District, the acknowledgment shall contain the appropriate name of the Electoral Province and Electoral District as so constituted under the Electoral Districts Act, 1947-1965 and in which the claimant lives or is deemed to live.
- (4) The prescribed form of claim shall so far as is necessary, be varied by endorsing thereon the name of the Electoral District for which the elector will be enrolled pursuant to these directions.
- (5) The Chief Electoral Officer may re-transfer to any roll a name that having been transferred therefrom pursuant to these directions was so transferred in error.
- (6) In relation to any by-election for an Electoral Province or Electoral District that it is necessary to hold before the next general election the Chief Electoral Officer may give, in lieu of these directions, such directions as he may consider necessary or expedient to implement the provisions of the Electoral Act, 1907-1964, for the proper and efficient conduct of that by-election.

Notice Directing Destruction of the Primary Noxious Weed Cape Tulip (*Homeria breyniana* (L.) Lewis and *Homeria miniata* Sweet).

To all Occupiers and Owners of Private Land Situated in the Shires Mentioned Below:

THE Agriculture Protection Board, pursuant to the provisions of sections 22 and 22A of the Noxious Weeds Act, 1950-1963, hereby directs that the primary noxious weed Cape Tulip (*Homeria breyniana* (L.) Lewis and *Homeria miniata* Sweet) if present on private land occupied or owned by you situated in any of the districts of the local authorities specified in either of the schedules below shall be destroyed by you in the manner following:—

- (1) If the total area of your private land does not exceed 500 acres, all Cape Tulip on a minimum of 25 acres shall be destroyed.
- (2) If the total area of your private land exceeds 500 acres, but is less than 1,000 acres, all Cape Tulip on a minimum of 50 acres, shall be destroyed.
- (3) If the total area of your private land exceeds 1,000 acres, but is less than 2,000 acres, all Cape Tulip on a minimum of 75 acres shall be destroyed.

(4) If the total area of your private land exceeds 2,000 acres, all Cape Tulip on a minimum of 100 acres shall be destroyed.

(5) The Cape Tulip shall be destroyed by use of either or both of the methods following:—

(a) Effective ploughing to the depth of the corms.

(b) Spraying with 2,4-D ester at the rate of 2 lb. acid equivalent per acre. Two pints of 80% 2,4-D ester contains 2 lb. acid equivalent.

If your land is situated in any of the districts of the local authorities listed in Schedule A you are required to comply with the requirements of this notice between 17th July and the 17th August, 1967.
