1. In these regulations the Registration of Births, Deaths and Marriages Act Regulations, 1963, published in the *Government Gazette* on the 29th August, 1963, and amended by a notice published in the *Government Gazette* on the 10th January, 1966, are referred to as the principal regulations.

2. The First Schedule to the principal regulations is amended—
- (a) by substituting for the passage, "For registration of a birth—" in line two under the heading "PART I—BIRTHS.", the passage "On notification of a birth to a District Registrar or to an Assistant District Registrar—"; and
 - (b) by substituting for the passage, "For registration of a death—" in line ten under the heading, "PART II—DEATHS.", the passage, "On notification of a death to a District Registrar or to an Assistant District Registrar—"; and
 - (c) by substituting for the passage, "For registration of a marriage—" in line eighteen under the heading, "PART III—MARRIAGES." the passage, "On notification of a marriage to a District Registrar—".

By-law Relating to Building Deposits.

IN pursuance of the powers conferred upon it by the above Act and all other powers enabling it, the Council of the Town of Mosman Park hereby records having resolved on the 25th day of May, 1967, to make and submit for confirmation by the Governor the following amendment to the Council's by-law published in the *Government Gazette* on the 13th day of February, 1948—

Insert a further clause numbered 128A and reading:—

Deposit Against Damage.

128A. Where any permit holder within the meaning of clause 128 of this by-law is directed by the Surveyor he shall deposit with the Council a sum as described within this clause to be held as a security against damage caused in any way whatsoever by the permit holder or his agents to any road paving, footpath, kerbing, drainage equipment or such other improvements carried out by the Council within the road reserve fronting the land subject to the permit.

Upon completion of the work detailed in the permit the Council shall retain from the deposit a sum equal to the cost of repairing, replacing or making good the damage caused and shall refund the balance of the deposit after deduction of the sum aforesaid, to the depositor named in the Council's records.

Where the land has a road frontage of 66 feet or less the deposit shall be twenty dollars (\$20) and where the land has a road frontage greater than 66 feet the deposit shall be fifty dollars (\$50).

By-laws Relating to Street Verandahs.

L.G. 771/66.

IN pursuance of the powers conferred upon it by the abovementioned Act and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on the 17th day of February, 1967, to make and submit for confirmation by the Governor, the following by-laws:—

1. The Council at any time after 1st July, 1968, may, by notice, require the owner of any verandah protruding into, or above, a street, way, footpath or other public place within the townsite of Morawa, and which is supported by posts erected in, or on, a street, way or footpath or other public place, to remove it within the time stipulated in the notice. The said notice shall be in writing and shall be given and served by the Council on the said owner.

2. If the owner of the said verandah fails to comply with the said notice, within the time stipulated therein, he shall be guilty of an offence. Maximum penalty one hundred dollars (\$100) and in addition a maximum daily penalty of eight dollars (\$8) for each day during which the offence continues.

3. No verandah shall hereafter be erected in, on or over a street, way or footpath or other public place, unless of the cantilever or suspended awning type and approved by, and to the satisfaction of, the Council.

Noxious Weeds.

A person shall not transport or cause or permit to be transported in any vehicle on any road within the district of the Municipality, any grain, small seeds or fertiliser in bulk or in open sacks, unless that vehicle is to the satisfaction of an inspector so fitted and equipped and the grain, small seeds or fertiliser so covered as to prevent the escape or spillage from that vehicle of any of that grain, small seeds or fertiliser while being so transported.

Penalty: For a first offence a fine not exceeding twenty dollars (\$20) and for a subsequent offence a fine not exceeding fifty dollars (\$50).
