WHEREAS by the Election of Senators Act, 1903, it is provided that the Governor may by Proclamation to be published in the *Government Gazette* not less than seven days before the issue of the writ for any election of Senators for the State of Western Australia, fix the places at which such election shall be held, and the dates for the nomination, the polling, and the declaration of the poll and return of the writ; and whereas Friday, the 13th day of October, 1967, has been fixed as the date for the issue of a writ for the election of Senators aforesaid: Now, therefore I, the Governor, by and with the advice and consent of the Executive Council, do hereby fix Friday, the 27th day of October, 1967, at 12 o'clock noon, as the day and time before which nominations for the said election are to be made, and Saturday, the 25th day of November, 1967, as the date for the polling at the said election, and on or before Thursday, the 11th day of January, 1968, as the date for the return of the writ; and do hereby fix the Office of the Commonwealth Electoral Officer at 55 William Street, Perth, as the place of nomination for the said election, and the polling places within the said State appointed under the law of the Commonwealth for the time being in force for the regulation of Parliamentary elections as the places at which such election shall be held.

May, 1967 and published in the *Government Gazette* on the 2nd June, 1967, applying the Act to the areas of the State set out in that proclamation; and whereas it is now desired to vary that proclamation: Now, therefore, I, the Governor acting with the advice and consent of the Executive Council do hereby vary the proclamation made the 24th June, 1967, by including therein the following areas of the State, namely those contained respectively in—

- (a) the municipal district of the Shire of Manjimup; and
- (b) the townsite of Australind as defined by Order in Council under the Local Government Act, 1960-1966, and published in the *Government Gazette* on the 14th August, 1964, together with any area that is within five miles of the boundaries of that townsite as so defined,

as being areas to which the Act shall apply.

WHEREAS by section 4 of the Mines Regulation Act, 1946-1965, power is conferred upon the Governor to proclaim any district as a mining district under that Act: Now, therefore, I, the Governor, acting with the advice and consent of Executive Council and in exercise of the power so conferred upon me, do hereby proclaim the districts severally described in the schedule hereunder, as mining districts within the meaning and for the purposes of the Mines Regulation Act, 1946-1965.

Schedule.

Nabberu Mining District: Bounded by lines commencing at the intersection of parallel 26 deg. South Latitude and the line of the No. 1 Rabbit Proof Fence, and extending northerly along the said fence to the Tropic of Capricorn (23 deg. 26½ min.); thence east along the Tropic of Capricorn to the 125th meridian of East Longitude; thence south along the 125th meridian to parallel 26 deg. of South Latitude; thence west along parallel 26 deg. to the starting point.

Warburton Mining District: Bounded by lines commencing at the intersection of parallel 30 deg. Eucla Mining District: Bounded by lines commencing on the seashore at the southeast corner of the Dundas Goldfield, and extending north along the east boundary of the said Goldfield to the south boundary of the North East Coolgardie Goldfield; thence east along the said south boundary to the 125th meridian of East Longitude; thence north along the 125th meridian to parallel 30 deg. South Latitude; thence east along parallel 30 deg. to the 129th meridian of East Longitude; thence south along the 129th meridian to the seashore; thence generally southwesterly along the seashore, and including all adjacent islands, to the starting point.

- (1) You shall on or before the 15th day of October, 1967, clear of all inflammable material firebreaks at least six feet wide immediately inside all external boundaries of the land; and
- (2) You shall on or before the 15th day of October, 1967, clear of all inflammable material firebreaks at least six feet wide in such positions as to divide properties of more than 500 acres into separate sections of not more than 500 acres completely surrounded by a firebreak at least six feet wide; and
- (3) You shall on or before the 15th day of October, 1967, clear of all inflammable material firebreaks at least six feet wide within 5 chains of the perimeter of all buildings and/or haystacks or groups of buildings and/or haystacks in such a manner as to completely encircle the buildings and/or haystacks; and
- (4) You shall on or before the 29th day of November, 1967, clear of all inflammable material firebreaks not less than six feet wide immediately surrounding all land on which crop is growing or standing; and
- (5) You shall on or before the 15th day of October, 1967, clear of all inflammable material two firebreaks of at least six feet wide and approximately one chain apart inside and along all boundaries which abut a Railway Reserve on which railway traffic is operating and where the Railway Reserve is situated outside a townsite boundary. Additionally, if directed to do so by a Fire Control Officer, you shall clear of all inflammable material the land contained between the two firebreaks specified under this section.

Dividing Line: An imaginary line commencing at the northeastern corner of Avon Location 1779, thence running south and southeast along the western boundaries of Buckland Road (Road No. 25) and Irishtown Road (Road No. 109) to the northwestern boundary of the Town of Northam, thence northeast along the said boundary, along the northeastern and southeastern boundaries of the said town to its intersection of the Avon River, thence south along the said Avon River to the southeastern boundary of the Shire.

If it is considered to be impracticable for any reason to clear firebreaks or to remove inflammable material from land as required by this notice, you may apply to the Council or its duly authorised officer, not later than the 7th October, 1967, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised officer you shall comply with the requirements of this notice.

The penalty for failing to comply with this order is a fine of not less than \$10, nor more than \$200, and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this order if it is not carried out by the owner or occupier by the date required by this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

Notice to Owners and Occupiers of Land in the Shire of Wandering.

PURSUANT to the powers contained in section 33 of the above Act you are hereby required on or before the 31st day of October, 1967, or before such later date as the Council may according to local conditions decide, to plough, cultivate, scarify or otherwise clear of all inflammable materials, firebreaks not less than six (6) feet wide in the following positions on land owned or occupied by you:—

- (1) Inside and around within one chain of the boundaries of all land used for pasture.
- (2) Immediately surrounding all land under crop.
- (3) Within five chains of the perimeter of all buildings on the land.

If it is impracticable for any reason to clear firebreaks in the positions required by this notice, the approval of the Council must be obtained to provide them in alternative places.

This approval may be granted by the District Chief Fire Control Officer or one of his Deputies.

Firebreaks in the places described hereunder will be accepted as complying with the requirements of this Notice so far as they apply to the common boundary between the land of any owner and the abutting lands referred to here:—

- (a) Where land of an owner/occupier abuts on a declared road and the owner/occupier has burned or cleared the bush satisfactorily and has maintained it in this condition between the road formation and the common boundary. (Note: ploughing of road sides is prohibited in the Shire of Wandering.)
- (b) Where the land of an owner/occupier abuts on Crown Land or Reserve and the owner/occupier has cleared a firebreak in accordance with the previous specifications in this Notice on the Crown Land or Reserve along the common boundary.

All firebreaks so constructed must be kept in a satisfactory condition, and must remain cleared of all inflammable materials, until 15th April, 1968.

If for any reason it is found impracticable to construct firebreaks in accordance with the provisions of this Notice, or by the date set, which is the 31st day of October, 1967, you are requested to advise the District Chief Fire Control Officer of the circumstances.

**TOWN OF COTTESLOE TOWN PLANNING
SCHEME.**

AS amplified and amended by resolutions of the Council of the Town of Cottesloe passed on the 25th day of May, 1966, and the 22nd day of February, 1967, and approved by the Hon. Minister for Town Planning on the 21st day of July, 1967.

1.—Object and Scope of Scheme.

This is the Scheme prepared and adopted by the Council of the Town of Cottesloe, approved by the Hon. Minister for Town Planning on 11th October, 1949 and subsequently amended from time to time.

The Scheme has been amended to comply with the requirements of section 35 of the Metropolitan Region Town Planning Scheme Act and with the amendment to the Uniform Building By-laws published in the *Government Gazette* on the 11th March, 1966.

It is complementary to and not a substitute for the Metropolitan Region Scheme. The provision of the Metropolitan Region Scheme, as amended from time to time, shall continue to have effect.

Notwithstanding anything to the contrary in this Scheme, the Council may, with the consent of the Minister or when required by the Metropolitan Region Planning Authority so to do, shall require that the development of any land within the district, however zoned, shall be subject to the provisions of Clauses 10, 24 and 30 of the Metropolitan Region Scheme.

The scope of the Scheme covers the districting and zoning of the municipality for Residential, Business and Industrial purposes as shown on the sealed plan and described hereunder; and the area of the municipality is hereby classified and districted.

1A.—Definitions.

In addition to the definitions listed hereunder, the terms used in this Scheme shall have the same meanings as laid down in the Town Planning and Development Act, 1928-65.

“Act” means the Town Planning and Development Act, 1928 and any amendment thereof.

“Building” means any structure, whether fixed or otherwise, permanent or temporary, which is roofed or wholly or partially enclosed by walls.

“Council” means the Council of the Municipality of the Town of Cottesloe.

“Dwelling House” means a building used or designed or adapted for use as a single tenement. The term includes such outbuildings as are ordinarily used therewith.

“Effective Frontage” shall be calculated for lots having parallel side boundaries, as the length of a line drawn at right angles to one side boundary so as to bisect the opposite side boundary and, in the case of all other lots, as the length of a line drawn parallel to the street frontage, between the two side boundaries at $\frac{1}{3}$ of the mean depth of the lot measured from the main street frontage: PROVIDED THAT nothing herein contained shall prevent the Council from deciding by other means, the effective frontage of lots of such irregular proportions that it considers the above formula cannot be applied. For the measurement of the width of frontage pertaining to development other than that controlled by the GR codes the provisions specified in the Uniform Building By-laws shall apply.

“Land” includes buildings and structures thereon.

“Land Utilisation Plan” means a plan of the Municipality of the Town of Cottesloe which—

- (i) depicts the various primary purposes for which land is being used within the district;
- (ii) has such uses denoted by different colours in accordance with the legend attached to the plan; and
- (iii) has been signed by the Mayor and the Town Clerk of Cottesloe and dated 25th May, 1966 for identification.

“Owner” in relation to any land includes the Crown and every person who, jointly or severally, whether at law or in equity:—

- (a) is entitled to the land for any estate in free simple in possession or;
- (b) is a person to whom the Crown has lawfully contracted to grant the fee simple of the land; or
- (c) is a lessee or licensee from the Crown; or

- (d) is entitled to receive or is in receipt of, or, if the land were let to a tenant, would be entitled to receive the rents and profits thereof, whether as a beneficial owner, trustee, mortgagee in possession or otherwise.

“Public Building” means a building designed, used or intended to be used by Government Departments, statutory bodies representing the Crown, or Councils as offices or for administrative or other like purposes.

“Residential Flat” or “Flat” means a separate tenement used for living purposes in a building containing two or more such tenements.

“Service Station” means land used for the purpose of fuelling motor vehicles, the sale of accessories and parts, the carrying out of routine service such as oiling, greasing, cleaning, etc. but does not include uses of spray painting, panel beating and major repairs.

“Shop” means any permanent building constructed and used for retail sales, or in which goods are regularly offered or exposed for sale and not being a Service Station, warehouse or wholesaler.

“Tenement” means a building or part of a building used or designed or adapted for use as self contained living quarters for a single family.

“Zoning Plan” means a plan of the Municipality of the Town of Cottesloe which has—

- (i) been divided into areas or zones for various primary uses;
- (ii) such areas or zones denoted by different colours for different primary uses;
- (iii) been signed by the Mayor and Town Clerk of the Town of Cottesloe and dated 25th May, 1966 for identification.

The Zoning Plan and this regulation shall be read in conjunction with each other and they shall each form part of this Scheme.

2.—Area to which Scheme shall Apply.

This Scheme shall apply to the whole of the Municipality of the Town of Cottesloe, as described in the *Government Gazette*, dated 27th September, 1907, page 3253 and as amended on 1st November, 1935, page 2068, 3rd July, 1964, page 2601 and the Act No. 3 of 1911 when a portion of the Eastern Railway Reserve was included in the district.

3.—The Responsible Authority.

The Council of the Municipality of the Town of Cottesloe shall be the Authority responsible for enforcing the observance of this Scheme.

4.—Repeal.

From the date of coming into operation of this Scheme all By-laws or regulations previously in force under the Town Planning Scheme for the Municipality of Cottesloe; are hereby repealed.

5.—Non-conforming Use.

If at the time this Scheme comes into operation any building or land is being lawfully used for a purpose other than is permitted under the Scheme (hereinafter called a non-conforming use) such building or land may continue to be used for such purpose and the Council may, at its discretion and subject to the Building By-laws, permit any such building to be added to or altered so as to cover so much of the site on which it stands as may be lawfully built upon at the time when this Scheme comes into operation.

When a non-conforming use has been discontinued or changed to a conforming one, such non-conforming use shall not thereafter be recommenced.

This section does not apply to the Third Schedule.

6.—Compensation.

No claim for compensation in respect of any land or property which is claimed to be injuriously affected by these By-laws, will be considered unless such claim is received within six months from

the date when notice of the approval of these By-laws is published, as prescribed by the Town Planning and Development Act Regulations.

7.—Control of Defence Areas Regulations.

All buildings erected within the municipality shall be subject to the requirements of the "Control of Defence Areas Regulations" as promulgated by the Department of the Army from time to time.

7A.—General Control.

(i) Entry: The Council may, by its Town Clerk or other authorised officer, enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of this planning scheme are being observed.

(ii) Orders: If any person contravenes or fails or neglects to comply with any of the provisions of this planning scheme, the Council shall, by notice in the manner set out in this Clause, order such person to discontinue forthwith any such contravention and within thirty (30) clear days after the service of such notice to remove, pull down, take up, alter or otherwise make good any work which contravenes this scheme, or carry into effect any provisions of the Scheme which are not being complied with.

(iii) Service of Orders: Any notice in writing under subsection (1) of Section 10 of the Town Planning and Development Act, 1928—

- (a) shall be served on the owner or owners of the land in question, or such of them as can with reasonable diligence be ascertained, either personally or by registered letter posted to their last known place of residence;
- (b) shall describe in general terms the manner in which the planning scheme has been contravened; and
- (c) shall require the owner or owners as the case may be, within thirty (30) clear days or such other period being not less than thirty (30) clear days as determined by the Council after the service of such notice, to discontinue such contravention of the Scheme and take such action as the Council may direct to cause compliance with the provisions of the Scheme.

(iv) Failure to Comply with Orders: Should the owner or owners, as the case may be, fail or refuse to comply with the notice within the time specified in the notice, the Council may, itself remove, pull down, take up, or alter the building, work or development accordingly.

(v) Recovery of Expenses: Any expense incurred by the Council under the provisions of this Clause may be recovered from the owner or owners of the land on which the building or work was so commenced, continued or carried out as a debt due to it by the owner or owners.

8.—Penalty.

If any person either by act or omission contravenes the By-laws under this Scheme he shall be guilty of an offence under such By-laws and on conviction for such an offence shall be liable to a penalty as prescribed under Section 10 of the Town Planning and Development Act.

9.—Reserved Land.

(a) Reservation of Land: Land set aside under this Scheme for the purposes of a reservation is deemed to be reserved for the purposes indicated on the approved Zoning Plan No. 2. The reservations of the Metropolitan Region Scheme are shown in the Scheme to comply with the provisions of the Metropolitan Region Town Planning Scheme Act.

(b) Development on Reserved Land: Except as otherwise provided in this Clause, a person shall not carry out any development on land reserved under this Scheme, other than the erection of a boundary fence, without first applying for and obtaining the written approval of the Council.

(c) Approval of Development on Reserved Land: In giving its approval the Council shall have regard to the ultimate purpose intended for the reserves, and shall in the case of land reserved for the purpose of a public authority, confer with that Authority before giving its approval.

(d) Reservations under the Metropolitan Region Planning Scheme: Any application for development on land reserved or abutting a reserve defined in the Metropolitan Region Planning Scheme shall be referred to the Metropolitan Region Planning Authority for determination in accordance with Section 29 of the Metropolitan Region Planning Scheme.

10.—Residential Areas.

(a) The whole of the lands within the Town of Cottesloe are declared to be a Residential Area, with the exception of those lands shown on the Zoning Plan No. 2, as Open Spaces, land used for Railway Purposes, Business Areas, Special Areas—Recreation and Service Station Areas.

(b) No land within the Residential Area shall be used for the establishment of Business or Industry except as provided in the Industrial Areas Clause.

(c) With the exception of a Duplex House complying with the requirements of the Uniform General Building By-laws, not more than one residence or dwelling, or in cases where one exists, no additional residence or dwelling shall be erected or constructed on any lot which is not within the areas defined by the First Schedule.

(d) Churches, Public Buildings or other institutional buildings may be erected in the Residential Area with the approval of the Council.

(e) No residential lot shall be built on so as to cover more than 35 per cent. of the area of such lot.

(f) The erection of tenement houses or residential flat buildings shall be limited to those areas as set out in the First Schedule.

(g) No dwellinghouse shall be erected on any lot of land having a lesser frontage than 50 feet and a smaller area than 6,000 square feet, except by permission of the Council, which may permit a dwellinghouse to be erected on any site of lesser frontage and area than hereinbefore prescribed, provided that such site comprises the whole of any lot shown on a plan of sub-division approved by the appropriate authority prior to the coming into operation of this Scheme.

(h) No lot of land shall be built upon until the land is drained to the satisfaction of the Council and provision is made for the disposal of roof water and house sullage.

11.—Flat Areas.

(a) The development of land for residential flat or tenement buildings within the Town of Cottesloe shall comply with the General Residential Zone provisions of the Uniform Building By-laws as applied to the areas described in the First Schedule hereto.

(b) Further to the provisions of subclause 11 (a) hereof, the Council may by resolution at an ordinary meeting, approve the erection within the Flat Areas, of residential flat buildings containing single-unit (one person) flats comprising a bed-sitting room of not less than 180 square feet, together with a bathroom and water closet required to be provided by the Health By-laws, subject to the following and such other conditions as the Council may in any particular case require—

- (1) the kitchen and bathroom-W.C. must be capable of being closed off from the bed-sitting room and from each other; and
- (2) not more than one person shall occupy any single unit (one person) flat.

12.—Business Areas.

(a) The Business Areas are defined as the lands described in the Second Schedule hereunder and as shown on the Zoning Plan No. 2.

(b) Where under the provisions of this Scheme any site is included in both a "Flat Area" and a "Business Area" and such site complies with the

requirements of a "Flat Site" and a "Business Site" under this Scheme, and the Building By-laws, then the following shall apply:—

Such site or sites may be used for any of the uses as are permitted within a Flat Area or a Business Area. The joint use of land for residential flats and any use permitted in the Business Areas may be permitted by the Council on those lots zoned for residential and business purposes and shall be subject to all the controls laid down in the amendment to the Uniform Building By-laws as published in the *Government Gazette* dated 11th March, 1966.

(c) The Business Areas may include the following uses:—

- (1) Any use permitted in a residential area under the Scheme, provided that no dwelling shall be erected except in conjunction with business premises and subject to either the prior erection of such business premises or their erection at the same time as the dwelling.
- (2) No shop and dwelling combined shall be erected except on a lot having a minimum frontage of 50 feet and a minimum area of 6,000 square feet, except with approval of the Council, which may permit a shop and dwelling combined to be erected on any site of lesser frontage or area than hereinbefore prescribed, provided that such site comprises the whole of any lot shown on a plan of sub-division or re-subdivision approved by the appropriate authority prior to the coming into operation of this Scheme.
- (3) The following: Theatre, hall, club or place of amusement, office, bank or hotel, fire station, police station, post office or public building.
- (4) Shops, salesrooms or showrooms for the conduct of retail business.
- (5) Workrooms connected with retail business in which not more than fifty per cent. of the total floor space is devoted to workrooms.
- (6) Service trades such as maintenance to plumbing and domestic appliances etc.
- (7) Such other accessory or ancillary buildings and uses, as the Local Authority may determine, but shall not include any industry or manufactory.

13.—Industrial Areas.

Definition: "Industrial Purposes" shall mean any work or manufactory, industry, or use, not permitted in the "Business Area".

- (a) No Industrial Areas are defined within the municipality and no building or use for industrial purposes may be established except as permitted in this section.
- (b) Industries which were established on lands within the municipality at the time of commencement of this Scheme as defined in the Third Schedule are permitted to remain and to carry on the present industrial use, but no other use, and to carry out such extensions on those lands as may be approved by the Council in accordance with the Building By-laws. No such extensions shall be approved which involve the installation of power or firing plant driven by other than electricity or smokeless fuel.
- (c) Subject to subclause 13(b) hereof, no offensive trade as defined by the Health Act shall be established within the Town of Cottesloe, with the exception of fish shops, which shall be licensed by the Council and located in the business areas of the Scheme.
- (d) Any industry established within the municipality shall, when and where the Council deems necessary, provide for drainage disposal, and elimination of smoke and odours, which the Council may consider detrimental to health and amenity.

(e) In addition to the industrial uses set out in the definition above, it shall be competent for land which is being used for industrial purposes to be used for residential, but not business purposes as set out in the Business Areas Clause.

(f) In the case of lands in the Third Schedule ceasing to be used for industrial purposes for a period of twelve months, then the land shall not thereafter be used for industrial purposes, but only for the use permitted by this Scheme.

14.—Special Areas—Recreation.

(a) The Special Areas—Recreation are defined as the lands described in the Fourth Schedule and shown on the Zoning Plan No. 2.

(b) These lands may be used for the establishment thereon of such recreational uses as the Council may approve.

15.—Service Station Areas.

(a) The Service Station Areas are defined as the lands described in the Fifth Schedule and shown on the Zoning Plan No. 2.

(b) These lands may be used for the purpose of Service Stations only, and Service Stations are prohibited elsewhere within the municipality.

First Schedule.

1. General Residential Zone—G.R.4:

IT is hereby notified, for public information, that the Hon. Minister for Mines has approved of the undermentioned rules and scale of fees to come into operation as from the 1st January, 1968.

(1) Assays, analyses and tests may be made of any Western Australian raw material or manufactured product by the Government Chemical Laboratories when not unduly interfering with official work, subject to the pre-payment of the fees set out below and the conditions laid down in paragraphs (4) and (6) hereunder.

(2) Reductions of the usual fees may be allowed under certain conditions, viz.:

(a) for a number of samples submitted by the one person at the one time for identical treatment:—

Five to ten (inclusive) 20% reduction.
 Eleven or more 25% reduction.

A special reduced fee may be charged where the extra work involved in a number of samples is so small as to warrant a special fee.

(b) Agricultural materials, including waters, will be charged at one-half rates to persons who provide evidence that they are bone fide prospectors, farmers, market gardeners, orchardists, graziers or other primary producers (name of owner or occupier, location number of site of sample, etc.) and that the examination is needed for the proper conduct of their business as such.

(c) At the discretion of the Director free mineral identifications and assays will be made for prospectors of Western Australian ores and minerals taken from ground not held under gold mining lease, mineral lease, reserve, dredging claim or mineral claim provided the exact locality where the specimen was found is disclosed.

Free assays will not be made of samples showing free gold, or of tailings or other metallurgical products or of umpire samples.

(3) A special fee will be charged for any abnormal, lengthy or intricate investigation, in accordance with the actual cost to the Laboratories. This includes assays for the less commonly occurring elements.

(4) All samples for examination must be addressed to the Director, Government Chemical Laboratories, 64 Adelaide Terrace, Perth, and must be marked on the outside with the name and address of the sender. This information should also be enclosed with the sample(s) and each sample should be distinctly and separately marked. A letter must be sent at the same time stating the reasons why the sample is submitted and enclosing the prescribed fee, or, if applicable, stating the exact locality from which each mineral specimen was taken (paragraph 2c).

(5) Samples will normally be dealt with in order of their receipt, at such times as do not interfere with Departmental work.

(6) The Director reserves the right to refuse to make any particular examination on the ground of (i) the laboratories being already too fully occupied to accept more samples; (ii) the sample being unsuitable for the purpose; or (iii) any other good and sufficient reason. He also reserves the right of publishing after the expiration of 12 months, the result of any assay or other investigation made at the public expense.
