WHEREAS by section 109 of the Land Act, 1933-1965, the Governor may resume, for any purpose as in the public interest he may think fit any portion of land held as a pastoral lease; and whereas it is deemed expedient that the portion of Pastoral Lease 394/1005 described in the schedule hereto, should be resumed for the purpose of "Extension to Exmouth Townsite": Now, therefore, I, the Governor, with the advice and consent of the Executive Council, do by this my Proclamation resume portion of Pastoral Lease 394/1005 for the purpose aforesaid.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order and with power of subleasing; and whereas it is deemed expedient, as follows:—

Corres. 3102/64.—That Reserve No. 27363 should vest in and be held by the Shire of Esperance, in trust for the purpose of "Public Recreation".

Corres. 1265/67.—That Reserve No. 10866 should vest in and be held by the Shire of Wanneroo, in trust for the purpose of "Public Recreation".

ORDER IN COUNCIL.

Corres. 2248/37.

ORDER IN COUNCIL.

WHEREAS by the Forests Act, 1918-1964, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) the Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation;
- (b) after such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication;

and whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the twenty-eighth day of October, 1964, for the revocation in part of the dedication of Crown lands as State Forest; and whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Governor with the advice and consent of the Executive Council doth hereby revoke in part the dedication of Crown land as State Forest No. 37 by excising that portion of such State Forest as is described in the Schedule hereto.

Metropolitan Water Supply.

ORDER IN COUNCIL.

M.W.B. 747790/67.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1965, it is provided that, subject to the provisions of the Act, the Metropolitan Water Supply, Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Shire of Belmont.

The construction of a twenty-four inch diameter cross connection and pressure reducing valve complete with valves and all other necessary apparatus and as shown on Plan M.W.B. 9824.
