STAMP ACT, 1921-1967

Office of the Commissioner of Stamps, Perth, 30th November, 1967.

HIS Excellency the Governor in Executive Council, acting in pursuance of the provisions of section 120 of the Stamp Act, 1921-1967, has been pleased to make the regulations set forth in the Schedule hereunder, to have and take effect on and after the 1st December, 1967.

Schedule. Regulations.

1. In these regulations the Stamp Act Regulations, 1966, pub-Principal lished in the Government Gazette on the 9th February, 1966, as regulation amended thereafter from time to time by notices so published, are referred to as the principal regulations.

- The principal regulations are amended by revoking regulation Reg. 9 substituted. 9 and substituting the following regulation:-

 - 9. In lieu of a stamped receipt, the Commissioner may, in the following cases, approve of an alternative method which, in his opinion, will ensure the payment of duty equal to the required receipt duty, which method shall, if adopted, be deemed a sufficient compliance with the law—
 - (a) where more than one payment, the receipt whereof is liable to duty, of wages, salary or pension is acknowledged on one sheet of paper, the total duty payable may be denoted thereon by one stamp either adhesive or impressed, and if adhesive, it may be cancelled by the employer;
 - (b) where more than one payment, the receipt whereof is liable to duty, of wages, salary or pension is made regularly by an employer to his employees or former employees, and it is so agreed between them, the employer shall deduct the amount of receipt duty charactels on such payments from the employer on such payments from the employer. chargeable on such payments from the amounts paid, and account to the Commissioner for the total of such duty as follows:-
 - (i) by affixing adhesive duty stamps of an equivalent value to the total of such duty to the wages or salaries records of such payments;

- (ii) by having the records of such payments impressed with the total of such duty;
- (iii) by, with the Commissioner's approval, accounting to him for the total of such duty by the submission of periodic returns; or
- (iv) by, with the Commissioner's approval, accounting to him by adding the total of such duty to the duty payable on the returns submitted under section 99B of the Act where the employer is a person who has elected under section 99A of the Act;
- (c) an orchardist or other primary producer who consigns fruit, grain, or other produce to a marketing board, fund or other authority, or an auctioneer or other agent, or trustees of a marketing pool, for sale or for sale on his behalf, shall be relieved from giving a stamped receipt for the proceeds of such sale when remitted to him, if a stamp equal to the required duty is affixed to the account sales sent to him, and cancelled by the person who affixes it, the value of which stamp may be charged in such account sales to the orchardist or other primary producer, or if the duty is otherwise accounted for to the Commissioner pursuant to the Act and these regulations;
- (d) if an orchardist or primary producer referred to in paragraph (c) of this regulation has made an election under section 99A of the Act, he may deduct such amounts received on which duty has been paid in accordance with the provisions of that paragraph, in a similar manner as exempt amounts are a deduction from his total of amounts received, to determine the dutiable amount on which the amount payable under section 99B is calculated;
- (e) any company, firm or person receiving approval to submit a periodic return in accordance with the provisions of regulation 10 of these regulations.

- 3. Regulation 9A of the principal regulations is amended as follows:—
 - (a) as to subregulation (7), by-
 - (i) deleting the word "appropriate" in line 6 of paragraph (a);
 - (ii) adding after the word "received" in line 3 of paragraph (b) the words "or deemed to have been received";
 - (iii) adding after the word "paid" in line 4 of paragraph (b) the words "or deemed to have been paid"; and
 - (iv) adding after the word "deposited" in line 4 of paragraph(b) the words "with or deemed to have been deposited";
 - (b) as to subregulation (10) by-
 - (i) adding after the word "received" in line 3 the words "or deemed to have been received";
 - (ii) adding after the word "paid" in line 3 the words "or deemed to have been paid"; and
 - (iii) adding after the word "deposited" in line 4 the words "with or deemed to have been deposited".

Reg. 10 amended.

- 4. Regulation 10 of the principal regulations is amended as follows:—
 - (a) by adding after subregulation (1) the following subregulation:—
 - (1a) The Commissioner may approve of any body or person referred to in paragraph (c) of regulation 9 of these regulations making periodic payments of the

stamp duty payable on the account sales sent to orchardists or other primary producers in lieu of the individual stamping of such account sales.;

- (b) as to subregulation (2), by adding-
 - (i) after the expression "(1)" in line 2 the passage "or (1a)";
 - (ii) after the passage "firm," in line 7 the passage "body,";
- (c) by adding after the word "instruments" in line 2 of subregulation (4) the passage ", not including receipts, and insurance policies and renewals of insurance policies,".
- 5. The Schedule to the principal regulations is amended by Schedule revoking Form P and Form R and substituting the following $^{\rm amended}$. forms:—
