WHEREAS it is enacted, *inter alia*, by subsections (1) and (5) of section 93 of the Electoral Act, 1907-1967 that a Province or District which is wholly or partly in any portion of the State, other than the North-West-Murchison-Eyre Area as defined in the Electoral Districts Act, 1947, may be declared by proclamation to be a remote area to which section 93 of the Electoral Act, 1907-1967 applies; and whereas the Boulder-Eyre Electoral District, the Merredin-Yilgarn Electoral District and the Murchison Electoral District were so declared by a proclamation made the 24th January, 1962 and published in the *Government Gazette* on the 24th February, 1962; and whereas by subsection (5) of that section, the Governor may by subsequent proclamation cancel a proclamation so made; now, therefore, I, the Governor, acting with the advice and consent of the Executive Council, and in exercise of the power conferred upon me by section 93 of the Act do hereby cancel the proclamation made the 24th February, 1962 and do by this proclamation declare the Boulder-Dundas Electoral District, the Kalgoorlie Electoral District, the Merredin-Yilgarn Electoral District and the Roe Electoral District to be remote areas, to which section 93 of the Electoral Act, 1907-1967 applies.

SUPREME COURT ACT, 1935-1964.

Rule of Court.

(Sittings and Winter Vacation for 1968.)

WE, the Honourable Sir Albert Wolff, K.C.M.G., Chief Justice of Western Australia and the Honourable Sir Lawrence Walter Jackson, Kt., Senior Puisne Judge, and the Honourable John Evenden Virtue, the Honourable Roy Vivian Nevile, the Honourable Gordon Bede D'Arcy, the Honourable John Hale, and the Honourable Oscar Joseph Negus, Puisne Judges of the Supreme Court of Western Australia, in pursuance of the powers conferred by the Supreme Court Act, 1935-1964, and the Rules of the Supreme Court, 1909, and of every other power enabling us in this behalf, hereby order as follows:—

1.—CIVIL SITTINGS.

The Civil Sittings of the Supreme Court for the trial of actions and issues of fact during the year 1968 shall be eleven in number and shall commence on the days hereunder mentioned, that is to say—

ORDER IN COUNCIL.

Corres. 2127/67.

WHEREAS by section 33 of the Land Act, 1933-1965, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any Municipality, Body Corporate, or other person or persons to be named in the Order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such Order and with power of sub-leasing; and whereas it is deemed expedient that Reserve No. 28839 should vest in and be held by the Shire of Port Hedland in trust for the purpose of "Housing": Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby, direct that the before-mentioned Reserves shall vest in and be held by the Shire of Port Hedland in trust for "Housing" with power to the said Shire of Port Hedland subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said Reserves for any term not exceeding one year from the date of the lease; such leases shall be renewable from year to year but subject to determination at three months' notice by either party after the initial term of one year.

Local Government Act, 1960.

ORDERS IN COUNCIL.

WHEREAS by section 288 of the Local Government Act, 1960, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the *Government Gazette* to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the Councils mentioned in the schedule hereunder, have requested that certain lands named and described in the said schedule, which have been reserved for streets within the said Councils, declared public streets: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be public streets, and such land shall, from the date of this Order, be absolutely dedicated to the public as streets within the meaning of any law now or hereafter in force.

- (c) That with respect to a net known as or called a "hauling net", when used or intended to be used for the catching of yellow-eye mullet, a net of not more than 300 yards in length having meshes throughout of not less than $2\frac{1}{8}$ inches shall, when used or intended to be used during the months of May, June and July in each year in the Swan and Canning Rivers and their affluents and tributaries, except that portion defined in the First Locality Schedule hereto, be a lawful net.
- (d) That with respect to a net known as or called a "sunk net", being a net the ground or lead line of which is moved along the bottom and the cork line of which is submerged during the process of hauling, a net of not more than 200 yards in length whereof the bunt does not exceed $66\frac{2}{3}$ yards or $\frac{1}{3}$ of the total length of the net, whichever is the less and having meshes of not less than 3 inches in the wings and 2 inches in the bunt shall, during the months of May, June, July, August and September in each year, when used or intended to be used for catching all species of fluviomarine fishes in the waters of the Swan River as defined in the Second Locality Schedule hereto, be a lawful net.

- (g) That with respect to a net known as or called a "crab set net", a net of not more than 70 yards in length having meshes throughout of not less than $2\frac{1}{2}$ inches shall, when used or intended to be used for taking crabs in the waters of the Swan and Canning Rivers and their affluents and tributaries, except that portion defined in the First Locality Schedule hereto, be a lawful net.
