WHEREAS it is enacted by section 18 of the Rights in Water and Irrigation Act, 1914-1964, that the Governor may by proclamation declare any part of the State lying north of the twenty-sixth parallel of South Latitude, named or defined in the proclamation to be a proclaimed area for the purposes of section 18 of the said Act; and whereas any proclamation previously issued under the authority of this section may be varied or cancelled: Now, therefore, I, the said Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, do hereby declare that part of the State lying north of the twenty-sixth parallel of South Latitude as described in the schedule hereto as shown marked and defined on Plan P.W.D., W.A. 44571-1-1 as kept in the Public Works Department, to be a proclaimed area for the purposes of the said section 18 of the said Act.

WHEREAS by the Metropolitan Water Supply Sewerage and Drainage Act, 1909-1967, it is provided that subject to the provisions of the Act, the Metropolitan Water Supply Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Workers' Compensation Act, 1912-1967.

ORDER IN COUNCIL.

WHEREAS by subsection (5) of section 6 of the Workers' Compensation Act, 1912-1967, it is enacted that if the Governor is satisfied that by the laws, operating similarly to the provisions of that Act, of any other country, whether part of the Dominions of the Crown or not, compensation for injury by accident to a deceased worker is payable to his dependants who are resident in this State, the Governor may, by Order in Council, declare that when a worker is so injured in this State and dies as a result of the injury, his dependants who are not resident in this State shall have the same rights and remedies under the provisions of the Act, as if they were resident in this State: Now, therefore, His Excellency the Governor, being so satisfied, doth with the advice and consent of Executive Council by this Order declare that when a worker is injured in this State and dies as a result of the injury his dependants, who are resident in the Netherlands, shall have the same rights and remedies under the provisions of the said Act as if they were resident in this State.

IT is hereby notified that the Arrangement set forth hereunder has been entered into by His Excellency the Governor General of the Commonwealth and His Excellency the Governor of the State of Western Australia.

AN ARRANGEMENT made between HIS EXCELLENCY THE GOVERNOR-GENERAL OF THE COMMONWEALTH OF AUSTRALIA, acting with the advice of the Federal Executive Council, and HIS EXCELLENCY THE GOVERNOR OF THE STATE OF WESTERN AUSTRALIA, acting with the advice and consent of the Executive Council of the State, WHEREBY, in pursuance of section 15 of the Petroleum (Submerged Lands) Act 1967-1968 of the Commonwealth and of section 16 of the Petroleum (Submerged Lands) Act, 1967 of the State, IT IS ARRANGED as follows:—

1. The powers and functions of the Designated Authority under the Commonwealth Act and the Regulations in respect of the adjacent area of the State may be exercised and performed—

- (a) by the person who for the time being holds the office of Minister for Mines of the State; and
- (b) by a person who is for the time being performing the duties, or acting for or on behalf of the holder, of the office of Minister for Mines of the State.

2. A person who is entitled to exercise the powers and perform the functions of the Designated Authority in respect of the adjacent area of the State by virtue of clause 1 of this Arrangement may, by instrument under his hand, delegate to a person holding office in the State all or any of such of those powers and functions as are hereinafter specified in relation to that person, namely—

- (a) to a person who for the time being holds, or who is authorized for the time being to act as the holder of, the office specified in Part A of the First Schedule hereto—the powers and functions specified in Part B of that Schedule;
- (b) to a person who for the time being holds, or who is authorized for the time being to act as the holder of, the office specified in Part A of the Second Schedule hereto—the powers and functions specified in Part B of that Schedule;
- (c) to a person who is an officer of the Department of Mines of the State and is an inspector appointed under section 125 of the Petroleum (Submerged Lands) Act 1967-1968 of the Commonwealth—the powers and functions specified in the Third Schedule hereto.

3. A person who is entitled to exercise the powers and perform the functions of the Designated Authority in respect of the adjacent area of the State by virtue of clause 1 of this Arrangement shall, when delegating a power under section 101 of the Petroleum (Submerged Lands) Act 1967-

1968 of the Commonwealth or under section 101 of the said Petroleum (Submerged Lands) Act, 1967 of the State, take appropriate steps to ensure—

- (a) that the delegate exercising the power under the delegation shall do so only in case of urgency in which it is not reasonably practicable for the person first mentioned in this clause to exercise the power; and
- (b) that the delegate forthwith reports to the person first mentioned in this clause concerning each exercise of the power.

4. A person to whom a power or function is for the time being delegated in accordance with clause 2 of this Arrangement may exercise the power or perform the function in accordance with the instrument by which the power or the function has been delegated.

5. This Arrangement shall take effect on and from the date it is made as hereinafter appears.

6. In and for the purposes of this Arrangement, except where a contrary intention appears—

- (a) 'the State' means the State of Western Australia;
- (b) 'the Commonwealth Act' means the Petroleum (Submerged Lands) Act 1967-1968 of the Commonwealth and the Acts with which that Act is incorporated and, if the Commonwealth Act is at any time amended, means the Commonwealth Act as so amended;
- (c) 'the Regulations' means the regulations under the Commonwealth Act as in force for the time being; and
- (d) words that are defined in the Commonwealth Act have the same respective meanings as in the Commonwealth Act.

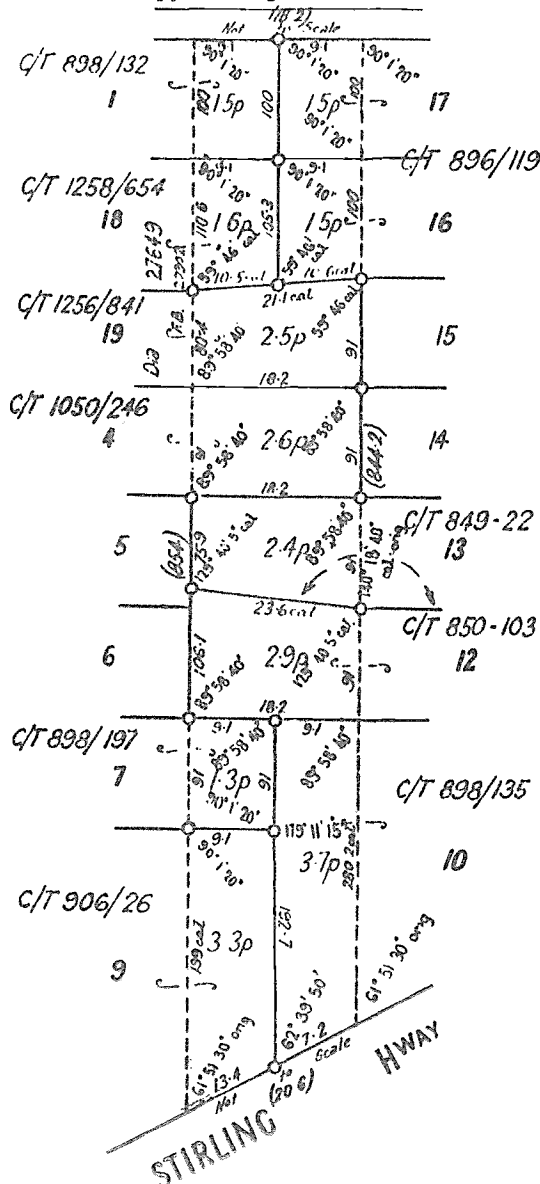
