WHEREAS it is enacted (*inter alia*) by subsection (2) of section 6 of the Marking of Lamb and Hogget Act, 1967, that the Governor may from time to time by proclamation declare that subsection (1) of that section does not apply to the area or areas of the State specified in the proclamation: Now, therefore, I, the Governor acting

with the advice and consent of the Executive Council, and in exercise of the powers conferred by subsection (2) of section 6 of the Marking of Lamb and Hogget Act, 1967 and section 11 of the Interpretation Act, 1918-1962, do hereby declare that subsection (1) of section 6 of the first-mentioned Act does not apply to any area of the State other than the areas described in the schedule hereunder.

Schedule.

All those areas of the State comprised within the circumference of a circle having a radius of 25 miles from the G.P.O. at Perth as its centre and also all those areas of the State outside the circumference of that circle which are comprised within the boundaries of every Municipal District constituted under the Local Government Act, 1960-1967 through which the circumference of that circle passes.

Constitution Act, 1889-1963.

ORDER IN COUNCIL.

P.W. 1060/58.

WHEREAS section 74 of the Constitution Act, 1889-1963, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that such power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Board) as vested in George Alfred Miles by Order in Council of June 6, 1947, should be revoked: Now, therefore, His Excellency the Governor by and with the advice of the Executive Council hereby revokes the power vested in George Alfred Miles of the appointment of foremen and all other persons employed on such works at a daily rate of wage.

Local Government Act, 1960.

ORDERS IN COUNCIL.

WHEREAS by section 288 of the Local Government Act, 1960, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the *Government Gazette* to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the Councils mentioned in the schedule hereunder have requested that certain lands named and described in the said schedule, which have been reserved for streets within the said Councils, be declared public streets: Now, therefore, His Excellency the Governor by and with the advice and consent of the

Executive Council, doth hereby declare the said lands to be public streets, and such land shall, from the date of this Order, be absolutely dedicated to the public as streets within the meaning of any law now or hereafter in force.
