## PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency The Honourable Sir Albert

WHEREAS it is enacted by section 18 of the Native Welfare Act, 1963, that the Governor may by proclamation declare any Crown Lands to be Reserves for Natives and abolish any Reserve so declared; and whereas by proclamation issued under the Native Welfare Act, 1963, and published in the *Government Gazette* on the 20th July, 1962, the Governor declared an area at Port Hedland more particularly described as Reserve No. 26362 and defined in the schedule to such proclamation to be a Reserve for Natives; and whereas it is now deemed desirable and expedient to abolish the said Reserve: Now, therefore, I, the Lieutenant Governor and Administrator acting with the advice and consent of the Executive Council and in exercise of the power in that behalf conferred by section 18 of the Native Welfare Act, 1963, do hereby abolish the Reserve for Natives as declared and described and defined in the hereinbeforementioned proclamation published in the *Government Gazette* on the 20th July, 1960, as aforesaid; and whereas it is deemed desirable that a Reserve for Natives should be declared at Port Hedland: Now, therefore, I, the said Lieutenant Governor and Administrator, with the advice of the Executive Council, do hereby declare all that portion of land, containing approximately 4 acres 3 roods 24 perches being Lot 953, to be a Reserve for Natives (No. 29084).

## PROCLAMATION

WHEREAS it is enacted by section 27 of the Rights in Water and Irrigation Act, 1914-1964, that the Governor, without constituting any irrigation district under Part IV of the said Act, may, on the recommendation of the Minister and acting with the advice of the Commissioners appointed under subsection (4) of section 3 of the Act, at any time and from time to time by Proclamation declare that Part III of the said Act shall extend to and have effect in and throughout any portion of the State to be defined in the proclamation, and shall apply to and have effect in relation to all rivers, streams, watercourses, lagoons, lakes, swamps or marshes situated within that portion of the State specified and defined aforesaid, but that no such declaration shall be made until after the expiration of thirty days after notice of intention to make such declaration has been given to the local authority or local authorities in or through whose district or districts such rivers, streams, watercourses, lagoons, swamps, lakes or marshes run or are situated to the intent that before the making of such declaration any objection by such local authority or local authorities may be considered; and whereas the Minister has recommended and the Commissioners have advised the Lieutenant Governor by Proclamation to declare that Part III of the said Act shall extend to and have effect in relation to that portion of the State that is defined in the schedule to this Proclamation and shall apply to and have effect in relation to all rivers, streams, watercourses, lagoons, lakes, swamps, and marshes situated within that portion of the State; and whereas after due notice given the local authority or local authorities concerned have not made any objection to the proposed declaration: Now, therefore, I, the Lieutenant Gov-

ernor, acting with the advice and consent of the Executive Council and on the recommendation of the Minister and with the advice of the Commissioners and in exercise of the powers conferred by the said Act, do hereby declare that Part III of the Rights in Water and Irrigation Act, 1914-1964, shall extend to and have effect in and throughout the portion of the State as defined in the schedule hereto and shall apply to and have effect in relation to all rivers, streams, watercourses, lagoons, lakes, swamps and marshes situated within that portion of the State and which portion is, for the purposes of that Act, to be known as the Greenough River and Tributaries Catchment Area.

Greenough River and Tributaries  
Catchment Area.

All that portion of land delineated and shown bordered in red on Lands and Surveys Department Miscellaneous Plan 384, (also shown bordered in blue on Public Works Department Plan W.A. 43922).

PROCLAMATION

WHEREAS it is enacted by subsection (2) of section 12A of the Fisheries Act, 1905-1967, that the Governor on the recommendation of the Minister, may at any time and from time to time declare a specific portion of the State south of the thirty-second parallel being any part of the seashore up to high water mark, and any portion of Western Australian waters contiguous to that part of the seashore, to be a proclaimed fishing zone for the purposes of that Act during any specified time in any specified year, or during a specified portion of every year; and whereas the Minister has recommended that the part of the seashore up to High Water Mark and the portion of Western Australian waters contiguous to that part of the seashore, as specified and described in the schedule hereunder, such seashore and contiguous waters being a specific portion of the State south of the thirty-second parallel, be declared a proclaimed fishing zone for the purposes of the Act referred to during the periods hereafter in this Proclamation mentioned: Now, therefore, I, the Lieutenant Governor, acting with the advice and consent of the Executive Council, do hereby declare that the part of the seashore up to High Water Mark and the portions of Western Australian waters contiguous to that part of the seashore, as specified and described in the schedule hereunder, shall be a proclaimed fishing zone for the purposes of the Fisheries Act, 1905-1967, during the period commencing on the 15th day of February, 1969, and ending on the 30th day of April, 1969, and during the period commencing on the 15th day of February and ending on the 30th day of April in each and every year thereafter.

Schedule.

All those waters bounded by lines starting from a point on the High Water Mark of Two Peoples Bay situate in prolongation easterly of the northern boundary of Plantagenet Location 3985 (Reserve 27956) and extending easterly along that prolongation 40 chains; thence north-northeasterly

to a point on the High Water Mark of Two Peoples Bay aforesaid; situate in prolongation southerly of the easternmost eastern boundary of location 3777 and thence generally southerly along that mark to the starting point.

ORDER IN COUNCIL.

F.D. 25/67.

WHEREAS the enactment contained in section 74 of the Constitution Act, 1889, whereby the appointment of all public officers under the Government of the State is vested in the Governor in Council, does not apply to minor appointments which by Act of Legislature or by Order in Council may be vested in the heads of departments or other officers or persons within the State; and whereas it is desirable that the appointment of persons as employees of the Forests Department and its branches at a daily or weekly rate of wages should be vested in Charles Edward Peaty or any person appointed to temporarily act in place of such officer: Now, therefore, His Excellency the Lieutenant Governor and Administrator by and with the advice of the Executive Council hereby vests in Charles Edward Peaty and any person appointed to temporarily act in place of such officer the appointment of persons as employees of the Forests Department and its branches at a daily or weekly rate of wages.

Corres. 6158/09.—That Reserve No. 13161 should vest in and be held by the Minister for Mines, in trust for the purpose of "an Explosive Magazine Site".

Corres. 6049/11.—That Reserve No. 13500 should vest in and be held by the Minister for Mines, in trust for the purpose of "an Explosive Magazine Site".

Corres. 13208/11.—That Reserve No. 13867 should vest in and be held by the Minister for Mines, in trust for the purpose of "an Explosive Magazine Site".

Corres. 946/47.—That Reserve No. 22663 should vest in and be held by the Shire of Manjimup, in trust for the purpose of "Recreation and Show-ground".

(The Order in Council dated the 11th June, 1947, is hereby superseded.)

Corres. 2300/67.—That Reserve No. 29229 should vest in and be held by the Shire of Kondinin, in trust for the purpose of "Club and Club Premises".

Corres. 1328/68.—That Reserve No. 29230 should vest in and be held by the Shire of Kondinin, in trust for the purpose of "Public Recreation".

Now, therefore, His Excellency the Lieutenant Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserves shall vest in and be held by the abovementioned bodies, in trust for the purposes aforesaid, with power to the said bodies, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said Reserves for any term not exceeding 21 years from the date of the lease subject nevertheless to the powers reserved to him by section 37 of the said Act.

## ORDER IN COUNCIL.

P.W.W.S. 148/68, M.W.S. 878541/64.

WHEREAS by section 8 of the Country Areas Water Supply Act, 1947-1964, and by section 7 of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1967, it is enacted that the Governor may, by Order in Council, from time to time alter or extend the boundaries of a country water area and of the Metropolitan Water, Sewerage and Drainage Area, or of any District thereof; and whereas it is desirable to alter the boundaries of the said areas and of the Metropolitan Water and Sewerage District, as hereinafter described: Now, therefore, the Lieutenant Governor and Administrator by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Acts, doth hereby order and declare as follows:—

That the boundaries of the Goldfields and Agricultural Country Water Area are hereby altered by excising therefrom, and that the boundaries of the Metropolitan Water, Sewerage and Drainage Area and of the Metropolitan Water and Sewerage District are hereby extended by adding thereto, the land described in the schedule hereto.

## Schedule.

Excision from Goldfields and Agricultural Country Water Area and Extension of Metropolitan Water, Sewerage and Drainage Area.

(a) All that portion of land bounded by lines starting from the southeastern corner of Lot 1 of Swan Locations 12, 327 and 1253, as shown on

Land Titles Office Diagram 12001, a point on the present boundary of the Metropolitan Water, Sewerage and Drainage Area, and extending easterly along northern boundaries of locations 3264 (A Class Reserve 7537), 1895, Reserve 11140, locations 7762, 2746 (Reserve 15955) and 1884 to the eastern side of Roland Road (Road Number 2004); thence generally northerly along that side to the southern alignment of Cameron Road (Road Number 10668); thence easterly along that alignment to the western side of Stoneville Road; thence generally southerly along that side to a point situate in prolongation westerly of the northern boundary of Lot 19 of Location 1310, as shown on Land Titles Office Plan 5646; thence easterly and southerly to and along boundaries of that lot to the northern boundary of location 12, as shown on Land Titles Office Plan 5828; thence easterly, southerly and westerly along boundaries of that location to the northeastern corner of location 2044; thence southerly along eastern boundaries of that location and location 2045 to the northern boundary of location 2086; thence easterly, southerly and westerly along boundaries of that location to the eastern boundary of Location 1956; thence southerly and westerly along boundaries of that location to the north-eastern corner of location 1850; thence southerly along the eastern boundary of that location to the northwestern corner of location 1995; thence easterly and southerly along boundaries of that location and onwards to the northern side of the Parkerville to Mount Helena Railway Reserve; thence generally easterly along that side to a point situate in prolongation northerly of the western boundary of location 1828; thence southerly to and along that boundary to the northern side of Stoneleigh Road; thence easterly along that side to the northwestern side of Sexton Road; thence northeasterly along that side to the northern alignment of Horace Street; thence easterly along that alignment and the northern boundary of location 1868 and onwards to the southeastern side of Sawyers Road; thence generally southwesterly along that side and the northwestern side of a 4 chain Pipe Track Reserve, to the eastern boundary of location 986; thence southerly along that boundary to the northwestern side of a 2 chain Pipe Track Reserve; thence southwesterly along that side and onwards to the northern boundary of Sawyers Valley Lot 44 (Reserve 6242); thence westerly and southerly along boundaries of that lot and onwards to a northern boundary of the Helena River Reservoir Catchment area (Reserve 6203); thence generally westerly along that boundary to a point situate in prolongation southerly of the western boundary of Sawyers Valley Lot 53; thence northerly to and along that boundary to the northeastern corner of Swan Location 1930; thence generally west-southwesterly along the northern boundary of that lot to the northernmost northwestern corner of Mundaring Suburban lot 100; thence easterly, southerly and westerly along boundaries of that lot and westerly along southern boundaries of lots 99 and 98 to the eastern boundary of Mahogany Creek lot 51; thence south-southeasterly and west-southwesterly along boundaries of that lot and west-southwesterly along southern boundaries of lot 52 (Reserve 1226) and Swan Location 1192 to the southwestern corner of that location, a point on the northern boundary of the Helena River Reservoir Catchment Area (Reserve 6203) aforesaid; thence generally southerly along that boundary to the southern boundary of location 1492; thence southwesterly, southeasterly and easterly along boundaries of the Helena River Reservoir Catchment Area (Reserve 6203) aforesaid, to the eastern side of Road Number 3447; thence generally southerly along that side to a point situate in prolongation easterly of the northern boundary of location 4898; thence westerly to the north-eastern corner of that location; thence westerly, southerly, again westerly and again southerly along boundaries of State Forest Number 50, as shown on Lands and Surveys Original Plan 5166, to the northwestern corner of Swan Location 3328; thence south-

westerly along the northwestern boundary of that location to the northern boundary of location 2621; thence westerly along that boundary and northern boundaries of locations 990 and 1037 to the northwestern corner of the last mentioned location; thence southerly along the western boundary of that location to the northernmost northeastern corner of Reserve 23118; thence southwesterly and northwesterly along boundaries of that reserve to its intersection with a line joining the northwestern corner of location 1421 and the southwestern corner of Reserve 5342, a point on the present boundary of the Metropolitan Water, Sewerage and Drainage Area aforesaid, and thence generally westerly and generally northerly along that boundary to the starting point, being the land delineated and shown bordered blue and marked "A" on Plan P.W.D., W.A. 44659-1-1 and on Plan M.W.B. 9932.

(b) All that portion of land bounded by lines starting from a point on the eastern boundary of Reserve 7889 (Pipe Track) situate in prolongation westerly of the northern boundary of Swan Location 1867 and extending easterly along that prolongation to the northwestern corner of that location; thence southerly and easterly along boundaries of that location to the northwestern corner of location 1829; thence southerly along the western boundary of that location and onwards to the southern side of Great Eastern Highway; thence generally northeasterly along that side to a point situate in prolongation southerly of the eastern side of Bambrook Street; thence northerly to and along that side to the northwestern corner of Sawyers Valley Lot 123; thence easterly and southerly along boundaries of that lot and southerly along the eastern boundary of lot 150 to the northern side of Great Eastern Highway aforesaid; thence generally easterly along that side to a northwestern boundary of the Helena River Reservoir Catchment Area (Reserve 6203); thence generally southwesterly and northwesterly along that boundary to the westernmost northwestern corner of Sawyers Valley Lot 6; thence northeasterly along a northwestern boundary of that lot to its northernmost northwestern corner; thence northwesterly to the southernmost south-eastern corner of the northern severance of lot 44; thence northerly, easterly, again northerly and westerly along boundaries of that lot to a point situate in prolongation southwesterly of the southeastern side of a 2 chain Pipe Track Reserve; thence northeasterly along that side to the eastern boundary of Swan Location 986; thence southerly along that boundary to the southeastern side of a 4 chain Pipe Track Reserve; thence generally northeasterly along that side and onwards to the eastern side of Sawyers Valley Lot 134 (Reserve 12527) and thence northeasterly to the starting point, being the land delineated and shown bordered blue and marked "B" on Plan P.W.D., W.A. 44659-1-1 and on Plan M.W.B. 9932.

Workers' Compensation Act, 1912-1967.

ORDER IN COUNCIL.

2. By deleting Clause 24 "Uses" and substituting in its place the following:—

(24) Uses: No person shall use any land or any building or structure in a General Industrial Zone except for one or more of the following uses:—

- (a) Aerated water and cordial making, agricultural machinery and implements, bicycle making and repairing, blacksmithing, blind making, book binding, bootmaking and repairing, box making, brush making, builders yard, builders merchant, block making, cabinet making, canister making, carriers or carters depot, case making, chair making, clothing manufacturer, commercial garage, cool store, coppersmith, dairy and milk depot, dicasting, dying and cleaning, electrical contracting and engineering, electro typing and stereo typing, electro plating, enamelling and engraving, fence and gate making, glazier, gunsmith, hardware manufacturer, joinery works, light engineering, monumental mason, motor engineering, motor repairs, painting, decorating and paper hanging, paper products, pastry cook, pattern making, plumbing and lead working, plumbing contractor, sheet metal working, shop and office fittings, sign writing, tinsmithing, tool making, upholstery, warehouse, open air storage, wholesale stores, woodturning and carving, a bulkstore a depot of a Government Department, Public Authority or Council, fuel depot, public open space, a car park, transport terminal, plastics factory, and other similar approved industries.

(b) Office, show-room in connection with any other use permitted in this zone.

(c) Dwelling house subject to the conditions specified in Clause No. 25.

3. By deleting Clause 25 "Industrial Zone Provisions" and substituting in its place:—

(a) The owner of the land on which a building is erected shall provide on the land or on land adjacent to the land on which the building is erected, permanent parking spaces sufficient to accommodate one car space for each two persons likely to reside or work in the building, or on the subject land.

(b) In the case of an industry in which employees work on shift work, the said parking spaces shall be sufficient to accommodate one car space for every two persons likely to be employed in the two largest shifts. Car spaces shall be provided on the basis of 242 sq. ft. per car.

(c) The parking spaces shall be so located that the vehicles have easy access thereto and the owner of the land whereon provision is to be made for parking spaces in conformity with this requirement, shall before any buildings are constructed or extended, lodge with the Council a plan on which it is delineated all parking spaces and access lanes to be provided in accordance with this requirement. The owner shall at all times clearly indicate on the ground the boundaries of all parking spaces and access lanes in conformity with the said plan.

(d) The owner shall, when lodging the plan referred to hereto, lodge with the Council a certificate stating the total number of persons employed and the number likely to reside or work in the building for which the parking spaces are shown on the plan lodged with the Council and in the case of an industry in which employees are employed in shift work, the total

- number of persons likely to be employed in the two shifts in which the largest number of persons are employed.
- (e) No person shall use a service road, accessway, or parking area situated on a parcel of land for any other purpose than a service road accessway or vehicle parking respectively.
- (f) No building or any other structure shall be erected closer than a distance of 50 ft. from any part of a residential zone, except with the approval of Council. Trees shall be planted and maintained in this setback to provide a suitable screen.
- (g) No building shall exceed two stories in height provided that this will not apply in the case of storage silos, water towers and similar uses.
- (h) Where any building is used or intended to be used for the purpose of classes, 6, 7 and 8, occupancy, as defined in the Uniform General Building By-laws of Western Australia, there shall be provided accommodation in the form of loading docks for vehicles delivering goods to or removing goods from such a building, every loading dock shall be so located that no portion of any vehicle occupying or adjoining same, shall project over the street alignment and where a site has an abutment to more than one street, the responsible authority may require that access to loading docks shall be only from such street or streets, as it shall so determine.
- (i) No buildings shall be constructed closer than 60 ft. to the alignment of the main road frontage or closer than 20 ft. to the alignment of the lesser road frontage unless the frontages are the same in which case, there shall be a setback of such distance from such frontage as may be nominated by the Council.
- (j) The whole of any wall or building facing any street shall be constructed in brick, concrete or masonry.
- (k) Notwithstanding the provision of the preceding paragraph an owner builder or architect may apply to the responsible authority for permission to use materials other than those prescribed and the responsible authority after consideration of a report by the Building Surveyor, may permit the use of such other materials, where it is satisfied that such use will not defeat the objects of the preceding paragraph.
- (l) Each open yard shall be screened from public roads by a close fence or wall not less than 6 ft. in height unless with special permission of Council.
- (m) The ground floor area of all buildings on any site shall not exceed 60 per cent. of the area of the site.
- (n) No person shall stack or place any fuel, raw materials, products or by-products or waste of manufacture in an industrial zone nearer to the road or street than the building setback line.
- (o) No person shall use the land between the building setback line and the road or street for any purpose other than a means of access, for parking of vehicles, for loading or unloading vehicles, or for lawns and gardens.
- (p) Save with the permission of the responsible authority, no advertising sign shall be erected in front of any building line whether prescribed herein or by the by-laws of the responsible authority. Any such sign shall be limited in size to 43 sq. ft. on which shall be marked only the name and occupation of the occupier.
- (q) On the same site as an industrial building, a dwelling house may be erected which forms part of or adjoins the industrial building. Such house is to be occupied by a caretaker or an employee of the industry and set aside for the exclusive use of the occupants. Where it is established that such a dwelling house is necessary for the proper operation of the industry, but not more than one such residence for each industrial site.
- (r) No person shall occupy a residence in an industrial zone as outlined in (q) above, if the industrial undertaking ceases to operate.

- (b) Spraying with 2,4-D ester at the rate of 2 lb. acid equivalent per acre. Two pints of 80% 2,4-D ester contains 2 lb. acid equivalent.
