ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1967, it is *inter alia*, made lawful for the Governor by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole

or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid: and whereas it is deemed expedient as follows:—

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1967, it is, *inter alia*, made lawful for the Governor to direct that any land reserved pursuant to the provisions of the Act shall be leased for the purpose for which the land is reserved as aforesaid, by Instrument of Lease in the form of the Fourth Schedule of the Act to any person (as defined in the said section); and whereas it is deemed expedient that Reserve 8357 (Bridgetown Lot 522) shall be leased for a term of twenty-one years to the Bridgetown Agricultural Society (Inc.) to be held in trust for the purpose of "Park and Picnic Ground", subject to the following provisions:—

- (a) The land shall not be used for any purpose other than a "Park and Picnic Ground" without the prior approval in writing of the Minister for Lands.
- (b) The Lessee shall not without the previous consent in writing of the Minister for Lands assign, transfer, mortgage, sublet or part with the possession of the demised land.
- (c) No structures will be erected without the prior approval in writing of the Minister for Lands.
- (d) The lessee shall maintain existing and future improvements to the satisfaction of the Minister for Lands.
- (e) Compensation shall not be payable to the lessee in respect of any improvements effected by him on the demised land and remaining thereon at the expiration or earlier determination of the lease.
- (f) It shall be lawful for the lessee at any time within the three calendar months immediately following the expiration of the term or earlier determination of the lease, to take down, remove, and carry away any buildings, structures, improvements and plant the property of the lessee.
- (g) On determination of the lease, the lessee shall fill in, consolidate and level off any unevenness, excavation or hole caused by him during the term of the lease or by removal of his improvements and shall leave the demised land in a clean, neat and tidy condition to the satisfaction of the Minister for Lands and shall remove any or all waste matter as required by the Minister.
- (h) The lessee shall take all reasonable precautions to prohibit the drinking of alcoholic liquor on the premises.
- (i) The Minister or his representative may enter the land for inspection at any reasonable time.

Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the abovementioned reserve shall be leased to the Bridgetown Agricultural Society (Inc.) to be held in trust for the purpose of "Park and Picnic Ground" for a term of twenty-one years at a peppercorn rental.

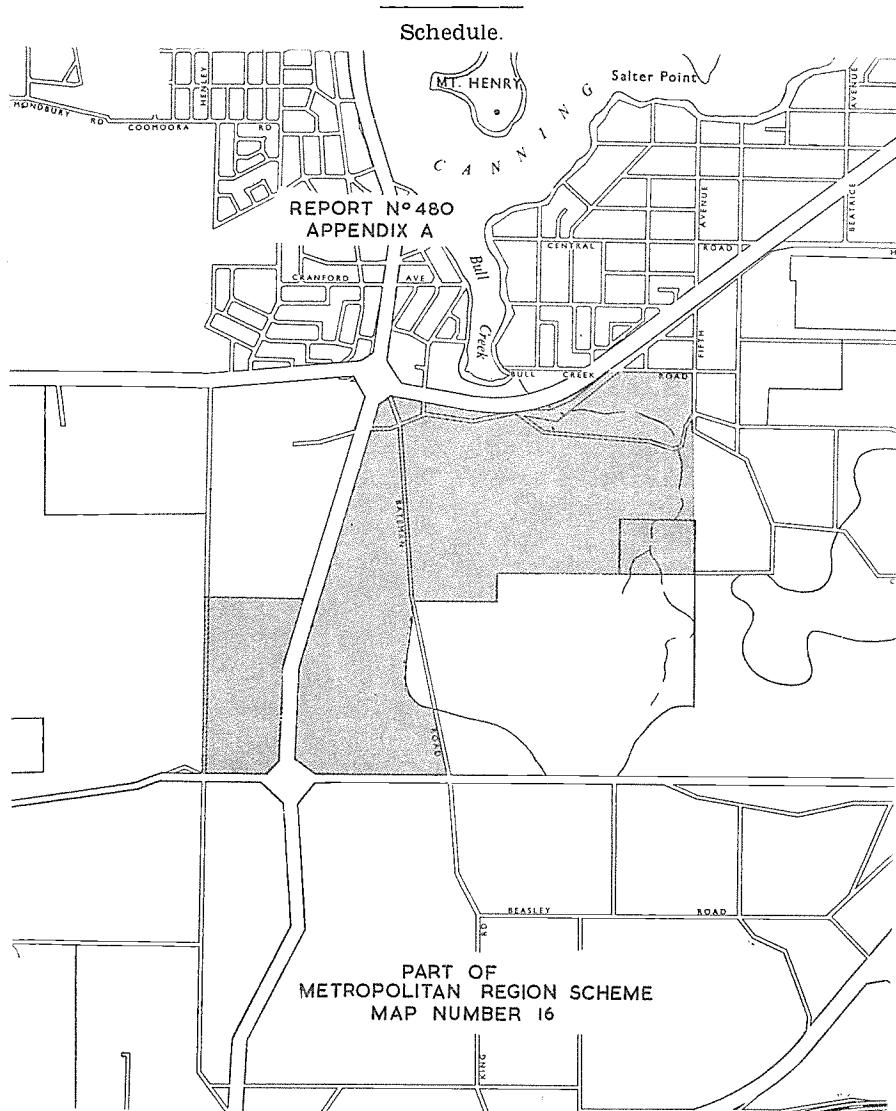
