WHEREAS by section 3 of the Perth Gas Company's Act, 1886-1937, it is enacted that the limits of the Act shall extend to and include the City of Perth, and every place being within a circle of five miles from the General Post Office in the City of Perth and every other place outside the said circle of five miles to which the Governor may, from time to time, by proclamation declare that the Act shall extend; and whereas it is also provided by that section that the Governor shall not make or issue any proclamation under that section to extend the limits of the Act to any place situate within the district of any municipal council or of any road board outside the said circle of five miles unless and until the municipal council or the road board concerned (as the case may be) has by resolution consented thereto; and whereas the Council of the City of Melville has by resolution passed on the 17th day of December, 1968, consented to the extension of the limits of the Act to the portion of the municipal district of the City of Melville described in the Schedule hereunder: Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council, do hereby declare that the limits of the Act shall extend to and include the portion of the municipal district of the City of Melville described in the schedule hereunder and which is outside the said circle of five miles from the General Post Office in the City of Perth.

The Schedule.

All that portion of land bounded by lines starting from the intersection of the left bank of the Swan River (Lucky Bay) with an arc of 5 miles radius from the Fremantle Town Hall (as defined in the Fremantle Gas and Coke Company Act, 1886) and extending generally northeasterly upwards along that bank to its intersection with an arc

of 5 mile radius from the General Post Office (as defined in the Perth Gas Company Act, 1886); thence generally east-southeasterly along that arc to the left bank of the Canning River; thence generally southerly upwards along that bank and the left bank of Bull Creek to a point situate in prolongation northerly of the eastern boundary of Canning Location 27; thence southerly along that prolongation to the centre line of High Road; thence generally easterly and northeasterly along that centre line to the northern alignment of Bulls Creek Road; thence easterly along that alignment to the eastern alignment of Fifth Avenue; thence southerly along that alignment and the eastern boundary of Location 26 to the northwestern corner of location 907; thence southerly, westerly and generally easterly along boundaries of that location to the northwestern alignment of Beasley Road; thence southwesterly along that alignment to the northeastern alignment of Clifton Road; thence generally south-easterly along that alignment to the northern alignment of Leeming Road; thence generally westerly along that alignment to the south-western corner of Jandakot Agricultural Area Lot 453 (Reserve 28600); thence northerly along the western boundary of that lot to a point situate in prolongation easterly of the southern boundary of lot 181; thence westerly along the northern alignment of Leeming Road aforesaid to the western side of Road Number 6222; thence generally northerly along that side to the southern boundary of Cockburn Sound Location 528; thence westerly and northerly along boundaries of that location to the southern side of Ellis Road; thence westerly along that side to its intersection with an arc of 5 mile radius from the Fremantle Town Hall aforesaid and thence generally northerly along that arc to the starting point (Public Plans 341A/40; F44-4; F60-4; F75-4; F76-4 and F77-4.)

ORDER IN COUNCIL.

Lands 3953/67.

WHEREAS by section 33 of the Land Act, 1933-1968, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes to be specified in such order and with power of subleasing; and whereas by section 310 of the Local Government Act, 1960-1968, it is provided, *inter alia*, that where a reserve is vested in a Council, the Council may, except to such extent as the Governor otherwise orders, exercise, in respect of the reserve, such powers and functions as would be conferred upon the Council if it were a Board of Parks and Reserves to which the reserve has been committed under the Parks and Reserves Act, 1895; and whereas it is deemed expedient that Class "A" Reserve No. 29056 should vest in and be held by the Shire of Tambellup in trust for the purpose of "National Park" but that the Council of that Shire should not exercise, in respect of that reserve, the powers referred to in paragraphs (e) and (f) of subsection (1) of section 5 of the Parks and Reserves Act, 1895: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Shire of Tambellup in trust for a "National Park", subject nevertheless to the powers reserved to him

by section 37 of the said Act, and doth hereby order that the Council of the Shire of Tambellup shall not, in respect of that reserve, exercise the powers referred to in paragraphs (e) and (f) of subsection (1) of section 5 of the Parks and Reserves Act, 1895.

Corres 335/22.—That Reserve No. 18944 should vest in and be held by the Shire of Gnowangerup, in trust for the purpose of Public Recreation.

Corres. 350/68.—That Reserve No. 29606 should vest in and be held by the Shire of Wyndham-East Kimberley, in trust for the purpose of Public Recreation.

1. Land Use Map.

1.5 Interpretation: In this Scheme the terms used will have the respective interpretations set out in Appendix "D" of the Town Planning Regulations, 1967, except the following terms as set out hereunder—

- (a) "Motel" in addition to the definition of a Motel as stated in the Town Planning Regulations, 1967, the following words shall be added—"A Cafe may also form part of such premises."
- (b) "Special Residential Building" means a building, other than a dwelling house, designed for use for human habitation together with such outbuildings as are ordinarily used therewith all to at least the standard and layout stated in the Caravan Parking By-law. The lot or lots shall remain with the Crown and be leased to the Council until twelve months after the main Ord River dam is officially opened, for the sole purpose of housing workers and their families on a site for a period exceeding that permitted by the Caravan Parking By-laws.
- (c) "Trade Display" means the display of goods for advertisement as approved by the Council.

2.2 Table No. 1 appended to Clause 2.3 of this Part indicates the several uses permitted by this Scheme in the various zones, "other than special zones" such uses being determined by cross reference between the list of "Use Classes" on the left-hand side of the Table and the list of "Zones" on the top of that Table. Provided that, where a proposed use is not included in the list of use-classes contained in the Table, the responsible authority may refuse to permit such use in the Scheme Area or may permit it in an area which it deems appropriate.

2.3 The symbols used in the cross reference in Table No. 1 appended to this clause have the following meanings—

- "P" = A use that is permitted under this Scheme.
- "AA" = A use that is not permitted unless approval is granted by the Council.
- "IP" = A use that is not permitted unless such use is incidental to the predominant use as decided and approved by the Responsible Authority.
- "X" = A use that is not permitted.

2.4 Flats, motels and residential buildings are uses permitted only in the special zones so named and indicated on the Scheme Map.

PART III.—NON-CONFORMING USE OF LAND.

3.1 No provision of the Scheme shall prevent—

- (a) the continued use of any land or building for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or
- (b) the carrying out of any development thereon for which, immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended), and any other law authorising the development to be carried out have been duly obtained and was current.

3.2 Where in respect of land zoned under Part II of the Scheme a non-conforming use exists or was authorised as mentioned in clause 3.1 of this Part on that land, and provided the prior consent in writing of the Council has been obtained, buildings may be extended to the limits prescribed by the Uniform Building By-laws made under the Local Government Act, 1960 (as amended), or by any other by-laws made under that Act for the purpose of limiting the size, location and distance from boundaries and any other matter required by law for that class of use within the boundary of the lot or lots on which the use was carried on immediately prior to the coming into force of the Scheme.

3.3 Discontinuance of Non-Conforming Use—

- (a) Notwithstanding the preceding provisions of this Part, when a non-conforming use of any land or building has been discontinued, such land or building shall not thereafter be used other than in conformity with the provisions of the Scheme.
- (b) The Council may effect the discontinuance of a non-conforming use by the purchase of the affected property, or by the payment of compensation to the owner or the occupier or to both the owner and the occupier of that property, and may enter into an agreement with the owner for that purpose.

PART IV.—SPECIAL PROVISIONS.

4.1 Amenity: The Responsible Authority may refuse to approve any plans or development or redevelopment of lots if in its opinion the siting, appearance, design and harmony of the proposed buildings would be detrimental to or destroy the amenities of the neighbourhood, nor shall any building be so constructed, finished or left unfinished that its external appearance would disfigure the locality or tend to depreciate the value of adjoining properties. Further, all land and buildings shall be so maintained as to preserve the amenities of the area in which they are situated.

4.2 Appeals:

- (a) Any person wishing to develop land who is aggrieved by a decision of the Responsible Authority exercising the discretionary powers embodied in Clauses 2.2 and 2.3 of Part II or Clause 4.1 of this part may appeal to the Minister against that decision.
- (b) An appeal under subclause (a) of this clause shall be made within 30 days of receipt of notice of such decision of the original application, the Clause or Clauses under which the decisions was taken, the reasons given for the decision, the Clause under which the appeal is made and the reasons for the appeal.
- (c) The decision of the Minister on an appeal shall be final.

PART V.—FINANCE AND ADMINISTRATION.

5.1 Disposal of Land: The Council may deal with or dispose of any land which it owns or which it has acquired pursuant to the provisions of the Scheme, in accordance with the Act and in conformity with the provisions of the Scheme, and for such purposes may make such agreements with other owners as it deems fit.

5.2 Compensation: Claims for compensation by reason of the Scheme shall be made not later than six months from the date on which notice of approval of the Scheme is published in the *Government Gazette*.

5.3 Entry to Premises: The Council may by an authorised officer enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed.

5.4 Penalties: Any person who fails to comply with any of the provisions of the Scheme is guilty of an offence and without prejudice to any other remedy given herein is liable to such penalties as are prescribed by the Act.
