WHEREAS it is enacted (*inter alia*) by paragraph (b) of subsection (2) of section 14 of the Fauna Conservation Act, 1950-1967, that the Governor may from time to time by proclamation, vary the provisions and operation of a proclamation promulgated pursuant to the power conferred upon him by that section by cancelling those provisions and that operation wholly or in part absolutely; and whereas by a proclamation promulgated in the *Government Gazette* on the 7th August, 1964, the Lieutenant-Governor did, in exercise of the powers conferred by section 14 of the Act, declare (*inter alia*) an open season in respect of Emus, known scientifically as *Dromaius novae-hollandiae*, in that part of the State which lies within the Shire of Bridgetown subject to the restrictions set out in that proclamation: Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by paragraph (b) of subsection (2) of section 14 of the Fauna Conservation Act, 1950-1967, do hereby vary the provisions and operation of the abovementioned proclamation by cancelling the provisions and operation thereof in

so far as they relate to that part of the State which lies within the Shire of Bridgetown.

Specified Conditions.

(ii) at least two able bodied persons fifteen years of age or over are in attendance during the whole of the time in which the fire is burning;

(iii) a hose long enough to reach all parts of the area to be burnt is provided and has water flowing through it continuously during the whole of the time in which the fire is burning; or

- (iv) where reticulated water is not available, alternative fire-fighting equipment of the nature of shovels, rakes, beaters, water in buckets, or similar equipment, sufficient to control the escape of the fire is provided.
- (2) Where the area of the land on which the proposed burning is to take place exceeds one-half of one acre.

Bush may only be burnt provided that a permit to burn is first obtained from an officer appointed by the Council of the municipality in which the land, on which the bush it is proposed to burn, is situated or from an officer appointed by the Fire Brigades Board under the provisions of the Fire Brigades Act, 1942, and amendments and stationed within the Metropolitan Fire District as defined under that Act and that the conditions prescribed in the permit are complied with. (a) On or before the 1st day of November, 1969, to clear of all inflammable material, firebreaks not less than 10 feet wide in the following positions on all rural and townsite land owned or occupied by you and thereafter to maintain the firebreaks clear of inflammable material up to and including the 30th day of April, 1970—
