PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Major-General Sir Douglas TO WIT, DOUGLAS KENDREW, Governor. IL.S.J Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Commander of the Most Excellent Order of the British Empire, Companion of the Distinguished Service Order, Governor in and over the State of Western Australia and Its Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 2 of the Liquor Act, 1970, that that Act shall come into operation on a date to be fixed by proclamation: Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council, do hereby fix the 1st July, 1970, as the date on which the Liquor Act, 1970, shall come into operation.




PART OF METROPOLITAN REGION SCHEME MAP NUMBER 7




STATE FOREST RESERVATION. PART OF METROPOLITAN REGION SCHEME MAP NUMBER 23
