## PROCLAMATION

WESTERN AUSTRALIA, TO WIT, DOUGLAS KENDREW, Governor.

[L.S.] Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Commander of the Most Excellent Order of the British Empire, Companion of the Distinguished Service Order, Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted, inter alia, by subsections (2) and (3) of section 172 of the Companies Act, 1961-1970 that the Governor may, by proclamation, declare that a company is a company to which Division 4 of Part VI of the Act applies and that a declaration shall not be made in respect of a company unless the Governor is satisfied that a prima facie case has been established that, for the protection of the shareholders or creditors of the company, it is desirable that the affairs of the company should be investigated under that Division: now, therefore, I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 172 of the Companies Act, 1961-1970, being satisfied that for the protection of the shareholders or creditors of the company the affairs of Benbullen Graziers & Producers Pty. Ltd. should be investigated under Division 4 of Part VI of that Act, do hereby declare that Benbullen Graziers & Producers Pty. Ltd. is a company to which that Division applies.

AT a meeting of the Executive Council held in the Executive Council Chamber at Perth, this 17th day of June, 1970, the following Order in Council was authorised to be issued:—

Explosives and Dangerous Goods Act, 1961.

#### ORDER IN COUNCIL.

WHEREAS it is enacted, inter alia, by section 14 of the Explosives and Dangerous Goods Act, 1961, that the Governor may from time to time by Order in Council, classify explosives and declare any specified explosive to be an authorised explosive for the purposes of that Act and that the Governor shall not so classify or declare any explosive until the Chief Inspector has defined the composition, quality and character of that explosive; but such definition in respect of the explosive is not required to be published in the Order in Council classifying that explosive; and whereas it is further enacted that an Order in Council made under the said section may be cancelled or from time to time varied by a subsequent Order in Council; and whereas the Chief Inspector has defined the composition, quality and character of the explosive hereinafter mentioned and it is now expedient that the Order in Council made by the Governor on the 22nd day of July, 1964 be varied accordingly: Now therefore, His Excellency the Governor acting with the advice and consent of the Executive Council, and in exercise of the powers aforesaid, doth hereby vary the abovementioned Order in Council by—

(a) adding under the sub-heading, "Division 2" under the heading "CLASS 6—AM-MUNITION" in the schedule to that Order, the item—

400 grain Primacord Initiators (ZZ);

(b) adding under the heading "CLASS 2— NITRATE MIXTURE" in the schedule to that Order, the item—

Nilite 303 (ZZ)

and declare those items to be authorised explosives for the purposes of the said Act, with effect from and including the day of the publication of this Order in the Government Gazette.

THE Shire of Merredin under and by virtue of the powers conferred upon it in that behalf by the Town Planning and Development Act, 1928 (as amended) hereby makes the following Town Planning Scheme.

#### SCHEME TEXT.

#### Citation.

1. This Town Planning Scheme may be cited as Shire of Merredin Town Planning Scheme No. 2—Northern Residential Area Scheme (hereinafter called "the Scheme").

## Responsible Authority.

2. The authority responsible for enforcing the observance of this Scheme is the Shire of Merredin (hereinafter referred to as "the Council").

#### Maps.

3. The following Maps are attached to this Text and form part of the Scheme:—

Land Use Map. Scheme Map.

#### Scheme Area.

4. The Scheme shall apply to the land contained within the inner edge of a broken black line on the Land Use Map. The said land is hereinafter referred to as the Scheme Area. The Scheme area is divided into Special Area A as indicated on the Scheme Map and the Unsubdivided Area being the remainder of the Scheme Area.

#### General Objects.

- 5. The general objects of the Scheme are-
  - (a) To facilitate and co-ordinate progressive subdivision and development of land within the Scheme Area.
  - (b) To plan within the Scheme Area suitable roads.
  - (c) To ensure the proper drainage of the roads and of those parts of the Scheme Area which require drainage or other such works.
  - (d) To have the land within the Scheme Area connected to a sewer.
  - (e) To make provision for land to be used for Public Open Space and Local Authority purposes.

### Method of Carrying Out Objects.

- 6. As and when owners of land within the Scheme Area subdivide their land such subdivision shall be according to a plan which will be capable of forming part of an overall plan of subdivision for the Scheme Area.
- 7. The Scheme Map forms a basis for subdivision and development of the Scheme Area but the Council may with the consent of the Town Planning Board permit alterations or variations to the Scheme Map where in its opinion circumstances justify such action provided that no such alteration or variation shall be permitted if in the opinion of the council it would impede the subdivision and development of the Scheme Area as a whole.

## Subdivision.

8. An owner of land within the Scheme Area who desires to subdivide his land either alone or in conjunction with other owners shall submit a plan of proposed subdivision to the Town Planning Board as required by the Town Planning and Development Act of Western Australia.

#### New Roads.

- 9. Subject to the following clauses all new roads within the Scheme Area shall be constructed and drained at the expense of the owners of land therein and each owner shall when subdividing his land make the land available for the roads and pay the costs of the construction and drainage of the roads within the land owned by him.
- 10. In cases where the situation of a new road within the Scheme Area is such that it would be fair and equitable that the owners of adjoining land should each contribute to the cost of the construction or drainage of that road and apportion the value of the land made available for roads and such owners are unable to agree upon the proportion of the costs payable by each of them the amount (if any) payable by each such owner shall be determined by arbitration in manner hereinafter provided.
- 11. The Council may construct and drain any new roads within the Scheme Area and acquire the land necessary for that purpose. If the Council shall do so prior to the subdivision of the lands adjoining such road the costs of the construction and drainage of the said road and all compensation and other costs consequent upon the acquisition of the land shall be paid to the Council by the respective owners of land in accordance with the foregoing provisions as and when they subdivide their land or after having received not less than three calendar months' notice from the Council whichever shall first happen.
- 12. If an owner shall claim compensation for the resumption from him of land to be used as a road there shall be set off against the amount

- of compensation payable to him the amount by which the value of the remainder of his land has been or will be increased by the construction of the roads within the Scheme Area and by the operation of the Scheme.
- 13. If an owner shall subdivide his land and if he or his predecessors in title shall have claimed or shall have been paid compensation by reason of the resumption by the Council of the land for a new road within the Scheme Area he shall before the approval of his plan of subdivision release the Council from the payment of compensation or repay to the Council the compensation paid by it to him or his predecessors in title as the case may be.

#### Closure of Roads.

14. Surveyed roads within the Scheme Area that are not shown as roads on the Scheme Proposals Map or are shown thereon as roads to be closed shall be deemed to have been closed as from the date on which this Scheme shall come into operation.

#### Sewerage and Drainage.

15. The Council shall at the appropriate time or times carry out such sewerage and drainage works as are in its opinion necessary for the proper drainage of the Scheme Area and the connection of the land therein to a sewer. The Council may acquire land for that purpose and may set aside land for drainage sumps and compensating basins and other works.

#### Public Open Space.

- 16. It is intended that the land coloured green on the Scheme Proposals Map shall be reserved for Public Recreation and Local Authority purposes.
- 17. The Council may as and when it deems fit acquire the said lands coloured green or any parts thereof either by purchase or resumption or partly by one method and partly by the other.
- 18. Each owner of land within the Scheme Area shall when subdividing his land and subject as hereinafter provided transfer to the Council an area of land equal to one-tenth of the total area of land being subdivided or developed by him or such other areas as the Town Planning Board shall upon approval of the Plan of Subdivision require.
- 19. If within a parcel of land the subject of subdivision and development it is not possible to transfer an area of land equal to one-tenth of the total area of land being subdivided the Council may make or receive a cash adjustment so that the value of land (if any) to be transferred with or subject to the cash adjustment equals one-tenth of the value of land the subject of the subdivision.
- 20. If within a parcel of land the subject of subdivision and development more than one-tenth is required by the Council for Public Open Space or Local Authority purposes the owner shall transfer to the Council the land required by it for that purpose and the Council shall pay to the owner by way of compensation the value of the land exceeding the said one-tenth as shall be required by the Council. If the Council so agrees the Council may transfer to the said owner other land in or near the Scheme Area either owned by the Council or acquired by it for that purpose to compensate him for the land in excess of the said one-tenth required by the Council in which case the amount payable by the Council to the owner shall be reduced accordingly.
- 21. The Council may sell or otherwise dispose of any land transferred to or acquired by it for the purpose of Public Open Space or Local Authority purposes provided that all moneys received by the Council in respect of such sales and all moneys received by the Council under Clause 19, hereof shall after making all necessary payments to owners and paying the costs of land (if any) acquired for transfer to owners under Clause 20,

hereof be expended by the Council in the acquisition or improvement of land for Public Open Space or Local Authority purposes in or near the Scheme Area concerned.

If the Council shall have resumed land for Public Open Space roads drainage or Local Authority purposes it shall be reimbursed all compensation and costs paid by it from moneys received by it from the sale of land or under the preceding clauses hereof and upon the owner from whom the land was resumed subdividing his land the value of one-tenth of his land to be made available for Public Open Space or Local Authority purposes hereunder shall be assessed on the basis that such land had not been resumed.

#### Scheme Costs.

- 23. The costs or estimated costs of the following items are hereinafter referred to as Scheme Costs:
  - (a) The administration of the Scheme.
  - (b) The drainage works necessary for the proper drainage of the Scheme Area.
  - The sewerage works necessary for the connection of the land in the Scheme Area to a sewer.
  - (d) All compensation payable and all costs and expenses of determining and settling compensation.
- 24. The Scheme Costs shall be apportioned between Special Area A and the Unsubdivided Area insofar as each of the items of costs refers to each of those areas respectively.

## Payment of Scheme Costs.

25. Each owner shall prior to the final approval by the Town Planning Board to the subdivision of his land or after having received not less than of his land or after having received not less than three calendar months' notice from the Council whichever shall first happen pay to the Council an amount which bears the same proportion of the Scheme Costs for Special Area A or for the Unsubdivided Area according to whichever part of the Scheme Area the land is situated as the area of the owners land bears to the whole of the land within such portion of the Scheme Area. land within such portion of the Scheme Area.

#### Estimate of Scheme Costs.

26. If any of the items of Scheme Costs have not been paid or ascertained at the time of subdivision of a parcel of land or at the time of the giving of a notice by the Council as aforesaid they may be estimated by the Council. An estimate may be revised from time to time.

#### Valuations.

- 27. Where it is necessary to ascertain the value of any land for the purpose of the Scheme the value shall be determined by either the Chief Valuer of the Taxation Department of Western Australia or at the option of the Council by a disinterested and competent valuer appointed by the Council the Council.
- If an owner objects to the value so determined he may give notice of such objection to the Council within twenty-eight days after having been informed of the said value or the revised value. If the valuer does not agree to change the value to a figure acceptable to the owner the value shall be determined by arbitration in accordance with the provisions hereinafter contained.
- 29. If a valuation made by the valuer shall be changed as the result of an objection the valuer may reconsider the values placed on other lands and make such revaluations as he considers just and equitable. The owners affected by such revaluation shall forthwith be notified of any change in values.

### Land Owned or Acquired by the Council.

30. All or any of the land now owned by or subsequently acquired by the Council within or near the Scheme Area may be used by the Council for any purposes appropriate to the Scheme. If such purpose is one for which an owner is required to make land available or for which land may be acquired by the Council pursuant to this Scheme the Council shall be compensated for the value of the land so used by the Council. 31. Any dispute or difference between the owners as to their respective rights under the Scheme and any matter which by the terms of this Scheme may be determined by arbitration may be referred to the arbitration of a single arbitrator in manner provided by the Arbitration Act 1895 or any statutory modification thereof for the time being in force and if the parties fail to agree upon any one single arbitrator he may be nominated by the Chief Valuer of the Taxation Department of Western Australia.

## Powers and Authorities of Council.

- 32. In carrying out the provisions of the Scheme the Council shall have the following powers and authorities:-
  - (a) To enter and inspect any land within the Scheme Area.
  - (b) To make agreements with the owners or occupiers of any land within the Scheme area.
  - To enter into agreements with purchasers or prospective purchasers or prospective occupiers of land within the Scheme Area.
  - (d) If any owner of land within the Scheme Area does not proceed with the subdivision or development of his land in accordance with the terms of the Scheme or by reason of the nature of his land is unable to subdivide or develop it and his failure to do so in the opinion of the Council will unduly delay the subdivision and development of the Scheme Area the Council may resume or purchase the land of such owner or owners or any part or parts thereof and proceed with the subdivision and development of the said land in accordance with the provisions of the Scheme.
  - (e) In the event of the Council exercising its powers under clause (d) it shall have all the powers of an owner in the subdivision development and disposal of the said land; and if the owner shall not have been paid compensation by reason of the resumption the Council before selling the land so subdivided and developed shall offer the new lots to the original owner upon his paying to the Council all costs and expenses consequent upon the resumption subdivision or development of the said land and upon or development of the said land and upon his releasing the Council from all claims for compensation in respect of such resumption. The said offer shall be made in writing and if not accepted within one calendar month of the service thereof the Council may proceed with the sale of the subdivided lots. All moneys received by it from such sale shall be applied firstly in payment of all costs and expenses consequent upon such subdivision and secondly in payment of all compensation in respect of the resumption of the said land. balance if any of such moneys may be retained by the Council and the Council shall make good any deficit.
  - (f) If the offer mentioned in clause (e) hereof be not accepted the Council may retain all or any part of the said land but if it does so it shall be responsible to pay such costs of subdivision of the said land and compensation for its resumption as are then unpaid.
  - (g) To resume any land within the Scheme Area for Public Open Space or Local Authority purposes.
  - (h) To dispose of any lots to which it becomes or otherwise upon such terms and conditions as it may think fit and without limiting the generality of the foregoing the Council may sell the lots singly or in groups and on the condition that buildings

of a specified character with specified parking or other facilities shall within a limited period be constructed thereon or that the land and buildings be used for a specified purpose.

- (i) Extend the time within which payments are to be made to the Council and agree to the securing of such payments.
- 33. Twenty-eight days' written notice is hereby prescribed as the notice to be given pursuant to section 10 of the Act. Any expenses incurred by the Council under the said section may be recovered from the person in default as a simple contract debt in such Court of Civil Jurisdiction as is competent to deal with the amount of the claim.
- 34. The Council may at any time exercise the powers conferred by section 13 of the Act.

### Claims for Compensation.

35. Claims for compensation by reason of the operation of this Scheme may be made within six months of the Scheme coming into operation.







Principal 1. In these regulations the Fisheries Act Regulations published regulations in the Government Gazette on the 6th May, 1938, and reprinted as amended pursuant to the Reprinting of Regulations Act, 1954, and published as so reprinted in the Government Gazette on the 30th May, 1967, and amended from time to time thereafter by notices published in the Government Gazette, are referred to as the principal regulations.

Reg. 3F

2. Regulation 3F of the principal regulations is revoked and re-

revoked and remade. made as follows:—

3F. (1) Subject to subregulation (2) of this regulation, every license issued under these regulations, except an exclusive license issued pursuant to the provisions of the Act, shall expire on the 31st December next following the date on which it is issued, but this shall not be construed so as to prevent the issue on payment of the appropriate fee of a renewal of any license within one month prior to the expiry date of the license being renewed; and notwithstanding anything to the contrary contained in these regulations, the fee for every fishing boat license issued on or after the 1st July in any year shall be one-half of the annual fee prescribed for that license.

(2) Every amateur fishing license and inland fishing license shall expire on the 30th June next following the date on which it is issued except that every amateur fishing license bearing an expiry date of 31st December, 1970, shall be deemed to expire on 30th June, 1971.

Reg. 15A amended. 3. Regulation 15A of the principal regulations is amended by adding after the word "crabs" in line three of subregulation (3) the passage "in any river, estuary or inlet".

## HEALTH ACT, 1911-1968.

#### SCHEDULE.

## PRIVATE HOSPITALS REGULATIONS, 1970

- 1. These regulations may be cited as the Private Hospitals Regulations, 1970.
- 2. The Private Hospitals Regulations published in the Government Gazette on the 9th February, 1945, and reprinted in the Government Gazette of the 9th February, 1967, pursuant to the Reprinting of Regulations Act, 1954, incorporating the amendments thereto published in the Government Gazettes of the 20th March, 1963, the 8th January, 1965, and the 9th March, 1966, and the amendments that, pursuant to the provisions of section 8 of the Decimal Currency Act, 1965, are deemed to be amendments to those regulations, are subject to regulation 3 of these regulations, revoked.
- 3. The registration of a private hospital granted pursuant to regulation 7 of the regulations revoked by regulation 2 of these regulations, that was in force immediately prior to the coming into operation of these regulations, shall remain in force and be subject to the same rights and liabilities as were provided under the regulations so revoked, until the 31st December, 1970, but thereafter the provisions of these regulations apply to any re-registration of, or any other matter concerning or affecting, that private hospital.
  - 4. In these regulations unless the contrary intention appears-
    - "application" means any application for registration of a private hospital whether an original application or an application by way of renewal; "approved" means approved by the Commissioner;
    - "conduct" in relation to a private hospital means to open, occupy or maintain a private hospital or to cause any private hospital to be kept open, occupied or maintained;
    - "general private hospital" means any private hospital that is not a nursing home as defined by this regulation;
    - "nursing home" means any private hospital to which only patients who require medical supervision but not constant medical attention are admitted:
    - "original application" means an application to register as a private hospital any premises that are not, at the time the application is made, already so registered.
- 5. (1) Every application shall be made in accordance with the form of Form No. 1 set out in the First Schedule to these regulations and shall be accompanied by the appropriate fee calculated in accordance with the Second Schedule to these regulations.
- (2) Where the application is an original application, the applicant shall cause notice of the application to be published in a newspaper circulating in the district in which the private hospital is to be established and the Commissioner shall not grant the application until at least one month has elapsed after the publication of the notice.
- 6. Every application other than an original application shall be made to the Commissioner not later than the 30th day of November in the year immediately preceding the year with respect to which the application is made.
- 7. (1) The Commissioner shall grant an application for registration of a private hospital, where the applicant satisfies the Commissioner that—
  - (a) the applicant or other person who conducts or will conduct the premises the subject of the application, as the case may be, is a fit and proper person to conduct the private hospital;
  - (b) the premises the subject of the application comply with those provisions of regulations 8 to 24 of these regulations which apply in relation to that particular hospital.
- (2) Where the Commissioner grants an application, he shall issue to the applicant a certificate of registration in accordance with the form of Form No. 2 set out in the First Schedule to these regulation.
- (3) The Commissioner, when granting an application, may impose such conditions as he thinks fit with respect to—
  - (a) the maximum number of patients that may be admitted to the hospital at any one time; and
- (b) the class of cases that may be admitted to the hospital, and shall cause those conditions to be set out in the certificate of registration issued to the applicant.
- 8. Every room in a private hospital occupied or intended for occupation by a patient—
  - (a) shall be independently and efficiently ventilated to the external air;
  - (b) shall be provided with windows in the external walls so that there is a ratio of one square foot of clear glass to each ten square feet of floor area of the room; and
  - (c) shall contain for each patient a standard hospital bed, a bedside locker with impervious surfaces, a wardrobe, an innerspring mattress and two pillows, a chair and a bed-lamp.
- 9. Every room in a private hospital occupied or intended for occupation by a single patient shall, in addition to the requirements of regulation 8 of these regulations, have at least one hundred square feet of floor area.
- 10. Every room in a private hospital, occupied or intended for occupation by more than one patient shall, in addition to the requirements of regulation 8 of these regulations, have—

- (a) at least eighty square feet of floor area for each patient;
- (b) a distance of at least eight feet between bed centres;
- (c) no bed placed lengthwise against a wall; and
- (d) individual bed screens
- 11. Where a private hospital is also licensed as a maternity home under the Act, there shall be provided—
  - (a) birth rooms located in such a position that pedestrian traffic does not pass through them, and which are in the ratio of one to every ten midwifery beds and each of which rooms has—
    - (i) minimum dimensions of 16 feet by 13 feet; and
    - (ii) the head of any bed located against one of the longer walls;
  - (b) patient toilet facilities adjoining or conveniently accessible to each birth room;
  - (c) a sufficient number of general nurseries containing not more than eight bassinets of a type approved by the Commissioner mounted on suitable stands and with at least thirty square feet of floor space for each bassinet;
  - (d) a sufficient number of isolation nurseries containing not more than six bassinets of a type approved by the Commissioner mounted on suitable stands and with at least forty square feet of floor space for each bassinet;
  - (e) in each nursery, a scrub up basin, stainless steel sink and bench, adequate storage for linen and other supplies, soiled linen receptacles, weighing scales, oxygen and suction facilities, and such other items as required by the Commissioner.
- 12. The inner surfaces of every wall and ceiling in a private hospital shall be so constructed that they can be frequently washed and disinfected without sustaining damage.
- 13. The external walls and the roof of a private hospital shall be weather proof and the roof shall be provided with gutters, downpipes and drains to carry off all rainwater falling on the building to a distance of at least six feet from the walls of the building.
- 14. The drainage system of a private hospital shall be, in the opinion of the Commissioner, adequate and comply with the by-laws of the local authority.
- 15. The water supply to a private hospital shall be abundant and whole-some.
- 16. Ablutionary and sanitary conveniences in a private hospital shall be provided in a ratio of at least one shower, one water closet and one hand basin for every eight patients or proportion thereof, together with at least one island plunge bath, available to patients, on each floor.
- 17. A laundry shall be provided in a private hospital together with sufficient appliances to cleanse and disinfect all bedding, clothing, linen, napery and other similar articles.
- 18. Adequate accommodation shall be provided for staff living on the premises of a private hospital.
- 19. Bathrooms, toilet facilities and change rooms shall be provided for living out staff in addition to any accommodation provided under regulation 18 of these regulations.
- 20. Sufficient storage space shall be provided in a private hospital for all food, drugs, linen, appliances and utensils necessary for the proper conduct of the hospital.
  - 21. Every private hospital shall be provided with-
    - (a) separate toilet facilities for each sex, clearly distinguished by signs, for use by the public;
    - (b) on each floor, not less than one water closet that is capable of accommodating a wheel-chair and is 4 feet wide by 5 feet deep with the pedestal positioned 18 inches from side wall to bowl centre;
    - (c) doors which open outwards on water closets, bathrooms and shower recesses;
    - (d) a chair in each bathroom:
    - (e) grab bars of a type approved by the Commissioner, fitted in an approved manner in shower recesses, water closets and near plunge baths;
    - (f) guide rails in corridors frequented by patients;
    - (g) emergency lighting for use in case of power failure, in operating rooms, birth rooms, nurseries and out-patients areas;
    - (h) an emergency patient-to-nurse communication system at each bed and in bathrooms and toilets; and
    - (i) heating and cooling appliances installed in all areas of the hospital frequented by patients.
- 22. (1) Every general private hospital shall have an operating theatre suite, located in such a position that pedestrian traffic does not pass through it to other parts of the hospital and containing—
  - (a) either a major operating room of at least 20 feet by 18 feet in dimension or a minor operating room of at least 18 feet by 16 feet in dimension:

- (b) sterilizing facilities situated near the operating room and including a hi-speed autoclave;
- (c) scrub-up facilities, adjacent to the operating room;
- (d) a utility room, containing a counter, clinical sink, waste and soiled linen receptacles;
- (e) storage for sterile supplies, unsterile supplies, anaesthetic agents, surgical and monitoring equipment, medications, nitrous oxide and for oxygen if it is not piped in;
- (f) a room containing lockers where personnel can change clothing; and
- (g) such other basic operating requirements as are approved from time to time by the Commissioner.
- (2) All floors in anaesthetic areas and rooms used for the storage of gases in a general private hospital shall conform to Australian Standard C.Z.9.
  - 23. Every private hospital shall have-
    - (a) a kitchen with space and equipment appropriate for-
      - (i) food preparation;
      - (ii) cooking:
      - (iii) handling and serving food;
      - (iv) washing up, consisting of a double bowl stainless steel sink and bench:
      - (v) hand washing; and
      - (vi) the storage of perishables, frozen goods, dry goods, bread, crockery and cutlery, and shall also have cleaning materials, facilities for garbage disposal and, in hospitals with over 20 beds, a cook's sink and bench;

- (b) a day room or lounge, appropriately furnished;
- (c) a separate dining room for the use of patients which has an approved capacity and is appropriately furnished;
- (d) a pan room containing-
  - (i) impervious storage racks of an approved kind;
  - (ii) a slop hopper;
  - (iii) a macintosh rail;
  - (iv) a pan sterilizer;
  - (v) a 24 inch stainless steel trough and stainless steel bench; and
  - (vi) impervious floor coverings;
- (e) a treatment room containing-
  - (i) a medicine cupboard with built in security locker for narcotics;
  - (ii) adequate storage for equipment and supplies;
  - (iii) a stainless steel sink and drainer;
  - (iv) a work bench with an impervious top;
  - (v) a small high pressure sterilizer for dressings and instruments: and
- (f) scrub up facilities in or adjacent to wards.
- 24. In every private hospital-
  - (a) all windows and outside doors shall be flywired; and
  - (b) rooms shall be numbered.
- 25. Where a change in ownership or conduct of a registered private hospital occurs, the registration of that private hospital lapses until the consent of the Commissioner to the change has been obtained in writing.
- 26. (1) Subject to subregulation (2) of this regulation, the registration of a private hospital granted under these regulations—
  - (a) in the case of an original application—has effect on and from the date of issue of the certificate of registration and expires on the 31st day of December in the year in which that certificate was issued;
  - (b) in the case of any other application; has effect from the 1st day of January to the 31st day of December, in the year immediately following the year in which the application is made.
- (2) The Commissioner may cancel the registration of a private hospital where-
  - (a) the private hospital ceases to comply with the requirements for registration set out in regulation 7 of these regulations;
  - (b) a breach of any condition on which the registration of the private hospital was granted, occurs; or
  - (c) an offence against these regulations is committed at the private hos-
  - 27. Every person who conducts a private hospital shall-
    - (a) accept only those patients recommended for admission by a medical practitioner;
    - (b) at all times, give access to every part of the premises to a medical officer, or Public Health Official, and afford to any of these officers any reasonable assistance that they may require for the purpose of making an inspection of the premises;
    - (c) at all times, exercise a close personal supervision of the premises and of the persons employed therein or thereon, and cause all orders or directions of a medical practitioner in charge of the treatment of any patient to be diligently carried out;

- (d) keep and maintain upon the premises, all materials, equipment and appliances necessary for the proper care of the patients and shall provide any additional equipment and appliances as may be directed by the Commissioner from time to time;
- (e) ensure that meals are prepared with due regard for nutritional and aesthetic aspects and that weekly menus are available for inspection;
- (f) ensure that animals and birds are not allowed on the premises;
- (g) at all times, keep all household linen, beds, bedding, furniture, cutlery, crockery, cooking and other utensils and all other things used in the conduct or management of the hospital, thoroughly clean and disinfected;
- (h) not permit persons of different sexes to occupy the same room except married couples or children under the age of twelve years, who should be accommodated in a ward separate from adults except in the case of a mother admitted with children;
- not permit more than one married couple to occupy the same room at the same time;
- (j) provide separate approved airtight receptacles into which all used surgical dressings, human tissues or fluids shall be placed;
- (k) cause all infected wastes, condemned linen or clothing and the matter referred to in paragraph (j) of this regulation to be burnt, or disposed of in any other manner as may be directed by a Public Health Official;
- (1) ensure that at least ten per cent. of the beds in the hospital have adjustable height facilities;
- (m) cause to be carried out forthwith all orders or directions that may be given him in writing from time to time by a medical officer of health or an inspector, with respect to sanitary arrangements, the collection and disposal of excreta, refuse, or liquid and other wastes.
- 28. (1) Every person who conducts a private hospital shall cause the private hospital to be so conducted as to comply at all times with the provisions of these regulations, and where the hospital is not so conducted and maintained, the Commissioner may, by notice in writing given to the person conducting the hospital, require him to carry out within a time specified in the notice. any work the Commissioner considers necessary to ensure that the hospital will comply with those provisions.
- (2) The Commissioner may suspend or may cancel the registration of a private hospital where the person conducting the hospital fails to carry out. within the specified time, the work required by the Commissioner pursuant to a notice given under subregulation (1) of this regulation.
- 29. A person conducting a private hospital shall not be absent from the hospital unless a responsible person is left in charge thereof and in any case shall not be absent from the hospital for a period exceeding one week without notifying the Commissioner of the name of the responsible person so left in charge.
- 30. A person conducting a private hospital in which notifiable infectious or contagious disease occurs or is suspected shall—
  - (a) immediately report the fact to the Commissioner;
  - (b) cause forthwith, the patient discovered, or suspected to be so suffering, to be isolated from all other patients in the hospital; and
  - (c) carry out forthwith the requirements of a Public Health Official and execute all cleansing and disinfecting as may be directed by that officer.
  - 31. A person conducting a general private hospital shall-
    - (a) where the hospital is also a licensed maternity home under the Act, provide for obstetrical patients to be treated in a ward or wards of the hospital set apart exclusively for that purpose;
    - (b) provide for surgical patients to be treated in a ward or wards of the hospital used exclusively for that purpose;
    - (c) not permit any obstetrical or surgical patient to be treated in the same ward as any other class of patient.
- 32. (1) A person conducting a private hospital shall keep and maintain a Register of Patients and shall cause to be recorded therein, in respect of each nation.
  - (a) full name;
  - (b) age;
  - (c) sex;
  - (d) home address;
  - (e) marital status:
  - (f) name and address of doctor or nurse under whose professional care the patient had been, immediately prior to admission; and
  - (g) a short history of the patient's stay in hospital stating particularly—

     (i) the name of admitting doctor and of doctor or doctors treating patient during stay;
    - (ii) the date of admission;
    - (iii) the nature of any disease manifest at the time of admission or that occurs after admission;
    - (iv) the description of any operation performed on the patient together with the name of the person or persons who operated and the result of the operation; and
    - (v) the date of discharge from hospital or, in the event of death, the date of death.

- (2) Where the hospital is also a licensed maternity home under the Act, there shall also be recorded in the register maintained under subregulation (1) of this regulation in respect of each patient admitted for confinement, the date of and a short history of the confinement, stating particularly—
  - (a) the date and time of the confinement and whether live-birth, still-birth or abortion;
  - (b) the weight and height of the infant;
  - (c) the sex of the infant or infants; and
  - (d) the condition of the mother and infant during their stay in hospital.
- 33. The Register of Patients kept pursuant to these regulations shall be made available, on demand, for inspection by a Public Health Official.
- 34. A person conducting a general private hospital shall forward to the Commissioner on the last day of each month a complete record of all patients discharged during that month substantially in accordance with the form of Form No. 3 in the First Schedule to these regulations.
- 35. A person conducting a private hospital shall not suffer or permit the number of patients accommodated in the hospital at the one time to exceed the number determined by the Commissioner and set out in the certificate of registration.
- 36. (1) A person conducting a general private hospital shall at all times maintain a nursing staff of the following numbers and with the following qualifications:—
  - (a) in a ratio of not less than one registered general trained nurse to every three patients or proportion thereof, but where a ward or wards of the hospital are set apart exclusively for obstetrical patients, the nursing staff for that section of the hospital may be in the ratio of one registered midwifery nurse to every four patients or proportion thereof accommodated in that section;
- (b) a sufficient number of nursing aides or nursing assistants to ensure proper patient care, and at all times there shall be on duty at least one registered nurse and where obstetrical cases are accommodated at least one registered midwifery nurse shall be on duty at all times.
- (2) A person conducting a nursing home private hospital shall at all times maintain a nursing staff of such numbers and with such qualifications that there is at least one registered general trained nurse to every ten patients or proportion thereof and so that, at all times, there shall be available at the hospital at least one registered general trained nurse and a sufficient number of nursing aides or nursing assistants to ensure proper patient care.
- 37. (1) Where by these regulations anything is directed or forbidden to be done, or authority is given to any Public Health Official to direct, or forbid anything to be done, and that authority is exercised, any person failing or neglecting to do anything so directed, or doing anything so forbidden, commits an offence.
- (2) Any person guilty of an offence against these regulations is liable to a penalty not exceeding two hundred dollars and in the case of a continuing offence to a penalty not exceeding four dollars for each day the offence continues.

#### Schedule.

#### INSTITUTE TRAFFIC BY-LAWS.

- In these by-laws unless the contrary intention appears—
   "permit" means a permit to park a vehicle, issued in accordance with these
   by-laws;
  - "sticker" means a parking sticker issued in accordance with these by-laws; "visitor" means a person who enters upon Institute land, other than a member of the staff or a student.
- 2. Separate areas of Institute land shall be set aside for vehicle parking for staff, students and visitors respectively.
- 3. (1) The Council may issue a permit to park a vehicle in accordance with these by-laws, in vehicle parking areas on Institute land.
- (2) An application for a permit shall be made in writing to the delegate of the Council and shall contain particulars of the make, type and registration number of vehicle and in the case of students shall include the student's registration card number.
- (3) If the holder of a permit changes the vehicle, or the registration number of the vehicle, in respect of which the permit has been issued, he shall forthwith give notice in writing to the delegate of the Council.
- 4. A permit shall be in the form of a coloured sticker signed by the delegate of the Council and shall, subject to by-law 14, be current until the date of expiry mentioned thereon.
- 5. Stickers shall be affixed to vehicles in such a manner that they are clearly visible to a person inspecting the exterior of the vehicle.
- 6. The delegate of the Council may, by notice placed on or near a parking bay in a parking area on Institute land, reserve that parking bay for a specific purpose of specific person.
- 7. A yellow sticker affixed to a car in accordance with by-law 5 of these by-laws entitles a member of the Institute staff to park that car, during the currency of his permit, in an unreserved parking bay in that section of the parking area set aside for staff, unless the Council has varied or suspended the terms of the permit for a special occasion.
- 8. A red sticker affixed to a car in accordance with by-law 5 of these by-laws entitles a student to park that car during the currency of his permit in an unreserved parking bay in that section of the parking area set aside for students, unless the Council has varied or suspended the terms of the permit for a special occasion.
- 9. Any sticker affixed to a motor cycle in accordance with by-law 5 of these by-laws entitles the holder of the permit to park that motor cycle, during the currency of the permit, in the section set aside for motor cycles in the parking area for which he has a permit.
- 10. (1) A visitor to the Institute may park a vehicle in an unreserved parking bay in that section of the parking area set aside for visitors.
- (2) A visitor to the Institute shall not park a vehicle on Institute land except in accordance with these by-laws.
- 11. A member of the staff or a student shall not park a vehicle on Institute land without a permit.
- 12. A person who holds a permit shall not park a vehicle on Institute land except in accordance with the terms of the permit as set out in these by-laws.
  - 13. A permit is not transferable.
- 14. (1) The Council may revoke a permit where the holder has been convicted of a breach of the by-laws or is no longer associated with the Institute.
- (2) The Council may for special occasions vary or suspend the terms of a permit for such time as it deems necessary.
- 15. A person shall not, unless specifically authorised by the delegate of the Council, drive a vehicle on any part of Institute land other than a road intended for vehicular traffic.
- 16. A person driving a vehicle on Institute land shall comply with any traffic signs exhibited on the land.

Where an authorised officer alleges that a vehicle is parked in contravention of these by-laws he may affix a ticket to the vehicle and include on the ticket details of the alleged offence.

18. A person who commits a breach of any of these by-laws is, in addition to any other legal liability, liable to a penalty of ten dollars.
